

THE PROOF.

We are not like the "pious old man" of the Lynchburg Virginian in any respect—thank God! More especially do we not make charges we are not able to sustain—neither do we try to conceal our weakness by ridicule of an adversary.

The following from the Virginian is characteristic of the Virginian and the writer: "The little fellow whose name appears as a figure-head in the columns of the PATRIOT AND HERALD, and who has now gone to Richmond to get his pay, in the shape of a clerkship, for serving the dishonest cause of his Boss, affects to regard us as being 'venomous,' because we are trying to make the Virginian 'a terror to evil doers, and a praise to them that do well.'"

"Why we can prove that you, eight months ago, regarded the payment of the debt of Virginia with indifference. But your political honesty is manufactured to suit the occasion."

Now, the dear little fellow must have had a strange faculty for reading between the lines, to imagine that the Virginian ever regarded the public debt with "indifference." But let him prove the charge, or be content to accept the graver one of having deliberately borne false witness.

Now if the "pious old individual of the Virginian" means to convey the idea that the PATRIOT AND HERALD is owned or edited by any one else than the man whose name appears at the head of his columns he only adds one more laurel to his fame as the chief of Pharisees of his party and its press, in that he deliberately bears false witness.

As to our knowledge of "State pride" we would hardly apply to the political Jesuit of the Virginian for an increase or true knowledge of the same were we deficient in either particular.

The following which appeared in the Virginian last Spring, about eight months ago, tells whether we have deliberately borne false witness:

We have labored earnestly to hold the Conservative people of Virginia to a sense of their obligation in this behalf, and strove to make them see that reputation would be dishonored to the State, as well as unjust to the people, if they were understood just where the Republican party professed to stand—on the high ground that public credit and public honor are worth infinitely more than a mere party triumph; and, although the most of our State bonds are held by northern people, and by Europeans—by people who have been hostile to us in peace and in war; we have preferred to set a high example of good faith and public morality. But now that this party, which affects to hold reputation in the greatest honor, has seen fit to take to their arms the leader of the faction of repudiators in this State, and, to achieve a temporary triumph, have bargained with him, to give to his repudiating followers, and especially his chief lieutenant, the author of the bill in which reputation was formulated, and its exact measure determined, we are absolved from all obligation to Northern bondholders and shall leave them to collect their debt as best they can. The Republican party has accepted Mahone, with his principles; and its Senators in Congress have championed the cause of the man who would revolutionize our State Courts, even the highest, and array them in hostility to the Supreme Court of the United States. It is their funeral now, not ours; and we wash our hands of the whole matter, and will look only to the material welfare of the good people of Virginia, and leave Mahone and his Republican confederates, to deal with the bondholders in any way they may elect.

The very honest (?) pious old man of the Virginian says, "we wash our hands of the whole matter," the very words in substance of Pontius Pilate, the biggest coward in Holy writ and slightly tainted with hypocrisy.

If ever we were the "organ grinder" of Fayette McMillin, we were the grinder for a better man than the editor of the Virginian. He was a brave man, and not a hypocrite.

THE Legislature of Va. met at Richmond on yesterday; but we have not heard what it did with regard to organization.

Mr. John E. Powell, of Nelson county, lost his barn and entire tobacco crop by a fire a few days ago. The loss on the barn was \$1,000; on tobacco, \$3,000.

Amherst New Era: We hear of one gentleman in the county who made a vote at the late election by nursing the baby of the voter while he went to the polls.

Pittsylvania Tribune: Capt. Joseph H. Seales, living above Cascade in this county, sold to a Northern sportsman a few days ago his fine red Irish setter for \$150.

Blue Ridge Echo: Mr. P. P. O'Bannon, an enterprising merchant of Sperryville, has shipped during the last three months 7,000 bushels of apples to Washington, D. C.

Harrisburg Spirit: The franking privilege of Judge Harris, our former member of Congress, expired on Wednesday night, the 30th of November, at 12 midnight, precisely.

Boston Post: Two men in Virginia recently came to blows over the question, "Which caught the biggest fish?" Strange that men should fight for the honor of champion liar.

Director General Kimball has designated Thursday, December 8th, as Norfolk's day at the Atlanta Cotton Exposition. On that day the delegation from Norfolk will be formally received.

Fincastr Herald: Over 350 men are at work at Roanoke leveling the hills for the new portion of that town and the contractors are advertising for more. They drill all day and all night, when there is less danger of accident.

Rocky Mount (Weekly) Journal: Some of the gentlemen interested in iron mining in this county were in town this week, and we heard a rumour that there is some likelihood of the mines near this place being worked again before long.

Nelson county Examiner: Last Friday morning Mr. Abram Smith's family went out to breakfast, leaving a young child asleep in a cradle. Returning they found the room and the cradle in a blaze. The child was so badly burned that death followed in a few hours.

Page Courier: During a religious meeting recently held at Berryville the financial secretary a man named Dungee, was robbed of \$1,500 of solvent bonds and \$14 of currency belonging to the order of which he was a member. They were taken from the valise in Dungee's room at his boarding-house in that town.

Luray (Page county) Advance: We learn from the gentleman near Shenandoah Iron Works that Mr. A. E. Kauldie has some seven or eight of the finest iron mines in Virginia. This prosperous and energetic gentleman will commence active operations in about six weeks. Mr. Kauldie, through his energy and zealous labors, has secured a fortune.

The Virginia Star, organ of the colored people at Richmond, says: "Hundreds of colored people have failed to be vaccinated, trusted in the merits of a bag of roots and other stuff sold them by some graceless scoundrel and which they wear around their necks next to their skin vainly believing that it protects them against the small-pox."

Mr. Gus Belcher, who lives in Chesterfield, about fourteen miles from Petersburg, was on his way home Friday when he met two of his neighbors on the road, from whom he learned for the first time that he was homeless—his house having been burned down during the day. Loss, about \$1,200, and uninsured.

The town Council of Harrisonburg has re-elected Chief of Police Braithwaite, who had no opposition. The Harrisonburg Spirit of the Valley says: "Mayor Bryan make a speech and an effort to defeat George W. Willis (on the ground, we suppose, of Willis having voted the Readjuster ticket, for surely no charge can be made that he is not an efficient and honest officer), but to the credit of the Council, we will add, seven voted for Willis to two against him."

Manufacturers in the South.

Mr. Atkinson brings a very weak array of reasons to the support of his proposition that the South cannot compete with the North in manufacturing, and his statements are not free from mistakes. The southern mills do not depend upon the local demand for the sale of their goods. Their markets are in New York, Philadelphia, and Chicago, as well as Augusta, Charleston, Savannah, and Atlanta. As to the question of operatives, the supply of skilled spinners and weavers is not at present large in the South, but neither was it large in New England at a corresponding period in the history of her manufactures; and it is absurd to suppose that operatives cannot be found in the South who will equal the French Canadians. Moreover, Mr. Atkinson seems to forget that wages of operatives in Georgia are 55 or 60 cents a day, and in Massachusetts from 80 cents to \$1. In Lowell or Fall River, where sufficient water-power is not to be had, it may please manufacturers to indulge in comforting illusions as to the superiority of the steam engine over the water wheel, but so long as the latter does its work equally well and at an expense a little less than half that of steam, the advantages vaguely alluded to by Mr. Atkinson are not apparent. The objection based on the existence of the manufacturing habit in the North is sentimental and flimsy. It has not long been the habit of the people of Patterson to make silks or of those of Trenton to make potteries. For that matter, the hog habit—there is really no limit to which this absurdity may not be carried—is of recent growth in Chicago and Cincinnati. Yet in each of these cases the industries have met with unmistakable success. —N. Y. Times, 25th ult.

A severe shock of earthquake occurred at Agram on Wednesday night.

Perry's petroleum stores at Temple-back, Bristol, England, were burned Wednesday night. Hundreds of barrels exploded throughout the night and the explosion continued.

The Court of Queen's Bench, London, Justices Field and Cane, have granted Mr. Willis' application for a rule nisi for a new trial of the Scotts-amun lime case, on the ground that as the plaintiff sought damages for defamation, of character the defendant's counsel should have been allowed to question him on matters affecting character.

The permanganate of potash hypodermically injected is authoritatively pronounced an efficient antidote to snake poison. It is thought that it may prove effective in cases of hydrophobia. The discovery is an important one.

Dr. Wormley's work on the "micro-chemistry of poisons" has depleted Columbus, O., of its cat species. More than 3,000 of these animals were sacrificed in the course of the tests and experiments required to illustrate that book.

The testimony of Guiteau's brother seems to show a mind divided between a desire to maintain the credit of the family and an honest conviction that the assassin deserves hemp.

Both in appearance and manner the brother is the very antipode of the prisoner. He is esteemed a man of sound sense.

It is to Mr. Keene's colt that Englishmen must look for a sire capable of infusing new vigor and stamina into what must, we fear, be pronounced a declining breed of horses; and it would be a singular climax to Foxhall's unique career if some wealthy English purchaser should induce Mr. Keene—which we think little likely—to part with the grandest horse in existence.—*London Field.*

BLACKBERRY CORDIAL.

The blackberry is said by chemists to have a remarkable effect as a tonic. Blackberry juice is recommended for nervous exhaustion. Put the Blackberries in a preserving kettle over the fire, mash them down with a wooden spoon as they heat until all the juice is boiled out. Strain through a cloth into a bowl; measure the juice. If you want to make plain syrup add one-fourth the quantity of good brandy to the juice and bottle. In cordial, allow two teaspoonfuls of ground cloves, ditto mace, ditto allspice, and four of cinnamon to each quart of the juice. Boil like simple syrup skimming carefully. Add the spices after you have removed the scum, and boil again till syrupy. Strain out the spices through a fine muslin. When cold add a pint of whiskey to every quart of syrup. Bottle immediately and cork. If you use brandy for the cordial the portion is one-fourth of your measure of the blackberry juice.

POINTS IN CAKE MAKING.

The butter should be perfectly sweet and free from buttermilk; the butter and sugar should be thoroughly beaten together. Powdered sugar is preferable to granulated, as the latter is slow in dissolving; the whites of the eggs should be beaten to a stiff froth, and added to the sugar, fruit should be rolled in flour and added at the last moment: Soda should be pulverized and sifted into the cake with the flour. The hand, or a wooden spoon, is best for mixing cake. An important point is the heat of the oven. The cake should begin to bake at once, but should not brown immediately, the oven door should be seldom opened while the cake is in. The gem-pans are excellent for backing cake, first heating them as for Graham gems.

Ribbons which are very much soiled can be made clean, and will look almost like new ones, if washed in ammonia and water. Use half a teaspoonful of ammonia to one pint of water. Some ribbons, after washing or sponging, do not need to be ironed, and in fact are injured by it. These should be fastened to a table or long ironing board, and when perfectly smooth let them alone until they are dry. If they are all wrinkled when dry, lay a cloth which is slightly damp over them and press with a hot iron. Black silk, if sponged with cold coffee and ammonia, will be wonderfully freshened. Use a flannel cloth to remove dust from silk.

A starving tramp will scarcely excite sympathy at the kitchen door now unless he says he has been without food for forty days, and then he will run the risk of being denounced as a fraud.

To say that one should not shout before he gets out of the woods is absurd. The woods is the place for a man to shout. When he gets out he should go and take his drink quietly if he is not a candidate.

THE EVILS OF WEALTH

When Samuel Johnson, the literary autocrat of London in the last century, had been thrown over a handsome mansion, he remarked, "All this includes only one evil—poverty." Trouble, sorrow, affliction, death, are not kept off by wealth. But Dr. Johnson's remark contained only half the truth. Wealth brings also troubles from which the poor are free.

I has its own annoyances and inconveniences which are not seen in the eager pursuit. The contemplation of these may nourish contentment in those who are not wealthy.

Wealth means care. Riches have wings, and they need to be constantly watched. This care takes time and thought might be better used on other subjects. It is apt to encroach upon the Sabbath and invade the sanctuary. It interferes with the pleasures which might otherwise be enjoyed.

The necessary care of wealth produces anxiety. The wealth is necessarily distributed. It cannot be hoarded in one place. If hidden in the earth it is useless to its owner. In order to be useful, it has to be entrusted to others. The greater the wealth the more persons have to be trusted. The rich man has no positive assurance of the capacity and the fidelity of his agents and his debtors. They may not be able to take care of his property, or they may divert it to their own uses and possession. Through their own negligence, or their dishonesty, the property may be lost. Fire may burn houses and storms may wreck ships.—Insurance companies may too fail. There are ten thousand ways in which property may be lost. Thus, in addition to the labor imposed upon the wealthy man, he is subject to perpetual anxiety, unrest and apprehension.

Wealth is a barrier to free social intercourse—not on the part of the rich man, but on the part of those who are not wealthy. Those who are not rich are not apt to be unreservedly friendly to the rich. It may be their fault. They ought not to let wealth stand between them and a friend, but they do. The barrier exists, and the rich man cannot remove it. The greater the wealth the more difficult is the barrier to be passed. Some who would be at their ease with the owner of a hundred thousand dollars will be reserved with a millionaire. This is another evil incident to great wealth—the loss of friends.

Wealth is a peril to the son and to the daughters of the wealthy. The school of application and industry is the best school for boys and girls; an idleness removes the incentive to industry and application. The heirs of a wealth man feel that it is necessary for them to make their own way in life, and they are tempted neither to study nor work as diligently as others. The heads of the young men of wealth in England (where fortunes are larger and better) are the emptiest places to be found on earth. And the evil influence of wealth on young is positively as well as negative. The possession of money leads the sons into dissipation and the daughters into frivolity.

But the greatest danger of wealth remains to be told. It is a foe to religion. The rich man's riches are his strong tower, just as the destruction of the poor is their property. It is easy and natural for the wealthy to trust to their riches. But Christ says: "How hard is it for them that trust in riches to enter into the kingdom of God. It is easier for a camel to go through the eye of a needle than for a rich man to enter into the kingdom of God."

The rich need as much preaching as the poor, and they get far less. The application of this article to them is so plain that it is not necessary formally to apply it. Let them thank God for the good things of this life which they have received. But do not let them pride or value themselves upon the possession of their wealth. Let them not trust in their riches, but in their God. Let them remember that they are stewards or God-keepers of their property for the time being—not its absolute owners.


