## Dies In The Prime of Life

### JAS. C. COPENHAVER DIES AT BRISTOL

James C. Copenhaver, prominent and popular Bristol business man, died at 6 o'clock Saturday morning at his home on Holston avenue, about an hour after he suffered an attack of acute indigestion. He died before medical aid could reach him. News of the sudden death of one of the best known and most active business men of Bristol, in the prime of life and in fine physical condition, shocked the entire city.

Mr. Copenhaver was at his office all day Friday and during the day casually mentioned that he was being slightly troubled with indigestion. He spent Friday night at home with his family and retired apparently in his usual health. He awakened his wife and daughter after 4 o'clock Saturday morning. The family did not realize that his condition was dangerous but telephoned to his cousin, Dr. Nat Copenhaver. The latter advised that he be given warm salt water to produce vomiting. This was done and seemed to relieve him and he passed into a quiet sleep for a few moments. He soon awoke in terrible pain, suffering a violent attack. He quickly grew worse and died before Dr. Copenhaver reached the home. Neither his son, Milton Copenhaver, nor his brother, Sam T. Copenhaver, reached the home before his death.

Mrs. Charles C. Lincoln, Jr., eldest daughter, was reached over long distance telephone in New York and will arrive Saturday with her husband. Meek H. Copenhaver arrived at 8 o'clock last night from Florida and did not learn of his brother's death until he alighted from a bus on Moore street.

Mr. Copenhaver was forty nine years old and would have celebrated his fiftieth anniversary on Christmas day. He was very active in business civic and social affairs. He was president and owner of the Bristol Seed and Grain Company, a director of the Bank of Bristol, director of the Kenwood Cemetery Association, president of the Bristol Athletic Land Corporation and a director and active member of the King's Mountain Memorial hospital.

aligned with many civic and religious movements in Bristol and has been one of the city's most valuable and progressive citizens. He supported every movement having for its purpose the material, moral or religious advancement of the city.

Mr. Copenhaver came to Bristol as a young man in 1900. He was born and reared at Seven Mile Ford, Smyth County, Va., the son of Wm. H. and Nancy Jane Copenhaver. He was educated at Oak Point High School in that county and at the age of twenty married Miss Minnie Farris daughter of Maj. A. J. Farris, of Chilhowie. He and his bride went to the state of Washington where Mr. Copenhaver farmed and taught school. His eldest daughter was born in that state. He came back east and was for a time associated with his brother Sam Copenhaver in railroad construction work. In 1900 he came to Bristol and bought an interest in Hamilton-Bacon-Hamilton Co. then conducted by W. R. Hamilton. He later became sole owner of the business. He sold this business to S. T. Copenhaver and twelve years ago bought out Cowan Brothers and organized the present Bristol Seed and Grain Co.

He is survived by his widow, one son, Milton Copenhaver, general manager of the Lincoln Furniture Manufacturing Company, and three daughters, Misses Margaret, Fay and Virginia Copenhaver and Mrs. C. C. Lincoln Jr., of Marion.

### WHAT WILL BE OUR POLICY.

"When Senator W. A. Garrett, the chairman of the Senate finance committee of Virginia had sat and heard all the argument for the reform of the State tax system presented at the State Chamber of Commerce meeting a few days ago, he summed up the situation by the following terse remarks: "I have sat here three days and have heard suggestions from representatives of every branch of industry, agriculture, and other activities, as to a reduction in taxes in the particular business of each speaker, but I have heard no suggestions made from any source as to how to make up this loss?"

Tax reform in the minds of many persons means a reduction of taxes especially affecting them, and without regard to the effect on the general treasury.

While there is a cry in the state for reduced taxes there is also an appeal for increased appropriations along a number of lines.

Additional money is demanded for public schools. President Alderman, at a recent convention, called attention to the need of millions of dollars of additional revenue for the operation of the colleges, in addition to the need of a bond issue for the construction of buildings. Other activities in the State also request more money from the state.

It is, of course, impossible to reduce taxes and at the same time greatly increase appropriations. The General Assembly in 1926 will have many difficult problems to solve. It will have to speak in unmistakable language as to whether Virginia is to increase her public expenses or whether the progress is to be made by more economical and efficient use of the money that is now appropriated. When it is considered that the total expenditures for all State purposes in 1916 were \$8,000,000, while in the last year they were \$33,000,000, an increase of over 300 per cent in eight years, it is reasonable that there should be a demand by the taxpayers, and especially the farmer, that expenses should be held down, and greater economy and efficiency exercised in the state's activities."

We give the above article from the Winchester Star, a newspaper owned by Governor-elect Harry Byrd as an illustration of what a quandary the Democratic selves to a reduction of taxation, yet now they are to reduce taxes and provide fat jobs for all their political henchmen is worrying their minds not a little. All that is necessary to achieved the desired ends is to retire about one-half of the forty odd thousands Democratic office-holders and abolish the useless Boards and Bureaus that have been created to give them a good fat living out of the public crib, and the administration will have no difficulty in reducing taxes and creating a surplus in the State treasury.

## For Better Movie Pictures

THE GREATEST MOMENT IN  
MODERN HISTORY TO BE PRO-  
DUCED IN MARION ON DE-  
CEMBER 7.

A few weeks ago a little company of Marion mothers, grand-mothers and spinners who met together by chance in the Woman's Rest Room at the Smyth County Court House were lamenting the fact that moving pictures, even those which are passed by the censors, are so seldom inspiring or educational. Those which are not actually salacious, so these good women claimed, are highly emotional, and designed with a view to making a direct appeal to the physical senses rather than the spirit or the intelligence. It was further lamented that this continual presentation of crime and physical emotionalism upon the screen had aroused and stimulated a morbid appetite on the part of the public, adults and children alike, for this particular form of picture, and that unless drastic measures were taken to bring about a reaction the taste for inspirational films would be totally destroyed. The situation is especially regrettable because of the debilitating effect upon the moral natures of American youth. It was agreed that the responsibility of this reaction was in the hands of the producers, who are slowly awakening to a realization of this responsibility, and who are endeavoring to bring about a reform in the moving picture industry.

At the time of this discussion no one participating in it was aware that the management of Marion College had arranged to bring to Marion the picture-play entitled, "The Greatest Moment in Modern History," one of the most notable educational films which has been produced.

This picture is not merely inspirational, but is highly instructive and of the utmost religious and historic significance. It is not a work of fiction built around a bit of history,

but is a direct presentation of a period and an event of vital importance in the religious and political progress of the world, the period of the Protestant Reformation under the fearless leadership of Martin Luther. One of the most stirring scenes presented is that of the Reformer facing alone and unsupported that great and august body, the Diet of Worms, and nobly refusing to retract one word of his published statements, though knowing in his heart that such a refusal might mean death. The moment of this refusal is called by Thos. Carlisle, whose high place in English letters justifies him in expressing an opinion, "The Greatest Moment in Modern History."

The customs, manners, costumes and scenery are faithful to the period, and the scenes are so vivid and so stirring that even those who are not concerned in history or religion will find the picture entertaining from the beginning to the end.

It would be a lasting reproach to this section and an inestimable loss to our moving picture lovers if such a play should not be patronized in Marion as enthusiastically as elsewhere. The play is not written for adults only nor for children only. It is adapted to both. The school children of Marion and of the neighboring towns and surrounding country may never again have an opportunity to see presented in lifelike scenes and characters the events of this special period, a period with which they are acquainted only through the circumscribed limits of the printed page. A liberal patronage will indicate that this section of Virginia is right in the forefront in the campaign for high-class and inspirational films.

"The Greatest Moment in Modern History" will be presented at the Marion Theatre on December 7, 1925, under the auspices of Marion College, and will doubtless be well patronized, not only by the picture enthusiasts of Marion but also by those from a distance.


