Progressives Back in G. O. P. All in a Bunch.

Marion, Ind., May 15.—Progressives have returned to the Republican party in the past one by one. It has remained for the leaders of the Progressive party in Grant county to return en masse and with a whoop. D. C. Pence, candidate for county clerk; Fred Sanders, candidate for county auditor; E. J. Holsinger candidate for state representative; Oren Dickey, candidate for prosecuting attorney; John J. Veach and Harlan Halsey, candidates for county commissioner, in the recent election upon the Progressive ticket, have announced their return to the Republican party. With them will come Verling W. Davis, chairman of the Progressive county committee, and Morris G. Callahan, editor and proprietor of the local bull moose paper. The announcement of the return of these prominent members of the bull moose party to the G. O. P. was made in this week's Observer, the local organ of the Progressive party in this county. Mr. Callahan announces that hereafter his paper will be found "fighting for progressive principles within the Republican party." He says that the "big men and big women will forget the past with its bitter quarrels and with faces toward the dawn will strive to build a better and happier Republican party, where people shall come into their own and real justice shall prevail.

Land Ejectment Suits Involving 100,000 Acres.

Abingdon, Va., May 17.—Hon. Henry C. McDowell United States Judge of the Western District of Virginia, has agreed to try in September at Lynchburg one case as a test in the ejectment suits which have been instituted by Jeffries & Jeffries, attorneys, of Norfolk, Va., involving the title to over one hundred thousand acres of valuable timber and coal properties in Buchanan county. This litigation promises to be the most interesting dealt with in years. The right of the General Assembly of Virginia to repeal a law, which was in force for Buchanan county at the time the plaintiff acquired rights they may have in the property will be attacked. It is generally known that titles have become badly mixed and involved in Buchanan county and the General Assembly enacted a law in 1912 making it lawful for persons to produce certified copies or originals of deeds prior to 1865, where these had been lost or destroyed in the records, in effort to establish a clear title. The General Assembly in 1914, by an act approved March 14, repealed this act and the right to do this is questioned in the ejectment suits. These suits were brought by the Norfolk attorneys in the name of Virginia and West Virginia Coal Company and it is said some fourteen or fifteen hundred persons are involved as defendants, some of them have lived on the properties for generations.

Appeal to be Made to Save Life of James Canter.

Bristol, Va., May 14.—The Supreme Court of Virginia will be applied to for a writ of error in the case of James Canter, the younger of the two brothers now under sentence to die in the electric chair June 11th for assault and murder in connection with the death of Mrs. James R. Wilson, who was brutally murdered in her home on the Bristol-Abingdon turnpike on the evening of April 23 or the morning of April 24th.

This course was decided upon today by Judge N. P. Oglesby, who represented the brothers in the trials. The decision followed a visit to Judge Oglesby's office by John Canter, aged father of the condemned brothers, who insisted that James was innocent and pleaded with the attorney to save him. In addition to this, a pathetic appeal came from the boy in the Roanoke jail. Judge Oglesby will enter no plea to save Luther Canter, but seems firmly convinced that James is innocent. Asked for a statement, Judge Oglesby said:

"After mature deliberation, being firmly convinced that James Canter is not guilty, I feel that I would not only do violence to my own conscience but would not be true to him if I did not do what I could to save him.

Death of Mrs. Kate Terry Green.

Wytheville, May 17.—The remains of Mrs. Kate Terry Green, who died in Lewis-Gale Hospital in Roanoke Friday night, arrived in Wytheville Saturday on the Memphis Special. Mrs. Green had been in ill health for several months, suffering from mastoiditis, and was taken to the hospital for a second operation about three weeks ago. She was the wife of Dr. P. B. Green, a prominent physician of Wytheville, the daughter of Gen. William Terry, one of the commanders of the Stonewall brigade, and was always an active member of the U. D. C.'s. She is survived by her husband and one daughter, Miss Katie Green.

Thaw Again Wins for Jury Trial.

New York, May 17.—The Appellate division of the Supreme Court decided Friday that it would not interfere with the plan to have Harry K. Thaw's mental status placed before a jury for determination.

The court dismissed the prohibitory writ which, if sustained, would have enjoined the Supreme Court from submitting the case to a jury next Monday.

State Senator Buchanan Presents His Resignation

The resignation of State Senator B. F. Buchanan, who represents the First Senatorial District in the upper branch of the Legislature, has been received and accepted by Governor Stuart.

Senator Buchanan is retiring from the legislative body to devote his whole time to his duties as counsel for the Federal Reserve Board at Washington. He was recently appointed to the position. It is not necessary for the senator to resign, as under the law his new position is not classed as a public office. Senator Buchanan, however, represents a district in which there is a large Republican vote. The hostile political element in the district would no doubt question the propriety of his return to the State Senate, while retaining a place of emolument under the Federal Reserve Board. Hence his friends agreed with him that the party interests would be better served by his retirement, although he has been regarded as one of the ablest legislators in the General Assembly.

The political situation in the First District, which is composed of the counties of Smyth and Washington and the City of Bristol, is somewhat complicated this year. Political disturbances due to the disclosures made when the books of county Treasurer Bradley, of Washington, were examined and a shortage of \$60,000 reported, have unsettled party harmony to some extent.

An element in Washington County favors turning out of office practically all of the incumbents. The Republicans are rallying for a determined fight. Two opposing factions in the Democratic party are struggling for supremacy in Washington County. The conservative element is striving to heal the differences and bring the factions together before the Democratic convention, which is to nominate a candidate for the Senate to succeed Mr. Buchanan is called. The prospect is for one of the most closely contested elections in the tempestuous political history of the district.—Times Dispatch.

"Don't Let the Republicans Know It." The South is in favor of Democrats at Washington revising the Tariff back to Protection for United States industries, but it insists on a flag being attached to the revision to inform the people that "this is done with the explicit understanding that it shall not be allowed by you to injure the prospects of the Democracy in the national election of 1916." In some respects that is fair, for the Democrats naturally hate to lose next time. They are good fellows at home, and it hurts them to be nice and quiet, so they want the offices. Here is the whole story in the Birmingham (Ala.) Age-Herald, a Democratic newspaper published where Congressman Underwood lives, and whence he is soon to hail as a United States Senator, but to retain the glory of his Free-Trade bill: "The 64th Congress will be wise if it revises the Tariff and if it does it in such a way as to give just and proper relief and at the same time afford to the Republicans an opportunity to make their old-time high Tariff slogan tell in the next campaign. If it shall be possible that the Republicans can sing better in the atmosphere of a Democratic and Protective Tariff for 'proper relief,' then this country, including the South, must not have that relief which it so much needs. That is the Southern Democracy, the most wonderful political aggregation in the history of the world. It hurls, 'Give us relief from Democratic Free-Trade, but don't let the Republicans know it.'"—Worcester (Mass.) Telegram.

School Books to Be Changed Again.

Richmond, Va., May 17.—Defeat of the Johnson Company's bid for supplying school books to the State is causing endless discussion. The board is composed of eight men. Three of these are elected by the people at large—the governor, the Attorney General and the Superintendent of public instruction. Three are elected by the legislature. Two superintendents are elected by the six. The award of the books was made by a recorded vote which shows that all of the men elected by the people voted for the Johnson proposition, which would have saved \$77,000 direct and an additional \$100,000, which will be lost because of the change of so many books, requiring exchange for new books.

These men identified with the higher institutions of learning voted against the Johnson books. They are Dr. J. W. Page, Colonel H. C. Ford and Dr. J. S. Wilson, Harris Hart, of Roanoke, and Frank T. West, of Louisa, voted with them. The schools are very much in politics, they will ever so remain, and judging by the vote of the men directly elected by the voters, if all of them were as responsive to the demands of the patrons of the free schools, the people of Virginia would not have to pay such enormous prices for school books.

About the same time that the board was rejecting the Johnson Company bid, the officers in charge of education at the various army posts of the United States, placed nineteen of the Johnson books on their lists, thus refuting the suggestion that the books lacked merit.

The New Prosperity.

Pittsburg, May 17.—Canada has a duty of \$7.84 per ton on steel rails. The Underwood tariff act put steel rails on the free list. In recent months 60,000 tons of rails have been imported into this country from Canada. In an address delivered here recently, Representative McCall asserted that in the vicinity of the great rolling mills at Gary and South Chicago, which are closed down, they are laying rails that were made in Canada.

Canter Boys Chained When Reach Richmond.

Richmond, Va., May 17.—James and Luther Canter reached this city at 2:15 Friday afternoon and were rushed to the penitentiary in the prison automobile. They were not allowed to make any statement what ever.

The men were chained together. They will die June 11. They were convicted of the murder of Mrs. Jas. Wilson near Bristol April 23.

Ronoake, Va., May 14.—Deputy Warden Penn, of the State penitentiary, arrived here last night to take Luther and James Canter, sentenced to die for the murder of Mrs. James Wilson, of Washington county, to Richmond. The condemned men were taken on the 6:40 o'clock N. & W. train this morning. The brothers are sentenced to die June 11.

Luther Canter has never changed his attitude of dumb resignation and indifference which succeeded a threatened break after his conviction. He seems morose and absolutely without hope. The younger boy, James, wept when he was told to prepare for the journey to the penitentiary, but when reminded that his removal would not affect any step that may be taken for a new trial, he seemed to brighten considerably.

Both the boys are of the most illiterate type. It is said that neither of them can read or write.

From the Pacific Coast comes the announcement of the engagement of Miss Enid Shaw, daughter of the former Secretary of the Treasury, Leslie M. Shaw, and Mrs. Shaw, to John McMillan, a banker, of New York. The wedding will probably take place in October.

Senator Buchanan in New Office.

Washington, May 14.—Senator B. F. Buchanan, of Marion, Va., recently appointed chief counsel in charge of insolvent banks, under the controller of the currency, arrived last Thursday to take up his duties. His arrival was delayed by the illness of his daughter, who suffered an attack of appendicitis.

Mr. Buchanan will, for the next few days, acquaint himself more thoroughly with the banking laws as they relate to insolvent banks, and the duties of his office.

He will not bring his family to Washington, he said. His duties will not take him out of Washington, for as counsel in charge of all insolvent banks, of which there are 61 in the country at present, he will be in control of the local counsel of those banks and conduct supervision from his office here.


