What the Postoffice Costs.

The money spent by Uncle Sam on his postoffice includes, as its largest item, the railroad transportation of mail, \$47,393,206 30. Compensation to assistant postmasters and postoffice clerks totaled \$45,785,826. Rural delivery something more than \$45,000,000; city delivery something more than \$36,000,000; compensation to postmasters, \$29,000,000; railway mail clerks, \$23, star routes, \$7,000,000, and so on down through a long list of expenditures that include everything from \$200,000 worth of wrapping twine and \$283,000 worth of mail bags. The manufacture of postage stamps cost \$687,000, the manufacture of postal cards \$272,000. Special delivery service cost \$1,685,000. Mail transportation in Alaska is listed as a separate item at \$231,000.—Leslie's Weekly.

Patronage Situation in 9th Endangers Democratic Success

Bristol, Va., March 23.—General dissatisfaction among the Democrats of the Ninth District over the failure thus far of the administration to hand out Federal plums was expressed last Wednesday at the big convention held here which nominated Tate Irvine, of Wise, for Congress. In his speech Senator B. F. Buchanan urged the Democrats to be patient. They are eager for the distribution of patronage and demand that something be done at once. Irvine, who is regarded as the strongest man in the Southwest with the administration, is pledged not to have anything to do with the patronage matters until after the election. The Democrats do not propose to wait and allow the Republicans to hold over. The leaders recognize that the patronage question is a grave one and unless properly solved may imperil party success.

Ships to Go Through Canal Soon

Washington, March 23.—Though merchant ships are expected to be passing through the Panama Canal within the next three months, yet builders of the big ditch still have much work ahead of them. Nearly all of what is known as the permanent dam and lock construction has been finished, but owing to the earth slides in the Culebra Cut many hundreds of thousands of cubic yards of earth must be removed there in to broaden the channel to its full width. During the month of February total excavation was 2,430,050 cubic yards, as compared with 1,514,972 yards in January.

Wife of Congressman Slemm Suing for Divorce.

Big Stone Gap, Va., March 23.—Mrs. C. B. Slemm, wife of Congressman Slemm, has filed suit for divorce from her husband in the Wise circuit court. This news was not unexpected here, as it has been known for a long time that there has been an estrangement between them and that they have not been living together. Mrs. Slemm, who was a Miss Barton, of Louisiana, has been living with her mother in Louisiana for a year or more. She is represented by Price and Shelton, of Bristol, and Bullitt and Chalkley, of this place. Mr. Bullitt, speaking of the case, said:

"It is the old story—incompatibility. The ground for the suit is desertion. Mrs. Slemm makes no other charge. No does Mr. Slemm make any charge against his wife. I have talked with him on the subject several times, and he always speaks of her in terms of highest respect."

It is understood that the chief trouble was that Mrs. Slemm did not want to live in Washington, but wanted to live in her native State, to which Mr. Slemm would not agree.

The complainant was prior to her marriage a Miss Barton, daughter of a wealthy planter at Barton, La., who is now dead. Mrs. Slemm makes her home with her mother at Barton, La., and has been there since the trouble resulting in the estrangement of her husband. Slemm is one of the wealthiest men in Virginia, and is still comparatively a young man. Because of his great popularity among the people of Southwest Virginia, many have expressed surprise that he and Mrs. Slemm should not have lived happily together. It is not believed that Slemm will make strenuous defense to the proceedings.

Southwest Disappointed.

Bristol, Va., March 23.—The appointment of J. M. Hart, of Roanoke, Va., to succeed David F. Bailey, of Bristol, as collector of internal revenue for the Western district of Virginia, is a serious disappointment to the Democrats of the Ninth Virginia district. The party in the Ninth had earnestly hoped to secure the collectorship, believing that it would aid materially in the struggle to elect a Democrat to congress this fall. It is understood that the appointment was more in the nature of a personal affair with the president than a recognition of party demands. It is contrary to the wishes of the senators from Virginia.

An order was issued Monday by the postoffice department at Washington, advancing the Bristol, Va., postoffice from the fourth class to the second class. The higher classification of the office comes as a result of its receipts, which for the first year aggregated \$31,779.61. The new classification of the office increases the salary of Postmaster Gauthier from \$1,000 per year, which is the maximum for a fourth class office, to \$2,800 per year.

Roosevelt Dipped in Rapids

New York, March 23.—Colonel Roosevelt's family and friends were today anxiously awaiting further advice regarding an accident by which the party lost its entire equipment in the rapids of a Brazil river. While on concern, it was stated, was felt for the safety of Roosevelt, it was desirable to learn just how and when the accident occurred and whether the expedition would be abandoned.

Fair Association for Southwest Is Formed.

Big Stone Gap, Va., March 24.—A new fair circuit was formed here consisting of Washington, Scott, Lee, Russell and Tazewell counties, as they are the banner counties of the best blue grass sections of the country adjoining and having to face the greatest developed coal field in the world, it is fitting that the new association should be called the Blue Grass Fair Circuit.

The following officers were elected: president, Dr. E. G. Hamilton, of Abingdon; vice-president W. G. O'Brien, of Tazewell; secretary, C. O. Blankenship, of Jonesville. The dates selected for the fair were Abingdon, week of September 7th; Gate City, September 14th; Jonesville, September 21st; Lebanon, September 28, Tazewell, October 5th.

Miss Betsy Jane Hash, who lives near Fox postoffice, died Tuesday of influenza and other complications. She was about 78 years old. She is survived by one brother, Aris Hash, who is deaf and dumb. Interment will be made at the family burying ground Thursday.—Grayson Gazette.

Appomattox, Va., March 23.—

The Methodist people here have broken the long custom of using wine at the communion service at Memorial church, and yesterday Rev. A. L. Wingfield announced that grapejuice will be used so that the many members of the new W. C. T. U. may partake. The Methodists are first in this section to make this change, and it is expected that other denominations will follow. This is the first real effect of the temperance work in Appomattox county.

Five Offices in Virginia Filled.

Washington, March 23.—President Wilson has made these nominations for federal offices in Virginia: United States marshal for the Eastern district, John G. Saunders, of Richmond.

United States district attorney for the Western district; Richard Evelyn Bird, Winchester.

Internal revenue collector for the Western district, John M. Hart, of Roanoke.

Collector for the East, R. C. L. Moncre, of Stafford county.

Collector of customs at Norfolk, Norman R. Hamilton, of Portsmouth.

The appointments were made after a long controversy between the so-called organization and anti-organization Democrats.

According to reports coming from trustworthy sources the Republicans of the Ninth district, facing the refusal of C. B. Bascom Slemm to stand for re-nomination to congress, will turn to Barnes Gillespie, of Tazewell, retiring United States district attorney, to take up their fight and make the race against R. Tate Irvine Democratic nominee.

So far as can be learned, Mr. Gillespie never has said he will not run. He has said that because of other professional business he does not care to try for a seat in congress, but Republicans in the Ninth who know his personal and political strength believe he is the man who can pick up more of the Slemm organization strength than any other in the district.

Mr. Gillespie has established an enviable record as government prosecutor in the western district and doubtless can do as much as any other man in the State to retain for the Republicans their stronghold in Virginia.

Aged Man Found Dead.

Gate City, Va., March 23.—Mathew Calhoun, a man past eighty years of age, was found dead to day in his home near Speers Ferry. He lived alone in a house in an isolated place. Not seeing him for several days, the neighbors went to his house and broke down the door. They found him lying on the floor. He had apparently been dead two or three days. He has sons living in the community.

As to what the new tariff was to

ports and exports, as compared with
the last three months of 1912. It

the increased roar of the wheels of

Over one hundred employees of the

Norfolk and Western at this point
were cut off yesterday and it was
stated last night that probably an-
other cut would be made today.
Thirty-five machinists were affected
and the contemplated cut will prob-
ably affect this department further.
The largest cut was made in the car
department, in which eighty-five
employees were affected. Common
laborers are being cut throughout
the entire motive power department
and are being given their pay as
soon as cutoff. No explanation was
given of the cut, or as to how long
the men will be out of work.—Blue-
field Telegraph.

The advice to young men to go

back to the farm, which has been so
frequently given during recent years
is no longer good advice. With corn
and meat coming from South Amer-
ica to the New York market cheap-
er than the same products can be
shipped by rail from Kansas, Ohio
and other States, and with big man-
ufactories moving to the seaboard so
as to get advantage of Free Trade
from cheap lands of other countries,
and with pasture land worth less
than \$5 per acre in South America
competing with land in our own
States that is assessed from \$20 to
\$50 per acre, there is little to en-
courage the farmer. With 90 per
cent of the people in other than food
producing occupations and with the
Democratic Tariff rendering it al-
most impossible for the food grow-
ers to exist, the farm offers little
to the man who must earn his own liv-
ing.—Goshen (N. Y.) Democrat.

Washington, March 26.—Congress-

man William A. Jones, of the First
district, who was one of the staunch-
est supporters in Virginia of Wood-
row Wilson for the Democratic presi-
dential nomination, will follow Un-
derwood, Kitchin, Doremus and other
house leaders in fight on the Panama
Canal toll repeal bill. Mr. Jones
will be the only Virginia Democrat
who will break with the president on
this proposition. Other members of
the delegation, who have a record for
free tolls, will reverse their position
and vote for tolls.

Congressman Slemo, Republican,

will also vote against the repeal bill.
Judge Watson, the Fourth district
representative, is still unsettled in
his views of the question.

Slemo Says Irvine Will Be

Defeated.
Washington, D. C., March 25.—
Congressman Slemo, of the Ninth Dis-
trict, who returned to Washington to-
day after an absence of about ten days
declared in an interview that R. Tate
Irvine, nominated to run against
Slemo or his successor in the Ninth
District, has no chances of election,
and that he was nominated by the
machine leaders, and not through any
response to the demand of the people
of the Ninth District.

"Mr. Irvine is a gentleman of high
character and ranks among the best
lawyers in Southwest Virginia," said
Congressman Slemo. "He has long
been anxious to go to Congress when
the time was ripe. He was not nomi-
nated in response to any demand on
the part of the people for his nomi-
nation, was through the work of the
machine leaders of the Democratic
convention who wanted a man to
hold up their organization in the state
they selected Mr. Irvine.

In regard to the suit for divorce re-
cently filed against him, Mr. Slemo
said he regretted the situation, but it
seemed unavoidable. He said his at-
torney would file an answer to the
suit.

Senator Edwin Curtis, of Geneva

County, elected to the last legisla-
ture as a Progressive, announces his
return to the republican party. He
says: "I do not believe there is any
longer any reason why men who
think alike politically should be vot-
ing different tickets. The great
question of a Protective Tariff is
really the only problem upon which
men are divided. Past differences
should, in my judgement, be far-
gotten and all unite in the one com-
mon purpose of restoring a Protec-
tive Tariff law on the statute books.
—Owosso (Mich.) Times.

stricken with apoplexy and fell
back on his pillow. He died almost

Emory is Selected for Sum-

mer Normal.
Emory Va. has been selected over
Bristol for the Southwest Virginia
Summer Normal.
Superintendent Fitzpatrick, of
the Bristol, Va., schools, who will
probably be appointed conductor of
the normal, visited Emory with the
other educators interested in the
matter including State Superintend-
ent R. C. Stearnes, and after consul-
tation with the people at Emory it
was decided to continue the normal
there.

The Big Stone Gap and Emory
Summer Normals will be combined
this year and the Normal at Emory
will be known as the Southwest Vir-
ginia Normal. It will have 400 or
more students. Owing to the large
increase in numbers, it was not
thought that Emory would be able
to accommodate the normal. The
educational authorities secured a
proposition for holding the normal
in Bristol, utilizing the two female
college buildings. But for the fact
that Emory made arrangements to
accommodate the increased number
of pupils, Bristol would have been
given the normal.

The Southwest Virginia Normal
at Emory will begin about June 25.
It will be the largest normal ever
held in this section of the State.


