MUSIC SECTION.

WOODRUM SINGS FOR CAPITAL WAR MOTHERS.

Roanoke music circles may be interested in a Washington reviewer's criticism of Congressman Woodrum's vocal abilities as demonstrated one night recently when he sang at a benefit concert under the auspices of the American War Mothers at the Willard Hotel.

The reviewer wrote: "Representative Woodrum sang an unusually interesting cycle of songs by E. A. Ashford, including "Moods," "Nights," "Sunset and Dawn," and "Ever a Song Somewhere." The last-mentioned was particularly delightful. Mr. Woodrum's resonant, mellow tones were given opportunity, for full power in Gounod's "Song of Vulcan," and his encores, "Were I a Leaf," "The Pilot," "O, Let Night Speak to Me" and "Carry Me Back to Old Virginia," were heartily received."

PHONOGRAPH DEVELOPE TASTE FOR GOOD MUSIC.

"When we recently purchased a talking machine, people said we would lose interest in our own music, as we would prefer to "run a piece" through on the machine rather than to practice," wrote "M. S." to a music teachers' paper. "It has had just the opposite effect with me. Why is it that people are affected in such contrary ways?"

"Untold good in musical progress has been accomplished by the talking machine," replied the editor of the paper. "It has been a great incentive to thousands to try to do something with their music. A man of my acquaintance would have nothing but the worst trash for his talking machine. One good record ("The Evening Star," by Wagner) happened to stray into his collection. Several weeks elapsed before he would put it on a second time, but gradually he began to like it, then to like it best, then he bought more that were good. Eventually his taste was for the best, now he insists on all three of his children studying the piano. So the sound producing machine does help the piano teacher."

STATE FEDERATION IN ANNUAL SESSION.

Representatives of thirty-three affiliated with the Virginia Federation of Music Clubs were in annual session at the University of Virginia Thursday and Friday last. Professor Armistead M. Doble, of the University, welcomed the delegates, and Mrs. Malcolm W. Perkins, State president, of Palmyra, made her annual report at the first of the business sessions.

Thursday evening a feature of the entertainment program was a concert of music by Virginia composers played or sung by native musicians. John Powell's Sonata Virginiaesque and his Rhapsodie were among the various native works presented. Songs of Anabel Morris Buchanan and piano compositions by Leslie Loth and Sam Sours, were others.

On Friday evening Miss Alfreda Peel, of Salem, gave a costume-recital of Virginia ballads, which was preceded by an address on the native ballad by Arthur Kyle Davis, of the University School of English.

KIWANIANS ENTERTAIN CONFERENCE DELEGATES.

At the regular meeting of the Kiwanis Club last Tuesday night quite a number of the delegates that were attending the M. E. Conference this week were guests. Many of the gentlemen were called upon for short talks, and several responded with fine short speeches, notably among the number being Rev. Mr. Crow of Wytheville.

Nine host of the Cafe set up a very fine feed, and the attendance of members was very good. The Attendance Prize for the evening was given by Mr. Wilson Scott and was awarded to Mr. James Shanklin; Dr. Lowry made the presentation speech very gracefully.

The chairman of the evening were noted for their absence, so there was no program for the evening given, but the time was taken up with short addresses, among the number being Rev. Dr. Crow, Rev. Mr. Sharretts, a missionary from China, Mr. Gentry from Hillville, Rev. Mr. Waggoner, and Rev. Mr. Evans of Galax.

Several of the committee made reports, and among them we note that the Camp for girls by the Cheezy Chase School has been abandoned, the parties proposing it not being able to get enough girls pledged to come to justify the venture.

Hon. Frank Buchanan on the location of the road from Independence, and the further statement was made that they would be no opposition to the route as proposed.

To Hold Clinic In Smyth Co.

Chest clinics will be held in Smyth County through the Marion Tuberculosis Committee in cooperation with the State Board of Health, Bureau of Tuberculosis Education. Dr. E. C. Harper, who succeeded Dr. Edwards as clinician, will have charge of the clinic: Miss Anna Tate Pope, field nurse for the Bureau, will be in the county for a month.

Clinics will be held in the following places:

- 26th, Court House at Marion in the afternoon.
- 27th, School House at Sugar Grove morning and afternoon.
- 28th, over Chilhowie Drug Co., at Chilhowie morning and afternoon.
- 29th, Community House at North Holston morning and afternoon.
- 30th, Dr's. Early and McKees office at Saltville, morning and afternoon.
- Mrs. Z. T. Atkins is County Chairman, while Mrs. Ernest Grier will act as Chairman in Chilhowie District; Mrs. Sleep in Sugar Grove District; Mrs. Z. T. Atkins in District Marion. Much interest is being shown in the work and a good attendance is expected.

Miss Pope reports that the latest figures from the Bureau of Vital Statistics shows that the reduction in the deaths from tuberculosis in the State, now amounts to 27 per cent, and that the total number reported in 1923 was 2915. Last year, 1922, 3092 deaths were reported, and this decline is considered very encouraging. It is thought that the field clinics have had a good part in this reduction, since it offers an opportunity for examination to many persons who while not actually sick, and therefore, unwilling to go to their own physicians, are "feeling badly" and are willing to come to the clinic. Frequently this "feeling badly" means that the person has a very early case of tuberculosis, and is, therefore in the very curable stage of the disease. The clinic unit will be increased this year, a second physician and three nurses being added to the staff, so that many additional clinics may be added.

Among the buyers of lots at the sale last Saturday of what will be known in the future as "Snowflake Park," was Mr. Charlie Wassum, and he has lost no time in taking advantage of his purchases and is now engaged in excavating for the foundations of houses to be put on the lots he bought.

The Theatre building on Main Street that has gone by names of the Star and Pastime Theatres, has been renovated this week and will in the future be occupied by the Virginia Motor Company, Mr. Q. A. Calhoun, manager, and will be the home of the famous Star and Durant autos.

Our town has been quite full this week with the delegates of the Holston Conference, which had been in session at the Methodist church. We understand that the Conference has been very fully attended, and the sessions have been very interesting and much important work pertaining to the work of the Conference discussed.

PARTY ORGANIZATION NECESSARY TO GOOD GOVERNMENT

The necessity of party organization to uphold party government as the means of obtaining best results for the country was asserted by President Coolidge in an address at the White House before the women students at the political campaign school conducted by the District of Columbia League of Republican Women Voters.

As the President walked into the East room, where the gathering had assembled, followed by his secretary, C. Bascom Slemph, the women raised their right hands and repeated the following salute:

"I pledge allegiance to Calvin Coolidge and to the Republican platform upon which he will stand in a government of honest integrity, with protection and progress for all."

The President said:
"Let me express my thanks to you for your pledge and your assurance of loyalty to party and to sound principles of government."

"It is necessary to have party organization if we are to have effective and efficient government. The only difference between a mob and a trained army is organization, and the only difference between a disorganized country and one that has the advantage of a wise and sound government is fundamentally a question of organization. Now I don't mean by that a narrow and bigoted partisanship, but one that recognizes the necessity to cooperate one with another, if we are in any way to secure the result that we desire."

That has been the model of our country from the time when it was established down to the present day. I don't know of anyone that has represented the real ideals of America any better than those of party loyalty either on the one side or the other. Men of the type of Lincoln and Grant, no less than the type of Cleveland and Wilson, have been loyal to their party, and desired to have party support and party government for the purpose of giving an efficient administration. So that whatever you may do in that direction I believe will be for the promotion of patriotic principles.

"It is a great pleasure to have you here and to give you just this word of greeting. I hope you have seen a great deal of Washington, and a great deal of the public men here that are striving to do the best they can for their country. If you have come here expecting to find the real seat of power here, I know you will be disappointed, for the seat of power does not rest in Washington—it rests back in those homes that you really represent, and if your coming here is to have any effect it will be on account of the message that you take back, the inspiration that you receive here, which you can reflect in your own homes and in the various communities that you represent. Take back that message to your co-workers, wherever they may be, to organize themselves for the promotion of sound principles of government."

Now that means of course a practical application of that principle. I have been in public life for some time and I learned to say a long time ago that I was all through looking for ideal candidates for office. They don't exist, and we have to make the best of what we have, for it is only in that way that we are able to make any progress. Now, get candidates that are just as near your ideals as possible. That is what we always want, and after you have done what you can in the way of selecting a candidate, get the best result and do what you can to support the principles that that candidate represents.

For, after all, if we are to promote good government, if we are to promote good principles, it must be by the support of those men and women that represent those principles. You know the principles that you represent, the principles for which our party stands, and if they are to be promoted and translated into sound government it will be by electing men and women to office that represent that thought and that ideal. So organize and select as good candidates as you can, and after they are selected do what you can to elect them. In that method I am certain you will secure the very best results for yourselves and the most patriotic results for this America which we all love."

SEE PROSPECT OF LOW EXPENSE FOR ELECTRIC POWER ON FARMS

Investigation in Many States of Theory That Use of Electricity in Every Possible Farming Function Will Reduce Cost for All Farmers.

Electricity for all the farms of the nation, by means of transmission lines to be extended from existing electric power systems, supplied by the big generating stations of the approaching super-power age, is the ambitious proposal put forward by several co-operating agencies which are making an investigation of the application of electricity to agriculture in its economic aspects. Already it has been declared that electric power service to farms can be put on a par with such service to city dwellers.



Electric Lights on Farm Not Enough

so far as expense is concerned, if farmers use it for as many operations on the farm as possible, instead of merely having electric lights or electric fans, and stopping there. This point has been emphasized with the utmost earnestness by those seeking to make electric energy available for the farms of America through the transmission lines of the power companies. The interested agencies are several. They include the National Electric Light Association, the United States Department of Agriculture, the American Farm Bureau Federation, the American Society of Agricultural Engineers, professors of prominent universities and conspicuous manufacturers of farm implements.

What Makes the Cost Greater
Statements as to the general purpose and scope of the study undertaken by these interests have been made recently by Dr. G. E. Neff of Wisconsin University, chairman of a joint committee on the relation of electricity to agriculture, and by Merlin H. Aylesworth of New York, managing director of the National Electric Light Association. They have dis-

SERMON BY RADIO WAS THEIR FIRST


"Down on the farm," to C. E. Brown, of Perry, Maine, means "down on the jumping-off place." He is located twelve miles from Eastport, Me., on the shore of a lake in a locality made very much isolated during the winter because of impassable roads, with snowshoes as the only means of travel for weeks at a time.

To that family, almost cut off from outside communication for part of the year, the voice of WGY, the radio station of the General Electric Company at Schenectady, N. Y., reaches regularly, taking profitable words and entertaining music. Voices and music come to their ears clearly and pleasantly, be the snows ever so deep, or the weather ever so stormy.

There are several children in the family, and on a recent Sunday night the younger children heard a sermon for the first time. It was a WGY church sermon. "Not that they are neglected," writes Mr. Brown, "but they have never been to church."

he demonstrated that by applying electric energy to all farm operations in which electricity can be of service, and to all possible duties in the farm household, the use of electric current will be so great that the power company will find it profitable to make the rates low. Otherwise, as already stated, the number of customers per mile of transmission line is so small in the country, as compared to the city, that the expense, and hence the rates, are much greater.

Solution Rests With Farmer
This puts the whole matter upon the shoulders of each individual farmer. Contrary to what the farmer might suppose, the more electricity he uses the cheaper he gets it—provided that every other farmer follows the same procedure. While it might cost every farmer in a given territory 25 cents a kilowatt hour for electricity if each of them used the electricity merely for electric lights in the farmhouse and the barn (because of the expense of building and maintaining the transmission line with only three customers per mile, compared to ten times that number in the city) it might cost each farmer only 10 cents



There Must Be Electric Power Also

ussed particularly the factors which make it difficult to furnish the farmer with electric energy as cheaply as it can be provided for the city and town user.

"One mile of city distribution line ordinarily serves from thirty to one hundred customers," said Dr. Neff. "But one mile of distribution line in farming districts usually serves only three customers. It can be readily seen, therefore, that a power company can serve city customers more cheaply than rural customers."

"But if farmers can use electricity for every possible farming purpose it seems likely that rural rates can be made so cheap that no farmer can afford to be without electric service, and every farmer can afford to have it. It is to prove or disprove this fact that the present investigation is being made."

To Put Theory to Test
This theory of securing electric service for farmers on a reasonable cost basis by electrifying the entire farm at the outset has many supporters. They are seeking, by the survey now proposed, to take the proposition out of the realm of theory and to establish it as a fact.

If their theory is upheld then it will

a kilowatt hour if each of them used electricity, not only for lights, but also for washing machines, electric irons, vacuum cleaners, water systems, wood cutting, ensilage cutting, thrashing, milking, feed grinding, churning, cream separating and any other farm work possible.

If this idea is found to be correct it will perhaps prove one of the biggest possibilities ever placed before the modern farmer. It will show a way out of the present dilemma—how to provide power line electric service on the farm at a cost which would make it economically justifiable to both farmer and power company.

Great Co-operative Enterprise
The co-operating interests making the present investigation propose to operate experimental rural transmission lines in about thirty states.

Assistance in developing new methods of using electricity on the farm and of improving present devices will be rendered in this undertaking by research laboratories, such as that of the General Electric Company. This will aid in solving the main problem from another approach, if the fundamental principle set up by the theory described is found to be sound.

"By command of the King." Magic words that call up thoughts of ancient castles, yes, and even dragons with tails that curled around the rocks in front of their lairs.

A phrase that has boded for good or evil throughout all ages, when people trembled for their lives or rejoiced at the omen of goo that the words portended.

Still a third meaning revealed in the phrase, one more modern and quite in keeping with our ideas of present day affairs. A mark of honor. The king has seen fit to bestow his royal attention on some one and that some one made for life.

The third meaning of the phrase explains its connection with the career of Percival Vivian actor and producer to plays, whose company is to present "As You Like It," Shakespeare's comedy at the Chautauqua this summer.

For Percival Vivian, as an actor in England, has appeared before the royal family by 'command'. His career began early, too. He was but seven years old when he appeared in professional roles on the English stage. He is still one of the youngest successful actor managers of America.

In 1907 he first came to this country with Mr. Ben Greet and a member of the famous Ben Greet Players has visited nearly every city and town of importance in the United States and Canada.

As an actor Mr. Vivian has played in nearly every theatre on Broadway and as a producer, his most noteworthy achievements have been the production of the comic opera "La Belle Helene," in conjunction with Mr. Richard Ordynski, of the Metropolitan Opera House; the staging of the mammoth spectacle, "The Wayfarer," at Madison Square Garden three years ago, in which 5,000 people took part. Mr. Vivian was also stage manager for Geo. Tyler in the production of "Ermine," with Frances Wilson and De Wolf Hopper.

When Percival Vivian, whose company will present the Shakespearean comedy at Chautauqua, produced the Biblical spectacle "The Wayfarer," for the International Church World Movement, at Madison Square Garden in December, 1919, his work as a stage director was acknowledged by the critics and managers of Broadway as being of the highest order.

Every member of the Percival Vivian Players presenting "As You Like It" on the Chautauqua, has appeared on Broadway. One of the rules that Mr. Vivian makes in engaging his companies is that each player must have had at least one Broadway appearance to his or her credit.

Last year we all saw something started by the Chautauqua Drama Board, the outcome of which has been watched with great interest and doubtless in some cases with anxiety. The leaders of the Chautauqua movement got together and decided that Chautauqua was big enough and good enough to have its own plays and not use Broadway's cast-offs. They therefore decided to offer a prize of \$3,000 for an original play of American life written by an American author.

The prediction was made at that time that the tables would be turned and Broadway would take plays from Chautauqua rather than Chautauqua depending upon Broadway for its plays. Has the prediction come true? We are happy to report that it has. The first play which we all remember was "Crossed Wires," featured on our Chautauqua program last year. On March 13, 1924, it opened in Philadelphia under the name of "Across the Street". Finally on March 27 it reached Broadway! We saw it nearly eight months before New York did! New York is waiting for "Their Honor the Mayor". But first it is ours.

This year the \$3,000 prize play is "Their Honor the Mayor". The author of the winning play is Emma Jane Behl, of Chicago. This play is said to be one of the finest comedies ever produced on Chautauqua. It contains all the qualities which make for a successful comedy. It has the humor of the love story, the professional politician, the suffragette and the exciting political race, all contributing to make an altogether wholesome, cheerful and satisfying entertainment.

The play is said to contain 30 snickers, 145 laughs, 50 roars and an eye dropper full of tears. To outline the plot of the play would be to deny you the pleasure that is to be experienced in its various twists of action. Doubtless you will wonder about the origin of the title and how they can refer to the mayor as "Their Honor," a strange situation indeed.

Play night has always been the big night of our Chautauqua program. This year it promises to be bigger and better than ever before.



BONUS BILL LAW.

This was a margin of two votes more than the necessary two-thirds majority as compared with the 52 votes that were to spare when the veto was overridden in the house last Saturday.
President Coolidge made a futile last minute effort to have his veto sustained in the senate, calling to the White House for a breakfast conference seven Republican senators. Four of these, who previously had voted for the bill, cast their ballots in support of the executive.
