COL. Wm. C. Knight and Mr. P. H. Starke, of Richmond, have given notice to Gen. Bradley T. Johnson and Col. Wm. Tanner, that they will contest the seats in the Senate, to which the last named gentlemen were declared elected in the recent Senatorial election in the Richmond district.

The Anti-Tammany Democrats have determined to enforce their recognition by the party in New York, and if they are not recognized in the next Convention their influence will not be thrown in favor of the Democratic party.

It is generally believed that the members of the Legislature, who have been elected as Independents, will not be allowed to participate in the Conservative caucus at the coming session.

KNOXVILLE, Tennessee, was visited by an Earthquake last Friday morning at 2 o'clock. It lasted about ten seconds, and was the severest one ever felt in that section.


