### 118 Years Old.

In the Alleghany mountains of Virginia, in the County of Bland, lives "Uncle Jimmy" Surratt, half Indian, half white man, said to be 118 years old. At this age he is still vigorous, and does a rude sort of farming at his mountain home, and when visited he was found mowing grass with a scythe, but immediately left off, and with child-like obedience stood in front of his cabin to be photographed.

Although illiterate, he talked very interestingly of his long life, stating that he walked from Alabama to North Carolina Carolina when he was a young man perhaps not more than twenty. His first wife died there, and he married a North Carolina woman, who came with him a few years later to Bland county, Va., where he has spent the remainder of his remarkable period of life.

His home is the most primitive, containing no windows, but a few splint-bottomed chairs and a bed evidently manufactured by "Uncle Jimmy," himself. He has a son, now eighty years old, living in Smyth county, Va., the child of his second wife, now dead. He spoke of her as "Old Suze," but evidently meant no disrespect. He is now living with a third wife, who is some forty or fifty years younger than he.

"Uncle Jimmy" is a teetotaler, having forsown drink and joined the "Sons of Temperance" some forty years ago, when only eighty or thereabouts. Although the organization soon perished from that particular portion of the earth familiar to the old man, he regarded his pledge as for life, and has clung to it with true Indian tenacity.

He stated that he could return to Alabama by the same paths over which he came nearly one hundred years ago, and could "cross the rivers at the same places." He claims that his father was an Indian chief.

### Goes to Birmingham.

Bristol, Va., Sept. 25.—The Rev. Eldridge Copenhaver and wife, who had been visiting at Mr. Copenhaver's childhood home in Tazewell county, Va., came to Bristol last Friday, being on route for Birmingham, where Mr. Copenhaver is to begin his duties as pastor of the Lutheran church. Until very recently he had charge of similar work in Chicago, but accepted a call to Birmingham prior to his departure from Chicago for his old home.

So way here in my Southern California bungalow, over three thousand miles from you all, I go over my past days among my many trips through the Southwest, and think of the many fine times I have had there and how I would like to step in some Monday morning to Marion on court day and stand on the old Valley House corner and take the hands of my friends that I was accustomed to see them in days gone by, and I hope to do so some day. This is, I think, one of the finest countries that the sun shines on and the more I see of it the more I am convinced it is the ideal place for one to live and enjoy life. Our summer here has been delightful and we have slept under double blankets the whole summer and we have the greatest quantity of fruit and vegetables of all kinds and at a low price, so that we can all live at small cost. I am so sorry that you have had such a drought in Virginia this summer, for I know what that means to so many a people and such a loss of money in grains, cattle, etc.

Well, I will close by saying that the latch-string of my California bungalow hangs on the outside for any of my Marion or Smyth county friends that may come out here.

### Old Resident Passes Away

Green Lake people were greatly shocked to learn that J. W. Anderson, residing with his family at 947 North Seventy-eighth street, had died quite suddenly at his home. The real cause of his death was paralysis, and the original trouble came about in this way:

Mr. Anderson was employed by the Washington Mattress & Furniture Co. at Western avenue and Pike street. On May 15th, while standing on a ladder performing some duty, he slipped and fell to the cement walk below, sustained injuries to the brain from which he never recovered.

He would have had spells, then rally, only to be again forced to take to his bed. Some weeks prior to his death, Mr. Anderson was forced to give up work entirely, and two weeks later took to his bed, and never arose from it again. It was ascertained that clots of blood had formed on the brain, and this caused paralysis.

The deceased was aged sixty-eight years, and leaves besides a wife, ten children, nine of whom were in attendance at the funeral. The Anderson family had resided in the vicinity of Green Lake for the past ten years, and were well known by the older residents and highly respected.

The funeral took place at three o'clock Friday, interment being in Oak Lake cemetery, the remains being followed to their last resting place by a large concourse of both relatives and friends.

The above notice is taken from a paper published at Green Lake, Seattle, Oregon, and was furnished The News by Miss Grace Anderson, daughter of the deceased, whose death occurred August 2, 1911. J. Wesley Anderson was reared in this county, and is known to a large number of our readers. He left this State perhaps more than twenty years ago. He was a man of sterling worth and highly esteemed by a host of friends. He was a brave Confederate soldier, and his old comrades and many friends and relatives in old Virginia will regret very much to learn of his death.

### Triple Tragedy in Family.

Bristol, Va., Sept. 23.—A telegram received here from Canon City, Col., several days ago, told of a sad triple tragedy there, involving a former Bristol family, Mrs. D. W. Garrett, who accompanied by her husband and child left Bristol for Colorado a few months ago, shot and killed her youngest children, D. W. Garrett, Jr., aged eight years, and Jauanita Garrett, aged six years, then killed herself with the same revolver. Only meager details are contained in such messages as have been received here, but it is believed that Mrs. Garrett had become in sane from despondency, due to leaving her old home here.

Mrs. Garrett was a daughter of the Rev. Asa Ruth, of Piney Flats, this county, and was about thirty-eight years of age. The family owned a farm in Holston Valley, East Tennessee, but for two or three years prior to their locating in Colorado had resided on Kentucky avenue, this city. The father was at that time employed in the department store of the H. P. King Co., while the eldest daughter was a stenographer for the Mitchell-Powers Hardware Co.




