BRISTOL KIWANIS AND ROTARIANS PRESENT AT MEETING ON TUESDAY NIGHT.

TRAINING CAMP.

Virginia has been allowed only the same attendance at the Citizens' Military Training Camps in July as last year.

It was explained at the Headquarters 80th Division today that this is due to the limited funds available and that the number permitted to attend in each State is apportioned strictly according to population.

The places available to Virginians have been apportioned to the various counties on the basis of population, as being the fairest distribution, but it can be stated that this arrangement is only tentative to permit an equal opportunity to all at the start. Places in one county will be given eventually to applicants from other counties unless promptly applied for. Under the apportionment Smyth County is permitted an attendance of 8.

The Virginia Committee believes this is a great opportunity for the young men of this State to obtain without expense a month's instruction and healthful recreation under the best conditions.

The Committee are particularly pleased with the hearty approval voiced by the parents who visited the camps last year and of the arrangements for receiving them this year, and stress the fact that parents, relatives and friends are most cordially invited to visit the camps which will be held from July 1st to July 30th at Camp Meade, Md., and Fort Monroe, Va.

Round Hill Cemetery.

Dear Mr. Editor:

While I have been away from Marion for a number of years I'm still interested in the town, in fact the one spot most dear to me is there. I refer to the Cemetery where I have a baby buried, this is the principal reason for my writing this letter.

I spent two days in Marion recently and while there I spent most of my time at the cemetery; I want to say that I was very much grieved when I saw the condition of the grounds. While there have been a great number of people buried there since I was last there, the place seemed deserted, no interest, no one in charge, no one to go to for information. I finally ran across a man who went to some pains to assist me in finding out what I wanted to know, and made two trips to the cemetery with me. Can't there be something done to improve this sacred hill? I am not a resident of your town but have always expected to some day make it my home, I don't believe there is a better town in the United States in which to live, yet conditions are not as they were in years gone by.

During the night I heard a number of pistol shots, and at the breakfast table I mentioned this and no one seemed the least bit surprised. Some one remarked "nothing unusual about that, we hear them most every night." Well the point is this: when I lived there and heard a shot at night, some one was told the next day that he would have to go around and explain to Jack why he disturbed the peace of the town by shooting within the corporate limits. Blaine had a way of finding out everything that went on, either in the night time or during the day. The people never realized what a treasure they had in these two men. They never passed the buck, they felt the responsibility and measured up to it. What a pity you people can't persuade them to again take over the management of the town, and give you a few more years of real worth while government. I have traveled a great deal since leaving Marion, and I have never yet found Blaine Richardson's equal when it comes to governing a town. I often wonder how he managed to be on the job all the time both day and night, but he did it. He was interested and considered himself responsible for everything that concerned the town and surrounding country. He made all the arrests within a radius of five miles. I saw him send out and pay for ten telegrams one time trying to catch a man who was wanted at Bristol for some offense. You don't find many officers who now go to any trouble to prevent crime. He never let a law-breaker get by, and still they all seemed to be his friends and would tip him off to what was going on, he was fair with them all and they knew it.

You didn't have to look at the calendar to tell when it was Sunday, all you had to do was to ask for a drink at the Soda Fountain. No gambling, I remember one time he and Jack Sheffer, who was mayor, made Ellis Dickinson stop running a pool-room because they caught some men gambling there one night. How is it now? Have you been in one of your pool rooms lately? Well it's no place for your boys.

It strikes me that you people are letting things get away with you, nobody seems to care. You may have, and I don't doubt that you have, good men in office, but good men don't always make good officers. I have been boasting about Marion's government ever since I left there, and have always said I would go there to live some day; but now I find the old town is being run about like the rest of them.

So much for the knocking, I was utterly surprised at the wonderful changes in the town, everything moving right along in a business way; many new buildings and new businesses, splendid growth, a real young city. Different people; I didn't meet but very few people I knew. New school houses, new college building, new bank and store buildings. Such a wonderful town you have, such a place it would be if you could only have such officers as you had fifteen years ago. Take it from me—get them—get them even if you have to go down in your pockets and pay them, it will be money well spent.



RECORD OF DEMOCRATIC EXTRAVAGANCE

Here are just a few of the high spots of the last administration, as revealed in the official inquiry of a congressional investigating committee which in the nature of things could get to the bottom of only a small percentage of the cases calling for condemnation at a time when incompetency was well nigh universal and graft ran rampant while the fate of the nation hung at stake in the most gigantic war of history:

Bought 41,000,000 pairs of shoes for 3,500,000 soldiers.

Bought 149,456,611 bread cans, or 42 for every man under arms.

Paid out \$484,425,566.11 on claims presented after the war, many of them without a contract, most of them without an accounting, many without any legal justification, over the continued protests of Republican members of Congress. A casual audit by General Lord indicated that on one-tenth of the settlements with contracts there had been over-payments of \$46,000,000.

Spent twenty million dollars on coke ovens which produced no coke.

Spent \$35,000,000 on picric acid plants which produced no acid.

Spent \$127,661,000 on terminals and docks at which no ship ever tied up.

Spent \$116,000,000 on poison gas plants which furnished no gas.

Four billion dollars was spent on ships which took no part in winning the war because they were not in use; it is estimated that half of this sum was wasted, much of it on wooden ships which proved unseaworthy and rotted at anchor; hundreds of other ships were sold at a small fraction of their cost.

Records were destroyed, papers hid and documents abstracted from the files, as shown by the report of the Graham committee in order to make impossible prosecution of criminality.

Eleven billion dollars were loaned to foreign nations without evidences of indebtedness making collection possible except by negotiation, of which \$1,500,000,000 was loaned after the war was over and \$300,000,000 to nations not involved in the war.

Trees were cut down on cantonment sites and lumber hauled for miles to construct buildings on these same sites; corn crops ready for gathering burned and grain purchased to feed the government's horses; valuable materials dumped in excavations or thrown into streams scores of thousands of unnecessary people employed at excessive wages on cost-plus contracts in order to run up the plus and encouraged to shirk on the job; materials bought at excessive prices in order to swell the contractors' profits on a percentage basis; scores of thousands of motor vehicles permitted to decay and rust exposed to the weather while the government had acres of covered storage; many millions of tons of excess canned food held from the market while prices were high to carry out agreements with contractors, from which this stuff was bought at excessive prices, in order to prevent breaking the market and afterwards sold for next to nothing; thousands of costly modern houses built for government employes and employes of government contractors at remote places and turned over to the bats and owls at the end of the war.

Purchased 945,000 saddles, 1,000,000 sets of double harness, 1,148,000 horse covers, 2,350,000 halters for the 391,000 horses and mules used in the army. If all the orders made by the War Department had been filled they would have required 300,000 more hides than the total output of the United States, which caused a doubling and trebling of the price of shoes and other leather products.

Purchased 195,000 copper-tipped branding irons to brand the government's 391,000 horses and mules: at the conclusion of the contract the government bought 20,000 pounds of left-over copper from the company at 39 1/2 cents and sold it back to them at 11 cents; then the government allowed \$40,000 for profits the company would have made if it had made more branding irons. Not a branding iron was used during the war.

We bought \$21,000,000 of ambulance harness when our ambulances were motorized.

Bought for 391,000 horses and mules 1,637,000 horse brushes, 1,148,364 horse covers, 2,033,204 nose bags and 712,510 sets of spur straps, or 36 sets apiece for every officer entitled to use them.

Spent \$206,632,920 for sixteen national army cantonments, built by the cost plus system, which could have been built for \$128,101,399, or \$78,531,521 less money with the waste and graft eliminated. Spent \$1,200,000 for camps and cantonments in which the conservatively estimated waste and graft was \$400,000,000. These contracts were let without bids.

Spent \$60,000,000 to build a powder plant at Nitro, W. Va., which never produced a pound of powder; after the war the entire plant, with personal property worth conservatively ten million dollars, was sold for \$8,551,000. The company which was paid \$11,293,297.11 for operating the Nitro plant produced no powder that could be used during the war.

Spent \$80,000,000 in constructing and operating a powder plant at Nashville, Tenn., which produced no powder that could be used during the war, and \$116,194,974.37 on nitrate plants at Sheffield, Ala., Muscle

Shoals, Ala, Toledo, O., and Cincinnati, O., which did not produce a pound of nitrates during the war.

Spent to the date of the armistice \$1,051,000,000 for aircraft construction without producing a fighting plane the total of observation and all other forms of planes sent to Europe being 3,214. A recommendation of criminal prosecution in this case was made by a legal commission of investigation headed by Justice Hughes, but no action was taken by the Wilson administration.

President Wilson spent over \$1,691,000 on his jaunt to Paris for board, lodging, tips, etc., a loose accounting for which was made upon the insistent demand of Congress. This was the price paid for President Wilson's signature to a treaty and covenant which the American people repudiated at the first opportunity, the treaty itself having brought untold suffering to humanity with the slightest compensation, material or otherwise, to the American people.

If all this, and much more like it, be "honest and faithful public service," Chairman Hull and his associates in Democratic leadership should make the most of it!—Nat'l Republican.
