The Professor just took the audience by storm, and the applause that was given at the end of each song was hearty and prolonged, and we can truthfully say that everyone was sorry when it came to an end. 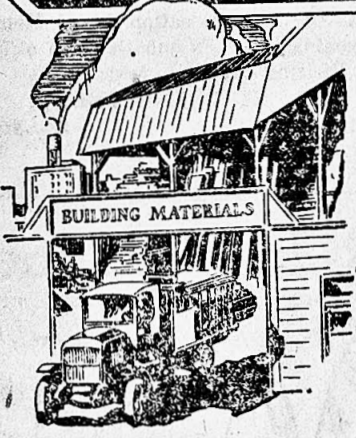

Marion Junior College Opens September 19

Marion Junior College will open on September 19th, with a large enrollment of both boarding students and day students. The buildings are being put in readiness by a force of workers and teachers and students will begin to arrive on next Monday. The opening date was fixed one week late on account of the absence of President Cox, but the session will be extended so that it will be of standard length.

Day students will register on or before Monday September 19th. Each has the privilege of a conference with the Dean or President for arrangement of schedule, when consideration is given to the future plans of the student and effort is made to choose a suitable course in view of these plans. Individual consideration is the key-note of the policy of the college.

M. on Thursday, September 22. Students who wish to take music should register early in order to get the special time which will fit in with their other work, since the music department will be full. This is particularly important with reference to day students who wish to arrange their music schedule to correspond with their public school schedule.

There will be a large class in the Secretarial department. This year the Gregg system of typewriting will be used. The course includes shorthand typewriting, business English, office management, etc. The head of the department is Miss Meta Tolbert, who was educated at Winthrop College, the University of Virginia, and Strayer's Business College of Baltimore.

Many of the parents who will accompany their children to the College have made reservation at the General Francis Marion Hotel since there will not be room to entertain them at the College.

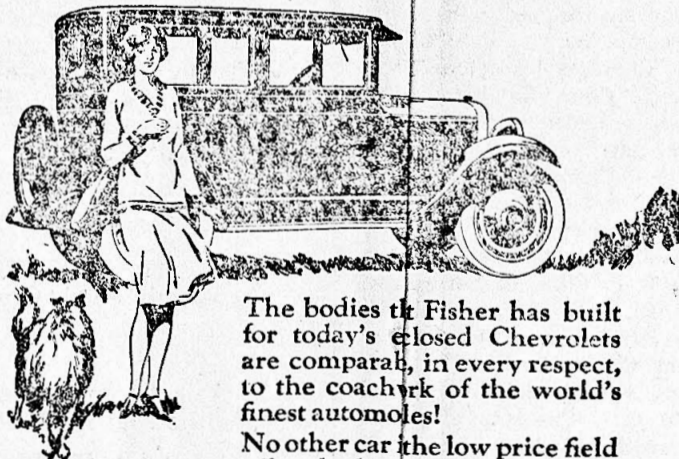

A YEAR TO THINK IT OVER.

When President Coolidge said: "I do not choose to run for President," it caused our country to consider what would happen if our present sound industrial structure and returning farm stability was tampered with, under a changed national policy by Democrats.

It makes no difference with what political party we are affiliated, we still must earn our bread and butter through regular and steady employment. It may be good sport for politicians or political parties to heckle each other with criticism. But when a public official of whatever party, who has guided his country through a troubled period in the world's history with increasing prosperity and reduced taxes, decides voluntarily to turn the reins of government over to a successor, he leaves a responsibility which causes aspirants for his position to think seriously before attempting to assume his duties.

It may have been good business to criticize President Coolidge for showing a favorable attitude toward business development. Some people may have seen humor in commenting on his New England thrift. The political wind-bag may have felt he was strengthening his own position by poking fun at the President's retiring manner, laconic statements and disinclination to talk except when required to do so.

But that is all passed. It is now up to the critics and the admirers of President Coolidge, in both parties, to see if they can match his record for sound administration of the greatest corporation in the world, namely the United States government. The stockholders of this corporation, the citizens of the United States, today know more about business, more about investments and more about conditions which are necessary to assure steady employment of labor than they ever did before. Most of the campaign thunder and political hocus pocus which was supposed to appeal to the voters in the past, will no longer fill the bill.

The voters of this country are like the baby that has grown out of the celluloid rattle and rubber doll stage—they want more solid meat, and making faces and acting the fool before them on the theory that it will please and amuse them, as it sometimes does the small infant, will no longer appeal.

The ten short words uttered by President Coolidge give this nation a year to realize and consider what would happen as the result of any radical change in our present constructive and conservative national policy. Banker, factory executive, laboring man, public utility president, railroad manager, clerk and housewife have an equal opportunity to think over the situation and their own position in the picture.

President Coolidge has left a mark for both the Republicans and the Democrats to shoot at. If the public officials chosen by either party miss the mark the nation will be the one to suffer.

THE DEMOCRATS DILEMMA.

Southern Democrats seem to regard the nomination of Governor Smith as more or less inevitable in 1928. That has been the feeling also in the border states and among northern Democrats who are inclined to oppose the New Yorker. The reasoning of Democracy runs something like this: Governor Smith was a candidate in 1924, will be a candidate in 1928, and if not nominated then he may be an aspirant in 1932. Meanwhile the party is rent in twain because of his ambitions. If he is nominated many Democrats will be temporarily alienated, but if he is not given his chance many other Democrats may leave the party for good. It is felt that Governor Smith must be given his chance, and while he may take one of the worst beatings any candidate ever took, it may not be said that he was denied his opportunity. While that kind of counsel is that of despair, the Democratic notion is that defeat may have to be faced for the sake of party solidarity in the future.—*Philadelphia Ledger.*

FARM RELIEF COMING.

Farm relief at the coming session of Congress is imperative. Such were the words this week of Senator Borah of Idaho, an opinion expressed after interviews with informed persons in travels from Chicago, west to the Pacific coast. They are in line only with the idea agricultural leaders have had since the last failure of the Haugen-McNary bill to be enacted into law.

Agriculture knows that it rightfully asks and expects the same federal aid, protection—or what have you—accorded American manufacturers or other industries enjoying a high tariff. That agriculture means to attain its objective was thoroughly demonstrated at the St. Paul Conference of agricultural leaders this summer.

While capital always wields a powerful hand when opposed to an issue, in this particular instance the forces are divided and for a very good reason, namely that there are manufacturers with vision enough to see and know that agriculture must be put on a sound basis for the nation's prosperity to be economically sound.

The mid-western manufacturer, closer than his Eastern brother to the seat of trouble, is in many instances now advocating the passage of a farm relief bill as sponsored by agriculture. Evidence of this comes in reports of an interview with Jaul F. Beich, a candy manufacturer of Bloomington, Ill., president of the Illinois Manufacturing Association, which was broad-casted quite generally last week. Mr. Beich said: "We must help the farmer. He works hard and gets less for his toil than almost anyone else in this land of prosperity and luxury."

Such expressions substantiate Senator Borah's latest declaration. And didn't he say a mouthful: "Farm relief is imperative."

ONE PARTY OFF THE MAP.

History repeats itself—sometimes. Quite often it does not. History of political parties in the United States almost never repeats itself, except when it wears its rue with a difference. For example, there is not the least prospect now that the Liberal-Progressive movement of 1924 will return to the political

stage next year. This seems to be the one point upon which skilled political observers agree in their predictions. They do not know what else may happen, but they are perfectly confident that there will not be another effort to combine socialists, radicals and the various tribes of discontent, such as Senator La Follette made in the last Presidential campaign. It is doubtful if his son and the other survivors of that zealous band will even muster up enough courage to present a name for nomination in the republican convention. There is some talk of bringing forward for this purpose Senator Norris of Nebraska, but that would be obviously only a forlorn gesture.—*New York Times.*

Marvin Raymond Carico, son of James and Alice Carico, was born Aug. 29, 1912, and died Sept. 4, 1927. Aged 15 years 11 months and 28 days. His neighbors say of him, that he was a kind accommodating boy from his childhood. He was a great joy to his home and loved ones. It seems strange that one so young and full of hope should be taken so suddenly and untimely from the home, in such a tragic way. He met death by the explosion of some explosive, which he and some other boys gathered near the Fair Grounds after the fireworks were set off Saturday night.

On Sunday morning, Sept. 4th, he in company with some other boys set fire to the explosives, causing it to ignite, setting his clothing afire and burning him so badly that he died about 8 o'clock P. M. of the same day.

As soon as he was burned he began to pray and continued praying until God saved him, and he smiled and said "Sweet Jesus is with me and the way is clear," and a few moments later passed into the Great Beyond.

We pray that God will sanctify the sad ending of this young life to the spiritual good of the entire family, and that some day they may be reunited in that lovely city where there is no death.

The funeral service was conducted from Greenwood church by the writer, in the presence of a large and sympathizing congregation, after

which he was tenderly laid to rest in the Greenwood cemetery.

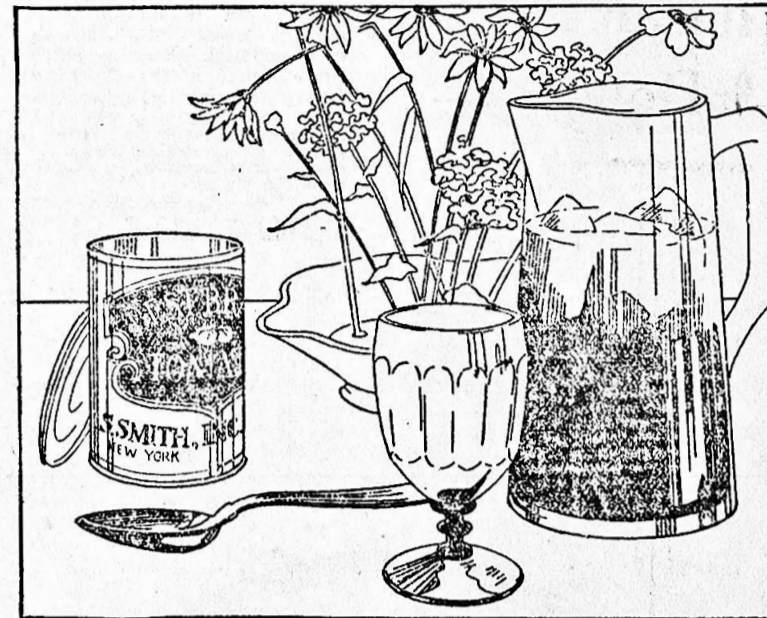

Style Changes In Tomatoes



THE tomato has worn many garbs during its four hundred years of appearing on the tables of Europe and America. First it was used raw. As soon as it was discovered that it tasted good when cooked, there came into existence for the delectation of millions of consumers that good old-fashioned dish, stewed tomatoes. How seldom do we see stewed tomatoes on a menu now! The stew has become a scallop, a soufflé, a tomato omelet. Canned tomato is used in a dozen new ways in dishes where it is the main ingredient, and as an accessory to other dishes. Lately, the juice strained from canned tomatoes has become popular with many people as a summer drink, either between meals or at the beginning of a meal. In some of the best-known health resorts a pitcher of tomato juice is kept on the table. **Tomato-Egg Aspic**—Blend a can of tomatoes with a can of beef bouillon, seasoning with salt, pepper, celery and onion salt. Soak gelatine in one-fourth cup of the liquid, allowing the proportion of gelatine indicated on the package to each one and a quarter cups of liquid. Bring the remaining mixture to a boil and dissolve gelatine in it, then allow to cool. Cut six hard-boiled eggs in two, remove the yolks, and mix them with mayonnaise, then replace in the whites and put the halves together, laying the eggs around a circular mold. Pour the cooled tomato-bouillon mixture over them and chill. Fill the center of the mold, when serving, with finely shredded cabbage generously mixed with mayonnaise dressing.

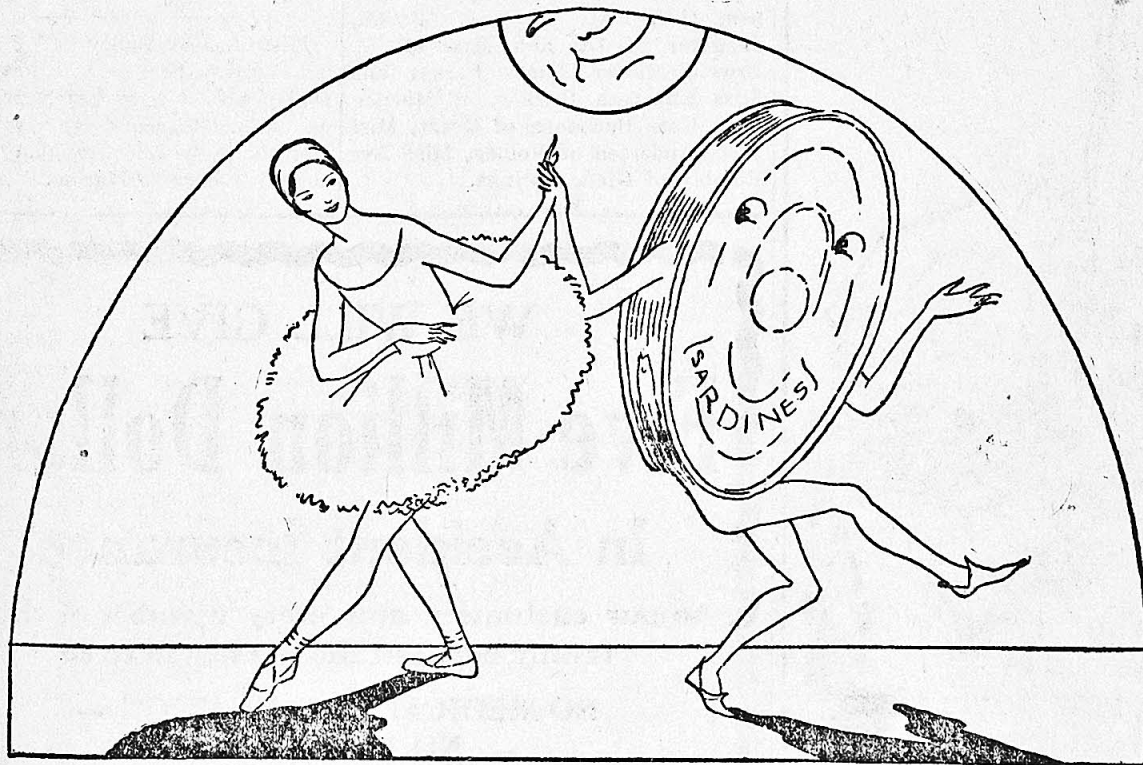
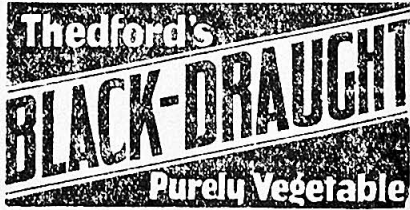

*"The way was long, the night was cold,
The ballet girl was growing old,
So she bought sardines with her hard-earned pelf
And had a can-can all to herself."*

THIS doggerel was written many years ago. Jazz dances have replaced the can-cans; but sardines have retained their popularity, and there are now many new varieties of canned food to comfort the ballet girl.

Strange as it may seem, there is no such thing as a "sardine."

Fish known as sardines, are small pilchard minnows abounding in Mediterranean waters and were called sardines because they were first canned on the island of Sardinia. Sprats, mussa, sild fish, all belonging to the herring family, are packed in various countries throughout the world as sardines. It isn't the fish that matters so much as the way in which it is canned. The French canners put oil, truffles, and other dressings with the fish, and pack them very closely into the cans. Most of the canners use olive oil alone.

The California small sardines resemble the Mediterranean species more than any fish of the same type in other parts of the world. Since 1905, however, Southern California canners have been putting up a larger variety combined with tomato sauce in one-pound oval tins, and these have become popular.

The large oval can has several advantages, a very obvious one being that it contains enough fish for a whole family. In college dormitories, too, where sardines have always been popular for impromptu feasts, the new style of can is recommended as being better adapted to the capacity of stu-

dent appetites—and also to student purses, for, comparatively speaking, the price of the oval can of sardines is in inverse ratio to its size.

So, though their salty, meaty taste is superlatively appetizing, sardines need no longer be relegated to the lesser place for an hors d'oeuvre. Anyone has only to try the two following dishes to discover that sardines as now canned are more than an accessory.

Duchesse Potato with Sardines—Boil potatoes, mash, add milk, salt and pepper, and heat until creamy. Make a large oval mound of them on a platter of oven glass. Sprinkle grated cheese over the potato, and surround it with small pieces of toast on which are laid evenly the contents of a large oval can of sardines halved lengthwise and boned. Put the platter under the broiler just long enough to melt the cheese. Serve with this dish finely shredded cabbage well mixed with mayonnaise dressing, a pinch of salt being added, and on top a generous sprinkling of paprika.

Broiled Sardines on Toast—Remove the contents from a large oval tin of sardines, place them on a broiler and broil them for about three minutes. Butter the toast and then spread it with a very thin coating of mustard. Place the sardines on the toast and serve immediately.

All who value their health should live on light diets during the summer. For these the great refuge is the salad, all kinds of salads. Sardines are a great asset to a salad, as

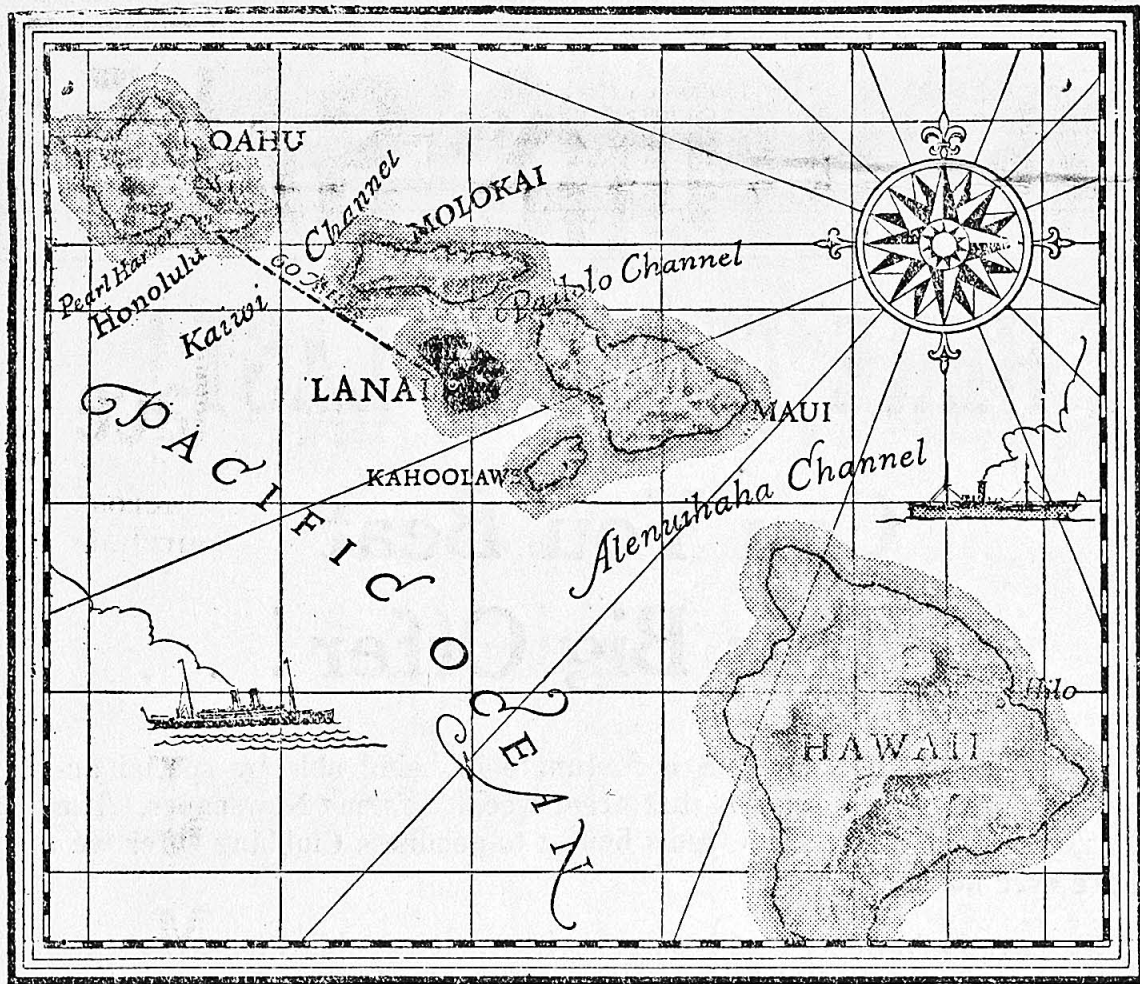
their spicy flavor leads to a larger consumption of leafy foods. The following suggestions are made for using them:

Sardines in Tomato Jelly—Strain the juice from a large can of tomatoes. Dissolve two tablespoons gelatine in half a cup of boiling water and add this with teaspoon of paprika, half a teaspoon of onion juice, and salt and pepper to taste. Add these to the tomato juice, simmer five minutes in double boiler. Strain through cheese cloth. Pour half the mixture into a ring mold and let it partially set. Then put in sardines that have been skinned and pour in the rest of the mixture. When firm turn out on a platter and fill the hole in the center with mayonnaise and garnish the outer edge with lettuce leaves.

Sardine Salad—Shred half a lettuce, chop three sticks of celery, skin, bone and break into pieces the contents of a large oval tin of sardines. Combine with mayonnaise dressing and serve on lettuce leaves.

Sardine and Egg Salad—Cut into pieces three hard-boiled eggs and contents of one large oval tin of sardines. Combine with mayonnaise dressing and serve on lettuce leaves in a circle of sliced cucumber and sliced radishes.

Picnic Sandwiches—Mash large sardines, after skinning and boning them, mix with mayonnaise dressing and chopped cucumber pickle. Spread between rye or graham bread.



Giving A Trip To A Whole Legislature

WHEN the members of both houses of the legislature of Hawaii went recently as the guests of James D. Dole to Lanai, the sixth largest island in the group, they marveled at the change which has been brought about in four years—a cactus-covered, South Sea Island converted into fertile plantations which this year will produce approximately 25,000 tons of pineapples. In a few years, it is estimated, Lanai will produce one quarter of the entire pineapple output of Hawaii, the greatest pineapple-raising country in the world.

The legislative party arrived at Kaunapali harbor, which is one of the first wonders that awaits visitors to Lanai. Kaunapali harbor was literally blasted out of the sea at a cost of \$750,000—one of the greatest engineering feats of modern times. The long wharf was constructed and a breakwater 300 feet long was made with 116,000 tons of rock to guard against the waves. It is down to this harbor that the big five-ton trucks bring their pineapples from the plantations to be shipped to all parts of the world.

Leaving the harbor, the visitors drove over seven and a half miles of concrete roads to Lanai City—a former cattle ranch. Today it is a spotless town of pink roofs and flower gardens, laid out in squares. The population, largely pineapple workers, is made up of Filipinos, Portuguese, Porto Ricans, Hawaiians, Japanese, Chinese, Koreans, Anglo Saxons and a

Russian—all living together under ideal conditions. Schools and playgrounds, churches and clubs, a city hall and public parks mark Lanai as a progressive American town.

A trip to the pineapple fields revealed further wonders which have been achieved in four short years. Orderly rows of pineapple stretch in all directions in patterns so geometrically perfect that visitors wonder how it had been possible to convert straggling cactus into such perfect pineapple cultivation. Guides explained that the fields were dragged clean of the giant cactus growths by means of tractors and chains. The soil is deep and fertile, red and dusty. The fields are in every stage of cultivation from the plants newly set out to plants about to bear fruit. Windbreaks of eucalyptus protect the tender young plants, and dustbreaks of elephant grass are grown along the roadways.

James D. Dole, president of the Hawaiian Pineapple Company, explained to the legislative members what Lanai will mean financially to the Hawaiian territory.

"The pineapple industry, which 25 years ago amounted to nothing, is now producing annually about \$35,000,000 worth of products," Mr. Dole said. "This export adds largely to the wealth, comfort and tax-paying ability of the Territory. In a few years this output will probably reach at least \$50,000,000 per annum. The development of Lanai will doubtless mean

an additional \$10,000,000 annual business done by the Territory."

Since it became generally known that the sunshine and soil of the Hawaiian Islands produces the smooth Cayenne, the finest pineapple grown, the demand for Hawaiian pineapple has rapidly increased. The world has been supplied with this field-ripened fruit by means of canneries located near the plantations which put the pineapple into cans at the moment of maturity.

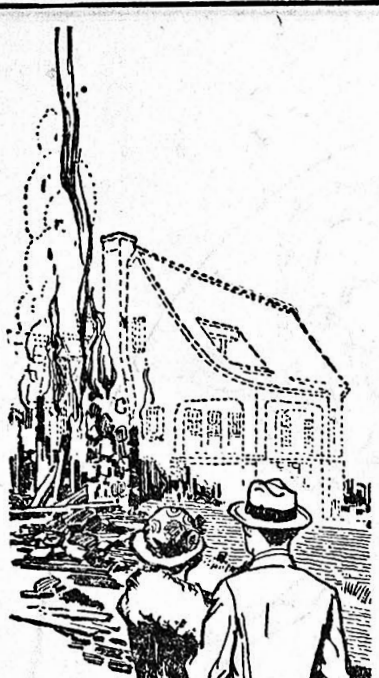
In 1922, however, it was foreseen that the enormous demand for Hawaiian pineapple would soon exceed the supply if more land were not acquired for cultivation. The islands, except Lanai, were good only for cattle raising, and pretty well filled up. Scouts investigated Mexico, Fiji, San Domingo, Malaya and even Australia. They came back again to Lanai, however, since the soil, climate, altitude, rainfall and natural drainage were about right for pineapple. But there were no harbors, no roads, no town, no food or water supply, no labor and the prickly pear cactus made it almost impossible. It was finally bought, however for \$1,100,000. Today Lanai is assessed at more than \$3,000,000.

The legislators proclaimed themselves delighted with the prospect which Lanai reveals. While Britain, Brazil and Cuba wrangle over the world's control of rubber, coffee and sugar, American business sense has secured the future of pineapple on Lanai—a territorial American estate.

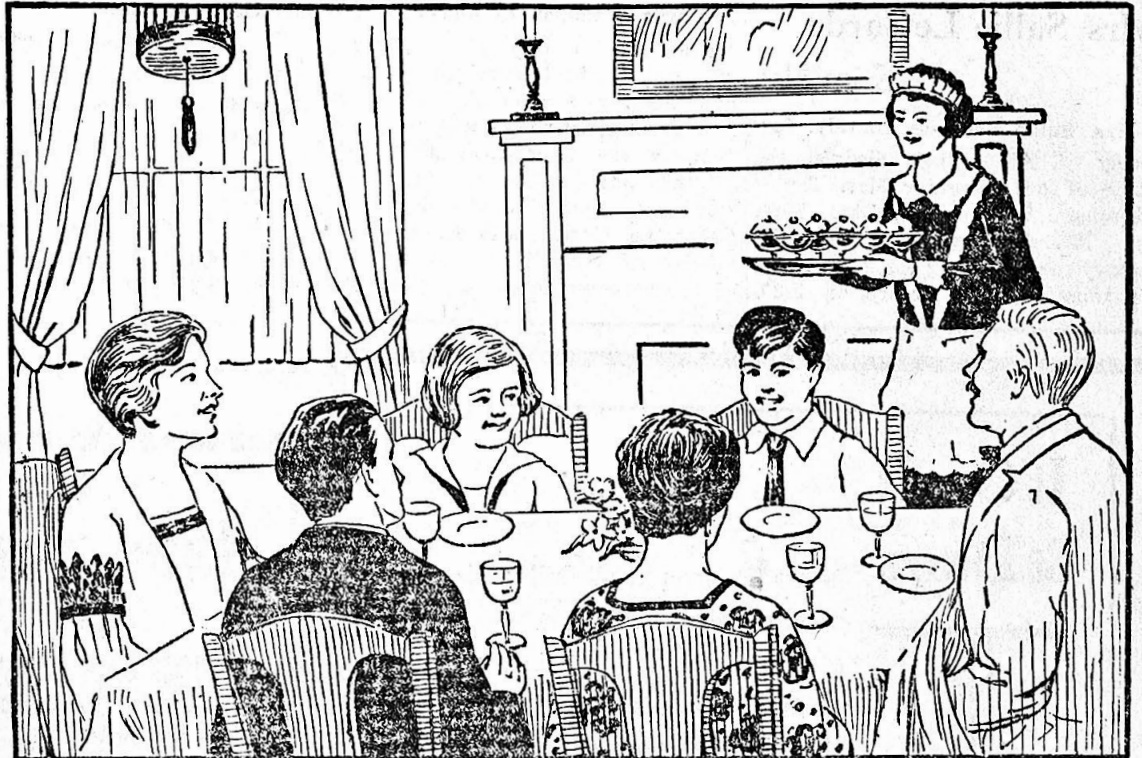

What Shall We Have For Dessert?

DESSERTS are not a burden if they are prepared well in advance. If they are made early in the day or even the day before, the housewife may go out shopping, or may take tea with a friend, without worrying about her dinner. Some desserts are much better for having been made the day before. For instance this crème brûlée. It is made by bringing to a boil two cups of evaporated milk, taking it off the flame and stirring into it four eggs, three tablespoons sugar and a pinch of salt, all of which have been beaten thoroughly together. Place in double boiler and continue stirring five minutes. Pour into pudding dish to cool. Top with either brown sugar or drained canned fruit mixed with powdered sugar. Any of the canned small fruits may be used thus. Hot puddings are better used when the first part of the meal is very light or takes little work to prepare. Peach cake tastes good cold, but it is ambrosia itself when hot. Make it by adding extra butter and sugar to any good muffin batter. Spread on a shallow greased pan, and press into it thick slices of canned peaches, dusted with powdered sugar and cinnamon. Sprinkle with ground nut meats and bake in a moderate oven. This steamed blueberry pudding may be cooked in advance and reheated when required: Sift together one and one-half cups flour, two teaspoons baking-powder, one-half teaspoon salt, one-quarter cup sugar. Add three tablespoons melted butter, beating it in thoroughly; then add two cups of canned blueberries from which the juice has been drained, and one-quarter cup milk. Serve with this a foamy sauce made by cooking together one cup brown sugar, two tablespoons water, and one tablespoon butter, then taking off the flame and beating into it a beaten egg. Shop once a week and keep the supply shelf stocked with ingredients needed for these desserts, so that any one of them may be made at any time. There should always be some cans of mixed fruits for salads, white cherries, sour red cherries, moist coconut, dry shredded coconut, peaches, apricots, blackberries and blueberries. masn, add sugar, vanilla, and enough evaporated milk to bind the mixture together. Put on individual plates in moulds; garnish with whipped cream, slices of canned pear, and lady fingers. Any kind of fruit sponge proves a popular dessert, the following, made with cherries, particularly so. Heat a can of cherries and strain off the juice. Soak one table spoon gelatine in a little water and add to the hot juice. Chill. When it begins to harden, beat it and add the whites of two or three well-beaten eggs. Pour into a mold with alternate layers of cherries. Chill. Turn out and garnish with whipped cream to which sugar and vanilla have been added. Coconut blanc mange is nice made in individual portions. Stir three tablespoons cornstarch in a little milk and cook in two cups of milk. Add one-half cup of sugar and three beaten eggs, then a cup of canned coconut, a pinch of salt and a tablespoon of vanilla. Pour into cups, cool, and set in the refrigerator. Use the remainder of the coconut as a garnish, along with little moulds of raspberry or apple jelly. The canned coconut is so moist and fresh that it is delicious in this blanc mange. A very simple cold dessert that may be made before it is required, is blackberry mash. Bring a can of blackberries to a boil and sift in one-half cup sugar and one-quarter cup flour, stirring all the time. Pour into a mould, chill and serve with cream.

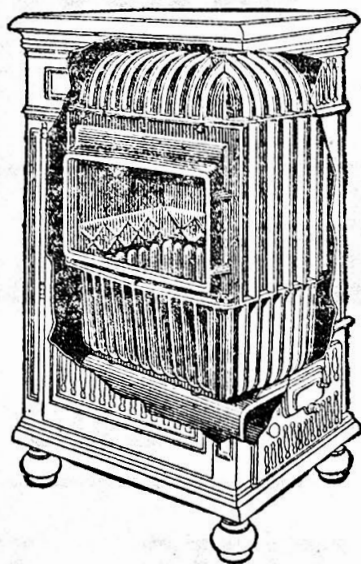

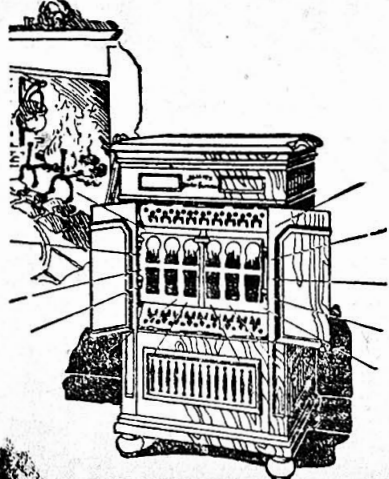

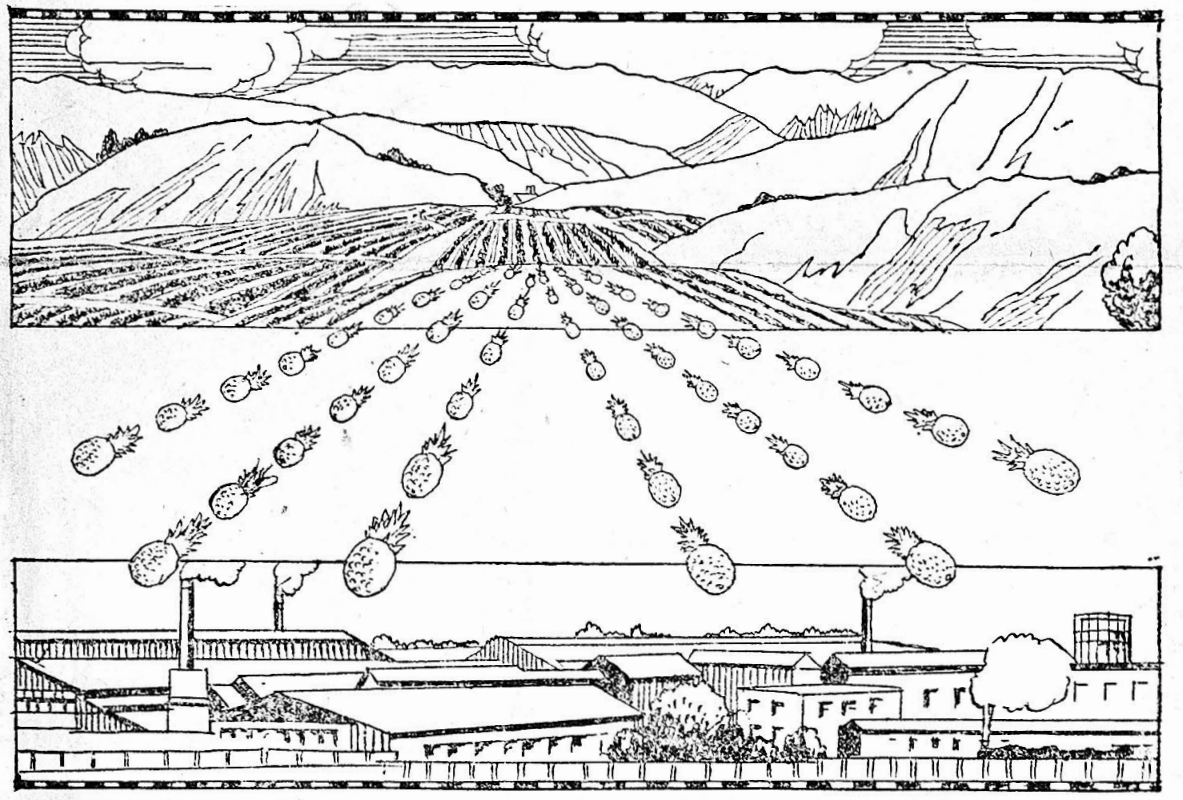

250,000 PINEAPPLES A DAY

THAT'S the number of ripe pineapples that travel down from the foothills daily, during midsummer, to keep the biggest fruit cannery in the world running full tilt. This is the cannery of the Hawaiian Pineapple Company located in Honolulu, the principal city of the Hawaiian Islands. Pickers, men and women, pass down the mile-long rows in the uplands, and break the pineapples off. They are carried to the ends of the rows in bags, and there workers cut off their spiky tops, and pack them into field crates, according to size, because each diameter of pineapple fits a certain diameter of can.

These pineapples are shipped to the United States, and nobody in Hawaii, where they came from, gets finer fruit than that put in the cans. Even in the public markets of Honolulu the fresh pineapples are seldom as good, because they often wait two or three days for a purchaser, while the canned pineapples are put up on the day they ripen. The pineapple cannery people know this, and often buy the canned fruit in preference to the fresh, right in Hawaii where it grows.

Many Ways to Use Pineapple

There are so many ways to use this popular, sun-ripened fruit it is hard to select from so many outstanding recipes. But, in addition to eating the pineapple or drinking the juice just as it comes from the can previously chilled in the ice-box, here are a few ways in which to serve it.

Pineapple Marguerite: Bring one and one-half cups of sugar and one-half cup of water and the juice of one lemon to a boil and add one can of crushed Hawaiian pineapple. Cool and freeze. Serve in sherbet glasses with whipped cream on top. Fresh sponge cake makes a delectable accompaniment for this.

Pineapple Mousse: Whip one pint of cream and one-half cup sugar until they are very stiff. Add half a cup of pineapple juice. Put in a mold. Pack the mold in the ice-cream freezer with ice and salt for three hours or until it freezes. Turn the mousse out of the mold and sprinkle chopped English walnuts over the top just before serving.

Brown Cream Mold: Put one quart of milk in a double boiler. When hot add two cups of brown sugar. Mix four tablespoons cornstarch with a little milk and add. Stir until it thickens. Cook for half an hour. Take from fire and add one teaspoon of vanilla flavoring and half a cup of chopped walnuts. Put in a mold and chill. For a sauce use chilled crushed pineapple.

Some Hot Pineapple Dishes

Pineapple Turnovers: Drain a can of sliced Hawaiian pineapple. Roll out rich pastry and cut in sheets three by six inches and lay on a baking tin. Lay a slice of pineapple on one end of the pastry, fill center with strawberry or other preferred jam. Wet edges of pastry, bring together over the pineapple, press firmly together, trimming away extra pastry. Bake in hot oven until pastry begins to brown, then reduce heat and finish baking.

Ham and Egg Special: With the old-fashioned but ever popular ham and eggs, fry rings of sliced canned pineapple. The ham, eggs and pineapple not only look well together but taste good too.

Desserts and a Salad

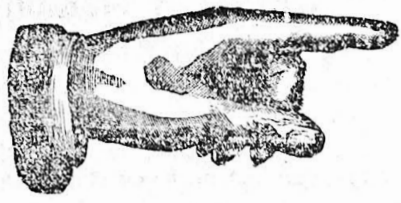
Pineapple Souffle: Melt two tablespoons shortening, add four tablespoons flour and stir till smooth. Add one-quarter teaspoon salt, one-third cup sugar, one cup milk, and bring to a boil, stirring constantly. Pour sauce over beaten egg yolks and mix well. Add one can crushed pineapple. Fold in stiffly beaten whites. Pour into a greased baking-dish, set in pan of hot water and bake in a moderate oven.

Date Goodies: Stuff pitted dates with pieces of sliced pineapple and roll in ground walnuts or powdered sugar.

Pineapple Marvel: Soak two and a half tablespoons gelatine in one-quarter cup cold water for ten minutes. Add one cup boiling water, one cup sugar, and two tablespoons lemon juice and stir till all is dissolved. Add one and a half cups crushed Hawaiian pineapple and juice. When mixture begins to thicken, beat till frothy. Pile lightly into sherbet glasses. Serve with crushed strawberries or whipped cream or both.

Olives with Pineapple: A salad green and pale gold in color, is cool-looking on a hot day. Such a one is this combination: Crisp lettuce leaves as a foundation, then a slice of canned pineapple, then a row of asparagus tips, and lastly sliced olives stuffed with pimiento. Serve with mayonnaise.

Pineapple Pastry: Some cooks introduce various flavorings into their pie crusts with excellent effect. Fruit pies with sweetened crusts flavored with lemon, spices, or the fruit that is in the pie are much more delicious than when made with plain crusts. For a pineapple filling use this crust: Sift together two level teaspoons baking-powder, three level cups flour, one level teaspoon salt, and cut into it with a knife one-quarter cup each of lard and butter. Rub lightly into it with the fingers three level tablespoons sugar, one well-beaten egg, and half a cup of pineapple juice. This makes enough for two large covered pies.
