### AMPHIBIOUS VENICE.

Water is the Venetian's native element. In the quaint gloom of twilight the canals of Venice are alive with her male population, men and boys, and very many little maidens, too, in cloth fig leaves, sporting in the waters like so many dark-skinned Polynesian. They dive, they gambol, they shout, they splash, they make the old walls and slimy waters merry with their cries and laughter, while their nude, white bodies come out against them in shiny, dripping relief, like so many figures of a far-away primitive world, where innocence still rules supreme. Mothers sit knee-deep in water on their house-steps, either holding their six months' old babies, while they kick and splash and cop delightedly on their own account at finding themselves thus early in life in their native element, or else they let the older ones loose, with ropes around their waists, securely fastened either to themselves or the door-rings, to be hauled quickly in in case of emergency. To aid them still further in their nautical exploits, these infants are supplied with breast-boards on which to float until they learn to swim, which feat is soon accomplished, for they take as easily to the water as other children do to green-sward. Indeed, at this time of day it requires some extra skill on the part of the gondolier to pick his way through the swimming, floating, plunging population, as thick in spots as shoals of mackerel in their season, screaming and hustling one another in the brine as vigorously as if sporting on shore. Where there is so much rickety nakedness about, stalwart models of men as nude, saving their waist-cloths, as the classical gods, and little girls and boys ragless, or next to it, at first blush on encountering them in these watery streets of a large city in broad daylight, the stranger is startled; but soon gets accustomed to this novel phase of Venetian life. Salt water is a great leveler.

### SUBSTITUTES FOR KISSING.

Some rude races have strange substitutes for kissing. Of a Mongol father, a traveler writes, "he smelled from time to time the head of his youngest son, a mark of paternal tenderness usual among the Mongols instead of embracing." In the Philippine islands, we are told, "the sense of smell is developed to so great a degree that they are able, by smelling at the pocket handkerchiefs, to tell to which persons they belong; and lovers, at parting, exchange pieces of linen they may be wearing, and during their separation inhale the odor of the beloved being." Among the Citagong-hill people, again, it is said, "the manner of kissing is peculiar. Instead of pressing lip to lip, they place the nose and mouth upon the cheek and inhale the breath strongly." Their form of speech is not "Give me a kiss," but "Smell me." In the same way, according to another traveler, "the Burmese do not kiss each other in the Western fashion, but apply the lips and nose to the cheek and make a strong inhalation." Moreover, "the Samoans salute by juxtaposition of noses, accompanied not by a rub but a hearty smell." There is Scriptural precedent for such customs. When blind Isaac was in doubt whether the son who came to him was Jacob or not, "he smelled the smell of his raiment, and blessed him."

### CURIOUS HABITS.

Great men often fall into curious habits, which they find it impossible to conquer. Augustus Hare, one of the ripest scholars in the English pulpit, and a refined gentleman, when he had ended a train of hard thinking, would spin around on his heel a few seconds and then resume work again. Neander, the famous church historian, could not lecture to his students unless he had a goosequill to pull to pieces as he talked, and it was necessary to supply a second quill when the first was completely stripped. William Wilberforce became so absorbed in conversation in evening companies as wholly to forget himself. He would lift himself from his chair in his earnestness, move forward a little, and gradually approach perilously near to the edge. It was a tradition in fashionable English circles that he had fallen several times to the floor. But in families where he was loved it was the custom to station one of the older children behind his chair to move it forward as he moved and guard him against peril. Some who afterward became leaders in English society retained among the pleasantest memories of their childhood the recollection of the services rendered to this brilliant and eloquent converser. ### HOW TO PRESERVE THE TEETH.

The following directions for the care of the teeth have been issued by the medical committee of the National Dental Hospital, London:  
(1.) The teeth should be cleaned at least once a day, the best time being night—the last thing. For this purpose use a soft brush, on which take a little soap and then some prepared chalk, brushing up and down and across. There is rarely any objection to the friction causing the gum to bleed slightly.  
(2.) Avoid all rough usage of the teeth, such as cracking nuts, biting thread, etc., as by so doing even good, sound teeth may be injured.  
(3.) When decay is first observed advice should be sought. It is the stopping in a small hole that is of the greatest service, though not infrequently a large filling preserves the teeth for years.  
(4.) It is of the greatest importance that children from four years and upward should have their teeth frequently examined by the dental surgeon, to see that the first set, particularly the back teeth, are not decaying too early, and to have the opportunity of timely treatment for the regulation and preservation of the second set.  
(5.) Children should be taught to rinse the mouth night and morning, and to begin the use of the toothbrush early (likewise the toothpick).  
(6.) With regard to the food of children, to those who are old enough whole meals, bread, porridge and milk should be given. This is much more wholesome and substantial food than white bread.  
(7.) If the foregoing instructions were carried out, comparatively few teeth would have to be extracted.

### FASHION NOTES.

Rows of feather stitch are set between the machine stitching on the backs of gloves.  
The name pagoda is applied to the sleeves which are wide and turn back at the wrist.  
An effort to bring back the laced shoe has been made, but buttons still remain in favor.  
Waistcoats are still worn with basques. The style is too pretty to be hastily abandoned.

**GOLD MINING IN CALIFORNIA**  
[New York Graphic.]  
Part of the town of Sonora, Tuolumne county, Cal., is built on a hill. Several gold bearing quartz veins run through this hill. These for thirty years past have been worked at various times, afterward abandoned and then taken up and worked again. Sometimes they yielded richly, and again not at all. They were of the character known as "pocket veins." As many as ten years have elapsed when not a pick has been struck on "Sonora Hill." Years ago the writer took up, and for a season worked, a portion of the hill—without success. Within the last two years out of this same portion \$300,000 have been taken, of which \$200,000 was "all in a bunch." This fact may give an idea of the uncertain character of gold mining as it exists to-day in California. This find has made no noise outside of its own locality. Had it happened in a new Territory it would have been published from one end of the country to the other. Such deposits still exist throughout the entire gold bearing region of California. But no one need rush thither in the hope of finding them. It is simply hunting the proverbial needle in the haystack. Men may spend their lives in such search, and perhaps when they have worked through quartz to within a foot of the "pocket" death or discouragement may overtake them and after a lapse of time the next adventurer may reap the reward which should have been theirs. There is a great amount of gold under the soil in California, but it's very difficult to say just where it is.

READJUSTERS MEETING.

A Fine Attendance—Speech by Capt. F. S. Blair—Resolutions passed Endorsing Cameron and Blair.

On Monday according to notice a meeting of the Readjusters of Smyth County was held in the court house at Marion. It was one of the best meetings we have ever seen held in the county for similar purposes.

Capt. BLAIR arrived in town just about the time the meeting commenced, and was invited in. He was called upon to speak, and made a ringing speech of about three quarters of an hour in duration.

Virginia News.

Most of the Shenandoah county farmers have finished planting corn. Fine veins of the richest copper ore are being developed in a number of counties.

The first shipment of strawberries this season from Norfolk was made on Monday last, and consisted of one crate.

The Sheets farm, 786 acres, near Winchester, Va., has been sold to George Strickland for nine dollar per acre.

Mr. Richard Brooks, of Warrenton, has just sold his picture recently on exhibition in Washington, to the Corcoran Gallery for a handsome sum.

A Teachers Institute will be held at New Castle, Va., May 27th and 28th. All the teachers of Craig are required to attend, and the public generally invited.

It is stated that the Southern terminus of the Shenandoah Valley railroad will be about one mile east of Big Lick, at the point where Tucker creek crosses the railroad.

A citizen of Roanoke county has patented a machine which is capable of making 120,000 cigarettes per day. The inventor, James W. Bon-sacks, is a young man of about 21 years of age, and has been working at his invention about two years.

Messrs. R. O. Gilliam and G. O. Wharton have discovered a valuable deposit of lead on the lands of Mr. Jas. L. Coffee of this county, and have sold the same to Northern parties for \$20,000. The purchasers intend to develop it at once.

The Mayor-to-day signed both of the Sunday bills passed at the last meeting of the City Council prohibiting the sale of intoxicating liquors, and tobacco, cigars or other articles of merchandise in the city on Sunday. The law is considered by many too sweeping.

The counsel for the liquor dealers of Richmond will appeal to the circuit court against the decision of Judge Christian, of the Hastings court, refusing to grant liquor licenses to the saloon keepers who have been fined for violating the Sunday law during the past year.

The Natural Bridge property has changed hands again. Mr. H. C. Parsons, who purchased it some time since for \$14,000, having sold it to the Alleghany Coal & Iron Co., for \$20,000. This property will doubtless become very valuable and a place of great resort when the improvements are all made, it being near the line of the Richmond & Alleghany Railroad.

Oh, and can it be! Hampton and Butler, of South Carolina, parties to another bargain after their recent denunciations of Senator Mahone! It is amazing and astounding. And yet here is what the Washington correspondent of the Baltimore American has to say about it.

Each has railroads in every county and almost in every portion of each county that were induced and secured by county subscriptions. Enterprising men who pioneer such public benefits should be liberally encouraged. Their demand of Smyth County is surely a moderate one. It was necessary to insure the branch railway contract made in behalf of our people by the Va., Ky. & Ohio R. R. Co. Go to the polls and stand by this praiseworthy Company.

The South Carolinians here are highly indignant, and say that the machine Democrats in the State are elated at having outwitted the Administration in this matter through the operations of their peculiar combination.

Religious Notes.

It appears that there are 25 distinct Methodist denominations in the world, with a total of 4,630,730 members.

In 37 years the Church of England has erected 2,651 churches and has expended on church buildings \$200,000,000.

The African Methodist Episcopal Church claims that it has 387,566 members and probationers, against 215,000 reported in 1879.

The Providence Methodist Conference has changed its name, and will be known hereafter as the "New-England Southern Conference."

The Catholic Bishops of the Province of Baltimore have met and selected three names for the Vatican to choose a Vicar Apostolic for North Carolina.

It was some time ago asserted that the deposed Bishop of Tournai was possessed of an autograph letter from Pius IX. in which he said that to elect Cardinal Pecci as his successor would ruin the church. The letter is now declared to be authentic.

The Bishop of Liverpool, in a recent address on the promotion of Christianity among the Jews, said the great differences between the world now and in the days of the great Roman Emperors were due to the conversion of Jews to Christianity, and for this reason he should do all he could to promote the spread of Christianity among the Jews.

Tremendous hail and rain storm.

Richardson, County Chairman, called the meeting to order and presided over its deliberations, with I. C. Wolfe as Secretary. The object of the meeting was explained briefly by Wm. C. Penleton. Capt. F. S. Blair was then called for and made a splendid Readjustment speech. On motion the Readjusters of Rich Valley District, Marion District and Rye Valley District adjourned to separate rooms to select delegates to represent their several districts in the State Convention, which is to meet in the city of Richmond on the 2nd of June 1881. After a brief absence they returned to the court room and the following list of delegates was reported:

RICH VALLEY DISTRICT.

W. M. Davis and F. J. Whitehead, delegates; Wm. Spratt and Wm. R. Tilson alternates.

MARION DISTRICT.

Dr. Geo. W. Hubble, Wm. C. Penleton and Geo. R. Rider, delegates; and Frank Leonard, J. T. Callum and N. S. Davis, alternates.

RYE VALLEY DISTRICT.

Rufus M. Gross, delegate, and R. L. Nelson, alternate. The selections were ratified by the mass meeting; and the following resolutions were then offered by Wm. C. Penleton:

WHEREAS, the Readjusters of Smyth County are heartily in favor of an early and fair settlement of the State debt; and whereas the Readjuster party has from its organization sought in every proper way to produce that desired result; and Whereas, during the brief period the said party has had control of certain portions of the State Government, reforms have been inaugurated that have saved thousands of dollars for the State, placed the Public Free Schools again upon a prosperous footing, and advanced the welfare of the people generally, therefore, be it

Resolved, 1st. That we, the Representatives of the Readjuster party in Smyth County, hereby express our unaltered and unshaken allegiance to the principles of Readjustment and Readjustment principles. 2nd. That we fully approve of the State Convention to be held at Richmond on the 2nd of June 1881, and hereby pledge ourselves to sustain its action.

3rd. That Capt. F. S. BLAIR, of Wythe is our choice for Governor of the State, and the delegate appointed to said Convention by this meeting be requested to cast their votes for him. 4th. That Col. Wm. E. CAMERON is the choice of this meeting as the Readjuster candidate for Governor, but we will support whoever may be selected by the State Convention.

The resolutions were adopted without a dissenting voice. No further business being before the meeting it adjourned.

LONDON, May 11 1881.

The Czar has issued a manifesto reminding the people of the glorious government of his father and the great reforms he accomplished. After alluding to the abominable murder of Alexander II. the manifesto says:—"In the midst of our profound grief the voice of God commands us to courageously assume the government of the country. Confiding in Divine Providence and in the power of the autocracy, which, for the welfare of the people, we have been called upon to consolidate and defend against all attacks, we in devoting ourselves to our high task, appeal to all faithful subjects to serve us and State faithfully and sincerely, in order to extirpate the horribly rebellious spirit which covers Russia with shame, to strengthen faith and morals and place the education of the youth upon a sound foundation, to eradicate all that is contrary to a sense of right integrity and to everywhere establish order and justice." The review of the troops to the public received the Czar with great enthusiasm. The Empress drove down the ranks of the paradise in an open carriage. A letter from a well informed correspondent in Russia, telegraphed to the Times from Paris says:—"The nearest approach that will be made to a constitution will be an endeavor to create in each province a sort of local council to communicate its wishes to the central government and exert a kind of local control over the employment of the resources of the province. Even this depends upon General Melnikoff retaining the ascendancy." The Porladok announces on reliable authority the impending appointments of General Mihutiu as Governor of the Caucasus; Court Heyden, now chief of staff, as Governor of Finland, and General Varonoff Dashkog as Minister of the Imperial Household.—By Cable to the Herald.

It is to be hoped that no pains will be spared in ascertaining whether or not Mrs. Patty A. Ward, now living near Crisfield, Maryland, speaks the truth in her confession that she, with the assistance of her son, now dead, murdered Azariah Dougherty in 1862. Two negroes were hanged for the crime, protesting until the drop fell that they were innocent. Mrs. Ward is dying from a cancer and the negroes are beyond the benefit of her confession, but their relatives and friends are entitled to the clear proof of their innocence, if it can be proved. Furthermore, the whole country is rightfully interested in knowing whether or not two innocent men were hanged, and if guilt attaches to any other person than the real murderers.

Mrs. Lincoln, the widow of the President, is in a grievous state of suffering. She was seriously injured by an accidental fall while in Europe and her nervous system is almost completely prostrated. She will be brought to this city for medical treatment next month if she can possibly bear the journey.—T. Tribune.

Mormonism in Botetourt.

Quite a large congregation assembled at Leonard's meeting-house on Sunday, the 1st instant, to hear two strange ministers expound the Scriptures. It was rumored that they were Mormons, which increased the desire of the people to hear them. One of the strangers preached upon the subject of baptism, and so nearly was the bait sugar-coated some of our Baptist friends considered the sermon "all right." On closing the services they informed the people that if it was agreeable to their wishes they would continue the meeting, upon which a proposition was made to take a vote upon the matter. This seemed to suit them well, and one of them at once requested all in favor of a continuation of the meeting to hold up their right hands. At this point the scene changed. An old man arose and said he wished to ask the gentleman a few questions before voting. He inquired of them if they were members of that body known as Mormons or Latter-Day Saints. They admitted that they were. He then asked them if they were in favor of polygamy as practiced in Utah. He said that was all he wanted to know; then turning to the congregation he remarked that we could now all vote understandingly—that for his part he wanted to hear no more—he knew something about their origin in Western New York and other places. The vote was taken, which resulted in a negative for Mormonism.—Fincastle Herald.

A Sad and Fatal Accident.

Henry Miller, a little son of George Miller, residing above Middlebrook, in this county, fell down a flight of steps in his father's house, on the 22d ultimo, from which he died on the morning of the 24th. He was asleep at the time of his fall, and was dreaming of performing some work on the farm. Falling on his head, concussion of the brain occurred, from which he died. He was aged nearly ten years, and was a bright interesting little fellow. He was buried at Mt. Tabor church by the pastor, Rev. T. T. Smith.—Valley Virginian.

The recent discovery of oil indications on the farm of C. P. Ramsdell, near Centerville, in Chesterfield county, has aroused a good deal of interest among the people in that vicinity.
