



### WEAVER'S WAGES.

Mr. W. M. Edwards, the editor and proprietor of the Montgomery (Ala.) News Item, published the following in that paper of the 28th July.

On the twenty fourth of June a conference of the Independent Greenback-Labor party, of Alabama, was held in the Exchange hotel in Montgomery. I had been asked to represent the Independents of Montgomery county, and went into the conference for the purpose of doing so. As I then understood it, the object of said conference was to inaugurate such measures as would tend to repeal certain odious laws in existence in this State, and to secure an impartial administration of State affairs. I was conscientious in what I did, as I conceived it to be a movement on foot by honest, intelligent men of the State, who were identified with its interests, and who had always labored to promote its welfare. I am now satisfied that I was deceived as to the intentions of the greenback party, and believe that the majority of those who took part in this meeting are to-day ignorant of the actions of those who control the movements of the party, and am satisfied that the men whose names are found on the greenback State ticket are the victims of a deliberate scheme to entrap good men. I know they are not men who would intentionally go against the interests of Alabama, and can therefore only suppose that they are themselves ignorant of what is going on between the greenback and republican committees. After taking part in the conference, I was looked upon as a leader of the movement in this State, and which Gen. Weaver came into the State, he at once communicated with me, asked me to aid him in his canvass. I met Gen. Weaver at Birmingham, and he there communicated to me some workings and intentions of the greenback party, and it was there that I was first convinced that the sole aim of the greenback-labor party was to overthrow the democracy, and also convinced that Gen. Weaver was in reality exerting himself in the interest of the republican party. I had no intention of allowing myself to be misled and made a dupe of, and did not intend to be nominally a Greenbacker, and, in reality, only an instrument in the hands of the republican party, to overthrow the State Government of Alabama.

I at once set to work to ascertain whether or not it was a party conducted in good faith, and whether or not it was only a deceptive scheme to mislead the people. The position I had taken in the new party procured for me the confidence of its leaders, and they did not hesitate to communicate to me their intentions. Before the Chicago convention I had openly expressed a determination to support Grant in preference to Tilden, and the Republican party, taking it for granted that my sympathies were with them, readily communicated to me what their side was doing; consequently I was soon placed in possession of the actual facts in the case. The information obtained from both parties convinced me that the whole movement was a daring and skillfully managed scheme to overthrow the government of Alabama. With all these facts before me, I determined to expose all that had come to my knowledge, and to sever all connections with a party which was sailing under false colors. I now assert that the leaders of the greenback labor party are in the pay of and in hearty co-operation with the Republican party, and the evidence I here introduce can not be truthfully denied, and I am satisfied that the charges I make cannot even be answered. I charge:

1st. Gen. Weaver is in daily communication with the leading republican paper of the north—the N. Y. Times; to this paper he reports daily his movements. While in Birmingham, on the 15th inst., he dictated a telegram to the Times. I wrote it out, carried it to the telegraph office myself, and paid for it. The telegram is now on file at the Western Union telegraph Co's office in Birmingham.

2nd. I know that Gen. Weaver's movements are directed by a committee at Washington city, and that on his arrival at Montgomery in was necessary for him to communicate with said committee in order to find

out when his appointments in West Virginia begun. He had no control over his own movements, but was ignorant himself when and where he would go.

3d. Gen. Weaver's expenses are paid by moneyed men of the north. They have sent him thus far, five hundred dollars. His money gave out when he reached Chattanooga, and he telegraphed for more, which was sent him by telegraphic money order to Huntsville, Alabama.

4th. The National Greenback executive committee is in communication with the National republican executive committee, and the two committees will meet in secret session, in Chicago, August the 9th. This was communicated to me by Jesse Harper, a member of the greenback national committee, who is now in Alabama, speaking. I met him in Birmingham on the 24th; and he informed me that Gen. Weaver would complete his canvass in West Virginia, DeLa Martyr and himself would finish up in Alabama, and they would all be present at the joint meeting of the committees in Chicago, on the 9th of August.

5th. It is the present intention of the two committees not to put a Republican electoral ticket in the field, but to put out a Greenback electoral ticket, with a secret understanding that half are to vote for Garfield.—This course was communicated to me by Jesse Harper, General Weaver and George Turner, chairman of the Republican State executive committee, who all approved of this measure.

6th. The Republican National executive committee has promised financial aid to conduct the campaign in Alabama, and the two committees which meet in Chicago are to determine upon the amount to be used in this State. The amount contributed will be between twenty-five and fifty thousand dollars, which will be used in supporting newspapers, paying the expenses of traveling speakers, etc.

7. The Republican party has already contributed money to conduct the campaign in Alabama, in one instance, as follows: George Turner, chairman of the radical executive committee, called upon the postmaster of Birmingham for the amount he had been assessed for campaign purposes. Col. Carpenter, chairman of the greenback executive committee of Alabama, wrote to Mr. Turner, and requested him to withdraw his demand upon the postmaster, in order that he might contribute the amount to the greenback party. Mr. Turner did so, and the money contributed by the postmaster was used in the county campaign of Jefferson.

8th. That the Greenback party of Alabama has, through Colonel Sloss communicated with George Turner, asking the aid of the Republican executive committee in the way of money. Mr. Turner forwarded Mr. Sloss's letter to Washington to the Republican National committee, with his hearty indorsement, accompanied by the urgent request that the money be forwarded immediately. The facts here stated, and as contained under the seventh charge, were told me both by Colonel Carpenter and George Turner.

9th. The policy of the Greenback party is to back their measures by force and to do by violence what they fail to do by other measures.—They propose to send five hundred northern men south, with money to pay their expenses, going in squads and accompanied by W. S. marshals. These men will occupy the time until the November election, making speeches and in endeavoring to incite a violent opposition to the democratic party, and they hope by placing the polls in the hands of United States marshals, and in stirring up the people to fight among themselves, that they will be able to carry the election.

10th. The policy of the party is to arouse a strong feeling in the north against the southern people. With this view a large number of men, both white and black, have been employed to visit all parts of the north making speeches, telling the people of the north that they are oppressed, bulldozed, and not allowed a fair count. They thus hope to incite a sectional feeling against the south, which will cause the people of the north to back them in their efforts to place the ballot boxes in this State in the hands of U. S. marshals.

In my various conversations with

leading greenbackers and republicans, I have taken down some of their expressions of opinions, etc., which I wish to give in the article, in order to show that in private they express far different motives from those expressed by them in public, and they are therefore deceiving our people as to their real sentiments.

Gen. Weaver says, in addressing his audience, that the financial issues are the ones for consideration, but in a conversation with Judge Rice and Mr. Dimmick, (republicans) he said "financial questions are of no importance, the main object is to overthrow the democratic party in the south, and it can only be done thro' the greenback party. The only hope for republicans in the south is under the name of greenbackers, and they must unite with them. He said to a party of workmen who called on him, that if a charge of an unfair count was brought against the managers of an election the best remedy was to hang a few to the nearest tree. That's what the world do in his State, and he advised them to do likewise in Alabama." He remarked to me time and again that he would make it hot for the people of Alabama before he got through with them. He remarked to Mr. James P. Armstrong that a Greenback Democrat was a humbug; laboring men must not support a Democrat, even if he does indorse the Greenback doctrine.

Jesse Harper, of Illinois, a member of the greenback national committee, said to me: "We come down here to fight this thing through, and we are going to bring a crowd that can't be scared. If the Alabama people want to fight we will make it lively for them." He said to Maj. R. Randolph, of Birmingham, and myself; "We have sent men down south that they didn't dare to kill; and while the people of Alabama are on their good behavior we are getting in the work." Here peatedly said that it was the intention of the party to send down men with sufficient force to protect them, and that any opposition on the part of the Democrats would be speedily met by force. I asked him for his candid opinion of Gen. Weaver's chances.—He replied: "There won't be any election by the people."

In reply to my questions as to what would be the result of the campaign, he said: "It is going to wind up in a fight."

In a conversation with Geo. Turner chairman of the Republican executive State committee, he assured me that he was co-operating with the greenback party, and would use his utmost endeavor to assist them in their State and national canvass. He approved heartily of a fusion electoral ticket between greenbackers and radicals, either openly announced or secretly understood, and was satisfied if the radical national executive committee sent twenty-five thousand dollars into the State of Alabama they could carry the State with the fusion ticket.

Gen. Reuben Davis of Mississippi, said to me: "I am satisfied that we will get enough assistance from U. S. marshals to enable us to carry the election in November next."

It will be seen by the above facts which have come under my observation, that the greenback labor party and the radical party are essentially the same. They are devoted to the same cause, are working in unison, and have no end in view, beyond the overthrow of the Democratic party. I am satisfied that the large majority of those who have identified themselves with the new party have been misled, and it is a duty which they owe to themselves and to the country to withdraw their support, and sever all connection with a party whose sole aim is to overthrow our home government. I, therefore, appeal to all who have, like myself, been misled as to the intentions of the greenback labor party, to come out and say so, and labor henceforward for the democratic party.—When a man finds he is wrong, the best way is to acknowledge it, wipe out old scores and start anew. Continue no longer to be made a dupe of. The bullet fired by accident is as fatal as that of the assassin. The aid given by you in breaking up the democratic party, and overthrowing home rule, though it may be unintentional on your part, accomplishes as fatal a result as the efforts of our bitter enemies.

Carefully consider what is contained in this article, and act upon it.

### Very Perplexing.

Mr. John Sherman said in his Cincinnati speech, August 30, 1880: "I have never said a word impugning General Arthur's honor or integrity as a man or a gentleman."

The same Mr. John Sherman said to Chester A. Arthur in a letter dated January 31, 1879, when the letter was removed from the collectorship of the port of New York for improper practices: "Gross abuses of administration have continued and increased during your incumbency. Persons have been regularly paid by you who have rendered little or no service. Bribes, or gratuities in the shape of bribes, have been received by your subordinates in several branches of the custom-house, and you have in no case supported the effort to correct these abuses."

This is perplexing. Mr. John Sherman plainly charges Mr. Chester A. Arthur as collector of the port with gross abuses in the administration of his office, including bribery-taking, and yet distinctly avers that he never said a word impugning General Arthur's honor or integrity as a man or a gentleman. It, therefore, follows that Mr. John Sherman does not consider the Republican collector of the port of New York a man or a gentleman. Of course the line must be drawn somewhere, but all this is very perplexing.—Balt. Gazette.

### A Deluge in Michigan.

GRAND RAPIDS, MICH., September 3.—The recent heavy rains caused a large washout at the intersection of Clinton and Mason streets laying bare the wooden main used for filling the city reservoirs. The main burst and 4,000,000 gallons of water swept down the hill in torrents, doing great damage to property. Five whole city squares were deluged and nine buildings damaged, five being total wrecks and the occupants narrowly escaping. The total damage is estimated at \$50,000.

The ex-Confederates are steadily advancing on Washington. Ex-Confederate Vice President Alexander H. Stephens has been unanimously nominated again for Congress, and the Republican convention of the district unanimously decided to make no nomination against him, and to offer no opposition to his election. The South seems to be getting awfully solid in Stephens' district.—Phila. Times.

The Richmond State for several weeks past has been ominously silent upon the political imbroglio in Virginia. The hitherto fierce utterances of the State and a few others of the irreconcilables have brought affairs to their present pass in this State, and upon them should rest the blame if Virginia is lost to the Democracy this fall.—Page Courier.

A German scientist has succeeded in obtaining a chemical composition by means of which a mirror image can be fixed and sold as a photograph. With this composition the mirror surface is painted, and the back part of the mirror also receives a coat of oil. The mirror thus prepared is held held before the person to be photographed. The Paris authorities are intent just now on measures to prevent delinquent articles finding a sale, and have seized American hams wrapped in a yellow cloth, rendered impermeable by chromate of lead.

A stalwart woman got employment in male attire as a farm hand at Hutchinson, Ill., but the farmer discharged her on learning her sex. She has brought a suit to recover wages for the whole contract.

There is at Elgin, Ill., a Society of Pandemonium; "devoted to the noisy recognition of nuptials" in other words, an organized band of serenaders with horns, tin pans, and other implements of noise.

A pilgrimage is to be made this month from England to Lourdes to beg the intercession of the Virgin for the restoration of England to the Roman Catholic faith. It will be headed by Cardinal Manning, and the Duke of Norfolk will carry the standard of St. George.

Jack Everman, a bank burglar, left \$5,000 at his death, in Philadelphia. He made no will, and his natural heirs refuse to touch the money, because it is the proceeds of robberies. The legal question arises whether, there being heirs, the State can take the property.

"Dar aint no use o' tryin' to hide yer sins under fine clo's," fide Lawd can see sliet froo broadcloth," said the Rev. James Delavan, at a Kansas camp meeting. Dan Kirby, a well-dressed gambler construed the words as a personal insult, and whipped the preacher after the services.

Olive Logan declares that Adelaide Neilson was to have been married to Admiral Glyn. The actress said so herself, and explained that the delay was because she desired to wait until the Admiral's daughter was wedded. The Prince of Wales had reminded Glyn that Neilson could never be presented at court.

Miss Smith was to have been married at Springfield, Ill., but she disappeared on the morning of the wedding day, and various were the conjectures as to her conduct. She has written from an adjoining State to her affianced husband, saying that she fled because she was scared, but is now ready to face the clergyman.

The German Emperor has approved of a plan for extending the famous Unterden Linden at Berlin by a splendid bridge across the Spree, leading to ground which has been given up for the purpose of themunicipality. The new part will extend to the northeastern suburb of Berlin, and will be called Emperor William street.

Queen Victoria has given an oil portrait of herself to the wife of the President of the Bank of Montreal; at whose cottage Princess Louise, and Prince Leopold were guests for some days. Such a gift makes a variety from the copy of the Prince Consort which has so largely figured as the royal presents of late.

Shetland women are noted for their ability in managing a boat, and Admiral Thomas, who was in Lerwick recently offered to act as coxswain to three strapping Shetland damsels in a contest between them and a crew of men from the revenue cutter Eagle. The match was keenly contested, but was easily won by the Shetland women, who used two oars each, and pulled gracefully.

George Mitchell, an Ohio wine merchant, declared that his condemnation to death was just, and that he would not have it changed if he could. He spent the night before the day appointed for the hanging in loud rejoicings that he was about to go to heaven; but when a reprieve came he shouted: "Blessed be God, didn't I always tell you that the Lord was on the side of a Christian man?"

Among the many Heidelberg traditions of duelling is the following: Two students fought, and each felled off the other's nose. The noses fell to the ground, and, being picked up by the seconds, were plastered again on the faces of the duellists. Their operation succeeded, but in the hurry the noses had been changed. The aquiline man henceforward had a snub, and the snub man had an aquiline.

A recent observing tourist in Portugal says that he has never been in a Roman Catholic country where there are so few outward signs of religious feeling, or even of worship. It is rare to find a service of any kind being celebrated in the churches, which are nearly always shut. A light is seldom burning before the altar, the few shrines and images by the road are neglected and often in ruins, and the monasteries have all been suppressed.

I hasten to assure you that not only do I not approve of, or sympathize with that announcement, but I deeply regret it and strove against it. True, I was for Blair. True, I contented that the Altizer Delegation" was alone entitled to cast the vote of Montgomery, and true also it was *playfully* charged against some of your friends that "they had stolen one and a half of the votes of that county." But it is also true that the evidence before the Committee on credentials showed that neither the "Altizer meeting nor the Miller meeting," was *strictly* regular; the former having been called for 1 o'clock P. M. previously and yet was held, transacted its business and adjourned before that hour, and the latter was called without proper authority, and met without notice. Altizer admitted there were several hundred Readjusters at Christiansburg on July Court who, not being able for the crowd to get into the Court house, did not participate in his meeting, and Haynes contended that he was out drumming up his 117 Fulkerson men to get them in at the 1 o'clock meeting but found that the meeting was over and yet that hour had not arrived. Therefore, both delegations were probably irregular. Yet the committee decided to admit all the delegates to the Convention. There were present six Altizer (Blair) delegates, and two Miller (Fulkerson) delegates. It was on my motion, as the supporter of Blair, with the approbation of his friends, that the eight delegates were allowed to vote *per capita*, instead of by *delegation*, (each delegation casting one half of the six votes of Montgomery, as the Fulkerson men contended for,) and thus giving four and a half votes to the Altizer (Blair) delegation, and only one and a half votes to the Miller (Fulkerson) delegation. Therefore, on reflection in cool blood, I must admit that if, in *playful* sense, it be true "that Fulkerson's friends stole one and a half votes," it is squarely true, in the same *playful* sense that Blair's friends stole four and a half votes out of the same batch. There was, however, in truth no theft, no fraud, no impropriety at all—only a difference of opinion widened doubtless by diverse inclinations and interests, and finally settled by a compromise by which Blair got out of six votes four and a half and Fulkerson one and a half votes.

When first discovered she was half hid behind a cliff of rocks, from which she ushered with such a deafening scream that Mr. Sullivan's horse became so frightened as to be unmanageable for several moments, after which he undertook to give chase, but the horse refused to go near the fleeing woman. Dismounting he made chase on foot, and taking a near cut over the hill, he came close up to her, when she turned towards him with her hands raised, making such a loud and tender like screaming noise that he had not the courage to proceed further, but turned away, leaving the curious feminine mistress of the woods and wilderness-like canon, through which she fled with unusual quickness. The subject of organizing a party to scour the country and capture the wild stranger is being agitated.

Religious Notes.

A Presbyterian theological seminary has been established in Tokio, Japan. Mr. James Buist of St. Andrew Scotland, bequeathed \$35,000 to missions.

A large number of Jewish negroes have been found in Africa, near the boundary of Barbary.

A London gentleman has given \$10,000 to fit up a mission-house in that city for the conversion of the Jews.

The Rev. Mark S. Gross, of St. Thomas Catholic church, Wilmington, N. C. was offered the bishopric of North Carolina by the Pope, but has concluded to decline it and remain a priest. His brother is Bishop of Savannah.

Professor Robertson Smith, in the course of some correspondence with a colleague, Professor Binnie, asserts his belief in the supernatural element of the Bible, and resents the imputation that he does not accept anything in the Scriptures of the nature of miracles.

The Times of India notes the fact that the car of Juggernaut was not dragged through the streets of Purich this year as usual on the 9th of July. According to custom the car cannot again be drawn until after twelve years have passed. The natives are greatly concerned about the omission and charge it to "the intermeddling Government officials."

Dr. Tanner lectured in New York Thursday at Booth's theater. He especially denounced Dr. Hammond, and renewed the controversy between them. He advocated fasting for all inflammatory diseases, and especially for dyspepsia and rheumatism, and said that to establish that system for the benefit of science he was willing to again undergo his arduous task.

The project for building the Alexandria and Mount Vernon railroad, it is understood, be pushed vigorously next winter. The length of the road will not be more than six and a half miles. The estimated cost, including a bridge across Hunting creek, is \$125,000, of which sum it is hoped Congress at its next session will appropriate \$100,000.

THE FARM AND HOUSEHOLD.

AGRICULTURAL ITEMS.

The rural boom—'Ensilage.' Every farmer should have a work-shop. Are you preparing for the Agricultural Fair? One-fifth of the earth's surface is covered with trees. Exterminate weeds, briars and brambles everywhere. The wheat crop of England will be only a fair average yield. There are 3,500,000 watermelons in a single path in Georgia. Alfalfa or Lucerne, is California's greatest forage and fodder plant. Cold green tea, well sweetened and put into saucers, will destroy flies. Quick lime is destructive to worms slugs and the larvæ of injurious insects. Rice is becoming one of the most important grain crops of south Georgia. Texas will grow more grain and cotton this year than during any three previous years. A Montreal mechanic claims to have discovered a new motive power as effective as steam. All work and no play makes Jack a dull boy. Let the boys go a-fishing occasionally. It is said it costs as much to raise one acre of tobacco as it does to raise eight acres of corn. New Orleans has shipped to France and Italy within a year 2,400,000 gallons of cotton-seed oil. Close training and hard labor are as damaging to beasts as to man. Be careful with your teams. An exchange says if hens get into the habit of eating their own eggs, the surest remedy is to cut off their heads. Salted soapuds that have been allowed to stand until sour, are recommended as a means to kill cabbage worms. The annual tribute paid as rent to the landed aristocracy of England by the farmers is estimated at \$500,000,000. In the United States there are now 900 miles of bridges, one-third of which are stone and iron and two-thirds wood. North Carolina is taking great interest in fish culture, stocking all its leading streams with the best varieties of fish. Water is one of the important elements, not only in rapid development of beef but in the production of choice qualities. Last year Indiana stood first in the yield of wheat per acre—20.3 bushels. The average of all the States was only 13 bushels. Cellars thoroughly treated with whitewash made yellow with copperas will not be considered desirable habitations for rats and mice. The area in wheat along the line of the Northern Pacific railroad this year is estimated at 10,000,000 acres, against 6,000,000 last year. Have something worthy of exhibition at your coming agricultural fair. Take your best, and secure the best premium, if possible. The wheat crop of the world (1879) shows a deficiency of 375,000,000 bushels. Nearly 200,000,000 of this deficiency was in Europe alone. The daily production of petroleum at the present time is stated to be about 72,000 barrels, an increase of 20,000 barrels during the past year. Millions of Concord grape cuttings have been sent to France from this country to serve as stocks on which to graft choice French varieties. The cultivation of wheat in British India has largely increased of late years, and it now ranks fourth in the list of wheat-producing countries. The fruit and vegetable business from Florida to the Northern States has grown from 25,000 boxes in 1874 to 950,000 in 1879 and is still increasing. If your horse is troubled with scratches, mix up a little saltpetre and lard and put upon the sore part renewed daily until cured. Keep clean by using castile soap. A premium of one cent per pound on beet sugar, made in Massachusetts this year, will be paid by that State, provided the quantity does not exceed 700,000 pounds. In general cultivation, an acre can be made to yield three hundred bushels of potatoes. Less than two hundred bushels would not be a profitable crop in many localities. All the saw-mills along the South and North Alabama railroad are kept busy supplying orders for lumber. Large quantities of this lumber are shipped to Northern markets.
