## Lou Summers Is The Nominee

### The Bristol Convention Unanimously Selects the Abingdon Man For Congress.

### C. C. Lincoln, of Marion, Named on State Central Committee

Lewis Preston Summers, of Abingdon, has been selected by Republicans of the Ninth Virginia district as the man to undertake the task of restoring the "Fighting Ninth" to the Republican column.

In the Republican district convention held in the Virginia courthouse Bristol, Mr. Summers was by acclamation chosen as his party's standard bearer in the coming congressional struggle. Mr. Summers in accepting the nomination, voiced a determination to carry the fight to every corner of the district and implored the rank and file of Republican voters to enlist at his side in a smashing offensive.

The assembly opened its session about 10:30 o'clock in the morning and before two o'clock in the afternoon had cleaned the slate and adjourned. Chief among the results of the meeting were:

Nomination of L. P. Summers as the candidate for congress.

Selection of John H. Hassinger, of Abingdon, and C. Henry Harmon of Tazewell, as delegates to the national Republican convention with George Southerland, of Dickenson county, and J. L. C. Anderson, of Smyth county, as alternates.

Selection of W. B. Snyder, of Giles county, as district elector.

Election of the following to represent the Ninth district on the State Republican committee: W. B. Phipps of Dickenson; C. C. Hyatt of Tazewell; R. G. Craft, of Scott; R. W. Dickenson, of Russell, and Mrs. H. B. Crockett, of Pulaski.

Election of C. C. Lincoln, of Marion, as member of the State executive committee.

**Opened by Pendleton.**

District Chairman Charles S. Pendleton, of Gate City, opened the convention with a brief statement and called on Colonel William C. Pendleton to take the floor. Colonel Pendleton spoke with feeling of the death of Woodrow Wilson and moved that the delegates remain standing one minute as a silent tribute to the former president.

While the assembly stood with bowed heads, Dr. J. L. Rosser, pastor of the First Baptist church, offered prayer in which he referred tenderly to the services rendered their country by Warren G. Harding and Woodrow Wilson. Two large pictures of Wilson and Harding draped in black were suspended above the rostrum.

**R. A. Anderson Speaks.**

R. A. Anderson of Marion, the next speaker, did not respond until his name had been shouted from every

corner of the hall. The Smyth county leader began by exhorting the Republicans to "stand by your guns in the coming campaign." He declared that the victory would rest with the Republicans if given "an equal show."

"We must have all corrupt Democratic registrars removed," exclaimed the speaker in launching a bitter attack on what he characterized as illegal practices of the opposition party. The greater part of his talk was devoted to an attack on Democratic campaign and election methods in the district.

**Nominating Speech.**

Mr. Summers was put in nomination as the candidate for congress by Senator Chase. "The Republicans were handicapped two years ago by having 2,000 votes left off the registration books," he asserted. "The Democrats made a hard fight. We have George Peery's number this fall. The man I'm going to put in nomination will inject great enthusiasm into the fight."

The nomination was seconded by John T. DeHart of Bristol who in an eloquent presentation reviewed briefly the career of the Abingdon man.

Mr. DeHart appraised Mr. Summers as a "worthy successor to Bascom Slempp—a man who possesses the qualities that will win."

With Mr. Summers in congress President Coolidge will know that he has a lieutenant there to stand by him, added Mr. DeHart.

The nominee was presented to the convention by Mr. Rider who served throughout the War between the States in the regiment commanded by Mr. Summers' father. The two were in many battles together.

**A Touching Moment.**

Mr. Rider's emotion and his halting words brought tears to the eyes of many as he stood with one hand on Mr. Summers' shoulder. "This is the happiest day of my life," choked the veteran as he spoke of his high regard for Mr. Summers and his father.

The nominee following the ovation he received dealt in forceful language with the situation brought about by his nomination. "With your help I'll be able to redeem the Ninth district," he declared. Republican leadership is the only one that can be depended upon to safely guide the United States, he said, adding that every Democratic administration had been beset with troubles and wars. He declared that the hope of the country was in the principles of Lincoln, McKinley, Harding and Coolidge.

## Virginia Republicans For Coolidge

### Send a Solid Delegation To National Convention Instructed For The President.

Roanoke, Feb. 5.—The Virginia Republican convention was brought to a close here this afternoon with the election of four delegates-at-large to the national convention; election of two electors at large; election of ten members to the state executive committee and the adoption of the party platform.

A resolution was adopted instructing the delegates to the national convention at Cleveland to cast Virginia fourteen votes for Calvin Coolidge for the presidential nomination.

More than 1,000 delegates and alternates attended the meeting and the utmost peace and harmony prevailed. One single contest, that being from Petersburg, was reported by the credentials committee, but both delegations were denied seats.

At 1 o'clock a recess was held by the convention as a tribute of respect to former President Woodrow Wilson. Following the recess taken after the temporary organization was affected, the convention started active work and it took but little more than one hour to hear the reports of the committees and to conclude all business.

A resolution was adopted deferring action on the nomination of a senatorial candidate and the power of naming of the candidate was vested in the state committee. The resolution provided that the candidate be named as soon after the Cleveland convention as is possible.

Lou P. Summers, of the Ninth district, Republican candidate for congress, nominated C. Bascom Slempp, secretary to the president; Joseph L. Crupper, present state chairman; Henry W. Anderson, of Richmond, and former Congressman John Paul of Harrisonburg, as delegates-at-large to the national convention. They were elected by acclamation.

Mr. Summers nominated Mrs. M. J.

Caples, of Norfolk; State Senator John M. Parsons, of Independence; Major Charles S. Roller, of Staunton, and J. B. Kimberley, of Old Point as alternates-at-large to the national convention. They were elected by acclamation.

R. Walter Dickinson, of the Ninth district and J. W. Flanagan, of the Sixth district, were named electors-at-large without opposition.

The ten members of the state executive committee were re-elected without opposition. They are J. W. McGavock, Max Meadows; C. G. Smithers, Giles county; W. Lee Brand, Salem; Harry Fulwiler, Botetourt county; G. M. Tucker, Danville; Mrs. M. M. Caldwell, Roanoke; Mrs. M. J. Caples, Norfolk; Miss Elizabeth Kern, Winchester; Mrs. Elizabeth Davenport and Charles A. Hamner, of Harrisonburg.

Following the transaction of the business of the convention several of the party leaders were called upon for speeches.

Lou P. Summers, who was acclaimed every time his name was mentioned, yielded to the repeated calls and addressed the convention. In his usual fiery manner of talking, he had the delegates yelling at every turn.

Mr. Summers devoted his remarks principally to a denunciation of Democratic principles and stressed what he said, was the misuse of the party machine. He referred to the Democratic party as a "damnable Democratic machine" and stated that he was going to "charge them with fixed bayonets" in the November election.

LEWIS P. SUMMERS.

At the meeting of the Bristol Convention, on Monday the 4th of February, the delegates from the various counties of the Ninth Virginia Congressional District unanimously nominated Hon. L. P. Summers, of Abingdon, Virginia, as the candidate for the Republican party for the position of Congressman, to represent the District in the United States House of Representatives. The present Representative from this District in that body is George C. Peery of Tazewell county, a democrat, who was elected at the last election.

The representatives of the Republican party of the District have made no mistake in the selection that they have made. They have selected a good and a strong man as well as an able man. Mr. Summers has long been in public life and most prominently connected with the Republican party of the State, and especially with the party in the Ninth District. ## GRADE CROSSING ACCIDENTS

Preliminary to an intensive campaign to be inaugurated in an effort to bring about a reduction in the number of grade crossing fatalities is annually cause thousands of casualties the American Railway Association has announced plans for a nation-wide contest, open to the general public, for the most expressive poster and slogan to be used throughout the nation in connection with the crusade to save lives at railroad crossings.

For the first prize, \$500 will be paid to the person submitting the best poster with \$200 for second prize and \$100 for third. In addition, \$100 will be paid in cash to the person submitting the best slogan for the campaign.

Selection of winners will be made by a special committee composed of persons of national prominence. The personnel of the Committee will be announced later.

The contest will be conducted under the auspices of the Committee for the Prevention of Highway Crossing Accidents of the American Railway Association. H. A. Rowe, 90 West St., New York, is Chairman of this Committee. The contest will close on February 11th at which time all persons must have their posters in the hands of the Committee.

The campaign to reduce the number of grade crossing fatalities is stimulated by the fact that in 1924, it is estimated that not less than 2500 persons, or more than 200 a month, will lose their lives at railroad crossings due almost entirely to automobile accidents while approximately 6,000 persons will be injured, or about 500 a month. Another reason for conducting an intensive campaign is the fact that during the present year of 1924 it is estimated that there will be about fifteen million automobiles in use, an increase of approximately twenty per cent over the preceding year.

The railroads are annually doing everything possible to reduce the number of grade crossings. In order further to protect the lives of motorists and others at such places new improved safety devices are constantly being installed. To eliminate all grade crossings, however, would be not only a physical but a financial impossibility on the part of the rail carriers. Report received by the Interstate Commerce Commission show

that in 1922 there were 256,362 grade crossings and to do away with these would mean an expenditure of approximately five billion dollars more than the tentative valuation made by the Interstate Commerce Commission of all the railroad properties used by the carriers for transportation purposes. The railroads did in 1922, according to the Commission, eliminate 706 grade crossings at an estimated cost of approximately \$70,000,000.



## Woodrow Wilson Passes Away.

BREATHED HIS LAST AT HIS HOME IN WASHINGTON FEBRUARY 3rd. AT 11:15 A. M.

WILL REST IN NATIONAL CATHEDRAL NAVE.

BORN IN STAUNTON.

Born in Staunton, Va., December 28, 1856, of Scotch-Irish parentage, he was christened Thomas Woodrow and he was known in early life as "Tommy." After he was graduated from Princeton in 1879 he was known only as Woodrow Wilson. His father was Rev. Joseph Ruggles Wilson, a Presbyterian clergyman, and his mother was Jessie Woodrow.

When he was 2 years old the fortunes of his father took the family to Augusta, Ga., and later to Columbia, S. C., where at the age of 17 Thomas Woodrow Wilson entered Davidson College, but left there soon to go to Princeton. After graduation at Princeton he studied law at the University of Virginia and in 1882 hung out his shingle in Atlanta, Ga. Meantime, he courted Ellen Louise Axson, the daughter of a Savannah Presbyterian clergyman. They were married in 1885 and had three daughters. Margaret, the eldest, who did not marry; Jessie, who became the wife of Francis Bowes Gayre, and Eleanor, who became the wife of William G. McAdoo, Secretary of the Treasury during her father's administration and later a presidential aspirant.

Mr. Wilson once said that as a young lawyer he wore out the rug in his office walking around the desk waiting for clients; so he abandoned a legal career and went to Johns Hopkins University, at Baltimore, for a post-graduate course in letters. While there he published his first book, "Congressional Government," a study in American politics. It evoked offers of professorships at Bryn Mawr and Wesleyan and won recognition at home and abroad. The young man who wrote of the defects of the American political system in 1889 found himself to deal with them later. Having written in a deprecatory tone of the tendency toward autocracy in American Presidents, he lived to hear himself called the greatest autocrat of them all and to see a resolution deploring his office vacant on those grounds introduced and tabled in the Senate.

Wrote Many Books. Successively, Mr. Wilson became professor of history and political economy at Bryn Mawr and at Wesleyan University and later professor of jurisprudence and political economy at Princeton, where subsequently, he was made head of that institution. Meanwhile, Professor Wilson had gained high reputation as a writer. The honorary degree of doctor of laws was bestowed upon him by Wake Forest College (1887), Tulane University (1892), Johns Hopkins (1902), Brown University (1903), Harvard University (1907), Williams College (1908) and Dartmouth College (1909). Yale made him a doctor of literature in 1910.

Elected as Governor. Nominated for Governor of New Jersey in a political situation about which many interesting things have been said and denied with equal fervor, he was elected on the Democratic ticket, and immediately took on the State "bosses" for a round of combat which attracted the attention of the country. In the Jersey Legislature he found the young lawyer, Joseph P. Tumulty, who became his private secretary and biographer.

Governor Wilson's nomination for the presidency at the Democratic convention of 1912 in Baltimore was one of the dramatic spectacles of American political history. It was a battle royal which brought him victory after more than forty ballots.

Wins Nomination. Champ Clark, the venerable and beloved Speaker of the House of Representatives, led Wilson in the early voting—in fact, polled a majority of the delegates. For the first time in history a Democratic National Convention refused to give the necessary two-thirds to a candidate who had gotten a majority. William Jennings Bryan, himself the nominee of three previous conventions, led the fight against Clark in one of the bitterest contests ever conducted in American politics.

At any rate, Woodrow Wilson got the nomination and won the election with 435 electoral votes. Roosevelt got 88 and Taft 8. He came to the White House on March 4, 1912, signaling the return of the Democracy to power, after successive defeats of sixteen years.

Dictates to Congress. Immediately he galvanized the country, appearing before Congress in person, publicly denouncing "a vicious lobby," which he charged, was attempting to influence in Washington, and launched a legislative program, which included repeal of the tariff, revision of the currency system, new styles of emergency system, the creation of many new government agencies, and such a multitude of other legislative business that Congress and the country had difficulty in keeping up with it.

Congress thought Theodore Roosevelt a "dictator" and an "autocrat," but it soon found itself dancing to Woodrow Wilson's tune, and at first it danced very obediently and with very little grumbling. Mr. Wilson early confessed that he had a "one-track mind," and he proved to Congress early in his administration that he knew what he wanted and how to get it. He had a Cabinet, it was true, but he consulted it after he had determined what he wanted to do. When he wanted a bill introduced in Congress, he frequently drew it himself, and if it hesitated on passage, he summoned the leaders—and it passed soon thereafter. In dealing with the Cabinet, he did his own thinking and conducted much important business of the various departments direct from the White House.

Trouble With Mexico. Hardly had Mr. Wilson gotten himself turned around when he had his first foreign situation to deal with.

It was with Mexico, and was a legacy from the preceding Republican administration. The Republican chieftains said they left it for Mr. Wilson, because they didn't want to embarrass him in dealing with it.

Mr. Wilson was much criticized for "weakness" in handling the Mexican situation, but his friends said he saw a world war coming and had told them he "did not propose to have the United States caught with one hand tied behind its back." He did not propose to be engaged in a war with Mexico at such a time. At all events, the World War broke out same year, Woodrow Wilson added his appeals to the futile effort to stay it, sitting by the bedside of his dying wife on a memorable August 6, 1914. Mrs. Wilson passed away that day, and with a world taking fire about him, he took her body to her girlhood home in Rome, Ga., for burial. The President was almost prostrated with his grief, and returned alone to the White House to face his burden. Mr. Wilson's always said that from the first Mr. Wilson saw it would be a World War, and that the United States eventually would be drawn in. But he realized that the country drawing its population from the states of Europe, which were going to war would face a much divided sentiment and a very difficult situation. His first words to his countrymen were a caution to strict neutrality.

War With Germany. Mr. Wilson's efforts were devoted to keeping his country neutral until the submarine outrages began. He was at first unable to believe that the atrocities had the sanction of the German government, but was convinced when they sunk the Lusitania. That incident brought the first rift in his official family. William Jennings Bryan, Secretary of State, and avowed pacifist, opposed Mr. Wilson's course, and left the Cabinet. Mr. Wilson nevertheless went ahead and warned the German government against sacrificing the lives of American citizens. Through a diplomatic correspondence which continued for two years, the President built up a record which reached its climax when he handed passports to Count Johann von Bernstorff, the German ambassador, and asked Congress to declare war, which it did. With that the President led the nation into the tremendous effort before it.

Meanwhile, with a World War all about him, Mr. Wilson had found time for an affair of the heart. He had met Mrs. Edith Bolling Galt, the widow of a Washington merchant. Their courtship was swift and they were married December 18, 1915. There were no children of this second marriage.

Close Race With Hughes.

A presidential election had intervened before the country went into the war, and this time Mr. Wilson's Republican opponent was Charles Evans Hughes, who left the Supreme Court bench to become a candidate. The issues of that campaign were very much muddled. The Democratic slogan was "he kept us out of war." Mr. Wilson's won over Mr. Hughes by a narrow margin. The result trembled in the balance three days and finally turned in his favor when California finally flopped to the Democratic column by a few votes. Mr. Wilson got 277 votes in the electoral college, and Mr. Hughes got 254.

President Wilson actually assumed his place as commander-in-chief of the army and navy. He took leading part in planning America's participation in the war. He insisted on the first for a unified command on the western front; for vigorous measures to curb the submarine menace. He personally initiated much of the war legislation, such as the passage of the selective service law, the creation of the Shipping Board, the War Industries Board, the War Labor Board and a multitude of other arms of the government for carrying on the struggle. He devoted his whole being to the war, seeing nobody and thinking of nothing else. Some of his days probably were like Lincoln's.

It was President Wilson who conducted the correspondence with Chancellor Max of Germany, when the request for an armistice came, and once the Germans laid down their arms he turned his thought wholly from war to peace, telling his friends that, while Germany must be made to pay to her full ability, Europe must not have another Alsace-Lorraine.

Firm in Resolutions.

It was quite a different Woodrow Wilson who sat in the President's chair when the war ended. With hair whitened and face lined he showed the effects of his long and something about men and human nature. He had learned, he told a friend "that some men become great and others swell up," but his penchant for doing things himself never lessened. He wrote state papers and read them to the Cabinet afterward; he became impatient with men who disagreed with him and frequently dismissed them. He quarreled with friends who in turn reproached him with being ungrateful, but he always kept on his course having once decided upon it.


Peace in sight, Mr. Wilson decided to go to Europe himself and take a hand in making it. Congress, no longer the suppliant handmaiden it was during his first administration, roared its disapproval. Mr. Wilson assured Congress that in the day of peace and cable it would know all he did. As a matter of fact he told Congress very little of what he was doing, or anybody else for that matter until it was done. That was not Mr. Wilson's way. The result was that he committed the United States to the League of Nations and was repudiated.

President Wilson's participation in the memorable Congress had been described by many people, friendly and unfriendly, and his part was so indelibly written in recent history that it needs little attention in a brief resume of his life works.

Died With Same Beliefs.

Woodrow Wilson himself would not wish it. When in 1920, he accepted the Nobel Peace Prize for being "the person who has promoted most or best the fraternity of nations and the abolition or diminution of standing of peace congresses," he said: "The cause of peace and the cause of truth are of one family. What ever has been accomplished in the past is petty compared to the glory of the promise of the future."

Woodrow Wilson lived his last years and died in "the glory of the promise of the future" confident that right as he saw it would ultimately prevail. He never lost faith in the League of Nations, but he lost faith in some of the human beings who were its inevitable elements. He closed his eyes confident that as a man of letters and a President he had done his best for humanity, but that his best was not all that he might have wished. Time alone can write his epitaph.




