THE TARIFF IN LOUISIANA.

Congressmen Wanted who Will be Solid for Protection.

NEW ORLEANS Oct. 6.—The fight for Congress is growing warm in this State. For the first time in many years a thorough and earnest canvass is made.

The contest is confined mainly to the First, Third and Fifth Districts. In the Second district, which has always been the closest in the State, Judge W. T. Houston, the Democratic nominee, has assured his election by the firm stand he has taken on the tariff.

In the Fifth district Judge E. T. Lewis, the present incumbent, was defeated on the tariff issue, he having voted for the Morrison bill. The Democratic nominee, Jude Iron has been called upon to give his views on the tariff, but as yet said nothing.

The fight in Louisiana, however, is mainly in the First, Third and Fifth districts. In the First and Fifth districts there is a bad spirit in the Democratic ranks and two rival candidates. Notwithstanding this, the Republicans will probably not be a candidate in the field in the district, but will take advantage of the Democratic quarrel to elect themselves and organize.

Carlton Hunt, the sitting member, was renominated by a party calling itself the Reform Democracy, and embracing many of the best men in the city. The nomination of the regular Democratic Convention went begging, and was declined by at least half a dozen persons before it was finally accepted by Col. Louis St. Martin, an old creole, who represented Louisiana in Congress in 1851.

The Republicans will meet on Friday, and will probably endorse Hunt, who is a strong protectionist. The contest will be a close one. The Third district has been Republican hitherto, but the Democrats are seeking to capture it on the protection issue. Their candidate is E. J. Gay, a sugar planter and the richest man in the State. Mr. Gay is an ardent protectionist, and was President of the late Sugar Planters' Convention, which threatened to put up a protectionist electoral ticket if the Democratic National Convention endorsed the Morrison bill or supported trade.

The aim of the protectionists in Louisiana is to secure a nearly solid Congress delegation. The State is canvassed, therefore, for Congress rather than for President, and the Presidential vote is as yet an unknown quantity.

Cleveland and the Farmers.

Grover Cleveland has made an impression upon the farmers of this State. It is deep but not good. The State Farmer's Alliance has addressed "to the farmers of the State of New York" and signed by the members of the Executive Committee of that strong organization.

The Farmers' Alliance is not a political organization, it does not call upon the farmers of New York to aid in defeating Cleveland because he is a Democrat. Opposition to him in this case turns simply upon the question of unselfish and patriotic devotion to the general good.

And doubtless the farmers will be confirmed in their opposition to Cleveland by reading a paragraph which appears in a recent issue of The American Dairyman. This paper is devoted to the interests of dairy producers, and naturally keeps a sharp eye upon the fortunes of oleomargarine.

"While Commissioner Brown is fighting the tail of the oleaginous dragon by suing men who sell the stuff, he neglects the head of it by refusing to allow the District Attorney to vigorously prosecute the McGann case that goes to the merit of the bill by representing the manufacturers. When this suit was last up for argument the District Attorney fought for delay, and failing to get it, made this extraordinary statement: 'Governor Cleveland sent for me and told me to procure the postponement of this case for the reasons which I have stated.'"

The Dairyman is in a position to know whereof it speaks. It does not hesitate to express the opinion that Governor Cleveland does not want the oleomargarine law tested.

Mr. Cleveland was not pains to attend the recent State Fair, and while there he had a number of pleasant things to say to the farmers. But fine words butter no parsnips. They will not vote for him.—New York Tribune.

S. W. LUNATIC ASYLUM.

AN ADDRESS TO THE VOTERS OF SMYTH.

The Benefits to be Derived by the Building Up of Our Town and County—Facts and Figures.

To the Voters of Smyth County: By an Act of the General Assembly of Virginia, approved the 8th day of March, 1884, a Board of Commissioners, composed of certain gentlemen, was appointed to select a site for a new Lunatic Asylum to be located west of New River.

The people of Tazewell offered a splendid site at Graham; Wythe had two valuable and beautiful sites and said to the Commissioners "choose either, and we will freely give the one chosen;" Washington had three valuable sites, two near Abington and the other at Glade Spring which were offered.

Professor F. H. Storer maintains that the action of shell and rock boring molluscs is not a drilling or any other mechanical operation, but a distinctly chemical process, the solvent being probably free muriatic acid. Scientific Notes.

Percite, a saccharine substance so closely analogous to mannite that until recently it has been confounded with it, occurs, say M. A. Muntz and V. Marcani, in the fruit of Laurus persea.

About 400 steel guns, of the six-inch class and of an electric type, have been finished for the rearmament of the smaller vessels of the British navy. Large guns, constructed on the same general principle, are now in course of completion for the larger iron-clads.

A new electric battery has been made by Tomassi and Radignet. Both of the electrodes consist of plates of coke, the one surrounded by a paste of lead peroxide, and the other covered on its horizontal upper surface with fragments of platinumized coke.

In the preparation of farm-yard manure M. P. P. Deherain states that straw is oxidized in contact with the air only under the influence of a "figured" ferment. There may be distinguished in dung a neutral fermentation producing carbonic acid and formene, and an acid fermentation in which are produced butyric acid, hydrogen, and formene.

When purified wood charcoal is thoroughly saturated with hydrogen gas, hydrochloric acid is formed with a fall of temperature. Berthelot and Gantz explain this anomaly by the consideration that the absorption of heat results not from the chemical action, properly speaking, but from the simultaneous evaporation of the chlorine condensed upon the charcoal.

THE ADVANTAGES.

In the first place TWO HUNDRED THOUSAND DOLLARS or more will be expended at the very outset in erecting the asylum buildings and in other improvements.

The amount that will have to be paid for the lands, water privileges, etc., will be \$26,745, this amount to be paid in bonds of the county that will not mature until twenty years after they are issued and bearing 5 per cent interest, but redeemable at the pleasure of the Board of Supervisors. It will be seen that if the whole twenty years for which the bonds are to run be taken for their payment, by regular annual installments, paying each year part of the principal and the annual interest, the average amount paid annually will be only about \$1,800.

DEMOCRACY AND LABOR.

For many years the Democratic party has looked to the laboring men of the country for its chief support. It has always claimed to be the friend of the laboring man; and somehow it has fooled the working and producing classes into a belief in the truth of such a claim. We are surprised that the laboring men of the country have so long been deceived by the Democracy. Its claim has never been sustained by its record or principles. Before and during the war the Democratic party was a pro-slavery party. In fact its strength was based on slavery. In other words the Democrats were the champions and defenders of slavery. As long as slavery existed in the United States the free white labor was forced to place itself in competition with the slave labor of the South. The result was ruinous to the free labor. We can well remember how the poor, white laboring men of the country were designated the "poor white trash." What was intended as a name of degradation, was given because such labor had to compete with the negro, slave labor. The white labor of the country is no longer spoken of in this way, because slavery, has ceased to exist, and the free labor of the country is no longer placed in competition with slave labor. If Democracy could have had its way, slavery would still curse our country, and its free labor still be sneered at by the white men who owned slaves.

Since the Democracy can no longer prove its friendship to the free labor of the country by compelling it to compete with slave labor, it seeks now to degrade and ruin it by forcing it into competition with the starved and degraded pauper labor of free trade England. Thus does it prove its friendship for the laboring man. Thus would it force the workingmen of the country to toil for wages that will give to them a bare subsistence, or alone sustain animal existence. The workingmen of the county have found out the false hearted Democracy at last; and will no longer listen to their false songs.

An intelligent Democrat asked us a few days ago what there was in the Mulligan letters "anyhow." We asked him what he thought of them. He said he could see nothing in the letters that was derogatory to Mr. Blaine. He is the richest Democrat in the Southwest, and will vote for Cleveland.

Dr. Storrs on the Political Situation.

The striking interview with the Rev. Dr. Storrs which was printed in the Tribune yesterday is a valuable contribution to the literature of the campaign. It is a strong, comprehensive and convincing argument in favor of the Republican candidates. Dr. Storrs rarely raises his voice on political questions; but when he speaks it is with no uncertain sound. He states clearly and forcibly his reasons for supporting Mr. Blaine. He has evidently been wrought up to a considerable pitch of righteous indignation at the wanton attacks made upon the great statesman who is destined to lead the Republican army to a glorious victory three weeks hence; but there is no hint of anger in his tone. His words are the calm and dispassionate utterance of one who has felt deeply on the subject and knows precisely what he wishes to say.

Dr. Storrs finds strong negative proof of Mr. Blaine's incorruptibility in the fact that the shrewd Oakes Ames made no attempt to get him interested in his schemes, although Mr. Blaine was at that time a most influential member of the House. The sentences which have been violently wrested from their proper connection in the ex-Speaker's letters, Dr. Storrs thinks, are "fairly susceptible of an interpretation not dishonorable to him"; and he emphatically asserts that the assaults of Mr. Blaine have not shown him to be unworthy of the support of his countrymen.

Of Mr. Cleveland Dr. Storrs says that since his nomination his character has received "a fatal wound." In language that is scorching in its severity he exclaims: "Forgiveness is one thing. Popular coronation is quite another." Such approval of such a man would be the worst of examples to young men and "would put dishonor upon the American name among all Christian peoples."

On the great question of protection what Dr. Storrs has to say is equally to the point. Without the ghost of a theory to support, he insists that a young nation like ours must protect its native industries, and that this policy "tends to diversify industry, to educate skill, to attract and reward inventive genius, to make a young nation more quickly independent of others, as well as richer in internal revenues." He sharply condemns the party which is disposed to face both ways on so vital and important a matter as this.

In conclusion Dr. Storrs pays a well deserved tribute to the Republican party, whose history he well says has been a noble one. And the old spirit permeates it—the spirit of patriotism, of fidelity to freedom and righteousness, of high statesmanship, of ready receptiveness to great ideas. That Mr. Blaine is inspired by this spirit, and that he will carry this spirit into his administration, the Brooklyn clergyman has no doubt. Nor have we. His course as President will unquestionably be marked by wisdom, prudence, sagacity and calm judgment; he will call the best men into his Cabinet; and his Presidency will "confirm the Nation in unity and peace, while conferring fresh honor on its name in the world."—N. Y. Tribune.

Blockading Chinese Ports.

PARIS, Oct. 11.—Admiral Courbet telegraphs from Kelung as follows: "I am erecting defences for troops to occupy at the post and mines. It will take several days to complete them. Landing parties from Admiral Lespes's squadron, at Tamsul, reconnoitred the posts from which the Chinese torpedoes were fired. They found that the posts were defended by a large number of infantry, who were ambushed in the dense thickets. An engagement took place and six members of the reconnoitering parties were killed, including a naval lieutenant. The harbor is defended by a line of torpedoes only. The shallowness of the water prevents the approach of large vessels. The torpedoes are close to the shore, and this renders the dragging for them dangerous. I am making an effective blockade at Tamsul. I am also blockading Tai-Wan-Foo and Ja-Kan-Kau, on the west coast of Formosa; the only points available on the island for the landing of reinforcements."

REPUBLICANS GAIN EIGHT CONGRESSMEN.

Have you heard from Ohio?

Last year the Democrats asked this question with smiles of exultation. Now when you ask them, "Have you heard from Ohio?" they turn pale and hang their heads with sorrow.

The Baltimore and Ohio Railroad Trouble.

PHILADELPHIA, October 11.—In the United States District Court for the Eastern district of Pennsylvania Judge McKennon presiding, this morning, upon the motion for a preliminary injunction made George Shears, Jr., J. G. Johnson, and John McClell, solicitors for the Baltimore and Ohio Railroad Company, Friday, October 17th, was set as the day for arguing the motion, and pending argument a restraining order was granted as follows: That the defendant, its officers, agents, and servants be restrained—(1), from abrogating or violating the existing contract (in the bill set forth and recited) or relations now in force between it and said complainant; (2) from violating said contract and from violating its duties imposed by the respective charters of its lessees in the bill complained of, and especially from refusing to receive and transport the complainants' cars containing passengers, express, or baggage over the defendant's line of road from the Philadelphia, Wilmington and Baltimore railroad, in the city of Philadelphia to the city of New York, and from the city of New York to the Philadelphia, Wilmington and Baltimore railroad at Philadelphia in the same manner upon the same terms now customary; (3) from interfering with the facilities now enjoyed by the complainants over said line of railroad in reference to all express matter in its cars; from interfering with the complainants' express-messengers; from refusing to receive and transport in the same manner it is now doing under the contract in the bill set forth and described express matter and messengers of the complainants; and from interfering with the complainants' business or present relations as defined with it by the contract in said bill set forth in any manner whatever.

DYNAMITERS AGAIN AT WORK.

Attempts to Destroy the New Parliament Buildings in Quebec.

QUEBEC, Oct. 11.—About 1 o'clock this afternoon an explosion occurred at the New Parliament buildings, destroying a considerable portion of the masonry and windows of the new structure which was just being roofed in. The explosion was at first supposed to be that of the boiler of the engine used for the hoisting of material, but this proved not to be the case. Neither can it be attributed to gas. The general impression appears to be that the explosion was caused by dynamite, but as none of that material is used on the works, the mystery is how it came there. An investigation is being held. The workmen all being away at dinner, but one man was injured, and he escaped with a slight cut from a piece of stone. The shock was very severe, and was felt all over the city. The windows of houses in the vicinity of the explosion were badly shattered.

At 3 P. M., a second explosion occurred at the Parliament House, but the buildings sustained no damage of any consequence. Carpenters working on the building say they noticed a box lying all the morning close to the wall where the first explosion took place, but they supposed it was placed there by the plumbers. After the explosion no trace of the box could be found. It is now believed the box contained dynamite and an infernal machine. The second explosion was about thirty feet from the place where the first one occurred. The new building is said to be so badly cracked from the force of the shock that it is feared that half of it will have to be taken down and rebuilt. After the first explosion men were sent all through the buildings to look for other suspicious boxes, but found nothing. The cause of the second explosion is as great a mystery as that of the first. The explosions did considerable damage to the windows in the vicinity of the Parliament House, and almost all the windows in the house itself in the section under construction, where the explosion occurred, are shattered. The only persons injured are Mortel, a workman, who was struck by a small rock from a portion of the shattered wall, and Mr. Charlebois, the contractor, who suffered a slight bruise on the hand. The damage by the first explosion was a considerable hole about twelve feet high by five feet wide blown out of the wall on the third story from the basement and directly over the right entrance to the Assembly chamber, and near the place where the Speaker's chair is situated. The second explosion occurred in the northeast corner of the same building. The cornerstones forming the support of the building are badly bulged, and it is doubtful if it can be repaired without letting down the whole wall. Whatever the reason may be for wishing the destruction of the building, there is no room to doubt that dynamite was used. A searching investigation into the cause of the explosion is now in progress. Everything is quiet in the neighborhood, and a portion of Battery A are patrolling the grounds around the Parliament buildings. The Government were only awaiting the completion of the building to call the House together for the dispatch of business. The building had been so far advanced that only part of the room remained unfinished. It is not known whether or not the explosion will delay the meeting of the House in December.

Several rumors are current regarding the cause of the explosion. French employes state that the work was done by Irish dynamiters, while some Irish citizens say, and the opinion is shared in by a great many, that French workmen committed the deed with the view to injure the contractor; but for what reason is not apparent. It is said the contractor and men are on the best terms. Serious trouble is feared between the two nationalities if these accusations be carried much further.

The German Blaine and Logan mass-meeting last night in the Germania Assembly Rooms, No. 291 Bowers, brought together a large and orderly assemblage. The hall was beautifully decorated and on the desk on the speakers' platform were placed two large vases containing choice native and exotic plants and shrubs.

Morris Friedsam called the principal meeting to order by requesting ex-Justice Flammer to take the chair, after which the names of a large number of vice-presidents were read out to the meeting. In a few pithy remarks ex-Justice Flammer explained the object of the meeting, and introduced the several speakers in succession. Among them were: Capt. John C. F. Beviland, Gen. Monk, Alderman Finck, Ferdinand Eitman, John E. Brodsky, Julius Langbein, Victor Heimburger, and several other prominent politicians.

Some trouble was anticipated on account of the expected presence of Joseph Brucker, of Milwaukee, who is regarded as a renegade to the cause of Socialism, and members of that organization were scattered numerously around, on the outer fringe of each meeting, with no good intentions, if Brucker presented himself on the platform. However, he did not reach town, and when that fact became known the disorderly element subsided. But the police arrangements were amply sufficient to meet any exigency that might arise, and one or two arrests had a salutary effect on those who were inclined to be turbulent.

The speeches were almost exclusively devoted to the issues of the campaign, and some of them breathed a spirit of invective against Mr. Ottendorfer for claiming the German vote for Cleveland, and scoffed at his pretensions.--N. Y. Star, (Dem.)

WORK DONE MONDAY IN VARIOUS PLACES.

STRONG OPINIONS OF DR. CURRY

Calling on Men Who Respect Womanhood to Vote Against Cleveland.

This paper on "A Preacher in Search of a Party," read by the Rev. Merritt Hubbard, of the Washington Square church, before the Methodist Episcopal Ministers' Association last week, has caused considerable comment this week, not only from the two hundred clergymen who listened to it, but also by those of other denominations who read an abstract of it, in the Tribune. Mr. Hubbard took the ground that it was the duty of temperance men to vote for Blaine and not for St. John, although he added that he should vote for a Prohibition candidate for Assembly. He said that while he was a Prohibitionist he had come to the conclusion that the only course left open for thoughtful, conscientious citizens in this contest was to stand by the party that has made the country worth living in, and closed by saying: "I can not be induced to vote for a man of straw for President, who even if successful could not bring about Prohibition."

Two St. John men replied to Mr. Hubbard, but they did not grasp the question broadly, and the overwhelming sentiment of the meeting was with him. Among the men who took part in the discussion and favored the Republican candidate was the venerable Dr. Daniel Curry, for twelve years the editor of The Christian Advocate, the official paper of the Methodist Church, and now editor of The Methodist Quarterly Review. He said that he had voted for every Republican Presidential candidate, but he was not wholly pleased with some of the party's action in recent years, and he had about decided to vote for the Democratic candidate this year. This decision has been reached before the characters of the parties and their candidates had been discussed, and now he had decided to vote for Mr. Blaine. He also said that he could not understand how a man who had a mother, or wife, or sister, and respected her, could vote for Cleveland. Like Mr. Hubbard, Dr. Curry said that he was a temperance man, but he could not vote for St. John because that would be casting half a vote for Cleveland.

Dr. Curry told a Tribune reporter yesterday that the Prohibition party did not suit him; that it was in favor of woman's rights among other things, to which he was opposed; that it had men on the National ticket who would never have been there had there been the remotest hope of securing an election. In reference to the so-called "Mulligan letters" he said: "I think the friends of Mr. Cleveland are making a great mistake in pushing those letters to the front so much. Since they were published I think they have helped Blaine. People see for themselves what a little thing the Democrats are making the great issue of the campaign. I had intended to vote for Cleveland when he was nominated, but when the stories of his immoralities became public I became convinced that not only were they true but that they were believed in Buffalo. To elect such a man to the Presidency is to say to every young man in this country: 'Live as you like until you are forty years old, and pay no regard whatever to the moralities of life, and you will be an eligible candidate for the highest honor in the gift of the American people.'"--New York Tribune.

of Supervisors for Smyth county at the Court-house, Lynchburg, Sept. 1884. This board in conformity with the Act of the General Assembly of Virginia, "approved 26th August 1884," entitled "An act to authorize the voters of Smyth county, to ratify the action of the board of Supervisors of said county, in donating lands for the establishment of a lunatic asylum," orders that the Sheriff of Smyth county, he is hereby required to give notice of, and that the Judges of election at the next general election to be held in November 1884, open a separate poll, and take the sense of the qualified voters on the question whether the board of Supervisors shall issue the bonds of the county for a sum not exceeding (\$30,000) Thirty Thousand dollars, for the purpose of the payment for the land water privileges, rights of way &c., or the site for the proposed Southwestern Lunatic Asylum at Marion, Va. Said bonds to be payable in twenty years or longer at the discretion of the board of Supervisors, the notice of the time of said election shall be given by publication in the newspapers published in Marion, and the said Sheriff shall post up at all of the voting precincts in the county copies of the said act at least thirty days before said election.

AN ACT

TO AUTHORIZE THE VOTERS OF SMYTH COUNTY, TO RATIFY THE ACTION OF THE BOARD OF SUPERVISORS OF SAID COUNTY, IN DONATING LANDS FOR SOUTHWESTERN LUNATIC ASYLUM.

Approved August 26, 1884.

Whereas the general assembly of Virginia, at its last session, by an act approved March eighteen hundred and eighty-four, appointed a board of commissioners for the purpose of selecting a site for a lunatic asylum for the accommodation of the insane west of New River; and whereas the said board of commissioners have made the selection of a site in Smyth county for the asylum, in pursuance of said act, and have received titles made to the supervisors of said county, by the land owners, upon whose lands it is proposed to locate said asylum, and said titles in fee simple have been delivered as aforesaid to said board of commissioners, for about two hundred and eight acres of land, including fine water privileges; and whereas some legislation is necessary to enable the board of supervisors of said county to comply with their contract in regard to the purchase of the purposes aforesaid, which amounts to nearly thirty thousand dollars; therefore,

1. Be it enacted by the general assembly of Virginia, That the board of supervisors of Smyth county, shall have power to pay the amount thereof, and shall execute the contract in regard to the purchase of the purposes aforesaid, which amounts to nearly thirty thousand dollars; and

2. That the bonds so issued, shall be in the name of the county of Smyth and State of Virginia; shall be signed by the chairman of the board of supervisors, and by the board of supervisors, and shall be a lien on the face when payable, which shall be twenty years or sooner, at the discretion of the said board of supervisors, or their properly constituted successors in office and shall bear not exceeding six per centum interest per annum.

3. Before the provisions of the two preceding sections of this act shall be operative, the board of supervisors shall make an order, and enter the same of record, requiring the sheriff to give notice of, and judge of election, at the next general election to be held in November, eighteen hundred and eighty-four to open a separate poll at the site of the lunatic asylum, and to take the sense of the qualified voters on the question whether the board of supervisors shall issue the bonds of the county for the purposes mentioned in the preceding sections. The said order shall require the sheriff to give notice of the time of said election in the newspapers published in Marion, and to post up at all of the voting precincts in the county, copies of this act, said notice to be given at least thirty days before said election. The properly constituted election officers shall conduct such election, and close the polls in such manner as is provided by law in other elections; and at said election, each qualified voter, who is the owner of the land on which the lunatic asylum is to be located, shall deposit a ticket or ballot, which shall be written or printed: "For Donation and Taxation." And each voter who shall so deposit a ticket or ballot, shall be deemed to have assented to the provisions of this act, and his assent shall be written or printed: "Against Donation and Taxation." The election officers at the several places of voting, shall, immediately after the closing of the polls at each said place, count the ballots deposited, and shall, within two days after said election, make return to the clerk of the board of supervisors of the number of votes cast for, and the number of votes cast against donation and taxation. And the regularly constituted commissioners of election, as soon thereafter as practicable, shall meet at the office of said board of supervisors, and after taking an oath before said clerk, faithfully to discharge their duty, shall open the said packages of ballots, count the same, correct the returns if needed, and ascertain and report how many of the said ballots were cast for and against donation and taxation, respectively, which said report, signed by a majority of said commissioners, shall be entered on the order book of the board of supervisors.

4. If it shall appear, by the report of said board of commissioners, that a majority of the qualified voters of the county voting upon the question are in favor of the donation and taxation, then it shall be the duty of the board of supervisors to issue the bonds provided in section one of this act, and to make deeds to the commonwealth.

5. All acts and parts of acts heretofore passed that conflict with this act, are hereby repealed.

6. This act shall be in force from its passage.






