

**BAPTIST WOMEN
 SEEK \$22,000,000**

SACRIFICIAL EFFORT IS BEING
 MADE TO RAISE THEIR FULL
 SUBSCRIPTION TO 75 MILLION
 CAMPAIGN
NEW PROGRAM PLANNED
 Provision Made For Support Of
 General Causes Through Canvass
 of Members November 30—
 December 7.

Under the leadership of the Woman's
 Missionary Union, auxiliary to
 the Southern Baptist Convention, the
 Baptist women of the South are seek-
 ing to raise \$7,000,000 in additional

cash between now and the end of the
 year for the Baptist 75 Million Cam-
 paign, thus matching their subscrip-
 tions in 1919, when the program was
 launched, with actual payments, it is
 announced at Baptist headquarters.
 The women were asked to assume
 responsibility for \$15,000,000, or one-
 fifth of the goal of the Campaign but
 their subscriptions went far be-
 yond this.

Their original goal of \$15,000,000
 in cash had been reached by the
 women June 1, 1924, and under the
 leadership of Miss Kathleen Mallory,
 corresponding secretary of the
 Woman's Missionary Union, they are
 making extra efforts to meet their
 pledges as well as their quota. Thou-
 sands of Baptist women throughout
 the South are practicing self-denial
 in many ways in order to make special
 contributions to the missionary,
 educational and benevolent enter-
 prises embraced in the Campaign,
 while other thousands who have al-
 ready paid out their subscriptions are
 making special thank offerings that
 the goal may be reached. Reports
 indicate that thousands of Baptist
 men as well will redeem their sub-
 scriptions in full during this year.

Large Results Obtained
 Indicating some of the results that
 had been realized from the Campaign
 up to May 1, 1924, the general head-
 quarters reports that the foreign
 mission force has been increased over
 100 per cent, while as many persons
 have been baptized on the foreign
 fields in the five years of the Cam-
 paign as there were church members
 there at the outset of this program
 after 75 years of missionary effort.
 In the realm of home missions the
 1,170 workers report the baptism of
 203,582 persons, organization of 1,095
 new churches and 3,383 new Sunday
 schools, and the completion of the
 \$1,000,000 Church Building Loan
 Fund.

An average of 2,734 state mission
 workers have been employed during
 the Campaign who report 240,686
 baptisms, organization of 1,646
 churches and 3,035 Sunday schools,
 and the erection or repair of 2,331
 houses of worship. Into the 119
 Southern Baptist schools, colleges
 and seminaries the Campaign has
 put \$7,528,485 in permanent improve-
 ments, \$2,910,420 in maintenance, and
 \$2,732,231 in endowment, while \$1,
 277,021 has been employed in the ca-
 ncellation of outstanding debts.

Old Preachers Aided
 As a result of the Campaign more
 than 1,000 aged preachers and their
 dependent ones have been helped;
 \$4,464,000 has been put into 19
 Baptist orphanages caring for 4,000
 homeless boys and girls; while the
 number of Baptist hospitals in the South
 has been increased from 12 to 24.

In order that there may be no let-
 up in the support of the general mis-
 sionary and other causes fostered by
 the denomination at the close of the
 75 Million Campaign, plans have been
 perfected for the projection of the
 1925 Program with the week of
 November 30-December 7, when an
 every-member canvass will be made
 of the 28,000 Baptist churches of the
 South for the support of state, home
 and foreign missions, Christian educa-
 tion, ministerial relief, hospitals and
 orphanages next year. These are
 the same interests that have been
 embraced in the Campaign but they
 will be supported in the future on
 the basis of annual subscriptions
 from the members of the churches
 rather than on a five-year pledge.

Want \$15,000,000 Next Year
 Reports reaching the general Cam-
 paign headquarters are to the effect
 that organizations have been set up
 throughout the territory of the South-
 ern Baptist Convention looking to the
 completion of the old Campaign
 through the redemption of the
 pledges, and the successful launch-
 ing of the new program through the
 taking of subscriptions for next year,
 at the same time. It is the hope of
 those charged with the leadership
 in these programs that a minimum
 of \$15,000,000 will be raised for the
 general denominational enterprises
 in 1925 and that each year there-
 after there will be an increase over
 the preceding year.





Twelve Southern States Enroll In Modern Crusade To Complete Work for Orphans of Near East

REPRESENTATIVE committees from twelve Southern states have completed a study of the humanitarian work done by the American public in the Near East during the post-armistice period. Their reports, based on personal observation abroad, emphasize economy and efficiency as the keynote of this relief and orphanage work, and they recommend the organization of special crusades in every Southern state for the purpose of carrying it to completion.

Mrs. Alice Hegan Rice of Louisville, Ky., author of "Mrs. Wiggs of the Cabbage Patch," reports: "The Near East Relief is not only America's greatest philanthropy, but the greatest single achievement in philanthropy ever accomplished in the world. A unique experiment in practical Christianity is now being tried out in the world with results that may be epochal. For the first time in history a day has been set apart in which Christendom is to put in practice what has been taught for over eighteen centuries. A day has been set apart, Dec. 7, named Golden Rule Sunday, for the strengthening of international friendship and the practical ap-

lication of the Golden Rule." The money raised on this day will go for the completion of the American orphanage work in Bible Lands. The twelve Southern states are organizing to do their share toward making this movement a success. Oliver J. Sands, president of the American National Bank of Richmond, Va., makes this report: "I

visited Turkey, Greece and Palestine, for the purpose of seeing the American work there, and to consult with representative people regarding the character of the work and method of administration, as well as the necessity for its continuance. I was tremendously impressed with the magnitude of the work and with the wonderful efficiency of the organization. The work in the orphanages, schools and hospitals was of the highest order. Not only myself but other business men who accompanied me came back determined to assist in every way until the last of these little ones has been permanently cared for. The American people must not relinquish this job until it is finished. Organization of the new "crusade" idea for carrying through this orphanage work, has been completed in Kentucky, Virginia, North Carolina and several other Southern states. The chairman for North Carolina is J. B. Ivey of Charlotte while the chairman for Kentucky is Dean R. L. McCreedy of Louisville. The state of Virginia has pledged itself to the entire support of industrial training schools for children, located at Syria, Ge-

RICHER LIFE SOUGHT BY FARMING PEOPLE

Comfortable Home, Leisure for
Worth While Pleasures, Would
Come With Electric Service.

That it is the enrichment of life, in all that this term represents, which the average farmer hopes electricity will ultimately bring him is the reflective opinion of H. W. Riley, professor of rural engineering of the New York State College of Agriculture. Professor Riley, who has lived with farmers and studied their problems for years, appreciates that the immediate ambition of the farmer, in respect to electricity, is to obtain a larger cash return from his farming; but he maintains that the farmer looks beyond this, and has in his mind, as the final goal, a greater share of the stimulating social and mental possibilities of life, which he hopes will come with an increased cash return. Showing that so far as getting through season after season of farm work and actually producing marketable crops is concerned, the farmer could "double" "get along" if he never secured electric power, Prof. Riley asks why, then, is there such an insistent demand for rural electric lines and what is the real service that electricity from such lines is to render?

"The answer to these questions," he asserts, "can be found readily enough when it is realized that the farmer's central objective in life is the maintenance of an independent and comfortable home, where he and his wife may live, where his children may grow up strong in body and resourceful in mind, and where he may live in peace to the end of his days. "Money must come in reasonable amounts sometimes, to be sure, or, like any other man, he will not count his work successful, but money is of value to him mainly as it enables him to improve his farm and home and to enjoy some of the pleasures and amenities of modern life. The ready sale of automobiles and small electric light plants to farmers, the extension of country telephone lines, the demand for rural free delivery of mail are instances that prove this point. Now interest is starting to concentrate on the extension of electric power lines into the country for the very evident reason that the whole farming population have seen what electricity has done in the cities and they want the same benefits for themselves. "The farmers want electricity mainly because they know that it will make their lives better worth the living. They do not want it to cost too much because cash money is scarce with them, but they want it mainly for what it will do for them and not primarily because of a possible low cost for the service."

BOOSTS THE OLD DOMINION TO NEW ENGLAND VISITORS

Sounding the material wealth as well as the traditional glories of the Old Dominion Governor E. Lee Trinkle made a profound impression on the group of twenty prominent New England manufacturers and capitalists who visited Richmond last week in their tour of the State. Referring to the agricultural resources of Virginia the Governor said:

"Virginia is not alone the largest producer of early potatoes, but is the largest shipper of sweet potatoes. In 1923 she ranked second in the production of peanuts, and is the third among the States as a producer of tobacco.

Virginia possesses more purebred horses, sheep, beef and dairy cattle than any other South Atlantic State. She ranks third in the number of farmers pledged to the use of purebred sires, losing second place to Kentucky, but recently Virginia leads all South Atlantic States in milk production.

Virginia ships nearly one-half of the commercial spinach crop. In 1923 she produced more cotton per acre than any State in the Union, and, while cotton was grown in only twelve Counties, the 1923 crop was valued at \$8,000,000.

Leaders of Southern Churches Plan for Religious Teachings of Children In the Holy Lands

CHURCH leaders from every part of the South are taking a large interest in the post-war problem of religious education for the remnants of the Christian races in Bible Lands. This interest recently crystallized in the departure for Palestine and Armenia of Bishop James Cannon of the Methodist Episcopal Church and Dr. James I. Vance, pastor of the First Presbyterian Church of Nashville. Dr. Vance, pending his entire summer in the East, was sent as the representative of a large committee of churchmen, to formulate a scheme for religious education, which the Near East Relief will put into effect in its Golden Rule orphanages throughout Bible Lands. In a preliminary report just received here, Dr. Vance says: "I have visited Cairo and ridden a camel around the pyramids. I have prayed where Jesus was born. I have spent a night in Nazareth. I have knelt on the traditional site of Calvary and the tomb in the Garden. I have rowed across the Jordan; stood on the shores of the Dead Sea; visited Bethany, Misphah, Jacob's Well, and many other places whose names are familiar to every student of the Bible. "But the great stupendous fact in Bible Lands to-day is the work of our American philanthropy. When I think of the Bible teachings as to the care of children, I realize that in the American orphanages, where thousands of smiling children are being brought back to life and hope, in the Holy Land is being well done. It provides an excellent foundation upon which we can build surely and solidly for the future good of these countries, which are the cradle of our civilization and our religion. I hope that many large givers in America will make special contributions for the further development of religious education in the Near East Relief orphanages." Bishop Cannon, in a letter urging the continued support of this American philanthropic work, says: "It must not be said of us that 'this man began to build and was not able to finish.' In December, fourteen nations of the world will observe our Golden Rule Sunday as a means of calling attention to the orphanage work in the Near East. Americans should participate in the Golden Rule movement heartily and purposefully." Dr. Vance will return to Nashville in September. Bishop Cannon will attend several important international conferences in Switzerland and be back in America in the early autumn.

Boys and Baby Beef

SMYTH COUNTY BABY BEEF CLUB AGAIN SUCCESSFUL. BOYS BRING HOME THE BACON, MAKE GOOD SALE

It will be recalled that Smyth County boys have never failed the race in competition with other boys of Virginia or when competing with the country's best, as for that matter. We should recall with pride the showing made by the Smyth County Livestock Judging Team, representing Virginia at Chicago last fall.

Their ability to produce livestock is not excelled by their capabilities in judging, for the boys have just completed the most successful year of Baby Beef Club Work that has ever been done in Smyth County. Not only were they contenders for high money in all classes, but thru a fine spirit on the part of buyers, met with a most successful sale in spite of a demoralized market.

The boys in Smyth County produced seventeen head of calves this year and exhibited them in competition at the Smyth County Fair, where three counties, with a total of thirty calves, were represented. The Grand Championship was awarded Smyth County, Jno. Fry Cole being the lucky winner with a deep, smooth black steer, while Robert Anderson came in for Reserve Championship with a mellow, evenly fleshed white face of the kind you could but call a credit to any boy. Down the line, the calves exhibited more finish and quality than in any previous year, indicating that the boys are mastering some of the principles of feeding. The entire exhibit was a credit to the boys of this section.

After leaving Smyth County, the calves of Wythe, Smyth and Washington were taken to the Roanoke Fair, thence to Richmond. At Roanoke the story is much the same, tho' the exhibit by breeds placed a new aspect on the show and resulted in renewed interest. Again the good Angus steer shown by Jno. Fry Cole headed his class, while the baby black heifer, exhibiting wonderful type and shown by Robert Anderson placed a close second. Washington County came in for third with a thick heifer, shown by ForestMcKee, Fleet, Va. The first seven places in the Angus show were awarded calves from Smyth and Washington Counties.

The Hereford show resulted in a loss of first place, the little steer heretofore mentioned going second in a close decision, while near the top were many white faces from Wythe and Smyth.

In Shorthorns, Washington County was a strong contender for first money, with a good red steer (and he was bred in Smyth by M. Sanders,) shown by Miles Eller, Fleet. This calf finally placed second, while third and fourth went to Wythe and Smyth respectively. Thus we find Smyth County and Southwest Virginia close contenders in all the breeds. Some eighty calves were exhibited at Roanoke, largely thru the efforts of T. Gilbert Wood, Agricultural Agent of the N. & W. Railway, who was instrumental in raising a nice purse for premiums on each breed.

Show at Richmond brought into competition all the calves fed in the state and to triumph there is an honor coveted by each and every Club Member. While the boys from Smyth failed by a small margin in this attempt for honors on individual animals, the merit of the work done here was demonstrated when the blue ribbon was awarded for the best exhibit of five calves from any county. Not only were our boys winners in this class, but also in the best car lot of fifteen calves.

Robert Anderson was in the high money in both the Angus and Hereford classes. Defeating the black steer, Robert came in for second prize in this show with the heifer already mentioned. He again placed second in the Hereford class which was a strong show. Tho' there were more than one hundred calves on exhibition, Smyth County was showing in the tops. All of the calves from Wythe, Smyth and Washington Counties were in charge of Lee M. Cole, Jr., County Agent for Smyth.

The auction sale of these good calves was the crowning feature of the years work and is deserving of special mention, because of the interest of the buyers, in the boys and girls on Virginia farms and their willingness to manifest this interest thru the purchase of the calves at good prices.

Buyers from many of the principal markets of the East came to Richmond on the day of the sale and extreme depression in the cattle market at that time, failed to make its way to the ring, where the calves produced by boys and girls, were being led out by them for the last time. The men who came there in the interest of this work maintained a lively spirit throughout the auction and if we are correctly informed, each of them left owning some of those good calves.

Buyers present were Swift and Company, N. Y., represented by Mr. Morgan; T. T. Keane & Company, Washington City, by Mr. Keane; Kingan and Company, Richmond, by Mr. Fields; Levison Packing Com-

pany, Newport, by A. Helstern & Sons; McComb and Block, Richmond, by Mr. Block; P. Brauer & Sons Company; and the Old Dutch Market of Richmond. It can be truly said that all of these were staunch supporters of the sale.

History repeated itself when Old Dutch Market claimed the Grand Champion Baby Beef. The price paid was twenty-six cents per pound. Not satisfied with just the Champion they bought the Reserve Champion at one half cent less. The spirit with which these calves were bought may be best illustrated by one incident. The Reserve Champion Angus had been bought by Old Dutch, at thirteen cents per pound and following this the third prize Angus was sold at eighteen cents. Immediately Old Dutch's representatives said this was not quite fair to the boy having the Reserve Champion Angus and suggested that this calf might be brought back and resold if anyone cared to bid more than the thirteen cents. Old Dutch again bought this calf, this time at sixteen cents. Old Dutch continued to buy and finished with a total of twenty-seven calves. The prices paid for the lots of five or more ranged from twelve and one-half to thirteen and one-quarter cents.

Kingan and Company bought the Champion Shorthorn Baby Beef at eighteen cents and later took another of the individual offering at sixteen cents. They also came in strong for the good ones in lots of five, buying one lot of Herefords at fourteen cents and five Angus at thirteen and one-half cents. Others bought ranged from twelve and three-quarters to thirteen cents. Their number totalled twenty-two animals.

Swift & Company's representative was anything but a "wall flower" for he was a constant contender for some of the animals offered, as is shown by the fact that thirty three calves went to Swift & Company at prices ranging from eleven and one-half to thirteen cents.

T. T. Keane & Company was there with the usual good support and while not so many animals were bought as in some former years, we were glad to see them take some of the good individuals back home. Chiefly among these were the second prize Hereford at twenty cents, third prize Angus at eighteen cents and a handsome little Shorthorn, originally bought by McComb & Block and donated by them to the Retreat for the stock. T. T. Keane's purchase totalled eight head.

Levison Packing Company bought the Reserve Champion Shorthorn at sixteen cents and one lot of five excellent Shorthorns at thirteen and one-half cents. In addition, they were high bidders on twenty-two head of the fat pig offering. Newport came back this year and Mr. Levison is likely to be in evidence again on similar occasions. He too, likes the work the boys are doing.



Mammoth Hotel with the adjacent houses to gether with Mammoth Camp resembles and is in reality a village of several inhabitants. The Camp here is one of the largest in the park. This place is the headquarters of the park. The Camp is located at the foot of the Jupiter Terraces in sight of Bunsen Peak. Very near the Hotel and even nearer the Terraces is a carroll with a large number of Buffalo, this is one of the three groups of Buffalo in the park and is called the "show" heard. There is another herd at Lamar River 29 miles away called the "tame" herd, besides there are the scattering wild bands that are not connected with any herd under the care of the government.

After spending about three hours in the Mammoth Hotel and at the Terraces we again board our cars for West Yellowstone, our entrance to the park. No one is missing from our party and Elden didn't lose his pocket book any more, but some one brought back a snap-shot of "Lance" high up on the Terraces all alone. This has been a great surprise to all of us and to his friends generally. I am sure that it was the only time "Lance" was alone with himself on the entire trip.

We brought Bill Vines along with us too, Bill was a good sticker. Our friends, Shoemaker and Hurd could always be counted upon to take the lead, and they were fully up to their reputation this time although they had been over to take in an extra the Museum.

On leaving Mammoth we ascend the mountain by an easy grade going up 1000 feet in less than three miles. The road passes through the limestone Hoodoos. We pass through great blocks of this limestone many of them standing more than a hundred feet high. There is about a mile of this wonderful formation. In the midst of the Hoodoos the road turns abruptly passing through great blocks of limestone to which is applied the name "Silver Gate." Golden Gate is a very picturesque drive. It is a rugged pass between the base of the lofty Bunsen Peak and Terrace Mountain. The sides of these rocky walls rise 200 to 300 feet above the road way and are covered with yellow lichen, which suggests its name.

Rustic Fall at the west end of Golden Gate canyon adds a charm to this beautiful spot. The stream, Glen Creek is fed by mountain snows along the base of the hills, at the falls it leaps over 60 feet some shallow basins and then disappears underneath an accumulation of rock in the canyon. Beyond Golden Gate we come to Swan Lake Basin which is a broad mountain prairie hemmed in by snow capped mountains two of the loftiest peaks in sight are the Mount Holmes and Electric, the former 10,578 and the latter, the highest in the Park 11,155. This peak contains a large amount of magnetic ore and hence attracts lightning during storms.
