## ORGANIZED LABOR.

"Labor leaders, who attempt to sell politicians the idea they are able to deliver or influence to any great extent the vote of organized labor at election time are merely kidding themselves.

"It can't be done. Like other Americans the members of organized labor vote according to their own dictates. And most important of all the organized and unorganized workers more readily understand the "bread and butter" language and adopt it in preference to accepting the advice of labor officials, who represent the American labor movement."

These excerpts voice the views and opinions of Richard J. Powers, who was elected the first president of the American Federation of Labor when it was organized in Pittsburgh in 1881. Mr. Powers visited Republican National Committee headquarters here and offered his help in the Coolidge-Dawes campaign. The veteran labor leader has lived in Chicago for years. He is a great friend and admirer of Samuel Compers and worked with him in the work to launch the American Federation of Labor. Mr. Powers was succeeded in office by the man who is now at the head.

"When election time rolls around in November," asserted Mr. Powers, "one will see both organized workers voting en masse for Calvin Coolidge and Charles Dawes.

"This LaFollette hysteria that some labor officials are trying to inoculate into the working classes will simmer out like the effervescence in a bromo seltzer long before election time. Signs have already started to appear which indicate that enthusiasm has begun to wane in LaFollette's various labor camps. The workers are getting wised up to the entire program which means absolutely nothing at all to them unless a period of slack times in the remote case of the program's being successful.

"The working classes in the country want a continuation of good times and a full dinner pail. They realize that anything that spells of LaFolletteism only means a four or six year period of depression and that is something they want to avoid.

"A glance over conditions in Europe is sufficient to inform the workers in this country the extent of good times here. High wages, employment and now industrial unrest are a few of the essential matters both organized and unorganized classes of workers consider very vitally on election day.

"Under the Republican administration of Harding and Coolidge the working classes have enjoyed large measures of success. Last year building construction in 269 cities amounted to \$3,099,694,905. And the significant part is that the erection of private garages far outnumbered the construction of any other kind of building. In the residential line of construction there were 211,235 one family buildings erected while private garages numbered 221,825. The sum expended for the latter was \$110,563,189; the cost of the former amounted to \$881,569,529.

"This tremendous building boom, which is now going into the fourth year, reaches back to ore mines and other sources of industry and aids the workers there. Along with the building boom conditions for the workers in other industries are good. The working classes receive a living wage and are contented. And these factors in the final analysis have more effect on the workers' vote than advice from the officialdoms of some labor organization."

Mr. Powers asserted that William Lee, head of the brotherhood of trainmen, reflected the true status of the political situation when he said that labor leaders don't carry the votes of their union members in their back pockets.

"The chief of the trainmen spoke the truth in that matter and also hit the nail on the head when he said it was an insult to the rank and file of trade unionism to have leaders posing around basking in the limelight under the false impression of being able to deliver the vote of organized labor.

"Labor leaders know only too well the absurdity of their claims but are willing to advance them if the public press and politicians are ready to dicker on that basis."

On July 30, 1924, Earl Morris Garretson, passed to his eternal rest, after a two week's illness in the Abingdon Hospital.

He was the son of J. Earl and Etta Morris Garretson. He was born October 22, 1910.

Impressive funeral services were held at the Marion Baptist church at 4:30 P. M., Thursday July 31, after which his remains were laid to rest in the beautiful Round Hill Cemetery. The services were conducted by Rev. James R. Edwards.

Besides his mother and father, Earl is survived by a brother, Joseph his grand parents, Mr. and Mrs. M. C. Morris and a host of relatives and friends.

Many beautiful floral wreaths were silent testimony of the large circle of those who knew Earl and loved him.

# To Be Seen At The Fair

SPECIAL FEATURES OF THE GREAT SMYTH COUNTY FAIR. AUGUST 26, 27, 28, 29, 1924.

Among the special attractions at the Smyth County Fair which should prove of special interest to farmers and stockmen are the exhibits of the State College.

The department of Agricultural Economics will display a model farm exhibit in the agricultural hall and will illustrate a good crop rotation for this section. Others than the one outlined may be used, but this particular one was worked out by Mr. Taylor representing this department of the State College, in cooperation with a group of leading farmers from Smyth County. Be sure to see this exhibit and discuss with Mr. Taylor any special features of interest to you. The exhibit has a real value and should be seen by all farmers in this section.

The Animal Husbandry Department of which Mr. R. E. Hunt is head, is this year for the first time offering an exhibit of the kind South-west Virginia has so long wanted and asked for. Many of our farmers were active in an effort to have established at our State College, an Animal Husbandry Department, in keeping with other Departments of the College. ## SHERIFF LITTON CAPTURES TUGGLE

R. Tuggle, notorious bootlegger of Russell and Washington counties, was captured late Wednesday afternoon by Sheriff Litton, of Abingdon and a party of police according to word received from Sheriff Litton Wednesday night. Many attempts had been made heretofore to catch Tuggle but the raid Wednesday was the first to meet with any success.

Sheriff Litton and his party surprised Tuggle at his home near Tumbling Creek, near Rich Mountain and found him talking to another man inside his house. The Sheriff and his party searched the house and premises and found, buried in the garden near the home a gallon of whiskey and half a bushel of malt. Upon further investigation they found the still which Tuggle operates with full equipment in the mountain not far from his house. Litton stated that Tuggle seemed unconcerned and showed no signs of nervousness until the search of the garden began in which the liquor and malt were found. He also stated that high powered rifles and pistols were found in Tuggle's house.

Sheriff Litton brought Tuggle to Abingdon, where he was lodged in jail, to await trial in court Thursday morning before Squire T. H. Crabtree.

Tuggle will be remembered as quite a notorious character in this section and three years ago figured in a scrape in Russell county, when he had three of his fingers shot off.







#### HISTORY OF PHENOMINAL PROGRESS OF HIGHWAY CONSTRUCTION IN VIRGINIA

Richmond, Va.—Asked for a brief but comprehensive summary of the activities of the State Highway Department during the period of its existence in Virginia Henry G. Shirley, Chairman of the Highway Commission and one of the first road engineers in the United States, outlined the following interesting and instructive facts, He said:

The State Highway Department was created in 1906, having supervisory powers only. In 1918 a system of approximately four thousand miles was established by an Act of the General Assembly and a Highway Commission was created in 1919. This Commission operated until 1922, when a new law reorganizing the Department was put into effect. This law required the Commission to take over not only the construction but the maintenance of all roads in the system and carried the right to increase the mileage annually 2 1/2 per cent.

Under the above Act and subsequent Acts of the law makers the system now possesses a total mileage of approximately 4,400 miles and is laid out to take care of the traffic between the leading cities, as well as to connect, either directly or by spur, all of the County seats in the State.

Approximately 1,800 miles of road have been constructed, of this total 1,300 miles were built by the State at a cost of \$22,000,000; 40 miles by the Federal Government, and about 460 miles by the Counties previous to the system being taken over by the Commonwealth.

At the present time there are under construction 514 miles, of which 320 are of hard surface and 194 of grading, sand-clay or gravel. Of these 68 miles are being constructed by the State's own forces, leaving a balance yet to be improved of approximately 2,100 miles. The greater portion of the 460 miles

taken over from the Counties by the State will have to be resurfaced and widened.

There is a secondary or State Aid system consisting of approximately 12,000 miles, of which 6,000 miles have been constructed, the State paying 50 per cent of the cost. This and the auxiliary system of district roads make up the entire mileage of the State.

The State and State Aid System will accommodate and serve at least 90 per cent of the traffic. The automobile license fee provides sufficient funds to maintain the State Highway System, making it open to traffic practically the entire year.

The condition of the roads of the State has been in the past criticized justly and unjustly, there being a general feeling that Virginia has but very few miles of improved roads whereas, taking the total, she ranks high with her sister States in the number of completed miles. Due to lack of a general highway system prior to 1918 there are many stretches of roads not connected, but when these have been joined together they will make a completed system which will serve the traffic needs of the people in a very satisfactory manner.

Practically all of the cities and larger towns will be connected and such historic points as Jamestown,

Wakefield, the home of George Washington; Yorktown, Williamsburg, Manassas, Appomattox, Luray, Natural Bridge, Lexington and a host of others, will be accessible. It is worth a trip through the confines of the State to visit these spots of historic interest and to enjoy the natural beauties and wonders of the Mother States.



## Baby Clinics In County

The Baby Clinics which were held in Chatham Hill and Sugar Grove under the direction of the State Bureau of Child Welfare and Smyth Red Cross nurse were very successful to say the least.

Dr. Gardner who was the examining physician, gave each child a thorough physical examination. The defects which were brought to light by this examination were explained to the mothers by the doctor and referred to their family physician for the proper treatment or correction. They were instructed in the care of children, as to diet, fresh air, sleep and regular habits that would be for the betterment of their children.

28 children attended these clinics. 28 were under school age. The major defects found were defective teeth, enlarged tonsils, skin eruption, defective hearts, defective lungs, defective eyes and many were underweight.

Other clinics of this nature will be held in other parts of the county with in the near future. Let every mother prepare to have her child examined when this opportunity presents itself.
