Sheriff Dillard Makes Big Haul

CAPTURED ONE THOUSAND GALLONS OF MASH.

Woeful News For The Believers In Nose Paint

The happenings of Friday last have cast a deep and abiding gloom over the lovers of corn "licker" in and around Marion, and when they consider the waste of good material for the manufacture of such a large quantity of "oh-be-joyful" they are sad indeed. All this simply goes to say that Sheriff Dillard and his men have again been on the war-path after the little copper still—and they got him.

The worst of the happenings took place up in Currin's Valley Friday morning, when Sheriff Dillard, Deputy Sheriffs Gullion and Whisman, and Town Sergeant Snively, captured a brand-new 60 gallons still and outfit, with about three gallons of whiskey and one thousand gallons of mash (mourn ye thirsty souls) and destroyed the whole outfit. The operators had got warning of the raid and vanished before the arrival of the officers, but it must have been a close call for the fire was still burning when the raiding party arrived on the ground. The officers report that the "creeter" were of the first order, and nothing but the best was expected to be turned out from such up-to-date arrangements.

Later in the week the Sheriff also captured up on Nick's Creek some 120 gallons of mash, but did not get the still on this raid. The majesty of the law is quiet for awhile and the festive boot-legger begins to gain confidence in business conditions, when bam—here comes the Sheriff and party and all the rosy colored visions of a good old time, and a pocket full of profit goes aglimmering, and the Sheriff walks off with the still and lands the operators in the jug, unless they are nimble enough to get into the bushes before he arrives.

MARVIN R. JOHNSTON, A. P. LINEMAN KILLED.

Never has the community had a greater shock than on last Saturday when news came that Marvin Johnson, familiarly known as "Bud" Johnson had been electrocuted while at his work in Pulaski. He was working on a pole at the intersection of Jefferson Avenue and by some means came in contact with a 2,300 volt wire. His safety belt kept him from falling. The current was quickly cut off but he died in a few minutes.

Bud was the youngest son of Mrs. Gussie and the late Chas. T. Johnson. He was born on July 6th, 1901 and died May 24th at the age of 22 years, 10 months and 18 days. He joined Ebenezer Lutheran Church at the age of 16 and was a conscientious and faithful member until his death. The remains were brought to his home near Marion Sunday morning. Funeral services were held at Ebenezer Lutheran church Monday morning at eleven o'clock and interment made in Ebenezer Cemetery. Bud was loved by everyone that knew him and the large crowd that visited the home, attended the funeral and the many floral designs attest the esteem in which he was held.

Marion High School Closes

MARION HIGH SCHOOL CLOSED ANOTHER SUCCESSFUL SESSION THURSDAY.

The Marion High School closed its school year Thursday night with the Commencement exercises, held in the Court Square Theatre, where the class with seventeen graduates, ten boys and seven girls received their diplomas. The exercises opened with the invocation by Rev. Eldridge Copenhaver, pastor of the Lutheran church, followed by a piano solo by Mr. George Glenn Killinger, one of the members of the class. Mr. Stuart Staley delivered the Salutatory and Miss Virginia Brisco was the Valedictorian. The class was very fortunate in being able to get Miss Sena Bryant, head of the Department of Music of Southern Seminary Buena Vista, Va., two vocal solos, one of which was composed by Mrs. John P. Buchanan, who accompanied her at the piano. The address to the graduates was delivered by Dr. James N. Hillman, president of Emory and Henry College, who was introduced by Rev. Hugh Brown. Dr. Hillman made a very attractive and stirring appeal for higher education, stressing the point of the necessity of trained men and women. He made it clear that even though the graduates represented part of the 300,000 graduating from the schools this year yet there was a constant need for all and each had a mission to fulfill. He also told of the opportunities the person had with mental training over those without training, starting that the high school student has a large ratio over those who do not graduate and the college trained mind has even a larger ratio. Dr. Hillman is a favorite throughout Southwest Virginia and people attended the exercises from several distant points to get the privilege of hearing him.

The Baccalaureate address was delivered in the Royal Oak Presbyterian Church Sunday morning with the address to the graduates by Dr. John Patty, pastor of the Centenary M. E. church South, of Knoxville, Tenn. Dr. Patty, presented the christian view of education very forcibly, and pleaded that the graduates have minds on higher rewards for service than the rewards capable of being given by man.

The Marion Grammar School presented one of the most attractive and prettiest little entertainments it has been the good fortune of the school to give to the patrons and friends. The stage was beautifully decorated, the students well trained and the costumes of the most attractive designs. Each child performing bringing great credit both to the teachers and children. It is hoped that all of the teachers will return for the next session as the work in the Grammar school is up to the standard and the teachers are selected from the vast number of applicants who file applications yearly for these positions. The people of Marion have cause to be happy over the work of the teachers who put all their efforts in bringing each child out so that it may develop rapidly and thoroughly.

The members of the class presented the comedy, "The Arrival of Kitty," to one of the largest and most enthusiastic audiences ever assembled in the theatre. The play was a success in every respect and was one of the best ever presented by local talent. Much credit is due Miss Josephine Sneyffey, the head of the Department of English, for the wonderful training they received with her as their coach. Miss Sneyffey has had charge of this work in the Marion school for several years and has had a great deal of experience.

Marion has been especially fortunate this year in having a strong Faculty, gathered from all parts of the state, for her schools and practically the entire staff of teachers are expected to return next year. COOLIDGE TO MAKE REDUCTION OF TAX ISSUE IN CAMPAIGN.

President Coolidge intends to make a paramount issue of taxation in the coming campaign. Signing of the tax bill does not preclude his appeal to the country for the election of a Congress which shall support his views.

Mr. Coolidge will insist that taxation reduction could have been greater — that the burdens on the many millions of people who pay indirect taxes could have been lifted and a much more productive revenue measure framed. Responsibility for the imperfections of the bill will be placed squarely on the Democrats. The claims of the latter that they have given the country a bill which favors the small tax payers instead of the individual with large income, the Republicans will not enter their dissent but they will point out that the failure of Congress to adopt certain recommendations of the Treasury will hamper instead of stimulate a reduction in the cost of living.

The President proposes to tie up the defeat of the surtax proposals to the general business condition and the country, arguing that a free flow of capital would have meant more industrial expansion, better wages, more employment and economic progress. The idea that every tax payer's private affairs may be open to everybody else is also counted upon as ammunition for the stump because it is not limited to persons of large income but includes everybody.

IN MEMORY

Into the lives and hearts of those who were to know and love him later came a bright spirit that was born twenty-two years ago, Charles Herbert Strouth, son of Mr. and Mrs. Henry Strouth, was born December 5th, 1901; died May 1st, 1924, aged 22 years, 4 months and 26 days. He leaves father, step-mother, seven brothers and sisters to mourn their loss. His sad death was caused by having his hand hurt at the saw mill on Lick Creek. He died in the Abingdon Hospital May 1st, 1924. DEATH OF AGED MAN
 Levi P. Ford was born March 24, 1842 and died May 24th, 1924 at the age of 82 years. Being one of the oldest citizens of the County. Sues Town For \$3,000

The new water line has been completed to a point near Killinger's Mill, where the work has been stopped on account of claims made by K. G. Killinger and the Marion Foundry & Machine Works for damage they claim will be caused to their mills by the diversion of water from Staley's Creek by the new pipe. The contractors have been paid off and the remainder of the work will be done by the Town when the question of damages is settled.

Mr. Killinger has instituted an injunction suit against the Town, which was argued before Judge Stuart at Abingdon on May 28th. W. R. D. Moncreu appearing for Mr. Killinger and B. L. Dickinson for the Town. The temporary injunction asked for was refused by Judge Stuart, but the case has been docketed for further proceedings when Court meets in August. Mr. Killinger asks \$3,000.00 for the damage which he claims will be caused to his mill by the diversion of water by the new pipe line, and the Town Council has refused to pay this amount.

The Marion Foundry & Machine Works has notified the Council that it will claim damages, but has not yet stated the amount.

THOMAS M. ROSENBAUM.

Mr. Thomas M. Rosenbaum one of the oldest citizens of the county, died at his home one mile West of Marion May 27, 1924 at the age of 81 years, 6 months and 19 days. He was the last member of a large family of brothers and sisters who lived to a ripe old age.

Mr. Rosenbaum was twice married. His first wife was Miss Nannie Virginia Bane of Montgomery County. They were married on Oct. 26, 1870. To this union four children were born. Mrs. Rosenbaum died May 24, 1880. Two sons have also preceded to the life beyond: Ansel who died in youth and Claud B. who was drowned March 11, 1922, near his home in attempting to ford the Holston river at high tide. The two surviving children are Major Otho Bane Rosenbaum of the U. S. War College, Washington, D. C. and Mrs. Georgia Repass of Marion. On September 18, 1881, Mr. Rosenbaum married Miss Nannie Victoria Copenhaver, who died August 1, 1909.

The deceased was a member of Company A, Eighth Virginia Cavalry in the war between the states. While in the service of his country, he was a good soldier and true to the principles for which he fought.

He was received into the membership of Ebenezer Lutheran church, December 1866 by L. A. Mann. As a member and officer in his church he was faithful to duty, and until prevented by age and physical infirmity he was rarely absent from any of the services. His funeral was conducted by Rev. E. H. Copenhaver at Ebenezer, Thursday, May 29, 1924 at 11 a. m.

Help Those That Need Help.

An appeal to all Smyth Countians to contribute articles of clothing which they have cast off for the winter to save human lives in the Bible Lands has been made by Rev. E. C. Burnz County Chairman for the Near East Relief. This call is supplementing the general call to Virginians made last week by Claude W. Hopper, of Richmond, State Director, for this great humanitarian organization.

Governor E. Lee Trinkle, Honorary State Chairman, Harry Flood Byrd, Bishop James Cannon, Jr., Bishop William Cabell Brown, Hon. G. Walter Mapp, Dr. Harris Hart, Hill Montague, Mrs. B. B. Munford, Dr. E. A. Alderman, E. E. Magill and a number of other prominent Virginians who are members of Near East Relief State Committee, have also supplemented this appeal.

While no definite date for clothing shipments in the State has been set by Mr. Hopper the Smyth County Committee is now collecting bundles and forwarding them to the National clothing warehouse of the Near East Relief in New York. Mr. Hopper has set the State's goal as 5,000 lives and this county's goal as 50.

Schools, churches, women's organization, colleges, business men's clubs and organizations of all kinds are aiding in this drive for cast-off clothing. All are asked to either take it to the place designated by Mr. Burnz or ship it to the Near East Relief Clothing Warehouse, U. S. Army Base, Brooklyn, N. Y.

Mr. Hopper and Mr. Burnz are particularly desirous of receiving as many as they can obtain of coats, trousers, dresses, sweaters, work gloves, mittens, boots and shoes, wool garments, blankets, sheets for bandages, new cloth or garments and any heavy warm clothing in which there is still some wear.

The Near East Relief cannot use laces, silk, veils, chiffons, evening clothes, satin slippers, muslin underwear, high-heeled shoes, straw or frame hats or silk stockings. If any considerable quantity of these articles are available it is suggested that a community sale or auction be held and the proceeds be turned over to the Near East Relief County Chairman or sent to Waller Holladay, State Treasurer, American National Bank, Richmond, Va.

ROY COMER

It is with deep regret that we record the sad and sudden death of one of our most faithful and valued men, Roy Comer, an employee of our quarry at Marion; whose death was the result of an automobile accident near Marion on April 27th. Roy, with a party of friends, was returning to Marion from Centenary at an excessive rate of speed. In passing another vehicle their car skidded, turned over several times, threw three men through the top and pinned Roy under the rear wheel. He lived but a very short time after reaching the Doctor's office.

Roy began working at the Marion Quarry on the rock-loading crew. His ability was soon recognized and he was shortly promoted to coupler on the engine and then to Engineer. He was always willing to do more than his share of work and was a leader in promoting co-operative spirit among the men with whom he was working. His perpetual smile gained him a host of friends and his sudden death brought a cloud of sorrow to every man working at the Marion Quarry.







value scale. The students were urged to think of the value of a home and life and development in a clear manner, that money should not be the goal unless attained through words of honesty, virtue and honor. His sermon was appropriately arranged for the younger students, and he gave some wonderful illustrations of the sacrifice that educated people had made to establish a higher plane for stronger morals. The college is especially fortunate this year in securing Dr. Frankenstein and Dr. Hugh Black, of New York city, a man of international fame as a minister, speaker and author.

Monday—June 2:

The last of the events held in connection with the closing of the Marion College for the year was the Commencement exercises held in the Royal Oak Presbyterian church Monday afternoon at 3:30 P. M. The exercises were opened with prayer by Rev. W. H. Brown, president of the Board of Trustees of the College, after the marching in of the graduates and the student body of the college. President C. Brown Cox then called upon Hon. B. Frank Buchanan who introduced in a most appropriate manner Dr. Hugh Black, D. D., D. Litt., of New York, a man of international prominence as a writer, speaker and author.

Dr. Black, a man true to men of his ability, delivered an address full of facts helpful in everyday life, frequently introducing wit in the good Scotch manner, since he is a Scotch Presbyterian. Dr. Black used as the theme for his address "Faith," and discussed its value fully from the stand-point of religion, education and business, as well as the social phase. He used several quotations, quoting freely from Robert Burns as well as many other poets. He illustrated the use and control of faith as being controlled by mental condition of the individual. Using several Biblical quotations he presented the necessity of faith from the time of the disciples up to the present time. Dr. Black also gave a very important place to faith in the life of the Scientist and the business man, and illustrated with the English words and their latin origin, that each term used in business means faith. Dr. Black presented faith from a Psychological position, again proving that our senses of perception and apprehension are controlled partially if not fully by faith. Dr. Black also gave a clear-cut illustration of the difference between general public and what pro-
