STICK TO THE COLORS!

No army can win a battle and triumph in a war that casts aside its colors when the enemy are in front and ready for action. Funderism never fail to rally around their flag. In a skirmish or in a general engagement they stick to their colors and by united action, standing shoulder to shoulder, they save their forces from utter annihilation. Knowing that they cannot cope successfully with the outnumbering army of Readjustment it has from the first been the policy of Funderism to try to accomplish by strategy what it could not and cannot do by numbers and power. To disintegrate the army of Readjustment has been the prime policy of Funderism. When a general engagement is about to take place, when a battle is to be fought which involves questions of great import to the State, Funderism tries in vain to work its plans. Consequently it has resorted to another method. In the skirmishes that are to precede regular pitched battles it has determined to try its work of disintegration. Next fall a general State election is to take place. Then a Legislature is to be elected that can more fully enforce the principles and policy of Readjustment or restore Funderism, and defeat the oft expressed will of the people in regard to the issues and questions upon which Readjusters and Funderists have heretofore joined battle. It is for that election Funderism is now mainly preparing. Seemingly acquiescing in what the Readjuster party has done for the relief of our State, Funderism is filled with bitterness and malignancy that will not rest satisfied until everything that Readjustment has done is undone—or until Funderism has spent its last breath in the vain effort to undo it.

In the county elections in May a skirmish is to take place. Funderism is looking with longing and hopeful eyes to the result. Are you prepared to say that the charges heretofore made my Funderism that Readjusters are not qualified to run the county and State governments are true? Are you ready to place the Public Schools again at the mercy of their treacherous foe? Are you willing to place free suffrage again in jeopardy? Are you disposed to entrust the financial management of the State once more in the keeping of a class of men who by incompetency and corruption depleted the treasury and rushed the Commonwealth to the brink of bankruptcy? Do you wish to see the bitter proscription, political and social, that is the watchword of Bourbon-Funderism prevail? If so listen

to the seductive voice of the enemy, leave your colors and fight temporarily under the banner of Funderism, then see how hard it will be next fall to prevent the triumph of the faction you have been fighting for years to save yourself and your State from ruin. Stick to the colors Readjusters in the skirmish, and all will be well when the great battle comes on.

That is, how the genuineness of printed or lithographed coupons could be proved. Will the PATRIOT AND HERALD have the goodness to point out the article to which it refers with so much apparent confidence in the accuracy of its statement.—Richmond Dispatch.

How innocent and dull of comprehension can our learned cotemporary of the Dispatch be when the occasion suits. If we had meant that he had written an article last year taking the grounds that printed or lithographed coupons could be proved to be genuine we would have said so plainly. What we meant to say was, that last year when parties in various courts of the State were undertaking to prove, and actually proving to the satisfaction of Funder courts and juries, the genuineness of printed or lithographed coupons no word was then uttered by the Dispatch, or any Funder, that called in question the ability of the holders of printed or lithographed coupons to prove them genuine. If the Dispatch can reproduce one line from its editorial columns written at the time the Attorney General and the Commonwealth's Attorney of Richmond were introducing experts to show that it was almost impossible to prove the genuineness of a detached printed or lithographed coupon, sustaining them in the position they held thereon or even entertaining the belief that they might be correct, then we would willingly admit that we have done the Dispatch an injustice.

But the Dispatch well knows that it and all Funderism gave support, by acquiescence or encouragement, to those who undertook in the courts to prove such coupons genuine. We defy the Dispatch or any other Funder paper in the land to show a line published by them doubting the feasibility of proving the genuineness of such coupons until after the decision of the Supreme Court of the United States on the Constitutionality of the Middleberger Bill.

I'LL PAY THE DIFFERENCE.

As the Western bound passenger train on the Norfolk and Western Railroad stopped at a tank, near Marion, last Saturday night, two men entered the first class car, when the following conversation took place.

Man to the Conductor—"Captain is this the second-class car?" Conductor—"No, sir." Old man in the car to newly arrived passenger—"Are you a native of this State?" New passenger—"Yes, sir?" Old man—"Well, then, if you are a democrat and a white man take your seat in here with the white men, and I'll pay the difference between first and second class fare; but if you are a d—n old Readjuster go in the other car with the niggers."

The man went into the other car, when the old man remarked: "I thought he looked like a Readjuster."—Montgomery Messenger.

COURTING FLOODS IN THE SOUTH.

The Destruction of Timber Lands in Georgia and Neighboring States.

MACON, April 6.—The recent terrible disasters by floods both at home and abroad, caused by the reckless and criminal destruction of forests, have drawn the attention of Georgians and citizens of other Southern States forcibly to the growing danger which threatens them in this respect and for the same reasons. One of the danger signals is the gradual disappearance of fish, but the relentless war now being waged on the forests is also being felt in other ways than the inability of the angler to catch anything but catfish, bullheads, mudcats, or suckers, as they are variously called, in the coffee-colored streams of Georgia and Alabama. From the red hills of Georgia come down even now enormous washings, which are filling the channels of the rivers, on the banks of which are situated many of the largest towns. The Ocmulgee, Oconee, Flint, Altamaha, Chatahoochee, and other streams all look as if they were trying to wash the neighboring country away, though the rains have been by no means heavy, and all show to the keen observer signs of inevitable disaster unless the reckless denuding of the forests is checked.

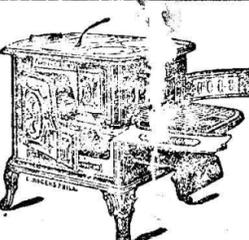
In Florida it is actually a fact that new railroad and canal companies have received grants of more land than there is in the State. These companies, without running a level, laying a tie, or digging a trench, are hard at work greedily and remorselessly cutting down and selling their timber. This once done, the chances of a road being built or a canal dug are exceedingly slim. In Georgia and through to the Mississippi the home demand alone for wood is enormous. The turpentine stills use vast quantities, as do the wood-burning locomotives of the railroads. As coal from Alabama costs \$8 a ton, there is a wood pile in every back yard. But there is a great deal of wood in Georgia, and the wood pile, for ordinary purposes, would last many a long year to come, were it not for gigantic wood piles of another kind, to supply which thousands of acres of land are cleared clean of timber every year. These are called pits, but are really above ground. Charcoal making is a great industry, and gives employment to thousands, and the inroads made by this industry on the forests may be imagined when it is stated that to supply the furnaces along the East Tennessee, Virginia and Georgia Railroad alone from 6,000 to 8,000 acres of land are cleared every year. These furnaces are over the State line in Alabama, south of Rome, and all use charcoal to reduce the ores. One large furnace uses over 2,000,000 bushels of charcoal a year, and to furnish this charcoal nearly 2,000 acres of land are stripped for the wood. To chop this wood 300 men are employed five or six months in the year, and it requires the services of 200 more to reduce the wood to charcoal. Then numerous men and teams are needed to haul the wood to the pits and the charcoal to the furnaces. These pits are from 20 to 40 feet in diameter, and from 12 to 20 feet high. They hold from 40 to 60 cords. Three cords of pine make 100 bushels of charcoal.

Ship Canal Across the Peninsular. WILMINGTON, DEL. April 6.—Details are published here this afternoon concerning the operations of the Maryland and Delaware Ship Canal Company, which was formed for the purpose of constructing a ship canal across the peninsula by what is known as the Sasafra route. It is stated that the bonds have been placed in France by the president of the company, and that the money has been raised for the canal, which is to cost eight million dollars. The canal, it is said, will be constructed within the next four years. Estimate of cost and specifications of the work for the use of contractors have just been issued, and it is expected that the contract will be awarded at an early day. The canal is to begin at Georgetown bridge, on the Sasafra river and will occupy the bed of the river for four miles, then, taking the main tributary, it will follow that to the dividing ridge between the waters of the Chesapeake and Delaware, and thence to Blackbird Creek Valley to a point near Taylor's bridge, where it will take nearly a direct course to a cove on Delaware bay, below the Gull bar. The whole length of the canal will be 20 miles. The width will be 90 feet at the bottom, and the depth will be 27 feet below main tide at Georgetown bridge.

President Arthur in Florida.

JACKSONVILLE, FLA., April 7.—President Arthur and party arrived here at 7:30 last evening. They were met at the Callahan by a committee of citizens, who escorted them in carriages from the hotel to the steamboat landing amid a salute of artillery and the cheers of 10,000 citizens assembled along the route. He left at once for Sanford, where he will remain several days resting quietly. The President says he has no definite plans, but if the weather is favorable he will remain ten days or two weeks, part of which time will be spent in fishing and hunting.

Citizens of Petersburg have contributed \$1,208.50 so far to the payment of their police force which was illegally elected, but served some six months.



New Postmaster-General.

WASHINGTON, April 4.—The President has appointed Walter Q. Gresham, of Indiana, Postmaster-General. He is now United States District Judge for the Seventh circuit of the State of Indiana.

General Gresham is a native of Indiana, a resident of New Albany, and has long been an especial friend of General Grant. After the surrender of Vicksburg, and while a colonel of the Fifty-third Indiana volunteers, he was promoted to be a brigadier-general on Grant's recommendation, and when a movement was put on foot to prevent his confirmation by the Senate, so great was Grant's interest in him that he used all of his then great influence to carry his point. When Grant became President he appointed General Gresham United States District Judge for Indiana—a position he has held ever since. It has been long understood, however, that he wished to enter political life, and in 1880 there was considerable talk of nominating him for Governor of Indiana, and later was put forward as United States Senator to succeed Joseph E. McDonald, but withdrew from the contest when it was found that a majority of the Legislature favored the election of General Harrison. When Garfield's Cabinet was formed his name was under consideration for a portfolio, and he would, doubtless, it is said, have received it had the Indiana Republicans united heartily in recommending him.

An Ottawa telegram says: On Wednesday afternoon, while Sergeant Hughes and Police Officer Cudd were in the hallway of the Eastern departmental building, a bottle containing some explosive was thrown from above, and burst with tremendous force. The man saw the bottle coming, and succeeded in getting into shelter behind a pillar before it exploded. The case, which has been kept secret till to-night, is in the hands of the police.

Dogs vs. Sheep.

Sheep killing dogs in the region of Clearspring, says the Hagerstown (Md.) News, appear to be too abundant for healthy advancement of sheep culture in that locality.

Feeding Calves.

I have generally fed bran and oats, and consider it the better food. The reason for it is given incidentally by Waldo, when he says "as the object with the calves would be growth rather than fat, and as bran contains a greater per cent. of flesh formers than corn, etc."

Fruit-Tree Culture.

When designed for small grounds plant peaches, quinces and dwarf pears where the entire soil will be cultivated. Standard pears, apples and cherries will better endure the hard ship of grass plots, but open the turf three feet wide about each tree and keep the soil mulched at least the first year.
