5 Va. Postmasters to be Considered Upon Soon

Washington, D. C., Nov. 2.—Just as soon as Postmaster General Burleson returns from registering his vote in Texas he will take up with President Wilson the disposition to be made of the five Virginia postmasters whose nominations were sent to the Senate during the past session, but not acted upon.

The five Virginia postmasters who failed of confirmation were as follows: A. B. Buchanan, Tazewell; Clinton B. Camper, Fincastle; John K. Kellam, Onley; William G. Stevenson, Accomac; Carroll C. Chowning, Urbanna.

Four of the above mentioned postmasters are now serving and no action is necessary in their case. The fifth, Camper, at Fincastle, has had his nomination withdrawn.

The Buchanan nomination is an old, old story. He was nominated on January 22, 1913, on the recommendation of Congressman Slem, to succeed the retiring postmaster, Mr. Pendleton. Buchanan is a Democrat and the choice of the Democrats of the community. He was chosen by Pendleton's bondholders, and, according to the postoffice regulations, placed in office by them.

The President forwarded his nomination to the Senate over the objection of the two Virginia senators who favor the appointment of J. W. Boyer. Although nominated over two years ago, Buchanan has never been confirmed. He still holds the office, however, and with the Postoffice Department favoring him he cannot be put out of office, so that the fact that he remains unconfirmed amounts to but little.

Clinton B. Camper, the editor of the Fincastle Herald, was recommended by Congressman Flood for appointment as postmaster at Fincastle. He asked that his nomination be withdrawn, and Flood forwarded the request to Postmaster General Burleson. Shortly afterward Flood recommended another man, but he was rejected by the department on the ground that he was too old.

James A. Hoofnagle Dies at Wytheville.

Mr. Jas. A. Hoofnagle, who resided near Mt. Carmel and Atkins, in this county, until some eight years ago when he moved to Catlett, Fauquier county, died at the home of his step-son, Mr. J. Floyd Johnston, in Wytheville, quite suddenly late last Thursday night from neuralgia of the heart. Mr. Hoofnagle recently bought property in Wytheville and three weeks ago took his family there to live, and he expected to engage in the milling business with Mr. Johnson. He was 71 years of age and is survived by his widow and two daughters, Miss Mattie, who is principal of the Catlett high school, and Miss Ella, at home.

The deceased had been a member of the Methodist church for a number of years and was a man highly esteemed by a large circle of friends.

His remains were brought here on No. 11 Saturday and taken to Mt. Carmel where the funeral service was conducted by his former pastor, Rev. G. M. Maiden, of Abingdon, assisted by Rev. Early of the Marion circuit, in the presence of a large concourse of friends and relatives after which his body was laid to rest in the cemetery nearby to await the resurrection morn.

Mr. Ira Philippi, of Groseclose, and Miss Nettie Grubb, of Wythe county, were quietly united in marriage at Chilhowie last Wednesday, Rev. Steele officiated.

Rev. F. T. McFaden, D. D., of Richmond, will preach at Royal Oak Presbyterian church next Sunday morning and night, and at Seven Mile Ford at 3:30 p. m. He will meet the men of the Royal Oak congregation at a social at Senator B. F. Buchanan's home on Friday night at 8 o'clock.

Dr. W. H. Bramblitt, who had his hip broken in a fall while getting out of his buggy at Pulaski last Sunday, died in that city on Friday evening. His condition had been critical from the first and on Thursday night pneumonia set in which soon caused his death. The funeral was held Sunday. He was one of the most widely known and highly esteemed citizens in Southwest Virginia.

Killed Near Graham.

Bluefield, Nov. 2.—Roy Johnston, member of a vaudeville company from Cincinnati, was knocked from a N. and W. passenger train near Graham, Va., late today, his body falling to the river. He was instantly killed.

He attempted to board the train after the Pullman doors were closed. He hung on to the hand-holds with his hat in his mouth and clung to the speeding train for ten miles unseen by any of the train crew or passengers. When a bridge was reached near Graham, his body struck the bridge with a terrible force, and he was knocked off. A small boy seeing the accident happen, dragged the lifeless body from the water.

Record Beef Cargo.

New York, Oct. 31.—The Lamport and Holt liner Voltaire, which has not been in this port in 10 months, arrived here yesterday with 35,000 quarters of Argentine beef, the largest consignment of chilled meat that has been brought to New York in one steamship. The record up to yesterday was 12,000 quarters, which came on the Vandyke some several months ago.

Twice as Many Men Paupers as Women.

Washington, D. C., Nov. 2.—Pauperism is decreasing in the United States, according to a census statement just issued.

The ratio of almshouse paupers to population has steadily declined at every census since 1880, the census bulletin declared.

One-third of the paupers in almshouses in 1910 were under fifty-five years of age, and one-third seventy or over.

The males outnumber the females two to one. Preponderance of paupers of foreign birth were also cited. The ratio of pauperism among negroes and whites is about equal, population considered. It was also declared that the almshouse is rapidly becoming merely a temporary shelter instead of a permanent home.

G. Waterhouse, Bishop E. E. Hoss and Dr. J. S. French, D. D., are to take prominent parts.

Europe's Daily War Bill is \$40,225,000.

Paris, Nov. 2.—The war bill which Europe is meeting daily is now figured as follows:

The French appropriation is from official figures as announced by M. Ribot, minister of finance; the English estimate by the London Statist; the German total from "an authoritative source," in a Geneva paper; and the other sums from various conservative estimates, which have appeared in one place or another. The item "various," represents the probable expense to which Serbia, Belgium and the neutral countries of Switzerland, Italy, Roumania, Turkey, Greece, Holland and Denmark have been put.

This vast total does not include the destruction of property where fighting is taking place nor the well-nigh incalculable losses to Europe of 20,000,000 under arms being taken from production. There are no indications in France that exhaustion has set in, but it is evident that the accumulated treasure of even the richest country on the continent is being poured out at a rate that adds \$100,000,000 a month on the national debt.

Washington, D. C., Oct. 31.—President Wilson on Thursday issued a proclamation designating Thursday, Nov. 26, as Thanksgiving Day.

Suit Against Water Company

Abingdon, Nov. 2.—Suit for \$25,000 against the local water company was brought last on Saturday. The suit is for damages growing out of the recent destructive fire which destroyed a part of the business section of the city. The water company is sought to be held on the ground that it was negligent in not having an adequate supply of water with which to combat the flames.

A Boy Shot to Death While Playing Pranks.

Hampton, Tenn., Nov. 2.—At 1 o'clock Sunday morning Charles Johnson, 16 years old, son of W. C. Johnson, was shot and instantly killed by Robert Teague, aged about 70.

Young Johnson was member of a party out playing Hallowe'en pranks, and while attempting to move some wood in front of the Teague home, the aged man came out on his porch and opened fire on the party with a shot gun, it is alleged. The entire load of shot entered the breast of young Johnson and he died instantly.

Teague, it is said, confessed the shooting and was arrested.

Friday evening the members of the Zetesian Literary society of Marion high school entertained at a Hallowe'en party in the attic of the schoolhouse in honor of the faculty. The large room was decorated with pumpkins, black cats, witches, etc., and dimly lighted. Hosts, hostesses and guests were masked and in costume, witches, old men, babies, colonial dames, hobos, and other characters being represented. The costume of Mr. Jennings Mitchell, who appeared as Mevhistopheles, was considered the most effective in all the motley array. Hallowe'en games were enjoyed until a late hour, and apples, doughnuts, chestnuts, sandwiches, stick candy and lemonade were served.

Thursday night there was a big excitement at Rural Retreat when Pepper Coffee invited some of his friends to an apple butter peeling so during the evening there was too much fire water drank and trouble began when Coffee got his shot gun to clean things up. In the trouble that followed, by trying to get the gun away from Coffee, his wife was shot in the leg. Friday morning the doctor had to amputate the leg. Two brothers, Raymond and Thomas Jackson, were arrested and at the trial from the testimonies given, they were held over and taken up to Wytheville and jailed.

37,000 Postmasters Named by Wilson.

Washington, D. C., Nov. 2.—A few more than thirty-seven thousand postmasters were appointed by the Wilson administration the time it came into power on March 4, 1913, and Saturday, October 24th, when Congress adjourned. This is about four times as many as were ever appointed by any former administration in the same length of time. The record is due to the executive order issued by President Wilson directing that all fourth class postmasters be placed under the civil service.

In the period between March 4, 1913 and October 24, 1913, 5,538 presidential postmasters were nominated. Of these the Senate confirmed 5,408 and left 55 unconfirmed, five of these being in Virginia. The "leftovers" will in all probability be given "recess appointments" by President Wilson, while Congress is in recess, has the power to appoint and place in office without securing the approval of the Senate.

In the same period 11,532 fourth class postmasters were appointed on the certification of the civil service commission; 19,982 on reports of postoffice inspectors and 204 by the department in cases of unmarried post-mistresses getting married and changing their names and other methods, bringing the total number of fourth class postmasters appointed up to 81,668, and the grand total up to 87,074.

The board of supervisors of Washington county has fixed the hunting season for one month in that county—Nov. 15 to Dec. 15.

Andrew J. Campbell, one of the discoverers of the Luray Caverns, was found dead at his place of employment in Luray one day last week, at the age of 76 years.

Mr. and Mrs. S. G. Parsons are off on an extended visit to Mrs. Parsons' mother and two sisters, Mrs. H. C. and Mrs. Levi Cole, at Chilhowie, and will extend their trip from that point to Ashland, W. Va., the home of Mrs. Parsons' brother, W. W. Greer.—Grayson Gazette.

Panama Canal Closed.

Washington, Nov. 2.—The Panama canal has been closed to navigation by another landslide. Colonel Goethals hopes to have it open again by Wednesday.

Colonel Goethals cabled the canal commission late today. "Rapid movement of slide material in the break north of Gold Hill locked the channel Saturday. Hope to open channel by Wednesday."

As understood at the canal office, this slide is only an aftermath of the big slide of October 14.

Burned to Death in Bluefield

Bluefield, W. Va., Nov. 2.—Frank Serber, a butcher by trade, who worked for a coal company, was burned to death in his room Saturday night. Serber and some friends had been drinking and he was put to bed late at night, his friends going to their respective apartments. Later an alarm of fire was sounded, the room occupied by Serber was all ablaze and it was impossible to rescue him.

Boy Killed by Traction Engine at Saltville.

Saltville, Va., Nov. 2.—William Price, the nine-year-old son of John Price, of this place, was almost instantly killed Friday evening about 5 o'clock. The boy, with some others were following a traction well-drilling outfit and were walking directly behind the traction wheels and between the machine and water wagon trailer. The machine had been driven up the steepest part of the hill and was on a gradual rise when a link in the traction chain broke allowing the outfit to run back down the hill catching the Price boy under one of the big wheels which passed diagonally across his body from shoulder to hip, killing him almost instantly. One or two other boys following the machine narrowly escaped a like fate.

The machine belonged to Harry Cole, of Chilhowie, and was being driven home by a man by the name of Warren.

William F. Quinn, a farmer, who lives about four miles below Saltville, was run over by the evening passenger train at Liberty Hill station about three miles from Saltville on the Glade Springs branch of the N. & W. about 6:40 o'clock last evening. His right foot was cut off at the ankle making amputation necessary about half way to the knee, his left foot was mashed and little toe cut off and right arm broken at the shoulder. He was removed to the offices of the company surgeons at Saltville by the train crew when amputation was performed and his wounds dressed by Drs. Early and McKee. Mr. O'Quinn supposing the train was going to stop at Liberty Hill left his seat in the coach and went to the platform of the car, and by some misunderstanding, the train slowed slightly and then started on, jerking him under the wheels.

Va., Mrs. R. G. Goolsby, Mrs. Ross Baylor, Mrs. Porter Ellis, Misses Ruth and Virginia Briscoe. The refreshments, which carried out the color scheme of yellow and black, were as follows: Fruit jelly in orange cups, sandwiches tied with black and yellow ribbons, chicken salad, yellow punch, hot turnovers, yellow ice cream in corn and pumpkin shapes, black and yellow cake. The decorations were elaborate, and consisted in yellow chrysanthemums, nasturtiums and autumn leaves. The party was arranged with view to the approach of Halloween, as indicated by the quaint witch which adorned the newel post in the reception hall, and the witch and pumpkin favors which were distributed among the winning players at the close of each game. The tally cards, painted with witches, pumpkins and black cats by Miss Schweikert, also carried out the Hallowe'en idea. The party in the afternoon was planned along the same lines as the one that was given in the morning.

What became of that 3500 majority in the paid up Poll Tax that Judge Hutton boasted of in his speech here last Saturday night? Two bad! Mr. Irvine and his friends lost their money on the poll tax and the election too.

The loss of that \$2312 by Mr. Irvine as filed in his statement made ten days before the election and we should guess a good sum added to that since that time to say nothing of poll tax expense, is not good news to the next democrat who will be forced to accept the nomination in the Ninth District.

The reduction from 156 democratic majority in Congress to 17 is good enough for one day. The Richmond Journal says the next House will contain 221 Democrats, 204 Republicans, 8 Progressives, 1 Socialist and 1 Prohibitionist and if the opposition should join, the Democrats would have the narrow margin of only seven.

The Roanoke Times and Lynchburg News continues to see bright prospects for the democrats in the 9th District. Sleep's majority in 1910 was 227, in 1912 was 1011 in 1914 is now 1318 and may reach 1400. The Times and News may see encouragement in these figures but democratic aspirants in the 9th District will fail to see much hope in these constantly increasing majorities.

Republicans Make Big Gains Throughout the Country.

New York, Nov. 4.—Sweeping Republican gains throughout the country, which reached a climax in this State by the overwhelming victory of Charles S. Whitman for Governor and James W. Wadsworth, to succeed Elihu Root in the United States Senate, were indicated Tuesday night in early returns of the elections.

Heavy falling off of the Progressive vote in many States, the return to Congress of former Speaker Joseph G. Cannon, decisive Republican gains in New York and Illinois in the House membership and the overwhelming defeat of Representative A. Mitchell Palmer, by Senator Boise Penrose, in Pennsylvania, were features of the early returns.

REPUBLICAN WINS WILSON'S DISTRICT.

Trenton, N. J., Nov. 4.—President Wilson's home congressional district, the Fourth of New Jersey, elected Elijah C. Hutchinson, Republican, to succeed Congressman Allan B. Walsh, Democratic, by about 2,000 plurality.

Meager returns indicate strong Republican gains throughout the state.

REPUBLICAN WINS IN N. C.

Asheville, N. C., Nov. 3.—Incomplete returns from the Tenth congressional district show that J. J. Britt, the Republican Progressive nominee for Congress, has defeated J. M. Gudger, Jr., the present Democrat Congressman. The majority is estimated to be from 700 to 1,000.

In the 8th the Democrats claim R. L. Doughton is elected, the Republicans making the same claims for E. A. Llaney.

Danville, Ind., Nov. 3.—Indications are that former Speaker Cannon has carried the eighteenth district by 3,583 over Frank O'Hair, Democratic incumbent.

"SOLID SOUTH" BROKEN

New Orleans, Nov. 3.—Indications at midnight were that the "solid south" had been broken by the election of W. P. Martin, Progressive candidate for Congress from the

Third Louisiana district. At Progressive headquarters victory was claimed by 1,500

BACK IN REPUBLICAN FOLD

New Haven, Conn., Nov. 3.—Connecticut returned to the Republican fold today. Frank B. Brundage was re-elected United States Senator over Governor Simon E. Baldwin by a safe majority. With the vote nearly all counted indications pointed to election of a solid Republican Congressional delegation.

The Progressives with nearly 35,000 votes last year, polled only a trifle more than five thousand today.

"UNCLE JOE" TALKS

Danville, Ill., Nov. 3.—Former Speaker Joseph G. Cannon tonight made the following statement:

"The returns from the election just closed show the intent of the people of the United States to return the Republicans to control and in 1916 the voters will have a Republican House and Senate and a Republican President. The people have shown their desire to return the Republican policies and Republican prosperity."

RYE IN TENNESSEE.

Knoxville, Tenn., Nov. 3.—For Governor: Returns from forty-seven counties give Rye Democratic a lead over Governor Hooper, Fusion, of 8,000.

A funeral service was conducted from the home of his son Del, with whom he had been living, at 2:30 p. m. on Saturday, being conducted by Revs. E. M. Harris and J. A. Early, after which his body was conveyed to Round Hill cemetery and laid to rest.




