Colored Readjuster Speakers in Smyth.

On last Thursday night, Stuart Lewis and J. Webster, colored Readjusters from Montgomery county, Va., addressed the colored voters of Smyth in the court house at this place. This don't suit Colonel Fulkerson, he harps at it and opposes it, and draws the conclusion that the Readjusters who passed this resolution are all Republicans, or 'intend to follow Malone into the Republican party'—a very lame and impotent conclusion. The Colonels 'Democracy' would allow him to commend the friendly acts and purposes of the present administration, towards Va., and the other Southern States. The Readjusters differ with him a thousand to one, and so this issue is made up squarely and fairly. The Colonel expects the aid and votes of the Democrats for this no doubt.
