

THEY WONT BE DECEIVED!

The coming fall the people of the Ninth Congressional district will be called upon to elect a member of Congress to succeed the Hon. C. F. Trigg, who is the present Representative from this district. At the last Congressional election the Democracy were able to delude our people into the belief that their party was not a free trade party, it was opposed to the Internal Revenue system and would abolish that iniquity as soon as the power was accorded it, that it was the friend of the Blair Educational Bill &c. We told the people in 1884, that such representations and professions of the Democracy were insincere and that the party would never make them good. The record of the Democratic party since 1884 has borne us out in our predictions. The party has had the power and failed to exercise it in behalf of the interests and wishes of the people or in discharge of the solemn pledges made with regard to the tariff, the Internal Revenue and the Educational question. The free trade Democrats in Congress, who are largely in the majority, and who are backed by President Cleveland, have lost no opportunity to make assaults upon the "protective" system; and "free trade" has only been averted by the solid front presented by a small minority of Democrats, headed by Samuel J. Bland.

I passed several hours at Mount BeGregor today. The Drexel cottage remains almost literally as when Gen. Grant died. There are the bed upon which the illustrious commander breathed his last; his favorite chair, his garments including dressing gown, slipper and hats, and even his medicines, cups and sponge with which he was wont to moisten his lips. You are shown pens with which he wrote the latter portion of his book, and quantities of paper, cut in small sizes, by which he was wont to compose his conversation. A number of the beautiful flower pieces wrought in immortelles, sent by the friends of the general, including the huge pillow from the Philadelphia Post, are also on view. All the relics are looked upon by the visitors in solemn silence. Some of them might with propriety be removed—notably the medicines and vessels. Outside the cottage all looks calm and beautiful.

But the Democrats are going to try to deceive the people of the Ninth District once more. They hope to win by running a man on a Republican platform. This purpose is indicated by resolutions that are being passed in the county meetings that are being held to select delegates to the Congressional Convention which meets at Wytheville on the 4th of August. In the meeting held at Wytheville on last Monday resolutions were passed in favor of a protective tariff, for the abolition of the Internal Revenue and advocating the passage of the Blair Educational Bill. These are things to which the Republican party stands pledged and things that will be carried out when the Republican party gains control again. They are the things that the Democratic party is bitterly opposed to as indicated by that party through its representatives in Congress. When the Democratic Congressional Convention meets at Wytheville, on the 4th of August, it will, no doubt adopt resolutions similar to those adopted by the Wythe county Democrats on last Monday. Will the people of the Ninth district be deceived by such chaff? Ask these gentlemen when they tell you that they are for a protective tariff, for abolishing the Internal Revenue, and for passing the Blair Bill, why they adhere to the Democratic National party that opposes these things and denounce a party (the Republican) that is friendly to them! The game can't be success fully played any longer. The enemy

can't win victories under false colors. The people are beginning to realize that a party can't be very bad that is the true advocate of sound principles and that a party can't be very good that is afraid to come before the people on a platform that speaks squarely out on leading National questions.

Snakes in Queer Places.

A chicken snake, killed in a Florida hen house, was found to contain a China nest egg.

At last he was compelled to stop, as his feet seemed to be tangled up with vines. He struck a light and found that his legs were covered with rattlesnakes, which had struck him and become fastened by their fangs to the gum boots he wore. He killed ninety-three snakes and several got away.

Where Grant Died.

A Washington dispatch to the Boston Herald says: Boyd Winchester, the consul general of the United States to Switzerland, has just completed some exhaustive researches in that country. He has made certain discoveries that the cheese makers of this country will be slow to believe. He claims to have seen cheeses that are more than two hundred years old. One of the customs that formerly prevailed in the cheese regions of that country, Mr. Winchester, says was for the friends of the bride and bridegroom to join in the presentation on their wedding day of an elaborate cheese. This cheese was used as a family register and heirloom, on which the births, marriages and deaths are recorded. He says that he has seen some of these "old cheeses" that date back to 1660. Our town was visited by a number of drummers this week.

Communion services are to be held in the Presbyterian church here on next Sunday morning.

Miss Laura Dickey, who has been visiting relatives and friends in this place, left for her home in Grayson last week.

Miss Eva Bowe, of Richmond, is visiting relatives in this place, and is stopping with Mrs. John R. Venable.

We are glad to know that the workmen are now at work on the addition to our depot and that soon we will have a comfortable place for people to be in when waiting for the arrival of trains.

Died near Marion on Tuesday evening last, Mr. Rufus M. Copenhaver, aged about 41 years, leaving a wife and several children. Mr. Copenhaver was a member of the Lutheran Church, a good christian, and an excellent citizen.

An old man, apparently about 68 years of age, passed through town pulling a little cart laden with bed clothing and cooking utensils, etc., followed by two or three women and several children and a number of different sized dogs, all seemingly perfectly happy.

A difficulty took place on the asylum building yesterday between a helper by the name of Corvyn and a brick layer named Wall, a deaf and dumb man, in which Wall was struck on the head with a brick-bat and seriously hurt, but is not considered to be dangerous.

Persons who have a superstitious dread of Friday will be pleased to learn that this is a thoroughly Friday year. It came in on a Friday, and will have fifty-three Fridays. There are four months in the year that have five Fridays each; changes of the moon occur five times on a Friday, and the longest and shortest days are Fridays.

On last Sunday evening Mrs. G. S. Smith died at her home in this place. She had been in very feeble health since about the first of November last, and as time rolled on her affliction became worse until her death. Mrs. Smith was an excellent christian lady, and was beloved and respected by all who knew her. She leaves a kind and affectionate husband and several grand children, all of whom have families. On Monday funeral memorial services were held at the Presbyterian church, conducted by her pastor, Rev. W. M. McVeaters, assisted by Rev. W. H. Leith, after which her remains were followed to Roundhill Cemetery by a large concourse of friends and relatives, where she was buried in a section belonging to the family. Many besides her relatives will miss her in life, particularly the poor, whose friend she always was.

On yesterday morning a young man was found dead by the side of the railroad, a short distance west of the depot at this place. A jury of inquest was impounded and from the evidence before it, it was believed that the young man was standing on top of a train which passed this place about 11:35 p. m., and his head struck against an overhead bridge and broke his skull. He was carried on top of the cars about 100 yards east of the bridge where the fell off and was found. From letters found in his pockets his name was ascertained to be E. L. Ballou, and his home in Wytheville, Va., his age is about 19 years. His sister at that place was telegraphed to, and her husband, Mr. Wm. DeVlaming, came on the local freight, and last night had the body taken to Wytheville for interment.

Clipped From our Exchanges.

To Let the People Know What is Going on in the Southwest.

CROPS IN THE SOUTHWEST.

GRAYSON.

Farmers have just commenced harvesting their wheat, and it is hardly known what the yield will be, but from the best information I can gain I think it will be something near an average yield, unless it should be lost by the continued rains, which have already injured it considerably.

The promise for the oat and hay crop is very encouraging, and if they can be properly taken care of will no doubt be largely in excess of an average crop.

Owing to the rains the corn crop has not been properly worked, but is looking better than could be expected under the circumstances.

No damage to mill dams or other property by rains, so far as I have heard.

SMYTH.

I have seen most farmers from the different parts of the county within a few days. They report the wheat crop generally in shock; the quality inferior, the yield below an average, and it is being further damaged from continued rain by moulding and sprouting.

The promise of the oats is good and if fair weather sets in soon a full crop is expected.

The continued rains have prevented the proper cultivation of the corn crop. Some farmers talk about a half crop compared with last year.

The grass crop is being damaged for hay. Clover is almost an entire loss for hay. The area of crops is above the average.

WYTHE.

The wheat crop is large and is not much damaged as yet.

Hay crop very large though but little has been cut.

Corn is small, weedy, and irregular.

Oats are the best in thirty years. We have had terrible storms of rain and hail in localities, but no great damage has been done. Generally the roads are washed out, but no dams are destroyed.

Cattle are fat and heavy.

WASHINGTON.

The wheat crop promised to be an average one for this section until the rains commenced, but the continuous rains for the last month have damaged it very much. It is all cut and standing in the field in the shock, and a great deal of it moulding and sprouting. Up to the time one third would be a fair estimate of the damage to it by the rains.

The hay crop is an average one, but not as good as last year. It also is being damaged by the continuous heavy rains. In the lowlands where the grass is heaven it has fallen down, and on upland meadow the growth of the weed is heavy. The crops will be very seriously damaged soon, unless there is a cessation of rain.

The oat crop is very promising: It is now beginning to ripen, and will be very good unless damaged hereafter.

The prospect for the corn crop is not good. Owing to the continuous rains the farmers have not worked their corn. The prospect now is for about half the average crop.

The North, Middle and South forks of the Holston have been rapidly out of banks for the last month, but not high enough at any time to kamage mill dams, bridges, or fences. I have not heard of any bridges being washed away except at Goodwin Burton. On last Saturday considerable damage was done by a heavy rain; two bridges were washed away and other prospects damaged.—In Rich. Dis.

There is no reason why we should not have as good a school right here in Lebanon as there is in the Southwest. A majority of our people—those who know the advantages of a good home school—are working for the school in earnest, while some do not seem to be interested as much as they should be. It will cost much less to repair the school houses and build up a good school here at home, than it will cost to send your sons and daughters outside of the county or state to be educated.

Wytheville Enterprise.

Mr. Robert Gibboney, of Winston, N. C., is in Wytheville on a visit.

Major Obenchain, of Kentucky, arrived Tuesday a. m., and is visiting his parents on church street.

The late Judge John Campbell, of Abingdon, had a five thousand dollar life insurance policy on his life. The policy was paid over to Mrs. C., a few days since.

Last Friday afternoon John Smith and George Shelton, two hands employed at a saw-mill in Crockett's Cove, about six miles north of town, got into a dispute about the performance of their duties, ending by John Smith cursing and vilifying Shelton, and the latter resenting the imputations by the free use of rocks at the former. As soon as Shelton commenced the attack by throwing rocks, Smith drew a pistol and returned it, running Shelton off of the mill grounds, out into the public road. Smith fired at Shelton three times—but with effect—twice while he was near the mill and once after he had gotten out into the road. Temperance Column.

The good that results to the individual and to society from the temperate living of a single individual cannot be estimated by the finite mind of any man. In as much as the influence of the gentle rains upon the crops and vegetation in general cannot be measured by the quart, and wherever the power of the warm rays of a summer's sun cannot be estimated by the yard, so the man of temperate habits and of religious living gives that cast to the community where he lives that no mathematical calculation can reach. Hence, the importance of a consistent life, and not that wishy-washy-namby-pamby way of living that seems to characterize the lives of some men. If a man joins an Order for his own good and that of his fellowman, he should try to get grit and grace enough to stick to it and to hazard even some so-called comforts to enable him to do so. No man ought to live unto himself, or to die unto himself. The Bible says that he cannot do so, and we admit that to be true. Now, the Order of Good Templary is a noble institution—it looks well to the habits of men—it instills noble sentiments into the minds of the young—it is educational as well as reformatory. It is the duty of all members of the Order to persuade men and women to engage in the work for the sake of example, if for nothing else. Whenever we can show the young that we are working for their immediate good, and eternal salvation, our labors will not be in vain. This is the experience and observation of all workers along this line of usefulness. We have written these views to stimulate some of our members who seem to be indifferent to everything else except their own personal good, if such a course can be said to produce anything beyond a present gratification.

The use of beer is found to produce a species of degeneration of all the organs. Intellectually, a stupor amounting to almost paralysis, arrests the reason, changing all the higher faculties into a mere animalism, sensual, selfish, sluggish, varied only with paroxysms of anger that are senseless and brutal. In appearance the beer drinker may be the picture of health, but in reality he is most incapable of resisting disease. Compared with inebriates who use different kinds of alcohol, he is more incurable, and more generally diseased. It is our observation that beer drinking in this country produces the very lowest kind of inebriety, close allied to criminal insanity. The most dangerous kind of ruffians in our large cities are beer-drinkers. Recourse to beer as a substitute for other forms of alcohol merely increases the danger and fatality.—Scientific American.

THEY WONT BE DECEIVED?

The coming fall the people of the Ninth Congressional district will be called upon to elect a member of Congress to succeed the Hon. C. F. Trigg, who is the present Representative from this district. At the last Congressional election the Democracy were able to include our people into the belief that their party was friendly to certain things that were very dear to the masses. For instance they deluded them into the belief that the Democratic party was not a free trade party, it was opposed to the Internal Revenue system and would abolish that iniquity as soon as the power was accorded it, that it was the friend of the Blair Educational Bill &c. We told the people in 1884, that such representations and professions of the Democracy were insincere and that the party would never make them good. The record of the Democratic party since 1884 has borne us out in our predictions. The party has had the power and failed to exercise it in behalf of the interests and wishes of the people or in discharge of the solemn pledges made with regard to the tariff, the Internal Revenue and the Educational question. The free trade Democrats in Congress, who are largely in the majority, and who are backed by President Cleveland, have lost no opportunity to make assaults upon the "protective" system; and "free trade" has only been averted by the solid front presented by a small minority of Democrats, headed by Samuel J. Baudell. Under a Democratic administration the Internal Revenue has been made more oppressive than it was in the days of extreme Radicalism, Revenue spies, Democrats appointed to pay them for their partisan work, infest every neighborhood in our district, poor men are dragged to Abingdon from their distant mountain homes upon the most frivolous charges thereby swelling the fees of the Deputy Marshalls. The Democratic party has found the Internal Revenue department furnishes a vast number of places to the hungry workers and office seekers in its ranks, so its pledges to the people are disregarded in its desire to give places to the office hunters. The Democratic party has been equally as insincere and faithless on the Educational question. It can no longer deny that it is the enemy of the Blair Bill. The Democratic party by its representatives in Congress have killed the beneficent measure that proposed to donate from the Federal treasury, to be distributed among the States upon the basis of illiteracy, the vast sum of Seventy-seven millions of dollars to aid the cause of popular education. Who will deny that Democratic Houses of Representatives have three times failed or refused to pass the Blair Bill, after it had been passed by a Republican Senate.

But the Democrats are going to try to deceive the people of the Ninth District once more. They hope to win by running a man on a Republican platform. This purpose is indicated by resolutions that are being passed in the county meetings that are being held to select delegates to the Congressional Convention which meets at Wytheville on the 4th of August. In the meeting held at Wytheville on last Monday resolutions were passed in favor of a protective tariff, for the abolition of the Internal Revenue and advocating the passage of the Blair Educational Bill. These are things to which the Republican party stands pledged and things that will be carried out when the Republican party gains control again. They are the things that the Democratic party is bitterly opposed to as indicated by that party through its representatives in Congress. When the Democratic Congressional Convention meets at Wytheville, on the 4th of August, it will, no doubt adopt resolutions similar to those adopted by the Wythe county Democrats on last Monday. Will the people of the Ninth district be deceived by such chaff? Ask these gentlemen when they tell you that they are for a protective tariff, for abolishing the Internal Revenue, and for passing the Blair Bill, why they adhere to the the National party that opposes these things and denounce a party (the Republican) that is friendly to them? The game can't be successfully played any longer. The enemy

can't win victories under false colors. The people are beginning to realize that a party can't be very bad that is the true advocate of sound principles and that a party can't be very good that is afraid to come before the people on a platform that speaks squarely out on leading National questions.

Snakes in Queer Places.
A chicken snake, killed in a Florida hen house, was found to contain a China nest egg.
Five snakes were killed in the top of a palmetto tree at Crescent City, Fla.
A citizen of Miller, Ga., found a couch whip snake under the head of his bed. He killed it.
C. O. West, of Butler, Ga., went fishing and wore an old vest. On returning he hung his wife was feeling in the pockets for a match when a rattlesnake two feet long dropped from the torn lining. It must have got there the day he went fishing.
Two boys living near St. Joseph, Mo., saw a large bulsnake in the act of swallowing a rabbit. One of the boys struck the snake with a hoe, whereupon a second rabbit popped out of the reptile's mouth and sat up looking bewildered. The snake was killed. It measured several feet in length.
Thomas Hightown, of Clark's Summit, Va., went con hunting one night. After walking some distance he felt his limbs becoming very heavy. At last he was compelled to stop, as his feet seemed to be tangled up with vines. He struck a light and found that his legs were covered with rattlesnakes, which had struck him and become fastened by their fangs to the gum boots he wore. He killed ninety-three snakes and several got away.

Where Grant Died.
I passed several hours at Mount McGregor today. The Drexel cottage remains almost literally as when Gen. Grant died. There are the bed upon which the illustrious commander breathed his last; his favorite chair, his garments including dressing gown, slipper and hat, and even his medicines, cups and sponge with which he was wont to moisten his lips. You are shown pens with which he wrote the latter portion of his book, and quantities of paper, cut in small sizes, by which he was wont to correct his conversation. A number of the beautiful flower pieces wrought in immortelles, sent by the friends of the general, including the huge pillow from the Philadelphia Post, are also on view. All the relics are looked upon by the visitors in solemn silence. Some of them might with propriety be removed—notably the medicines and vessels. Outside the cottage all looks calm and beautiful.

Cheese Two Centuries Old.
A Washington dispatch to the Boston Herald says:
Boyd Winchester, the consul general of the United States to Switzerland, has just completed some exhaustive researches in that country. He has made certain discoveries that the cheese makers of this country will be slow to believe. He claims to have seen cheeses that are more than two hundred years old. One of the customs that formerly prevailed in the cheese regions of that country, Mr. Winchester, says was for the friends of the bride and bridegroom to join in the presentation on their wedding day of an elaborate cheese. This cheese was used as a family register and heirloom, on which the births, marriages and deaths are recorded. He says that he has seen some of these "old cheeses" that date back to 1600. In many parts of Switzerland cheese forms the principal diet of the people. He says that new cheese often causes sickness. When this is the case the patient is treated in the homeopathic fashion with old cheese, which generally effects a cure.
