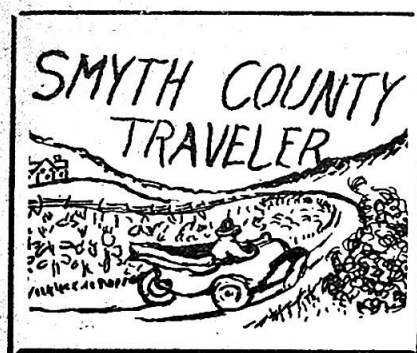

Down Here We Hunt 'em

News dispatches from Richmond a week or two ago told of the puzzlement of Gov. Pollard, who received from the city of San Francisco a gift of two buffaloes.

The Governor didn't know what to do with them.

The game department's records, the news dispatch said, showed not a single buffalo in Virginia now.

Doubtless the Governor knows by now what to do with his two large and shaggy pets. Smyth county citizens—and most notably E. K. Coyner, who started here several years ago the only buffalo herd in Virginia—have informed Governor that there not only are buffaloes in Virginia, but they are in addition ranging in a semi-wild state on the slopes of White Top, where they were taken at the invitation of John Blakemore and the White Top Company after having been raised in the Smyth County Fair Grounds.

The matter of transferring the herd, then consisting of four, caused the death of the old bull when about twenty men, with ropes, tried to rattle him down. After the big buffalo hunt there was buffalo steak on many Marion tables.

Doc and Dad held their lights on the fox's eyes, blinding him. J. W. slipped up behind him and got his hand on the back of the animal's neck. Then it crouched and croaked out from under his hand before he could clamp and lift.

The fox trotted over the bank and the hunters went on.

A few minutes later Jack Reedy, following in another car, found it in the road at the same place. He first thought that one of the hounds had come in and hopped out to pick it up. When he grabbed he found himself grabbing at a fox—which again trotted over the bank.

Women's Club Highway Beautification Proposal Endorsed By Civic Clubs

A proposal that Smyth county make application for part of the federal funds to be used in Virginia for landscaping along highways was made this week by The Woman's Club and heartily endorsed by Kiwanis and Rotary.

Of the seven million dollars federal road funds to be expended by the state highway commission in Virginia, a part must, by federal provision, be used for landscaping along highways.

The move to get some of this money for Smyth county was launched by The Woman's Club with Mrs. W. H. Carter, president, leading.

On Tuesday night the Rev. Carter presented the proposal to the Kiwanis and Rotary Clubs and they enthusiastically endorsed it. In both clubs it was the unanimous suggestion that the money be asked to apply along the B. F. Buchanan Memorial highway from Marion to the new Forest Lake State Park, creating a park appearance from the town limits to the park proper.

The Kiwanis Club appointed John D. Lincoln, Marvin Copenhaver and L. Preston Collins as a committee to pursue the matter. Rotary named E. K. Coyner, Dr. Willis Sprinkle and R. Crook Gwyn.

A meeting on the project was held on Wednesday afternoon with representatives of The Woman's Club. Application for the funds must be made to the state highway commission. At the meeting there was some doubt expressed as to whether the funds should be asked for the B. F. Buchanan Highway or for the Lee Highway. All seemed to prefer the B. F. Buchanan highway idea but were a little doubtful of the chances of getting it before appropriations are made to relocate and rebuild the road.

John D. Stirs Up Kiwanis

John D. Lincoln stirred up the Marion Kiwanis Club at its weekly meeting last night with a list of three projects for Marion.

They were a real paved main street; the new postoffice; the B. F. Buchanan Memorial Highway to Forest Lake State Park.

The club agreed enthusiastically to get to work and President Bill Slater appointed a committee consisting of John D., Col. Jim Tate, L. P. Collins and Robert Lane Anderson.

Ralph Repass presented Walt Huffaker as his guest of the evening. "Harmonica Mike" Sullivan, a wandering minstrel who said Marion's was the 679th Kiwanis Club he had broken bread with, gave 15 minutes of Harmonious harmonicaing.

There was some more discussion of the progress of negotiations for settlement of rights of way along Lee highway just east of Marion which will make rebuilding the road possible. The matter was continued in the hands of Jim Shanklin.

John D., in his talk, said that army engineers, here a few days ago, had approved camp sites at Forest Lake and that three camps, probably from the far west, would probably arrive within a couple of weeks. He said there is a probability the camps will be down to skeleton organization of 50 men each which would mean that they would take on some 450 men to be drawn from Smyth and nearby counties in Southwest Virginia.

VIRGINIA VOTES ON REPEAL NEXT TUESDAY

On next Tuesday, Oct. 3rd, Virginia goes to the polls to vote on ratification or non-ratification of the 21st amendment (the amendment which repeals the 18th amendment) and with all indications pointing that the commonwealth will on that date become the 32nd state to go for repeal.

Surveys of the state, conducted by observers for centrally located daily papers, indicate votes of from 3 to 1 to 2 to 1 against prohibition in the cities and lesser wet majorities in every county with the exception of one or two in the far southwest—possibly Scott and Lee.

Local observers are pretty generally of the opinion that Smyth county will be found for repeal when the votes are counted. "Of course I'm going to vote for repeal. I'm sick of seeing the bootleggers get it all—" is what the man in the street is steadily saying.

Drys in Smyth County have appointed a committee to get out the vote for prohibition and will make the best fight they can—but they are encountering a good deal of difficulty in their precinct work because it is so very difficult just now to tell who is really dry.

Opponents of prohibition will make no organized effort to get out the repeal vote but will instead depend on the general reaction against continuation of national prohibition.

All persons should remember to vote next Tuesday.

Both wets and drys want to see the biggest possible turnout out of voters in the state. After the election is over—if the vote comes out strong—there at least won't be any "if we had only got out our vote" talk from which ever side loses.

All voters should bear in mind that they will cast two ballots. The first, the long one, is purely on the question of repeal of national prohibition. It is so worded that the voter who wants repeal must vote for ratification of the 21st amendment by scratching out the line which reads "Against Ratification (Against repeal)." Drys will do the opposite. The second ballot gives the voter a chance to express his choice between a continuation of state prohibition or a plan of liquor control which includes local option for the counties and towns.

How ballots can be marked is clearly illustrated in a repeal advertisement which will be found on page five of this paper.

The list of judges of the special election next Tuesday is also announced in this paper.

In the meantime, until election day, all voters who want a clearly marked sample ballot showing how to vote either wet or dry on both national and state prohibition can have the same free by calling at the Print Shop which has a "sample" ballot which is a bit complicated.

Horse And Hound Show Hits The Mark

The first annual Horse and Hound show of the Southwest Virginia Fox Hunters Association was held Saturday at the Smyth County Fair Grounds here in Marion and proved a great success.

All morning, and into the afternoon, something like 147 of the best hounds in Virginia, West Virginia, Tennessee and North Carolina competed for handsome silver trophies and second and third place ribbons in the fifteen hound classes shown in the ring before the grand stand.

The hounds were judged by Mr. Samuel L. Woodridge of Versailles, Ky., a noted hound breeder and editor of the magazine "The Class." Mr. W. R. Dudley of Toms Creek, Virginia, was ring master and J. W. Williams, secretary of the association, and Frank DeBord were ring secretaries.

The program was opened by Mr. Williams, who read the bench standard for fox hounds and other information pertinent. Then Dr. George Wright of Marion, president of the association, introduced Judge Woodridge.

In addition to the 147 competing dogs there were about the same number on exhibition which were not shown in ring classes.

Leading all these in interest among fox hunting men was Champion American Flag, a two year old Walker, who last year won the National Bench Championship. The dog is owned by Mr. J. E. Spencer of Kingsport, Tenn., who made a fine and gracious gesture when he brought his dog just to help out with the show although the dog, by reason of his previous winnings, was not eligible to compete. The complete last year's winning record of this outstanding dog is: Harrods-show; Iroquois Hound Show—best hound in show; Kentucky State Fair—best of opposite sex; Kentucky State Championship; National Bench Championship.

Dr. Harry M. Hayter of Abingdon, last as last year when the event was purely a hound show and was held at Lake Forest, led all winners his dogs bringing him seven

Specialty competition in every class. Dr. Hayter's dogs topped off a sweet day for him when his "Little Nell" out of "Firt" and by "King Blanton," took the sweepstakes and his "Riley," same breeding, took the cup for best of opposite sex.

Smyth counties who took cups or ribbons with their dogs were Dr. Wright, Mr. Charles DeBusk of Saltville and Mr. J. Fount Rector of Seven Mile Ford.

In addition, when about 40 hounds ran a drag race of several miles over the hills adjoining the fair grounds after the horse show, Mr. Rector's "Fly" was the first across the finish line, bringing him the \$10 first prize money. Second prize money of \$5 was won by "Polly," entry of O. C. Corvin of Wytheville.

It was an exciting race. There were several more hounds with chances of winning but these failed to follow the trail during the last few yards through a hole in the fence into the fair grounds.

After the hound show, the horsemen and their steeds put on a nine event show which went off rapidly and brought out classes which, though small, had plenty of class and revealed some of the best horses ever seen on the local grounds.

Both jumping classes were especially good, with Honey Girl, owned by G. Y. Booker of Abingdon taking first over Frisco Earl in the green hunters class and placing second behind the same horse in the high jumping. Frisco Earl is owned by G. B. Crockett and was ridden by Mrs. R. R. Madron.

Count Pulaski, the fine five-gaited horse owned and ridden by Fred Cole, former Smyth county boy who is now in business in Pulaski, took the five-gaited class and Flaming Rex, one of the splendid mounts brought by Mr. E. S. Penn of North Carolina, took the three-gaited class. Mr. Phil Delp, another North Carolinian, took the gentlemen's riding contest, and Miss Jane Madron of Tazewell took the ladies riding. Nancy, owned by W. B. Gillespie of Tazewell, was first in the class for plantation horses and Rex and Bonny, both owned by Keller Brothers, took the pony class.

In a lull between classes, horse

Gives A Mountain To Virginia

Richmond, Va., Sept. 23—The princely gift of a 4,500 acre tract of timber covered mountain land in Patrick county has been made to the state by Junius B. Fishburn, Roanoke capitalist and publisher. The tract will be converted into the fifth in a chain of parks reaching from Southwest Virginia to the sea. The donor presented the park to the state in fee simple, including mineral and all other rights.

The new area is located 14 miles from Bassett, 19 miles from Martinsville and eight miles from Stuart. The body of the mountain is covered with hardwood timber and stands approximately 1,500 feet above sea level, with peaks reaching 2,500 feet. Three C. C. C. camps are expected to be put in the area very shortly, each camp to be composed of 200 men.

Prospective plans provide for a dam on Goldmang Creek in which will be impounded from 500 to 1,000 acres of water, thus forming a lake suitable alike for fishing, boating and swimming. Along the lake shore a 10-mile drive is contemplated, as well as the erection of 100 cottages of the log cabin type. The park will likewise include 40-miles of bridge paths, 20-miles of foot paths, together with a nature guide service and other features. It will lie on the main highway connecting the park near Marion and the seashore park at Cape Henry.

The gift from Mr. Fishburn should prove especially acceptable at this time, providing, as it does, not alone a picturesque and valuable addition to the park system in the state, but also large employment to labor during this era of depression. It is indeed, a munificent donation.

The state commission on conservation and development, which made announcement of the gift, also states that the 2,500 acre tract near Marion, recently presented to the Commonwealth by J. D. Lincoln and C. C. Lincoln, the town of Marion and the county for park purposes, is to be enlarged to 8,000 acres. All of the five parks so far arranged for by the state will be developed under direction of R. T. Burson, associate director of parks for the commission.

Print Shop the other day with an interesting pair of old documents he found among some old family papers.

The first document is a license granted by the collector of the 2nd collection district of Virginia, bureau of Internal Revenue, at Harrisonburg, Samuel R. Sterling, collector, dated February 1st, 1866. It reads as follows:

To All Whom It May Concern: This License is granted to Solomon Crow, in the county of Smyth and State of Virginia, to carry on the business or occupation of Distiller, having paid the tax of Seven and No 100 dollars therefor, conforming to provisions of an act entitled "An Act to provide Internal Revenue to support the Government, pay interest on the public debt, and for other purposes," approved June 30, 1864, and the amendments thereto. This License shall be in force until the first day of May, 1866.

The other document found by Mr. Moxley is a receipt from the United States Internal Revenue office issued to Mr. Crow on Feb. 26, 1866 for "twenty-seven dollars, being the amount of tax assessed on eighteen gallon of apple brandy."

Those documents were issued sixty-seven years ago and are in good condition, almost as good condition as the hundreds of beer licenses which have this past month been issued in Virginia and some twenty other states in the union.

Dental Survey To Cover State School System

(By Carter Wormeley)

Richmond, Va., September 23—State-wide surveys of the condition of children's teeth in Virginia, Maryland and North Carolina were planned at a tri-state meeting in Washington on Friday, September 15, and are expected to result in detailed examination of the teeth of children from kindergarten through the seventh grade.

Directors of mouth hygiene of the state health departments of the three states met at the request of the American Dental Association and the U. S. Public Health Service. Dr. T. C. Messner, Dental Surgeon of the U. S. Public Health Service and Chairman of the committee for the survey of the dental association, presided at the Washington conference. Campaigns were organized to enlist who, assisted by county clinicians, will conduct detailed examination of the teeth of the children. The information which the surveys will furnish has been requested by the American Dental Association of all states.

"Our goal in Virginia," said Dr. N. T. Balloy, Director of the Virginia Bureau of Mouth Hygiene, "is a complete survey of 100,000 children."

In order to reach this goal, health authorities seek the cooperation of parents, teachers, dentists and all organizations concerned with public welfare.

Beginning this month, a series of dental clinics will be conducted in the public schools throughout the entire State and the information thus gained will lay the foundation for what is expected to be the most extensive program of dental corrections ever carried out in Virginia.

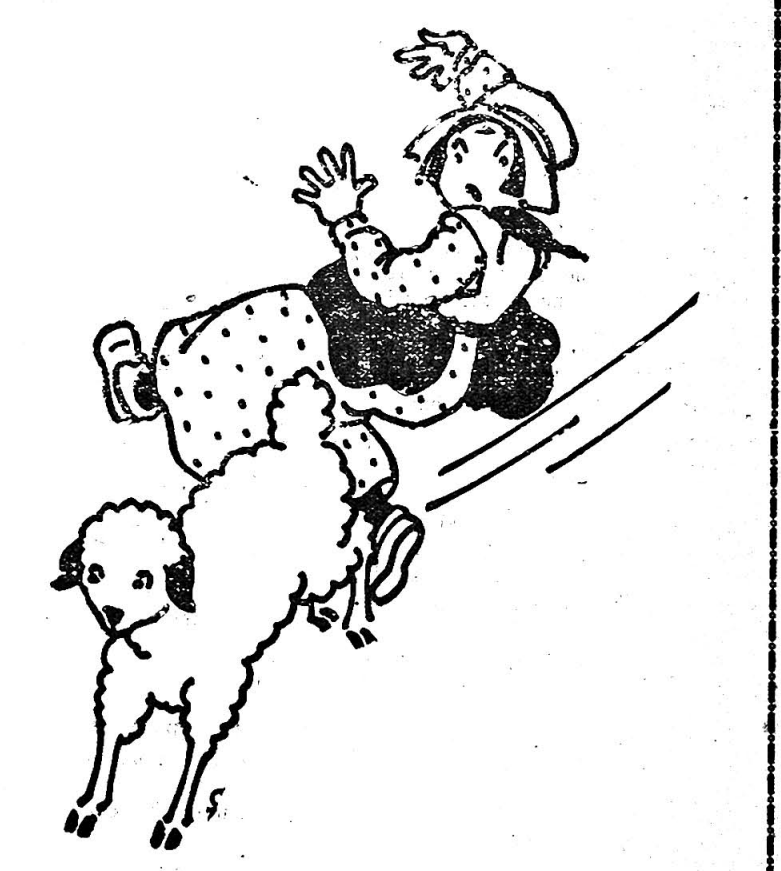

**Union Study Week
Planned**

Under the direction of a committee composed of representatives of the women's missionary societies of each of the local churches and the pastors, plans are now being formulated for a week of intensive study of church extension work. A week of this kind will, it is believed, be very helpful and inspiring, and will result in giving all the churches a broader vision and a large inspiration.

Tentative plans provide for this study to be held the week of October 29, November 3. Starting with an inspirational service to be held in the Presbyterian church Sunday evening, October 29th, at 7:30 p. m., the classes will meet each night at that hour, with the study closing promptly at 8:15. The meeting places and the details, according to the tentative plans, are as follows:

Monday—Baptist church. Devotional service led by a representative of the Methodist church.

Tuesday—Episcopal church. Devotional in charge of the Lutheran church.

Wednesday—Methodist church. Devotional led by a representative of the Presbyterian church.

Thursday—Lutheran church. Devotional under direction of the Baptist church.

Friday—Presbyterian church. Devotional led by a representative of the Episcopal church.

The committee requested the pastor and the president of the woman's missionary society of each church to serve as a committee to provide a teacher for each class and a leader for the devotional service each evening, and the pastors are to take turns in summing up the work at the close of each evening's study. The program for this brief summary is as follows: Monday, Rev. H. J. Rhyne; Tuesday, Rev. G. A. Wilson; Wednesday, Rev. W. H. Carter; Thursday, a representative of the Episcopal church; Friday, Rev. E. A. Shugart.

The book to be used in this study is "The Never-failing Light," by Dr. James H. Franklin, Corresponding Secretary of the American Baptist Foreign Missionary Society. It is a book of absorbing interest, and will be a source of much inspiration and information to all who take part in the study. There will be five classes each night, one being especially for the young people.

**Local Men To Have Char-
ces In Tennessee Valley
Development**

Last Tuesday the Tennessee Valley Development became a reality to the citizens of Smyth County. On that day Mr. J. P. Wilson of the Personnel Department of the Tennessee Valley Authority came to town for a conference about selecting some men from Smyth County for work on the Norris Dam.

A group of citizens including Mayor R. T. Greer, Senator Bert Dickinson, J. A. Eller, Lynn Copenhaver, B. E. Copenhaver, J. L. C. Anderson, Rev. Hugh Carter, Rev. Hugh Rhyne, Paul Bird, Crockett Gwyn, and several others, were told the story. It ran something like this.

The Tennessee Valley Authority under the direction of Dr. A. E. Morgan, President of Antioch College, is ready to begin work on the development of the Tennessee Valley. Surveyors are already completing plans for the building of the Norris Dam at Cove Creek. Actual work will begin there in a few weeks.

Workers for this \$30,000,000 project will be selected from the counties which are drained by the Tennessee River. Smyth County will furnish from 20 to 50 men. These men will be selected on a purely competitive basis. Men in the county who are interested in getting one of the men listed above who attended this meeting to recommend them. They will also write at once to the Tennessee Valley Authority, at the Abingdon Post Office, for an application blank, which blank they will fill out and send back to the same address before October 7.

On October 15th an examination will be held in Marion to determine which men out of those applying will be selected for the job. Anyone who does not get his application in before October 7, will not be considered.

Any citizen of the county from 16 to 60 may apply for work. If a person is selected he does not have to sign up, but it is hoped that he will plan to stay the four years at the job.

Homes will be provided for all married workers. The unmarried men will stay in dormitories. Hospitalization will be provided free by the government.

This project is intended to build not only the Norris Dam, but also a finer citizenry in the Tennessee Valley. The men who are selected will be given ample chance to go to school under the direction of some of the best teachers in our land. Courses will be given in all the trades as well as straight literary courses. Young men who want to will be sent to College, working part time on the Dam, and going to College part time.

This a great experiment, and it will be a blessing to many of our folks who are now unemployed, or who want to get a chance to better themselves for future living.

Those who are interested will see one of the men listed above. Prof. B. E. Copenhaver is in charge of sending in the recommendations from Smyth County.

**The Last Sunday Before
Conference**

Dr. E. A. Shugart, pastor of the Methodist church is closing the year here Sunday, October 1st and has called upon the entire membership to make a sacrificial offering that Sunday. In making the announcement he said, "I have been your pastor for four years, during that time I have not taken a public collection for the budget of the church. I wish every member on next Sunday to make a sacrificial offering, whether you have paid your subscription to the budget or not. This is to be an individual offering, and it is believed that every member will participate."

He leaves Tuesday for the seat of the Conference at Church Street Church Knoxville, Tenn.

During his pastorage 159 members have been added, a pretty good sized church they would make if organized separately from the other members of First Church.

**Appeals To Women To
Try New Road To
Temperance**

Mrs. Julian Keith of Warrenton, one of the most prominent women in the State and for years a worker in behalf of temperance, yesterday came out in a final appeal to the women of Virginia to go to the polls on Tuesday, October 3rd and vote for repeal of prohibition.

She addressed herself especially to the thousands of Drys who have at least found out that prohibition is not the road leading to temperance. "Prohibition was tried out by those who really desired to find a way to temperance!" she said. "It proved, instead of the golden pavement we expected, a by-path to a morass."

"Let us vote Repeal, both National and State, and then join forces, doing everything in our power to make the new laws effective, and together, "Wets" and "Drys," marching up the new road and making of it a happy highway leading to righteous living, temperance and achievement."

Her appeal is in line with those made by several other men and women of eminence in the public life of Virginia, many of whom were formerly Dry.

W. W. Beverley, State Chairman, explains that the method of voting is simple in spite that there has been some confusion about it. A vote "for ratification" means a vote for repeal and also a vote for the thirty repeal delegates listed on the ballot, he points out, adding that it isn't necessary to scratch out the names of the Dry Delegates listed. Similarly, a vote "against ratification" means a vote against repeal and at the same time automatically means a vote for the Dry Delegates.

"If you are for repeal, simply scratch out the words "against ratification," just as you scratched out the name Hoover if you voted for Roosevelt," Mr. Beverley said.

In urging Virginia women to go to the polls in large numbers and vote for repeal, Mrs. Keith speaks officially for the Women's Organization for National Prohibition Reform in Virginia, of which she is president, but unofficially she speaks as a grandmother.

"I have four grandchildren," she said, "and I want them to grow up in more temperate times than prohibition has given us."

She is convinced that it will be much easier to control a legal liquor traffic than it is to control an illegal one that has grown to vast proportions.
