READJUSTMENT is on the "boom" in Smyth. Keep it booming until Funderism is buried for ever.

AFTER all the Funder blowing about Mr. GARFIELD yielding to the importunities of Gen. WICKHAM, it is ascertained that the President gave that gentleman cold comfort.

READJUSTERS, you may expect much bitter abuse of your cause and leaders in the coming canvass. A good cause and noble leaders are always so treated by their opponents.

THE meeting of the Readjusters held in the Court-house Monday, was an excellent one in point of numbers, and character. The action of the State Convention was ratified by a unanimous vote. Proceedings of the meeting will be found in another column.

We have noticed in the Wytheville Enterprise an item in which it is stated that the Democratic Readjusters of Tazewell county will not support the Readjuster State ticket. We made a trip recently to Tazewell, and never saw men more enthusiastic in their support of a ticket than the Readjusters of Tazewell (May and July) are for our State ticket.

THE following named counties voted subscriptions to the capital stock of the Va. Ky. & Ohio Railway: Smyth \$20,000, Russell \$45,000, Bland \$20,000, Tazewell \$45,000. They now have two corps of engineers in the field locating the road, one in this county and one in Tazewell. Two more will be placed in the field by Gen. WHARTON in a short time.

It there was any disposition on the part of the Readjusters to be dissatisfied with their ticket that feeling would be overcome by the alarm and disgust expressed by the Funderers for the make up of our ticket. We are not around making tickets to suit the Funderers, you know, and the more heartily they disapprove of our action the more satisfied are we that the right thing has been done.

"THREATENING THE PRESIDENT."

Under this caption the Ohio State Journal says:

"Congressman Tucker, of Virginia, a day or two ago had an interview with the President regarding the course of the administration as to the coming election in Virginia. Mr. Tucker urged against any support of the Readjusters by the administration, saying that it was a State contest, and that the readjusters, in favor of repudiation, would hurt every interest of the State if they got control of it. The President did not indicate what policy he would pursue, but said the matter would be decided by the Cabinet. As the Virginia campaign is not yet really opened, there is no need for immediate action, but the Cabinet will consider the whole question at some meeting soon. There is a strong inclination on the President's part to help Mahone. Tucker and other prominent Democrats have said to the President that if the administration supports Mahone the Democratic Congressmen will consider it a matter for their resentment."

We doubt the truth of this story, not believing that Mr. Tucker has been in Washington lately; but if what he is represented to have said to the President be correctly reported, it is about what ought to have been told his Excellency. The Democrats will present in Congress any effort on his part to help this foul coalition against the public credit of Virginia.—Lynchburg Virginian

So the Bourbons as well as the Grip-Sackers are trying to intimidate Mr. GARFIELD into support of Funderism in Virginia. And the Virginian threatens that the Democrats in Congress will resent any effort on the part of the President to help the Readjusters. What impudence on the part of the Funderers to ask Readjusters who have been Democrats in National politics to give their support to candidates of the Funder party, because they claim to be Democratic, when the representatives of the National Democracy in Congress are announced in this manner to be the bitter and unrelenting foes of Readjustment.

The Virginian and the Funderers are willing to coalesce with GARFIELD and the WICKHAM faction of the Republicans, but it wishes to damn the Readjusters for uniting with the LEWIS wing of the Republican party, and also to denounce GARFIELD if he aids our party. Oh! what people these Funderers are, anyway.

The Gist of it.

Many of the leading anti-partizan journals of the North and South have noticed and kindly cheered our humble efforts in advocating the incalculable liberal views and progressive tenets into the Democratic party of the country, and particularly of our own State. The Cincinnati Enquirer was particularly eulogistic and patronized us far beyond merit.

We do not wonder that these efforts should attract attention, when, with enlightened people, the hide-bound Bourbonism exercised in political feelings and actions of the South is a subject of adverse comment. They cannot understand why we should cling to those ideas which can only tend to prevent those very things we most clamorously desire: immigration and the influx of Northern capital. To them, that we should furnish brains and vote for that wing of Northern men whose political theories are as antiquated as the couriers of Louis XVI, is a matter of special wonder. And yet we cannot tolerate the person who would dare tell us these things. Nay, as a Northern writer has very justly observed, we regard all the criticisms, however proper, as personal insults. Deep in us lies the fiction that we are losers by a cause in the late contest. That it is a fiction, we have then only to inquire of ourselves to determine. It is true, reconstruction was an evil which no one can measure save those here who experienced it, from this sprung bad officials and ignorant rulers. But reconstruction was an effect in itself. It is equally true the war an evil, bringing to our firesides all the horrors to which mankind can be subjected. But the war was an effect. The cause for all these ills was summed in slavery—an institution without a defence and scarcely an apology.

War and reconstruction have passed and gone forever, but the blight of slavery still remains. It remains to meet us in the false civilization born of and nurtured under it. A civilization that judged itself perfect and struck down with an imperious hand every opposition. It cloaked itself in the simple toga of Liberty in 1861, and proclaimed that the North desired to wrest from us "rights we held dear," and plunged the people of the South into a contest which was hopeless from the hour that Sumpter's gun awoke the slumbering Nation. Defeated in the field, it shadowed itself under Andy Johnston's wing and augmented the ills of a suffering and ruined people by the enactment of a system of peonage statutes, and by that sin made that worse than hell, reconstruction possible. And yet this "civilization," rank with feudalism, from its strougthold of Bourbonism, terrorizes those who dare expose its sins, and reeking with the crimes it has committed against the South and her people, brazenly proclaims itself the party which has relieved them of ill.

If the people were contented and happy under the iron-handed rule of a Bourbonism, which is intolerant in all its acts; which vilifies, abuses and terrorizes every citizen who dares stand up in the broad light of our American civilization and independent government and proclaim the right to speak, think and act, free from the shackles which it has so long fastened upon the people of the South; which pins its faith to dead issues, and builds its hopes of future usefulness, glory and greatness upon abstract ideas belonging to the "dead past," and which need a burial no resurrection trumpet can ever call to light again, would they clamor for a change and fill the land with continuous demands for something better, purer, more in consonance with the restless spirit and increasing activity of the times?

The same party of "abstract ideas" and issues, settled beneath the sulphurous smoke of hundreds of battlefields, are eternally vociferous about the "bloody-shirt" mania of the Northern Republicans, while they fail to discern the crimson stain on their own garments, while they shout an unflinching fealty to a "Solid South," and appeal with frantic eagerness to the spirit of 1861.

To-day there is a new generation of voters in the land from what there was over a score of years ago. Men who have enlarged ideas—an excited conception of the needs of the present times—whose minds grasp with tenacious power the requirements of progressiveness in politics, as well as in science and art. These men will not be hampered and shackled by "abstract questions" or "dead issues." They propose to battle right royally—not for a "Solid South," nor a "Sectional North"—but for one country, with a similarity of ideas in all its limits, whose progress, greatness and grandeur shall be their chief aim, and far removed from the spirit which has made the late session of the national Congress a burlesque on deliberative assemblies, the ridicule and reproach of all classes of well-thinking men.

This spirit, born of the exigencies of the times, means a liberty of thought and expression which has been drowned down, brow-beaten and abused without stint or measure. If progressive ideas, which meet the full measure of the present, are not to be contented or tolerated, because they are considered an innovation on principals of a century ago; if they are considered inimical to what some think the true status of Democracy—a Democracy which tenaciously clings to the issues of 1861, believes in slavery, State sovereignty and the right of secession—the sooner it is disbanded the better for the country.

If Republicanism means a continued hatred of one section by the other, of keeping up the issues and heart-burnings and jealousies and enmity of twenty years ago, of bitter

reprisals because of the blind fury of fanatics in the other section, then, the sooner it is disbanded, the better for the land.

We are, as we always have been, a Democrat—but of such a mould as would advocate the claims of our common country, intact in all its parts, whose interests, from the Atlantic to the Pacific, from the Gulf to the St. Lawrence, are so intricately interwoven that there cannot be, must not be, any division lines, or sectional prejudices. We want a Democracy that is live in its ideas, whose aims and purposes and intent is to build up a National feeling, a land that shall be the pride and boast of its people, the wonder and admiration of the nations of the earth.

We are aware that these are broad principles to assume and promulgate. We have already adopted a platform clearly and tersely enunciated. We propose to discuss it logically, intellectually, with reason, judgment and calmness. We do not propose to deal in innuendoes, abuse or vilification. Such are poor weapons with which to fight facts, and are not argument. Our ideas are fast taking hold and becoming a motive power among the people, and the future looks bright for the establishment of a Democratic party on whose standard will be emblazoned: No North, no South, no East, no West. One country, one people—a Nation whose interests are identical.

An Awful Slaughter of Roosters. CINCINNATI, June 17.—A great cock-fight took place yesterday at Avondale, in the suburbs of this city lasting from 6 in the morning until 10 o'clock at night. Over two thousand people were present, and all the sporting characters in this section of the country, and especially of Kentucky, were noticeable around the pits. Five hundred cocks were fought, ten mains going at once, and one hundred and fifty of the combatants bit the dust. Vast sums of money changed hands, and the scene all day was a veritable pandemonium. Pool-sellers drove a thriving business before and during the slaughter, and there was considerable feeling manifested between the backers of the various feathered knights of the pit.



THE FARM AND HOUSEHOLD

Liberal manuring on poor soil always pays.

How to paste labels on tin. Pass a sponge saturated with muriatic acid over the tin, then use gum tragacanth paste.

A piece of muslin put next to every layer, of leather in a sole will prevent the shoe from squeaking.

If a little vinegar or some cider is mixed with stove polish it will not take much rubbing to make the stove bright, and the blacking is not likely to fly off in fine dust.

Economical Jelly Cake.—One egg, one cup of sugar, one tablespoonful melted butter, one-fourth cup of sweet milk, one teaspoonful cream-tartar, one and one-half cup of flour.

The best grass for wet land is red-top, to this may be added meadow spear grass, fowl meadow-grass and perennial rye-grass. Of these about six pounds each may be used to the acre.

Waffles.—One pint cold boiled rice, thin it with cold milk, and add one egg, beat all together well; add a small piece of butter, and stir in flour enough to make a batter, stiff enough to bake.

Rare-cooked fresh meats far more easily digested and furnish much more real nutrition than those "well done." Habit will make one enjoy the rare cooked steak as more juicy and palatable, and it certainly better as food.

Correspondent of the County Gentlemen say: "We have been pestered with little red ants for a year, or two in winter as well as summer, and had tried everything without doing any good. Raw onions were recommended, which I think have succeeded in banishing them from closets, etc. We are particular that the china shall be perfectly dried, as the least moisture seems to attract them."

Towels with handsome, bright borders, should never be boiled; or allowed to lie in very hot water, they should not be used till they are so much soiled that they need vigorous rubbing to make them clean. It is better economy to use more towels than to wear out a few in a short time. A gentle rubbing in two suds and then in cold ought to be all that is required.

Cucumbers for pickles are grow best on light sandy or gravelly soils, planted in hills six feet apart, and well manured in the hill with rotten manure. The Green Prolific is usually grown for pickles. The cucumbers are gathered, when from two to three inches long, and by picking them in this condition a very large number are left in each hill, and the ends of the vines should be pinched in to encourage side shoots, which bear most fruit.

Floet or French Custard.—Beat the yolks of five eggs with ten tablespoonfuls of sugar stir in a quart of new milk, place over the fire and stir until it creams (don't cook too long). Pour in a dish you can cover. Spread carefully over the top the whites of the eggs, which must have been beaten to a stiff froth, cover and leave till cool. Grate nutmeg over the top before serving. This is nice for tea.

Chopped Onions and Potatoes.—This makes a nice breakfast relish. Take boiled potatoes that are a little under-done, and chop them fine, add a boiled onion minced. Put a large coffee-cupful of milk into a saucepan or spider, let it boil up and add a piece of butter as large as an egg, let it melt, and turn in the onion and potatoes, and let them cook until they look creamy—perhaps twelve or fifteen minutes. Serve very hot. Omit the onion if it is not to your taste.

Creamed Mackerel.—Wash a sdt mackerel, and soak it all night in cold water. To prepare it for breakfast, wipe it well to get off the salt crystals that may be lodged in the creases, put into a broad pan of boiling water and cook steadily half hour. Drain when done, and transfer to a hot dish. Pour over it a sauce made by stirring into a cupful of boiling water a heaping teaspoonful of cornstarch, two of butter, one of vinegar you can put in a teaspoonful of green pickle minced fine. Stir over the fire until smooth and as thick as custard, when add minced parsley, if convenient. Pour upon the fish cover, and let it stand five minutes in a warm place before it goes to table.

Dolley Varden Cake.—Three eggs two cups of white sugar, two thirds of a cup of butter, three cups of flour one of sweet milk one teaspoonful cream of tartar, half teaspoonful of soda, take half the mixture, flavor it with lemon and bake in two tins, as for jelly cake, to other half add one tablespoonful of molasses, one cup of chopped raisins, one teaspoonful each of cinnamon, cloves and nutmeg. Bake in two tins. Put the cake together with jelly a light-colored layer at the bottom, the light one being less likely to crumble.

Light Brown Bread.—Mix together three cupfuls of rye meal, not rye flour, two of Indian meal, one of molasses, one teaspoonful oil salt, and four cups of milk, sour milk may be used, with the addition of two level teaspoonfuls of soda dissolved in it, and it makes better bread than sweet milk. Beat these ingredients to a smooth batter, pour it into a butter covered mold or tin pail, set it in a pot containing enough boiling water to reach half way up the side of the mold, and steam it for at least two hours; then uncover the mold, and bake it for half or three-quarters of an hour in a moderate oven; the bread is done when top and sides are light brown.




