Resolved, By the Conservative party of Virginia in convention assembled. That while the Conservative party is true to the past glorious history of Virginia, and proud of her good name and fame amongst the nations of the earth, would scorn to repudiate her past obligations, and are resolved to preserve inviolate the public faith and credit, yet we cannot but view with concern and anxiety the accumulation of our financial difficulties and the increasing weight of the public debt; we therefore earnestly urge upon the Legislature and Executive branches of the government the importance of using all just and honorable means of bringing about an adjustment of the obligations of the Commonwealth which will bring the payment of interest upon our entire indebtedness within the resources of the State derived from the present rate of taxation and do justice to all classes of our creditors.

ELECTION DAY.

On next Tuesday the people of Smyth County will be called upon to exercise the right of suffrage for a Governor, Lieutenant Governor, Attorney General, State Senator, and Member of the House of Delegates.

The coming Legislature will be one of greater importance, perhaps, than has ever assembled in the State, on account of the great questions, that will necessarily come under its consideration, the one of the most magnitude being the State debt problem, which must and will be solved. Now see that you vote for none but the right man. Be not deceived by the men who say it is a mere nothing—that retrenchment and new subjects of taxation will relieve all difficulties. We tell you, in all honesty, that it is patent to our mind that nothing but adjustment will save the State, financially. The great era of prosperity predicted by the funders, and those who hold the funding bill as a sacred contract, will never arrive until the immense burden, the State debt, is reduced, until the tax paying men can breathe more freely. Go to the polls and vote for none but readjusters, forcible ones, at that. Read the letter of R. M. T. HUNTER, the distinguished statesman, and Treasurer of Virginia, and be sure you are right.

THE FRIENDS OF PUBLIC SCHOOLS

The State Constitution provides that a certain portion of the revenue shall be set apart for the support of public free schools. By the funding bill this provision of the Constitution is defeated, as it allows the school tax to be paid in coupons. The result is that there is now a deficiency in the School fund of nearly a million of dollars. The only remedy is the enactment of a law which will force the payment of the school tax in currency. Such an act has passed in the House of delegates several times during past years, but was defeated each time by a funding Senate. You who are friendly to the public Schools, see to it that your representative in the Senate is all right on this question. Vote for no man who would not aid in the passage of a law which would enforce the payment of the School tax in money.

OFF THE TRACK.

From a card, published elsewhere, it will be seen that Col. RICHARDSON is no longer a candidate for Lieut. Governor in opposition to Gen. WALKER. Gen. WALKER has not only pronounced in favor of Readjustment, but now prosecutes bitterly GILBERT C. WALKER, and all the original friends of the funding bill. The prodigal is truly repentant, and will no more, in reckless folly, wander from his father's house to feed upon the dirty husks the funders would provide for him. Col. RICHARDSON deserves the gratitude of the readjusters for bringing about this result.

THE STATE DEBT.

The amount of the State debt, West Virginia's portion included, amounts to about sixty-one millions of dollars, according to recent estimates of the 2nd Auditor, and ex-Governor Walker. Two-thirds of the debt, with the amounts due the school fund, unpaid interest, and what the State has recently borrowed, foots up the sum of forty-one millions. Mr. TRIGG, candidate for the Senate, says persons who present these figures are trying to humbug the people. He places the State debt at a little over thirty-three and a half millions. He is humbugging himself, if no one else.

READ what Mr. Grey, State Causarver for the Augusta district, says about the State debt. He was with Gen. Walker at Harrisonburg, and no one will say that he is not on the platform, except funders. He is an honest man, and reflects the views of the party. See what he says about retrenchment and economy, and heed his remarks:

Valley Virginian: "We would not and could not repudiate it, nor can we get rid of it by an attack upon the courts, nor can we increase taxation sufficiently to meet the demands made upon us. Already the burdens are as great as they can be borne. What then? There is only one way—Readjustment. You could find men who tell you that there is no cause for alarm—that with retrenchment, economy, &c. &c., the obligations can be met without increase of taxation. Beware of such men! They are dangerous, and either do not know the whole truth or else conceal it. Men who try to delude the people with promises of a millennial prosperity by and by, cannot and must not be relied on. If you give heed to such men, when the time for action comes, you will find little consolation. Therefore, when you go to the polls select those in whom you can trust in individual affairs

men of honesty, integrity, and capacity, and who have not sought to mislead or conceal either in private or public affairs." ALL efforts of the funders to cast reproach upon the readjusters by calling them repudiators have proven signal failures. Candidates who have heretofore been clamoring for the honor of Virginia, which was preserved only by the payment of the debt, as ascertained by the funding bill, now see which way the wind is blowing, and are falling into line as readjusters. Marshal Hanger, former Speaker of the House of Delegates, the protégé of Sandy Stuart, and a pronounced "pay all" man has declared in favor of readjustment. Still the funding papers are boasting that the readjustment party is a dead thing. The 6th of November will tell a tale.

THE Wytheville Enterprise, and other funding papers, while they did not hesitate to publish the action of the State Executive Committee, taking from Col. RICHARDSON the position of State Causarver, have failed to say a word about the Committee's refusal to pass, or even vote upon, a resolution, offered by Mr. J. B. BARRETT, a "pay all man" of the State's debts, endorsing the course of Gen. JAMES A. WALKER, and his views on the debt. The Committee could not conscientiously do it, knowing the character of public sentiment. The reproach to Gen. WALKER, we take it, was greater than the one given to RICHARDSON.

SOME candidates say they are for an honorable adjustment of the debt that will be acceptable to the creditors. Vote for no man who says this. The adjustment will be the payment of every dollar of principal, interest, and interest, compound interest, and doubly compound interest. Would such an adjustment be acceptable to the people? Would it be honorable? We say not.

IN a municipal election held at Baltimore last week, the Democrats won a grand victory. Kane, the Democratic candidate for Mayor, was elected by nearly twenty thousand majority, and the entire city council is Democratic.

FROM latest advices it seems that fortune is favoring the Russian armies, and the "Crescent" is about to go down in ruin. The rapid approach of winter may give the Turks an opportunity to recover from several recent dangerous disasters. Before the winter is over mediation will probably put an end to the war.

LET the people on next Tuesday put an end to that iniquitous law the Funding Bill. The voice of the people must and will be heard. If they declare against the measure that overrides State sovereignty it will be well, otherwise farewell to the future welfare of the State.

THE qualified adjuster, as a general thing, is a funder—a wolf in sheep's clothing. Let the people beware.

NOTE for no man who says that the funding bill is paramount to the sovereignty of the old Commonwealth.

BE not deceived by the will of the wisp new subjects of taxation.

THE ISSUE JOINED.

MR. EDITOR: In the discussion between Messrs. Fulkerson and Trigg at Abingdon, the whole debt was stated by Fulkerson to be about sixty millions. West Virginia's third off (which, with interest, is about twenty-one millions,) leaves forty millions as the debt of Virginia—viz.: Consol Bonds, twenty millions; Peeler Bonds, nine millions; back interest thereon, about five millions; literary and sinking funds, five millions; and one million of overdue interest on the Consols. These are round numbers. If the funding acts of the Legislature of Virginia had not been passed, our debt would now be only twenty millions interest bearing or principal, and ten millions of interest due. The operations of the funding, and their direct effect, if carried out, is to double our interest bearing debt, and thus necessitates nearly double the taxation.

Mr. Trigg declared that he never would consent that Virginia should pay West Virginia's portion of the debt, yet he contended that the decision of the Supreme Court puts it out of our power to repeal the funding act. But he failed to tell the people that the same Court decided that Virginia was bound to pay the whole debt, or how he would get out of the obligations the Court says we are under to pay all the debt. Col. Fulkerson comes up to the work boldly, and tells the people what legislation he thinks is necessary to free us from the power of the Consol bondholders, while Mr. Trigg argued that it would not be consistent with "honor" for us to attempt by legislation to destroy the force and effect of the funding bill. That is the radical difference between them. The one asserts our sovereign rights—the other is willing to submit to the enforcement of an act of the Legislature of 1871 that he himself said was "wrong." Fulkerson is heart and soul with the people; and says if elected he will do all he can to correct the great

"wrong" of the funding act of 1871—Mr. Trigg says if elected he will not try to relieve us of the burthens imposed upon us by that act, which he himself said was wrong, but intimated that he would try and raise the unjust taxes imposed upon us by the funding act, by curtailing the cost of, sweeping the House of Delegates, and by cutting off part of the pay of a few committee clerks, and intimates that the County Clerks might be abolished also, to "save expenses," and raise money for the bondholder. The line of argument adopted by Mr. Trigg seemed to be nothing less than tripping with a great subject, involving such vast interests as are involved in the issue now before our people; and he, and those thinking as he does, propose no reduction of our debt, but, on the contrary, favor the payment of all, with compound interest and without any abatement, to do which, General Walker recommended an increase of our taxation. Col. Fulkerson, and those acting with him, declare that a reduction must be made; that right and justice demands it, and that the State and her people should not submit to wrong and injury any longer. Mr. Trigg said he was in favor of readjustment—not forcible, but such only as the bondholder will agree to. Fulkerson said the Legislature could "readjust" without calling on the bondholders for help; in other words, that the very existence of the State, and of our public schools, demands readjustment, with a reduction of our burthens, and equal justice to all bondholders. Thus is the issue joined. The people of Smyth should also remember that a Circuit Judge is to be elected by the coming Legislature, and their county having an honest, upright, pure and able man (the present Judge), they have a double interest in the success of Col. Fulkerson.

FEEDING CATTLE.

A correspondent of the Rural Sun gives his experience in feeding cattle as follows:

If they are sometimes stuffed and at others starved, they will soon go through the process of "eating off their heads." In feeding meal, I want it ground fine, as my experience is that three bushels of fine meal is equal to four ground coarse, though an overfeed of fine meal will scour worse than the coarse. This the feeder must guard against. Always give each a box to himself, so that you know he eats what you give him, and always accustom them to being tied up from calves; if this is not convenient when you begin to feed, tie them up at night and let them run loose in the lot of a day. Keep them well bedded, and never allow a hog in their stalls, or you will lose much of the manure they will make, and that with me is a big item. When your stalls begin to get too hot to be healthy, clean out and haul directly to where you want the manure.

In commencing to feed, if you intend to feed five or six months, don't feed too heavy at the start, but gradually increase so as not to cloy them, as it is difficult to make profit on one that has been over-fed or foundered. For two years past I have been turning mine off at two to two-and-a-half years old, at from sixty-three to seventy-eight dollars, always with satisfaction to myself and all parties who handle them.

I once tried a three year old scrub steer until he was four years old, with a lot of young grades. The grades made a gain of 615 pounds in ten months and two days, and the scrub made 323 pounds in the same time, and through the feeding season he ate three pounds more of meal per day than any other in the lot, and I think full as much hay, though that was not weighed. He weighed at four years old 1,400 pounds, and sold at 4 cents per pound, while the two and two and a half year olds averaged over 1,400 pounds and sold at 5 cents.

In feeding, a few ruta-bagas are a great help. Hay and corn fodder fed alternately are a great deal better than either alone.

CLEAN VESSELS FOR MILK.

Speaking upon this subject, Prof. Lav, of Cornell, says:

Few people have any idea of the perfect cleanliness necessary to the preservation of milk. An ordinary washing with water, though uncomfortably warm for the hands, or even with soapuds, is utterly insufficient. There should first be the thorough cleansing of the dish, and then a rinsing with water at a boiling temperature, which must be poured out, and the vessel dried by simply inverting it over a drawer or a table, but without the possibility of contact of its interior with any solid body. If dried with a towel, or if hand or finger, or indeed, any solid body, is brought in contact with its interior after it has been scalded, organic matter, bacteria, and other germs may be deposited which will precipitate decomposition in the milk placed in it. But if the vessel is first thoroughly cleansed from all organic matter that may cover and protect such germs, then rinsed out with boiling water, set aside to drip, and finally filled with milk, having had nothing to touch its inner surface from the contact with the boiling water until now, such vessel will not communicate to the milk any decomposing element. Every vessel from the pail which receives the milk as drawn from the udder, to the bottle from which the baby sucks its supply, must be treated in the same way. In the case of babies bottles, it is best to keep two, to be used alternately, the one with its tubes and the teat being thoroughly washed with soda, and then immersed in a dish of pure water until wanted, when it may be taken out and scalded before the milk is put in.

No farmer who feeds grade Short horns judiciously, and takes care to get the benefit of manure, will ever need credit. As for scrubs, fight shy of them, for if the market is dull and slow you are compelled to sell for less than they cost you, and seldom, under any circumstances, at a profit.
