**Confederate Veterans
Entertained by Holston
Chapter U. D. C.**

The Confederate Veterans of Smyth County were delightfully entertained by Holston Chapter, Daughters of Confederacy, on last Wednesday, Sept. 21st. On that day the Daughters gave their annual dinner to the veterans, in the banquet room of the Presbyterian church. Previous to their attendance at the dinner Gibson-McCreedy Camp of Confederate Veterans assembled in the Sheriff's office at the Court House with sixteen veterans present. These sixteen were enrolled, showing the date of their respective births as follows: W. E. Copenhaver, May 25, 1843. Z. T. Atkins, June 26, 1847. W. M. Shuler, November 26, 1845. James Sheffey, Jr., Nov. 10, 1844. J. H. Kegley, February 1, 1845. S. T. Totten, September 20, 1846. J. D. Williams, February 15, 1847. L. M. Cole, February 27, 1846. C. T. Durman, September 9, 1938. J. H. W. Snider, July 7, 1845. Rees D. Stone, June 25, 1942. H. W. Umbarger, March 9, 1844. Marshal Mabe, April 6, 1842. Samuel McClure, May 19, 1844. Wm. C. Pendleton, January 16, 1847. B. C. Wilson, December 25, 1842. E. H. Snavely, July 5, 1842. N. B. Dodson, May 1842.

As soon as the enrollment was completed the sixteen first named veterans were gathered on the front steps of the Court House and grouped in three rows to be photographed. This being accomplished, they were lined up two abreast, and marched in good order but very slowly, to the place of entertainment, where they were graciously and cordially received by the Daughters. They were joined there by three more veterans, who did not know of the meeting at the Court House, thus swelling the number present to nineteen.

After a reasonable time had been occupied by the Daughters in greeting and conversing individually with the veterans, they were invited to be seated at the table. Rev. W. M. Shuler, a veteran, returned thanks, and the Daughters then placed before each of the old soldiers a plate filled with delicious viands that would have whetted into activity the sated appetite of an epicure. And the veterans partook of the excellent food with a zest that proved they were still as good eaters, if not as good fighters, as they were in the late sixties. Ice cream and cake were then served and each of the old fellows arose from the table with a happy smiling face.

The occasion was made more enjoyable by interesting talks given by Mrs. B. E. Copenhaver and Dr. Wilson, pastor of the Presbyterian church. Wm. C. Pendleton then expressed the sincere thanks of the veterans to the Daughters for the pleasurable entertainment. The affair was concluded with a prayer by Dr. Wilson.

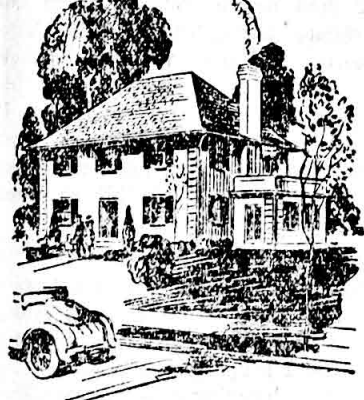
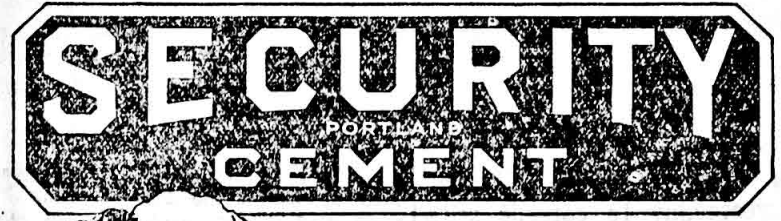

Unfair Tactics in Mail Vote is Charged by Buchanan Candidate.

Bluefield, Sept. 27.—S. G. Wright of Grundy, Republican candidate for the State senate from Buchanan, Russell and Tazewell counties, visited Tazewell yesterday to consult with Tazewell attorneys in what Mr. Wright alleges to be the abuse of the mail voting system in Buchanan county. Mr. Wright said that certain registrars of Buchanan county are crossing the line into West Virginia coalfield to call on Buchanan voters who are employed in West Virginia, and having these voters fill out their ballots, for the Buchanan county election. Mr. Wright, an attorney, expressed the opinion that such tactics were not in keeping with the spirit of the mail voting law, if not a violation of the letter of the law.

A spirited contest is in progress in Buchanan County over the county offices. Mr. Wright did not intimate for whom the votes were being cast. It was understood that Barnes Gillispie former United States attorney for the Western district of Virginia, was among the lawyers consulted by Mr. Wright.

The question under dispute centers around the right of a Virginia registrar leaving his State to solicit the vote of a Virginia voter who at the time the ballot is filled out is in another state. Mr. Wright stated that in his opinion the personal visit of the registrar would constitute a violation of the law, where the registrar leaves the state in delivering the ballot.

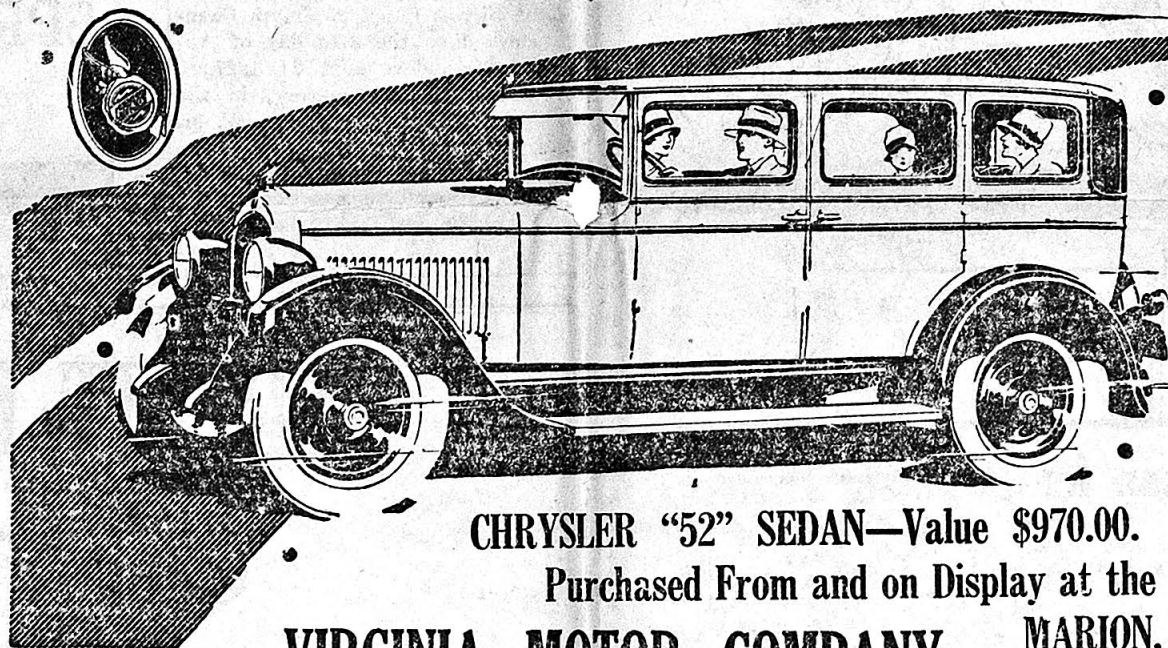

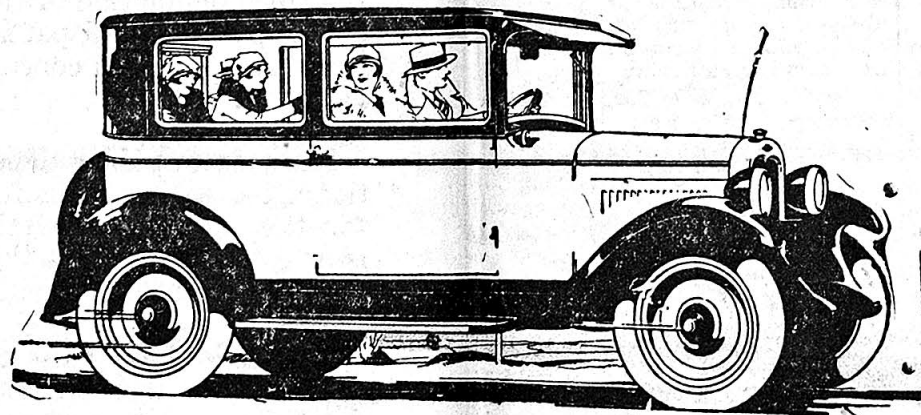

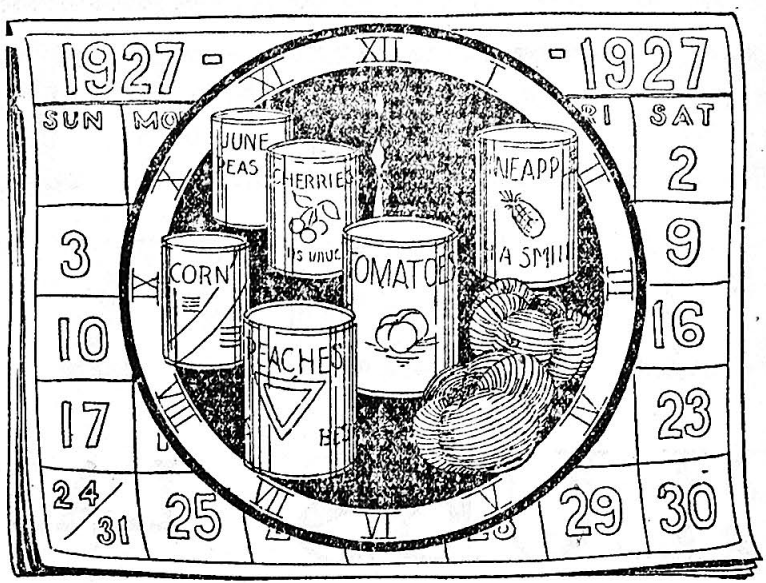

Eat Vegetables and Fruit Every Day

At least two kinds of vegetables and one of fruit should be eaten by everyone each day, according to the latest dictum of the food authorities. One of the vegetables should be a leafy one, preferably raw, and fresh or canned tomato may take the place of the fruit. Clearly the experts have in mind the necessity of balancing the grains and meats of which the average diet mainly consists, with what may be called the "protective" foods, those that are rich in vitamins and that keep the body functioning properly.

But, except during two or three months of the year, many districts have no fresh fruits and vegetables, and in others the price is prohibitive. Moreover, vegetables grown under glass are not as valuable from a vitamin standpoint as those grown right outdoors in the sunlight, as the glass prevents the transmission of the violet rays.

Canned Foods Keep Their Vitamins

Canned foods qualify on all these points. They are grown in the full

sunshine, picked at maturity, and canned at the place where they are grown. Because they are processed in air-tight containers they lose little or none of their vitamins, due to oxidation. Even though care is taken to keep a cover on a vessel in which food is cooking, the process is not as scientifically exact as when the food is processed in a factory in air-tight cans.

There is the matter, too, of price. When peas, corn, or tomatoes are obtainable at three cans for twenty-five cents, as frequently happens at the cheaper stores, they cost very much less than the same quantity of those vegetables would cost if bought at market prices and canned at home, and this makes no allowance for the time and labor involved.

Dr. Royal C. Copeland, writing about canned foods recently, said: "The canned fruits and vegetables of today are wholesome, nutritious and safe for young and old. No one need fear to eat the well-prepared products of the commercial canneries. This applies, too, to the jellies and preserves."



The Season for Solacing Drinks

WE AMERICANS as a nation go in for iced drinks more zealously than any other under the sun. It is a national habit; some say a bad one; certainly it is a universal one.

The resourceful housewife has many frapped beverages with which to tempt her family. Of all the fruit flavors, however, there is probably none which adds more of a zestful tang than pineapple juice.

The use of Hawaiian pineapple juice in summer drinks is not an extravagance, for the fruit itself appears so often in the summer menu, that using up the juice in tempting ways is really an economy. Hawaiian pineapple juice can also be purchased separately in cans. When large quantities are required, it should be used in this form.

Fruit Punches for Crowds

Waikiki Punch: (Serves 50) Make syrup of five quarts of water and two pounds of sugar and let it cool. Combine with it the following fruit juices: one quart Hawaiian pineapple juice, one quart lemon juice, one quart orange juice, one quart white grape juice, two quarts black tea infusion, five quarts water, one quart red fruit juice or ginger ale. Let stand several hours in the refrigerator. If ginger ale is used, add just before serving.

Ambrosia Fruit Punch: (For one gallon) Make a syrup by boiling four cups of sugar and four cups of water until it is about a quart in quantity. Add to this the following fruit juices: one pint Hawaiian pineapple juice, juice of six lemons, juice of six oranges, juice of six limes, two cups strong tea, eight cups sweet cider, four cups cold water. When ready to serve, add slices of Hawaiian pineapple, orange, and a few strawberries.

Pineappleade: Mix one cup water and one-half cup sugar, boil ten minutes and chill. Add three cups ice water, two cups of the syrup drained from crushed or grated Hawaiian pineapple and one-half cup lemon juice.

Pineapple Milkshake: Beat one egg until it is very light, add four tablespoons Hawaiian pineapple juice drained from the can, one tablespoon raspberry syrup, one pint of rich milk and plenty of cracked ice. Serve immediately.

Sparkling Punch: Combine the following fruit juices: juice of four oranges, juice of two lemons, one pound can Hawaiian pineapple juice, one small bottle maraschino cherries, two quarts sparkling white grape juice. Place the juices in a punch bowl over a cake of ice, add the grape juice when ready to serve, and use tall, hollow-stemmed glasses. The illusion of champagne punch is very real.

ALL SORTS OF SALADS
SUMMER or winter, cold days or hot, canned pineapple is at hand to lend its succulent gold to salads. It is always in season, and always a treat.
 Most of us remember the first time we saw pineapple used in salad. It isn't so very long ago. Perhaps it was at a luncheon party where a slice was served on a lettuce leaf and sprinkled with blanched almonds. How good it tasted! It just fitted in after the Maryland chicken with sweet potatoes and peas. Every-one at the party resolved to introduce it into the home meals. Soon it was seen everywhere, in any course, in dishes hot or cold. It is amazing how many ways people are finding to use pineapple.
History Like a Romance
 Indeed, the quick acceptance of pineapple by the American people as an everyday food reads like a romance. In 1892 an English nurseryman, Captain Kidwell, and his friend, John Emmeluth, after many difficulties shipped the first canned pineapple from Hawaii to the United States. They operated their modest canning plant until 1898, when they sold out, little suspecting what they had started. Then James D. Dole, a young Harvard man, came to Hawaii, intending to grow coffee. Instead, he became interested in pineapples. This fruit, he concluded, was the ideal crop of Hawaii, and canning the ideal way of sending it to market. So he urged his neighbors to plant pineapples, while he himself went back to Boston to raise money to build a cannery. In 1903 Dole's cannery put up 1893 cases of pineapples. Fifteen years later the output from Hawaii was 5,000,000 cases, and each year the number grows, as more people try canned pineapple and find it good.
"Praise from Sir Hubert"
 So vast has this industry become in Hawaii that Hubert Work, Secretary of the Interior, who was recently escorted through the great Hawaiian Pineapple Company's cannery by Mr. Dole, said:
 "Aside from the magnitude of the plant, what impressed me most was the cleanliness apparent everywhere, and the high health standard of the employees. Every-one looked happy and worked cheerfully. There can be no doubt but that the Hawaiian Pineapple Company ranks among the most advanced plants in the United States from the standpoint of size, sanitation and efficiency."
 So, we shall always feel safe eating canned pineapple—indeed, many doctors have said that canned food is the safest food that comes to our tables—for we know that it has been picked in its fullest maturity, and canned with the utmost care and cleanliness. Its stimulating flavor is imprisoned in the cans, and we have only to open them to taste pineapple as it tastes in the fields of Hawaii.
 Here are a few recipes for salads in which pineapple is the distinctive feature:
Pineapple Supper Salad: To make a salad for six people, mix one and a half cups of drained crushed pineapple with two cups finely shredded cabbage, one-half cup seedless raisins, one-half cup French or mayonnaise dressing, and arrange on shredded romaine or lettuce leaves.
Pineapple Waldorf Salad: Place slices of canned pineapple on crisp lettuce leaves. On top of each put a mound of chopped celery, diced apple, and walnuts, all well combined with mayonnaise. Decorate each serving with prunes stuffed with walnuts.
Mixed Fruit Salad: In the center of a nest of lettuce place a slice of canned Hawaiian pineapple. Arrange on top and around the pineapple, slices of orange, grapefruit, banana and dates. Thinly sliced fresh pear is also a welcome ingredient in this salad. Use a whipped cream or mayonnaise dressing.
Pineapple and Chicken Salad: For six people mix two cups of diced cooked chicken with three-fourths cup chopped celery, one cup drained sliced pineapple cut into small pieces, and one cup mayonnaise dressing. Arrange on lettuce leaves either shredded or whole, and garnish with thin slices of cucumber and stuffed olives.
Pineapple and Cream Cheese Salad: Arrange slices of pineapple on lettuce leaves, and in the center of each slice put a square of cream cheese decorated with slices of stuffed olive. On the outer rim of each slice of pineapple put thin rings of sweet green peppers and inside of these, slices of orange.
 With any of these salads except that which has chicken in it a cooked pineapple dressing may be used if desired. The recipe for this dressing is as follows: Melt one tablespoon of butter in the top of a double boiler, add one tablespoon of flour, and one-eighth teaspoon of salt. Stir well and add one cup pineapple juice and two tablespoons lemon juice. When smooth, remove, chill and fold in one-half cup of whipped cream.

Rich Valley High School Notes.

Rich Valley High School began Monday, Sept. 19, 1927. Devotional exercises were conducted by Rev. Jno. R. Martin, and a brief talk was given by Prof. B. E. Copenhaver.

The teachers of the High School department are as follows:

Prof. Dutton, Mr. W. A. Preston and Mrs. J. W. Buchanan. Those of the Grammar and Primary grades are Misses Mary Pratt, Gray Duchanan and Virginia Taylor.

The enrollment of pupils greatly exceeded the expectations of both the patrons and the members of the school board, numbering in the high school 81, and 121 in the grades.

A new Agricultural building is being constructed and a course is to be given by Mr. J. H. Brown, of Blacksburg. There are seventy-three boys in this class.

Progress is soon to be made on the athletic field. Plats have been laid off for basket ball, foot ball, and volley ball. It is the intention of both the faculty and the pupils to organize two Literary Societies in the near future.

Parents, teachers and pupils have co-operated and will try to make this one of the best schools in the county.

The school building is situated in Long Hollow, just across the river from Mr. Sam Gass, and one mile east of Capt. Taylor's home. This structure consists of seven class rooms, a large auditorium, and all modern conveniences, the water being piped from a fine spring forty-four hundred feet distant. There are two busses for the transportation of pupils from Chatham Hill, North Holston and Pleasant Grove.

Our next letter will contain a more detailed statement of the work and activities of the school and community life.

A Dollar Dinner For Four



The Dollar Dinner is now as famous as the Daily Dozen, and it is thought by many housewives to be equally healthful. Even in these days of high prices they can make a dollar cover the cost of a good dinner for four people, as is shown in the following menu:

Beef Consommé
Salmon and Peas in Cream Sauce
New Boiled Potatoes
Deep Dish Cherry Pie
Rolls and Butter
Demi-tasse

SUPPLIES for this dinner will cost as follows: One can of beef consommé, 10 cents; one tall can evaporated milk, 9 cents; one tall can salmon, 13 cents; one can peas, 9 cents; one can cherries, 23 cents; new potatoes, 5 cents; 4 plain rolls, 5 cents; 4 pats of butter, 5 cents; flour and shortening for one pie crust, 6 cents; coffee (at 40 cents a pound), 4 cents; total, 89 cents. These prices are those often obtainable in the cheaper stores. Eleven cents will cover the cost of minor ingredients.

How to Cook and Serve
Serve the consommé in bouillon cups. Bone the salmon and drain the liquid from the peas, saving it for use in soup the next day. Mix the cream sauce, using the evaporated milk

diluted only to half quantity, and seasoning with parsley, onion, celery salt and salt and pepper. When dinner is almost ready, drop into the sauce the salmon and peas and serve as soon as they are hot.

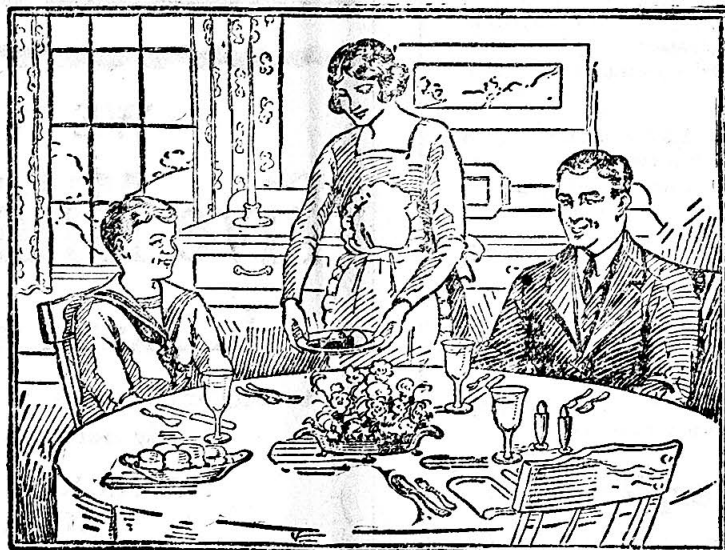
To make the deep dish cherry pie proceed as follows: pour one-fourth cup syrup drained from the cherries on 2 teaspoons cornstarch, and mix. Add one cup of the syrup, and after stirring well, boil two minutes. Remove from the stove, add one tablespoon butter and the cherries. Invert a heavy cup in the center of the baking dish and put in the filling. Cover with crust rolled a little thicker than usual, and slashed to allow the steam to escape. Bake in a hot oven. Sprinkle with powdered sugar; serve either hot or cold.

That Muttony Chop

MAN is undoubtedly a carnivorous animal. Ask any housewife who has offered her lord and master, or the son and heir, a pick-up supper, or a dainty little luncheon consisting of a soufflé or some other airy trifle. She was probably the recipient of many black looks and loud protests.

By the same token, to the masculine mind a sandwich is not a sandwich unless it contains something as heavy as ham, tongue, or at least chicken. Offer a man one of the feminine favorites, such as lettuce, egg or olives chopped with mayonnaise, and he will look upon them as mere piffle and eat a dozen at a sitting without feeling that he has really tasted food.

Can you not imagine how much more ingrained this taste for meat would be in the confirmed bachelor who has never felt the deterring feminine influence where food is concerned? There are no meatless days on the calendar in bachelordom, nor in clubs where the assembles. It is of one mind on that point.

Even when life with its domestic bliss and the felicities of the home has passed him by, when the joys of single blessedness have begun to pall a bit and the erstwhile rapture of "wine, women and song" seems a little

stale and unprofitable, then the aged clubman can still find solace in his mutton chop. Not the common or garden variety perhaps, but the thick, juicy, luscious English sort, the savory kind, served with hashed brown potatoes and red-hot biscuit.

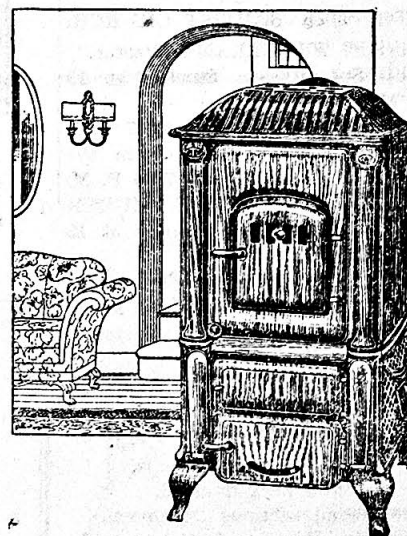
But here is a suggestion which should make even the most blasé of aged clubmen sit up and take notice, a toothsome way of preparing that same chop, of dressing it up, so to speak, and making of it a real Epicurean morsel—a dish fit for a king. Even the name of this delicacy has an intriguing sound: "Hawaiian Pineapple Stuffed Mutton Chops." They are prepared after this fashion. Clean chops, cut one and one-half inches thick, and make slit in meat, cutting to the bone. Melt butter, add chopped onion, minced parsley and cook five minutes. Add flour, salt and well-drained crushed pineapple. Cook five minutes longer. Press this mixture into slits made in chops and hold together with tooth picks. Lay chops in shallow pan, bake in hot oven (450 deg. F.) twenty-five to thirty minutes. When partly done sprinkle with salt and pepper. If chops do not brown sufficiently in oven, place under broiling flame for a few minutes. Garnish with parsley.
