SHOWED BOSS RULE

Significant Result of Recent Progressive Primaries.

Explanation Made Seems to Reflect on the New Party as the Champions of Nomination by Primaries Instead of Bosses.

The followers of Colonel Roosevelt have been the champions of the primary, as against the party convention, to defeat boss rule. If there is a Progressive party now in existence it has not made itself manifest in the primaries so far held in any state. The story is the same in Pennsylvania, Ohio and Kansas. The Progressive vote was insignificant in all these states and the explanation offered is that there were no contests for the nominations and therefore no incentive for the Progressives to show their hands in the primaries. That was the explanation offered for Mr. Pinchot's small vote in Pennsylvania, for Mr. Garfield's insignificant vote in Ohio, and for Mr. Murdock's vote of less than ten thousand in Kansas.

The explanation may prove true in November, but it seriously reflects on the professions of the Progressives as the champions of nominations by primaries to defeat the rule of the bosses. In every state named the Progressive candidates were hand-picked. They were selected by an organization machine, perhaps a gentleman's agreement. There was only one Progressive candidate at the primaries. The Progressive voters had no part in the selection of the candidates they are to vote for in November. The leaders of this party of political purists have been more successful in boss rule than ever were Thomas C. Platt and Matthew S. Quay in their palmy days.

The Progressive party was made up of men who had been persuaded that the bosses and not the rank and file controlled the Republican party. They revolted against boss rule and opposed conventions as too easily controlled by the bosses. They refused to be like sheep, herded and delivered to this candidate or that one.

That the great majority of them were honest in this belief goes without saying. It is also to be assumed that the great majority of those men who followed Roosevelt out of the Republican party still believe in the primary as the only fair and honest way to make party nominations, and that they are just as much opposed to hand-picked Progressive candidates as they were two years ago to convention-selected candidates. They do not differentiate as to party bosses. They are as indifferent to the party whip when cracked by Colonel Roosevelt, Mr. Pinchot, Mr. Garfield and Mr. Murdock as they were to the old party whip in the hands of the Republican leaders. This would appear to be the only explanation of the small Progressive vote in Pennsylvania, Ohio and Kansas, in keeping with the professions of Progressives.

The new party has in two years become boss ridden, and like the Populist party of 20 years ago, one campaign exhausted its strength as well as its principles. It was a quarter horse in politics.

Maryland and Louisiana.

Mr. Roosevelt has been advised that unaffected Democrats in Maryland are turning to the bull moose party, and he is said to be much heartened by the information.

Why to the bull moose party? Why not to the Republican party? The Republican party in Maryland has for years been strong and well led. Its leadership has been native, and representative of the best citizens in the state. Ability and character have both been manifested. A Republican governor—and a good one—is now in office.

When the great national crisis came in 1896, Maryland threw her weight into the scale for sound money. Many Democrats voted for McKinley that year, and repeated the performance four years later. The Republican party was then their refuge. Why not now?

November Will Show.

The Wilson-Underwood tariff for revenue, free trade scheme, is working mighty hard for the retirement of the majority in the lower house of congress. Its success is now apparent, and in November the decree will be handed down in favor of Republicans and against the Democrats.—Cedar Rapids (Ia.) Leader.

Wythe County Homes.

The United States Census Department at Washington has just issued a bulletin dealing with the ownership of Wythe county homes. The important facts contained in the bulletin relative to that county are as follows:

There are 4004 homes in Wythe county.

Of this number 1628 are farm homes. 1204 of the farm homes are owned by their occupants and are free of mortgage incumbrance.

The mortgaged farm homes number 180.

Renters occupy 254 farm homes in Wythe county.

Out of a total of 4004 homes in the county 2881 are urban homes.

There are 850 urban home owners in the county.

Of this number 98 are mortgaged.

669 of the urban owned homes are free of incumbrance.

There are 1456 rented urban homes in the county.

The census enumerators were unable to secure data pertaining to the ownership of a small percentage of both the rural and urban homes in Wythe county.

Former Abingdon Man in Wreck

New Orleans, Sept. 19.—Search was being made to night for train-wreckers believed to have caused the death of ten persons and the injury of 30 others, by derailling Queen and Crescent train No. 2 at 3 a. m. today at Livingston, Ala. Bloodhounds late today failed to pick up a trail.

The train, composed of 6 sleepers, two day coaches, mail, baggage and express cars, left Meridian shortly after midnight. It was running at a good rate of speed when it struck the switch, where the engine crashed into a loaded freight car. All of the train except the last three sleepers piled onto the engine in a heap.

Among those killed was Captain John A. Preston, who was captain of a company in the Thirty-seventh Virginia regiment of the Confederates, during the civil war. He was a bachelor and his home was for many years at Abingdon, Va. When killed he was on his way from his home in Texas to Abingdon to visit relatives. His body was shipped to Abingdon for burial.

New Tariff Blamed.

Washington, Sept. 21.—The internal revenue war tax plan, designed to raise \$465,000,000, framed by the Democratic leaders in Congress and approved by President Wilson, was laid before the House today by Democratic Leader Underwood. A call was issued later for a meeting of the ways and means committee tomorrow when the Republicans, called in for the first time, will record their opposition.

The first attack of the Republicans since the completion of the bill was made today by Representative Moore, of Pennsylvania. He contended the war tax is unnecessary and is due mainly to the Democratic tariff rather than to the European war.

Last Thursday morning Miss Grace Pemberton, who has been a teacher in the high school at Wytheville for several years, became the bride of Mr. Daniel Welch, of Cambridge, Mass. The marriage took place at the Methodist church in Wytheville, the pastor, Rev. Brown, officiating.

The catalogue of the seventh annual exhibit of the Washington County Fair Association to be held in Abingdon on October 1st, 2nd and 3rd, was issued several days ago. The fair this year is expected to break all records for general good time occasion. New attractions have been added to the program, among others being a daily parachute leap. Every day of the fair, during the lunch period, a lady performer will make her desperate leap from her aerian apparatus several hundred feet in the air.

Good Roads Convention.

Bristol, Va., Sept. 21.—The people throughout the Southern Appalachian country, appreciating the valuable work being done by the Southern Appalachian Good Roads Association, are showing deep interest in the sixth annual convention of the association, to be held at Bristol, October 6-9. Several Southern Governors, including Governor Craig, of North Carolina; Governor Governor Stuart, of Virginia; Governor Hatfield, of West Virginia, and Governor Hooper, of Tennessee, are expected to attend.

Every citizen interested in the good road movement is invited to attend the convention. All railroads will make special rates to those attending the convention.

The questions of financing, location, construction and maintenance of roads and State and federal aid, will be discussed by some of the leading men of the country. Among the speakers already announced by Hon. Joseph Hyde Pratt, president of the association are: Major W. W. Cosby, of Baltimore; G. P. Coleman, State highway engineer of Virginia; W. S. Keller, State highway engineer of Alabama; Henry R. Brown, president East Tennessee Good Roads Association; F. L. Seely, of North Carolina; Congressman John H. Small, of North Carolina; Samuel R. Rats Cost State Millions Yearly

Richmond, Va., Sept. 23.—At the instance of Governor Stuart, who is deeply interested in the subject from its effect on agriculture, the State Board of Health has just issued for public distribution a bulletin suggesting methods for ridding Virginia of the pest of rodents.

In recent conference with health officers, Governor Stuart explained that rats in Southwest Virginia had become a very serious economic problem. Large field rats, he stated, had settled in various sections of the Southwest and were destroying grain, feed and fowls to the value of many thousand dollars.

At the Governor's suggestion, the Board procured the services of an investigator from the Biological Survey to study conditions in Southwest Virginia. In addition the Board prepared the new bulletin on the best methods of eradicating rats and of the economic loss to the country every year from rodents. Accepting the usual estimate of at least one rat for every human being and the further estimate of the destruction of one half cent's of food by every rat daily, the Board computed the cost to Virginia of rats at something more than \$8,700,000 annually or more than half the entire revenue of the State from taxation. This estimate is considered low by those who are familiar with such conditions as Governor Stuart has found in Southwest Virginia.

Oldest Man in U. S.

Omaha, Sept. 20.—Thomas Morris, of Wateryille, Neb., has lived through the terms of every President of the United States and most of the big historic events of the last 120 years, and is vigorous today on a Nebraska farm. In six months he will be 121 years old, and is believed to be the oldest white man in the United States, and in all probability the oldest in the world. He has lived in three centuries. He was 3 years old when Washington's term as President closed. This connects him with the administration of every President of the United States.

TARIFF A FAILURE

Its Supporters Unable to Refute Stern Facts.

With the Country's Business Paralyzed, and Prices of Necessaries Not Lowered, the Ordinary Citizen May Well Wonder.

The revised tariff has been in force for a year, or nearly so, and no American table at breakfast, lunch, dinner or supper has seen an egg, a beefsteak, a chop, a slice of bread, a bit of butter, or any other edible or potable thing sold at a fraction of a cent cheaper than under the high tariff.

The putting of raw material on the free list came with promise to stimulate American industries by importing this from abroad, and this other false prophecy has not been fulfilled in a single instance. American business has been stagnant all over the country in spite of plenty of money, good crops, and every other stimulus that might be given to business. Imports and exports are both smaller and dwindling lower and lower.

And this has always been so. Whenever American industries have been protected they have prospered. Whenever the American people have been generally employed at good wages they have bought domestic and foreign goods and kept the wheels turning at home and abroad. America is one of the most populous countries in the world, its people spend more than any other people in the world, and when they prosper all the world prospers with them, and when depression hits our shores it spreads like the plague in ever-widening circles until it embraces the world.

Party Not Fitted for Power.

When the Democrats succeeded to the control of national affairs there was a surplus in the treasury which they have cut down by \$40,000,000. Notwithstanding a huge increase of expenditures, receipts, especially from customs, are falling off at a rate that suggests the possibility of a need within the next nine months of raising money by the sale of bonds for the purpose of eking out the amount required to run the government. Independently of the question of protection, the Democrats showed poor judgment in cutting down the tariff, for it now appears there is danger of a deficit in the treasury. They estimated that their income tax law would yield from eighty millions to a hundred millions a year. Current calculations are that it will produce not more than forty millions to seventy millions. It is a long time since the Democratic party was the party of great financiers.

The Recall in Colorado.

What have the initiative and referendum and the recall done for Colorado? Judge Ben B. Lindsey says: "Colorado has perfected the science of corrupting men. Its judges, its supreme court judges, are owned like office boys. Its lawyers, its business men are all owned." Judge Lindsey does not, of course, admit that the initiative and referendum and the recall are responsible for the conditions he has described, but Judge Lindsey is a prominent member of the political party which prescribes these instruments of popular government as a cure-all for every kind of social and political ill, and he does not explain why they have failed to accomplish their purpose in Colorado.—Springfield Union.

Country Demands a Rest.

The honest, legitimate business of the country has been fairly legislated and billed into a state bordering on nervous prostration, and is entitled to a rest. Let us at least have an interlude of peace and recuperation in the game of Politics vs. Business, that has been going on ever since Mr. Taft turned the country over to Mr. Wilson in such excellent condition.

Europe the Beneficiary.

A decrease of more than \$37,000,000 in the value of exports and an increase of more than \$27,000,000 in the value of imports in April, 1914, as compared with April, 1913, is announced by the department of commerce. The United States authorities ought to be on the watch for a European get-rich-quick concern located somewhere in this country.



Gilding.
The method of gilding a picture frame or other similar surface, is as follows: The wood is first given a coat of oil paint, and from four to ten coats of fine whiting mixed with fine glue are put on, each in its turn being smoothed with fine sandpaper. This done, a coat of gold-size is given to those parts which are not to be burnished, but those which are, receive only a coating of clear animal-size. The gold leaf is then laid on, and burnished where desired. Instead of real gold leaf, Dutch metal which is simply copper beaten like gold-leaf, is sometimes used, as is also the so-called gold paint, which is finely powdered brass or similar alloy mixed with size.
