Death of a Good Woman

MRS. W. M. HAYS.

On Thursday May 15, Mrs. Mary Buchanan Hays, wife of William M. Hays, of Rich Valley, passed to her eternal reward, and on Saturday morning her body was laid to rest in the churchyard cemetery at Pleasant Grove among the loved ones who had preceded her to the home above. Her parents were the late James C. and Sally Campbell Buchanan and her birthplace was close to the little plot where she now sleeps. Born and reared in a Christian home, she gave her heart to Jesus Christ in the happy morning of life, and united with the church of which her father and grandfather were ruling elders. On February 19, 1912, she was married to W. M. Hays of Rich Valley. Five children, one son and four daughters, were born to this union. She is survived by her husband and children and the following brothers and sisters: Mrs. Lee Miller of Wytheville, Miss Margaret Buchanan, Robert M. Buchanan, Mrs. John G. Buchanan, Mrs. Joseph S. Roberts, Mrs. T. H. Buchanan and Archie W. Buchanan, all of Rich Valley.

About two months prior to her death, the health of Mrs. Hays became so impaired it was thought best to take her to the Johnston Memorial Hospital at Abingdon for treatment. After a diagnosis of her case, it was decided that a major operation was essential, and for several weeks she was under treatment preparatory to this operation. When the time arrived, she was willing and ready to undergo the ordeal, expressing the hope that she would soon be able to return to her little children, but fully realized the seriousness of her condition. As she was taken from her room to the operating table, she waved her hand and smiled at the group of loved ones who had assembled to be with her. She rallied from the operation and give her friends hope of her ultimate recovery. But complications arose which baffled the skill of her doctors, and on the third day following the operation, she passed from the life here to the larger, better life above. She was born on May 12, 1881, and at the time of her death was forty-three years and three days old.

Notwithstanding the frailty of her health, the life of Mrs. Hays was one of unusual activity. Gentle, quiet, unassuming, she won people to her, and in her church and community there are none who will not miss her. Truly may it be said of her "None knew her but to love. None named her but to praise." As a wife, she was a wise counselor, affectionate companion and a faithful helper in every hour of need. As a mother, devoted to her children, gentle, loving, forgetful always of self in ministering to their wants. Her last earthly thought was of them and of their welfare. As a Christian she exemplified in a remarkable degree the graces of the spirit. Her hope and faith never wavered, but shone steadily through shadow well as sunshine. She gave freely of her labor and of her substance in ministering to those less fortunate than herself. She loved her church and was a faithful attendant upon its services. And now that we see her face no more, her memory is still with us, a star to guide us along life's pathway to better, higher things.

"I cannot say and I will not say That she is dead, she is just away; With a cheery smile and a wave of the hand She has wandered into that far-off land, And left us dreaming how wondrous fair It needs must be since she lingers there."

LINEMAN T. M. JOHNSON KILLED AT PULASKI

T. M. Johnson, a lineman of the Appalachian Power Company was killed on Main Street Saturday afternoon about 3 o'clock. He was working on a pole at the intersection of Jefferson Avenue and by some means came in contact with a 2,300-volt wire. He must have slipped in some way and caught this wire as both hands were badly burned. His safety belt kept him from falling. The current was quickly cut off but he died in a few minutes. He was unmarried, 22 years old and familiarly known as "Bud". His body was taken Saturday night to his home in Marion.

Funeral services were held at Ebenezer near Marion at eleven o'clock yesterday morning. Several employees of The Appalachian Power Company attended.

KILAUEA DISPLAYING ALARMING INDICATIONS.

Hilo, T. H., May 20 (A. P.)—The volcano of Kilauea, which has been in eruption for several days, is today displaying the most alarming indications, due to the large number of earthquakes that are rocking the district, according to Roy Finch, volcanologist, in charge of the observatory.

An explosion at 9 o'clock last night was most spectacular, bright moonlight silhouetting the black column of smoke rising to an invisible height. There was also a small explosion at 4:45 this morning.

The military camp has been moved to Glenwood, where a danger line has been established. Captain Perkins is remaining at the volcano and two soldiers have volunteered to remain at the pit, which formerly 2,800 by 2,050 feet, is now 275 to 100. All markings and monuments have been swept away.—Bluefield Telegraph.

It will be interesting for a great many people of Smyth, Grayson and other adjacent counties to know something more of the Captain Perkins mentioned in the above clipping. He is a son-in-law and nephew of our townsman, Attorney J. D. Perkins, and a son of W. Y. Perkins, deceased, late of Grayson County, Virginia, and of the State of Idaho, and Margaret Carson Perkins, the later being a daughter of the late William Carson of Chatham Hill, this County.

Captain Perkins has been in the Territory of Hawaii for the last two years and has recently been placed in command of the U. S. troops in that territory. His family, consisting of wife, Claudia Lee, whose father reside in our City, and a son, James William, about 15 years of age, are with him in Hawaii.

Captain Perkins was born in Grayson County, Virginia, was taken west with his father's family while quite young, graduated in the military course of the University of Idaho, just prior to the late World War, was appointed to a Captaincy in the regular army and during the war assigned to important special service in the west and permanently retained in the army with the rank of Captain, at the close of the war. He is noted for his fine military training.

PRESIDENT COOLIDGE ENDORSED.

There has been widespread commendation of President Coolidge's demand that the Senate discontinue unconstitutional methods in conducting investigations that interfere with the orderly conduct of the Nation's business. As will be seen by the following quotations, Democratic editors join in the commendation:

New York Sun—President Coolidge's letter to the Senate shows the courage of common sense and an appreciation of the fitness of things. It is a dignified protest against the persecution of an able and trusted member of the Administration under the guise of constructive legislative investigation.

Chattanooga Times (Dem.)—President Coolidge is unqualifiedly right in his protest against the proposed action of the Senate investigating committee when it undertakes to usurp the functions of the Executive and to unlawfully interfere with the orderly functioning of one of the most important departments of government.

Brooklyn Eagle—Congress has the right to investigate Government departments whenever it chooses to do so. But when it so chooses it must show plausible grounds for the undertaking. It has not shown plausible grounds in the case of Mr. Mellon.

Minneapolis Journal—Here is a strong indictment of the procedure of the Senate's other investigating committees, with their dead men's tales, their hearsay scandals, their roundabout gossip, their lethal stabs in the dark at reputations for which no defense is permitted. The country is as tired of government by investigation as the President.

Portland Oregonian—The President's message is far more than a defense of his authority against invasion by a co-ordinate branch of the Government. It champions the rights of the citizen against invasion by arbitrary, unconstitutional acts.






