Mrs. David A. Greenwood was born Oct. 10th, 1851 and died at her home near Seven Mile Ford on January 22nd, 1920, at the age of 68 years, 3 months and 12 days.

Her funeral was conducted by Rev. E. H. Copenhaver, was held at Ebenezer last Sunday morning at 11 o'clock, in the presence of a large congregation of sympathizing relatives and friends. Before her marriage to Mr. Greenwood, December 24th, 1883, she was Miss Eunice Melissa McGhee, of Seven Mile Ford.

HOUSE VOTES TO REFER SUFFRAGE TO PEOPLE.

Delegates' Action is Surprise Move

By a vote of 55 to 39, the House of Delegates yesterday afternoon voted to pass by at this session the question of ratification or rejection of the Susan B. Anthony Federal suffrage amendment and submit it to the voters of the State in a referendum.

This action by the lower branch was wholly unlooked for and followed almost four hours' argument for and against ratification of the resolution to pass by was as follows:

WAR NURSE FROM ARMENIA ASKS AMERICA'S AID

Soldier Husband and Battlefield Baby Touring Country With Her for Near East Relief.

A mother, father and daughter, the latter born in a tattered Red Cross tent in the icy Caucasus while guns roared all around and Turkish shells, ignoring the mercy emblem, burst near it, are touring America in behalf of their native Armenia. They are General Mezzop Nevton Azgapatian, his

wife, Lady Anne, and Irene Esther Araxie Azgapatian, whose baby eyes opened upon scenes of horror and later through them saw much of the sufferings of the people of Armenia.

The family are making their tour under auspices of the Near East Relief, the big organization which has saved hundreds of thousands of the people in that part of the world from death by hunger and cold and is soon to open a nation wide campaign for funds to complete the work of saving the survivors, more than a half million of whom must perish unless aid comes to them soon. America is their only hope.

General Azgapatian served gallantly in the Russian armies in the Caucasus against the Turks. His wife, who accompanied him to the front, did noble work for the wounded and sick, and it was while in this service that her baby was born in a hospital tent during a battle. An army blanket swung from two poles in one corner of the tent was

MATCHING WITS OF THE CANADIAN BORDER

Buffalo, Jan. 28.—Old tricks are being revived and new ones invented by smugglers who are matching their wits against those of the customs officers in an effort to bring contraband whiskey from Canada into the United States.

The tide of the whiskey movement which for more than two years flowed from the United States into Canada has turned back. Of the same smugglers who once took long chances to send liquor across the border into Canada now are attempting to evade the American instead of Canadian laws.

There has been a partial lifting of the ban in Canada. The ordering-council issued by the Dominion government in wartime which prohibited inter-provincial traffic in intoxicating liquor was rescinded on December 31.

Ontario still has a dry law prohibiting the sale of liquor across bars or in any way except by government vendor upon an order from a physician. This, Ontario law, however, cannot prevent interprovince traffic by mail and express. Consequently Americans who want to take chances with the customs laws have experienced little difficulty in having liquor delivered at the United States border.

REPUBLICANS MAY PUT MUNICIPAL TICKET IN FIELD

Virginia election laws came in for a strong attack last night by Delegate R. A. Anderson, of Smyth County, in a speech before the Republican club of Richmond at its monthly meeting at Murphy's hotel.

The requirements that a prospective voter shall have paid his poll taxes at least six months prior to the general election and that he shall be able to read and write were denounced as principles of an autocratic rule.

No such standards, he said were exacted when it became necessary for the nation to defend itself and fight the battles of civilization. The boy who could not read was required to show himself just as much of a patriot as the one who had enjoyed more of the privileges of education.

"The Democrats are afraid of the rule of the people," he charged. "We are standing for an enlarged electorate

and already have introduced at this session a number of bills with this in view.

The advisability of putting in the field at the next municipal election a Republican ticket was referred to the executive committee of the club, which will confer on this matter with the Republican city committee.

President Melvin Flengenheimer turned the chair over early in the meeting to Joseph P. Brady, clerk of the United States district court and prominent member, of the Republican party, who presided throughout the rest of the meeting and introduced the speakers. These included Senators, Parsons, Profit, Hassinger, and Pendleton and Delegate Garber, Fulton and Templeton, all members of the general assembly.

CALL FOR NEW DEAL

Reapportionment Bill Offered in
House by Republican Members

(Richmond Journal.)

Credit for the first move toward obtaining for the cities and counties legal representation in the general assembly is claimed by the Republican minority. Roland Chase, of Wise, and Robert A. Anderson, of Smyth, Republican members, have introduced in the house of delegates a measure calling for reapportionment of the senate and house districts, as required by the state constitution. This constitutional mandate has been ignored by the general assembly since 1912. Attention was first called to the situation by The Evening Journal last Monday.

Reapportionment of the state will result in Richmond gaining three more representatives in the house and one in the senate. Norfolk, Roanoke, Lynchburg and Newport News will also make gains, receiving the representation in the general assembly which has been denied them since 1912. The Chase-Anderson reapportionment bill gives Richmond only six members of the house, but it is believed the Democratic majority will so amend the bill as to give the capital and the other Virginia cities the representation they are entitled to by reason of increased population.

Provisions of bill, on the basis of the 1910 census, would provide senatorial districts in Southwest Virginia as follows:

1—Lee and Scott Counties; 2—Washington, Russell and City of Bristol; 3—Wise and Dickenson; 4—Buchanan and Tazewell; 5—Bland, Smyth and Wythe; 6—Patrick, Grayson and Carroll; 7—Giles, Pulaski and Montgomery Counties, and City of Radford; 8—Franklin and Floyd, City and County of Roanoke.

The House districts would be as

follows:

Lee County, one delegate; Scott, one Washington and Bristol, two; Smyth, one; Wise, two; Buchanan and Dickenson, one; Russell, one; Tazewell, one; Grayson, one; Carroll, one; Patrick, one; Floyd, one; Franklin, one; Montgomery and City of Radford, one; Wythe, one; Pulaski, one; Pulaski County, one; Craig, Bland and Giles, one; Roanoke County, one; Roanoke City, two.

URGENT NEED FOR CONSTITUTIONAL CONVENTION

The necessity for another constitutional convention is the subject of much comment in both houses of the legislature, and it is not at all unreasonable to suppose that some member will start a movement to this end before the present session is concluded. Criticism of the convention of 1920-2 is heard almost every day. Senators and delegates are unsparing in their condemnation of a constitution, which seems to require amending almost twice daily.

Amendment after amendment has been introduced into both bodies of the assembly, with no sign of abatement. One senator estimated the cost of advertising the amendments already introduced at not less than \$20,000.

Should the prevailing sentiment find expression in definite action, the procedure will be to introduce a bill submitting the question to the voters at the next election. If the people decide for the convention, the assembly of 1922 will fix a date for the election of delegates. This would probably be in 1923.

Senators who are thinking seriously of urging another convention, are of the opinion that twenty years is sufficient time to elapse before the constitution is overhauled, renovated and re-drafted to meet the rapidly changing conditions of the present day. The last constitutional convention prior to the one of 1901-1902 was held in 1869, but it is pointed out that more changes have taken place in the last twenty years than in the period separating the last two conventions.

STAGGERING COST OF GOVERNMENT OWNERSHIP.

Government ownership of railways has already directly cost the people of the United States nearly three billion dollars, or about \$150 per family. The railways collected in 1918 and 1919 an average of one billion dollars a year more in freight and passenger rates than in 1917. During the same two years the deficit paid out of the government treasury was seven hundred million dollars, which was necessary to make up to the railroads a net rental equivalent to the average net earning during the three year period to government operation. As compared with 1915 the loss to the people on these accounts during the two years was nearly five billion dollars. But of course that does not tell the whole story. Increased freight charges have contributed to increased prices of every commodity carried by rail. In addition to all this, tie, rail, ballast and car renewals have been reduced to the minimum, so that there is a serious car shortage in many quarters, and the railways have been hurried toward the junk pile. In all the history of politics and industry there is no parallel for the staggering waste and inefficiency which has accompanied government operation of railways and is the inevitable accompaniment of political control of any industrial enterprise.

PRECAUTIONS ARE URGED AGAINST SPRED OF FLU.

Disease Has Been Present In State Throughout Past Year, Subsiding Rapidly in Spring

Richmond, Va. Jan. 29.—Fresh outbreaks of influenza in widely separated parts of the country justify every individual citizen and community in Virginia in taking every sensible and reasonable precaution against the spread of the disease. Dr. Ennion G. Williams, State Commissioner of Health today declared. The State Board of Health has never ceased its campaign of prevention since the subsidence of the epidemic last spring and continues to reiterate preventive measures. It calls on every person to smother the cough and sneeze as the germs of influenza are transmitted from one to another by means of the drops or spray that have been sneezed or coughed into the air by an affected person as well as by taking into the mouth something that has been soiled by the spit of the sick person.

The Commissioner of Health urges the following program an every individual.

Ten Rules for Saving Yourself and Others.

Influenza is conveyed by the fresh secretions of the nose and mouth.

1. Avoid people who are coughing or sneezing.
2. Do not attend crowds or large gatherings indoors or outdoors.
3. Keep three feet from person talking.
4. When you cough or sneeze, cover your nose or mouth with a handkerchief, or turn your face downward.
5. Don't use cup or other eating utensils used by others without thoroughly washing and boiling it.
6. Don't put into your mouth fingers, pencils or other things that do not belong there.
7. Wash your hands before eating.
8. Eat plenty of simple, nourishing food.
9. Sleep and work in rooms filled with fresh air, but keep the body warm.
10. If you get influenza, go immediately to bed ward off pneumonia, and stay in bed several days after fever subsides to avoid subsequent weakness

571 "FLU" CASES IN RICHMOND; 1 DEATH.

Health Authorities in Capital Plan Drastic Precautions To Ward Off Epidemic

Richmond, Jan. 29.—One death from influenza and 287 new cases were reported to the board of health, swelling the total influenza cases to 571 and the deaths for the past two weeks to 4.

Health authorities are planning drastic precautions to ward off a possible epidemic. Plans have been made for the inauguration of "stagger" hours for work, and employers will meet tomorrow morning to prepare a schedule to reduce crowds. All hospitals have been ordered to prepare for

the emergency and a volunteer force of physicians and nurses is being recruited to combat the epidemic, should the situation get out of hand.

Richmond physicians have endorsed the use of whiskey in influenza treatment and the co-operation of the Prohibition officials in arranging a supply for medical purposes is being sought.
