May Day at Marion College

The beautiful weather, the beautiful flowers and the beautiful girls all combined to make the May Day Fete which was held at Marion College on Monday a very great success. The first view which the guests got of the College lawn was a beginning of the pleasures of the afternoon. The Queen's throne was erected on the first terrace and had in addition to the natural background of trees and shrubbery large banks of dogwood. The platform and throne were covered with the colors of the Senior Class and were decorated with white and purple lilac. The large audience was tense with excitement waiting for the appearance of the May Queen when the Senior procession began. Twenty members of the Senior Class came across the wide sweep of College lawn carrying large bunches of lilacs. Their dresses of different shades of crepe were very attractive, and color scheme adding greatly to the beautiful tableau. The Senior procession apparently brought Spring right into the hearts of the on-lookers. Mary Cox, Mary Caroline Jennings, Alice Claudia Culbert, Elliott Lee Coyner acted as flower girls and scattered posies over which the May Queen walked. Miss Hazel Neff, of Rural Retreat, was Maid of Honor. Her dress was of lavender satin and was made in a charming and becoming style. Following the Maid of Honor Miss Audrey Fritts, of White Post, who had been chosen May Queen by the Senior Class, entered gowning in white satin carrying a large bouquet of white roses. Her train was carried by Helen Greever Copenhaver and Margaret Trimble King, who were the pages for the procession.

The Queen ascended the throne and the Maid of Honor placed on her head a very handsome crown of peonies. From her throne she watched in a most queenly manner the succession of folk dances which were done in her honor, the first to pay homage to her being the children of the music class of the College whose Peeka-Boo dance was very pretty. The Swedish Clap Dancers dressed in their quaint costumes of red and black were the first in the list of the folk dances, and they set the standard for grace and beauty which was carried out throughout the entire program. The Ribbon Dance was one of the most effective of the dances, the twelve girls who took part in the dance were dressed in yellow. As they wound in and out with their yellow ribbons keeping perfect time to the rhythm of the music, the audience was delighted with their grace and beauty.

The Japanese maids who followed tripped in a truly Japanese fashion. Their Japanese kimonos and umbrellas added to the realism of their dance. All characters had been selected carefully and the Japanese maidens were chosen from the dark haired girls at the College.

The Spring Dance and the Wreath Dance which followed were both charming and were probably the most difficult in the group of dances. They were done with a grace which was the result of the year's training under Miss Anglin who had charge of the presentation of the May Day Pageant. Miss Anglin arranged the pageant and trained it also. Following the Wreath Dance, the entire group gathered around the throne and did obeisance to the Queen before they began the winding of the May Pole which was the grand finale of the evening.

The costuming of the entire caste was under the direction of Miss Bortz of the Household Economics Department of the College. Miss Kerrick who has contributed greatly to the success of former May Day Fetes by having charge of the music played for all of the dances.

Why is it that Democratic politicians and their radical allies resort so customarily to personal defamation, the weapon of small minds, as a campaign expedient?

The spectacle now being staged in Washington as a curtain raiser for the 1924 campaign is not unprecedented. Four years ago Democratic politicians were using the same methods. Candidate Cox seized as his paramount issue early in the campaign the theory that the Republicans had raised a "slush fund" which he estimated at from eight to twenty-five million dollars. Investigation of his charges by a senatorial committee bore out none of his wild assertions, but it did disclose "slush fund" operations by Candidate Cox himself in his home city of Dayton which caused him to suddenly drop that issue and begin to talk about something else.

Another side issue of that same campaign is well remembered. The notorious Dr. Chancellor was procured to broadcast infamous charges against the racial integrity of Senator Harding.

The effect of this sort of campaigning was not just what was expected. Mr. Cox ran a mud campaign and his name was mud after the election was over.

The same type of politician has begun the same sort of campaign in 1924, just where it left off in 1920. Taking as the sole basis for their outcry the offense of a single ex-official, they have been busily engaged in trying to make the people think that the government at Washington is rotten from the President down. How small a basis for such reckless accusations, based upon gossip, rumor and innuendo.

The hypocrisy of these chief accusers is evidenced by the fact that while making pious outcry against the wrong-doing of Secretary Fall, they have openly defended as entirely worthy of a presidential candidate of their own party, retirement from the cabinet of his father-in-law by Secretary McAdoo to take huge fees as a prosecutor of claims against the government by corporations, and efforts to affect the relationships of our government with Mexico. This includes not only the hard-boiled Democratic bourbons, but the railroad brotherhood politicians whose Washington publication has been screaming against "big biz" every week for many months.

The Senate has rung for weeks with the most reckless, irresponsible and personally defamatory speeches that have ever been heard in either house of Congress. The cheapest gossip, the most preposterous slanders, the most distorted misrepresentations of motives ever resorted to in a legislative body have been bandied about to the disgust and even horror of millions of Americans, who have been astounded that debate in a national legislative body could sink to so low a level.

This libelousness has been carried on by a few senators, it is true, but their Democratic colleagues have by their silence given consent and even approval to such tactics. It reached its climax in the effort to connect President Coolidge with the oil scandal on the basis of two telegrams of courtesy, bearing no relation to the subject of inquiry, to a Washington publisher whose name has been connected with the scandal through the effort to use him as an "alibi" by Senator Fall when asked to account for the receipt of the \$100,000 it developed he had actually borrowed from Doheny.

When protest was made in the Senate against the effort to impugn the honor of the President on such preposterously flimsy grounds, the reply was made by one of the Senate he-gossips that Woodrow Wilson had been bitterly assailed by Republican senators and leaders generally during his life-time. But it is not true that at any time was an effort made by Republican leadership in the Senate or elsewhere to raise a question as to the personal integrity of President Wilson. Efforts were made to interest the Republican management in a personal attack on President Wilson in 1912 and in 1916, but Republican speculators personally and politically close to the administration would have none of it. No Republican hefted arose when it was disclosed that a leak from the White House relative to an impending message had enabled speculators personally and politically close to the administration, to clean up huge profits in the stock market, to say that President Wilson must have been personally interested in the speculation, and to suggest that his secretary be called to find out if that were not true. There is a distinction known to men of dignity and honor, between attacking a man politically and attacking him personally.

Republican senators have been criticized for their failure to meet and repel the attacks made by Democratic senators of the Haffin-Caraway type. There is this to be said in extenuation, that it is impossible to engage in that type of controversy on the floor of the Senate without the loss of dignity and self-respect. There has been opportunity for utterances, pitched on a high level, calling the Senate back to its high traditions, which has not been entirely overlooked. It is undoubtedly true that in the mud-slinging game Republican leadership is out-classed, but perhaps no matter what the temporary advantage of such a situation may be, in the long run the urge to decency may not be a liability.

A study of the history of American politics proves that mud-slinging has seldom, if ever, paid the party or the individual indulging in it. Jackson, Lincoln, Garfield



FARMS USING RADIO NEAR 150,000 MARK

Survey Reveals Its Value in Agriculture—Stations Broadcast Special Farm Information.

The rapidly with which radio has spread in farming communities is revealed by a recent survey made by the United States Department of Agriculture. County agents estimate that there are approximately 40,000 radio sets in 700 counties. This is an average of fifty-seven sets per county. Applying the average to 2,850 agricultural counties, a total of more than 145,000 sets on farms throughout the country is estimated. The survey covers every state in the Union.

Radio broadcasting stations, and there are now about 600 licensed stations in the country, devote part of their programs to the interests of the farmer. WGY, the General Electric Company's station at Schenectady, N. Y., reads daily produce market quotations, weather reports and gives out other information of value to the farmer. During the month of July a special harvest weather report was sent out each noon, and Arlington time signals are broadcast daily at noon.

A new feature of interest to farmers has just been announced by WGY. On the last Monday evening of each month there will be a special talk on farm bureaus and farm information, which will be given from 7:15 to 7:45 o'clock, eastern standard time. This has been arranged in co-operation with the New York State Farm Bureau Federation.


That the farmers appreciate the broadcast reports is daily brought to the attention of the management of WGY through letters. H. A. Williams, living on R. F. D. No. 1 Bethel, Vt., recently wrote as follows: "I beg to advise you that your weather forecasts are valuable to a farmer just as much as they enable us to govern our harvesting movements more successfully than we could do if we did not have a general idea of weather prospects. Your reports give us from 24 to 36 hours advance information. We appreciate the benefits we receive in this way."

Lynn Brown, a farmer at Roseboom, N. Y., wrote: "We are farmers and greatly enjoy your program. We also like the weather report as it keeps us informed as to the weather for haying. This is especially important when help is scarce and the radio weather report helps out a lot."

FARMING BY MOTOR

Churn Is One of Modern Farm Devices That Has Been Electrified.

When grandma and grandpa started housekeeping on the old farm, young and lusty in years, it didn't seem such a terrible job to churn four or five gallons of cream, working the handle of the churn up and down, with the cream getting stiffer every minute. But as time went on and the multitude



When Electricity Makes the Butter of other farm chores piled up the churning frequently became one more muscle-acher, the prospect of which didn't always bring smiles.

There are farms today where ham churning is never known. Butter is produced in large quantities and in quick time, with unflinching regularity but no muscles feel any the stiffer for it. The secret lies in the presence of that little black motor that takes care of all the muscle work and never grows tired or feels used up after hours of work.

The electric motor has entirely altered the aspect of this particular chore, as it has also done in the case of many other farm duties, some of them much heavier than that of churning. The electrified farm can take full advantage of this ingenious arrangement, which helps to save time and thereby make the farm family's family of leisure. And someone has defined leisure as being simply "time to live."







ELECTRIC IRRIGATION HELPS WESTERN FARMS

Provides Artificial "Rainfall" Whenever Needed for "Basic Industry" of Agriculture.

Progress in agriculture, particularly as applied to the western farmer, is symbolized by one thing, prosaic enough in itself—the irrigation ditch. The farmer no longer blames the weather for crop failures, and "hopes

for better conditions next season." Nowadays, if the rainfall does not suit him, he produces his own rainfall by a twist of the wrist, or the push of a button, in exactly the quantity he desires, and at precisely the time it is needed. Furthermore, he puts it on the particular piece of ground which he wishes to cultivate.

The application of electric power to irrigation, through the rugged electric motor, has simplified and economized the process for the farmer,

especially the farmer with small holdings. What electric power can mean is evident when it is realized that agriculture is a great "basic industry"; that hard times invariably follow crop failures; that irrigation is the solution of the western farmer's problem; and that electric power for irrigation pumps is making irrigation easier, more efficient, more reliable and less expensive.

It has been found, incidentally, that in most cases the farmer wants to install too large an irrigation system. The ideal plant is the one that operates continually and has a storage reservoir so that a large, expensive pump is not needed.

When a small installation of this sort is at work, with a storage reservoir capable of holding all the water

pumped over a period of twelve hours, the plant could be run all night, and in the morning the farmer would find a full reservoir, from which he could water his land as needed through the day; and at night the reservoir would be empty, thus completing the cycle.
