What will they call him after he presides, in all probability, over their convention at Lynchburg? At any rate ABE will be a conspicuous man in their convention. He runs their meeting at Abingdon, and he is an individual who will rule or ruin. The Funders are welcome to all such.

The Funder candidates are basing their hopes for election on the support of Readjusters. They know their party is in a hopeless minority, and only through a division in the ranks of the Readjusters is there any prospect of a Funder victory. THE EXPIRING AGONIES OF FUNDERISM.

Should we begrudge the poor deluded and defeated party of corruption the only pleasure it has in its moments of expiring agony. Verily not! Like the starved and thirsty traveller on a vast desert, who with deluded vision can see just before him inviting fields of fruits and flowers and springs of living waters that cannot be reached or partaken of, so does Funderism, with its "ruling passion strong in death," now look out into the future, with beclouded reason from long waiting and optical illusion that comes from intense desire and see the political field rich with fat offices and streams flowing with plentiful, refreshing waters, whose source is the treasury—all of which Funderism is eager soon to occupy and enjoy.

Funderism, that has so long in Virginia turned its brazen front directly in the path of progress and sought in every way to curtail the personal liberties of our citizens, now shouts over what it calls "Democratic prospects." What this means as to the Union we will not undertake to say; but as to its meaning in connection with our own State and its internal affairs the people can well understand and appreciate. It means the expected restoration to power of a faction, call it party if you please, that while hiding its deformities under the sacred garb of Democracy, has violated every principle of sound Democracy and Republicanism. It means that Funderism intends under its former false cry of "Democracy" to try to secure the confidence once more of the people of Virginia, obtain possession of the State government, institute again its policy of feeling Brokers and Bondholders at the expense of the people, and undo all that Readjustment has done to relieve us from the burdens of taxation.

Funderism would now try to make the people believe that it is the friend of personal liberty; but confronting this pretended friendship stands free suffrage to accuse and convict insincere Funderism. Talk about a party being the advocate and friend of "the personal liberty of the citizen" when that party tries to restrict the use of the ballot and give suffrage to only a "preferred class" of citizens! Talk about the Democracy of a party that would oppress and ruin the producing class of citizens in the interest of foreign syndicates and bondholders! Talk about the Democracy of a party that appeals to Federal Courts, asking them to take charge of the financial affairs of our State. Does such a party want "the States to control their own domestic affairs so as to escape the danger of centralized government?" Is the party that threatens with the decrees of Federal Courts, that are to be enforced by the strong arm (the military) of the Federal government, Democratic or friendly to the people? If so, God save the people from such Democracy and such friends! Is a party Democratic that denounces corrupt lobbies in National legislation and that protects and fosters them in State legislation? Is the party sincere that declares "that sectional feeling shall pass into the grave of infamy and oblivion," and yet appeals to the prejudices of race and condition, and tolerates, alone, the citizens of certain sections who worship at the shrine of Bourbonism? Is a party progressive and non-sectional that wheels into line upon the dead sectional issues of the past? Surely not! Funderism, Democracy so-called, in Virginia is just such a party. The people grew tired of it and cast it out of power forever. "The people were tired of a party that so long lived upon prejudices, and preyed indiscriminately upon their rights, liberties and properties." The people will have no more of a party that would deprive our citizens of free suffrage, would keep the children of the land in degraded ignorance to feed the hungry SHY-LOCKS, and that would hold as a cardinal principle, "a preferred class of citizens shall control everything."

WILL it not be in order for the Funders to abuse the Court of Appeals for its decision in the HOLLADAY mandamus case? But what cares the Court of Appeals for the abuse or applause of the Funders. The court is composed of Readjusters; but they are men who can rise above politics and give something else than partizan decisions.

The brothers Morris have been convicted in the Circuit Court of Nicholas county, West Virginia, of the murder of a man named Henson, and sentenced to the penitentiary for fifteen years. The American Institute of Mining Engineers will meet this year in Lynchburg, and after the transaction of their business will fully examine the resources, mineral and otherwise, of the James River valley. The Winchester Times says that Mr. Tebs, Chichester, who went out West several months ago, has returned thoroughly satisfied that the Valley of Virginia is superior to any part of that much vaunted country. Norfolk Landmark: A shrewd man in Chicago make a fraudulent sale of English lands to a British syndicate, and this State is enjoying the honor and responsibility of the operation in the columns of certain English and American newspapers. Monday a murderous attack was made in Lovings-ton, Nelson county, by Ferborn Woody on John E. Powell. It grew out of Powell's agency in the commitment of Mrs. Gardner to jail last week for the alleged murder of her infant grandson. The Situation at Wesson and Beauregard, Miss. NEW ORLEANS, April 30. - The Times-Democrat's Wesson special says: "William Blackburn, aged fifty five, died of injuries received during the cyclone. The other wounded are generally doing well. The Red Cross Society is doing noble service for the relief of the sufferers. The Relief Committee at Beauregard will continue to supply the immediate necessities of those in the city limits until the funds on hand are exhausted, when the Red Cross Society will take charge of the relief work there. The Wesson mills are running regularly, and a large force is rebuilding the destroyed houses on Peach Orchard street. The Red Cross Society acknowledge the receipt of additional contributions and supplies. The committee sent to ascertain the damage in Lincoln county in the path of the cyclone report thirty seven families in distress, their property having been swept away. Crowds of citizens of Beauregard can be seen setting on dry-goods boxes apparently unable to act for themselves. The worst is now over, and the resumption of business at Beauregard will be at no distant day." The Times-Democrat's Jackson special says that Colonel J. L. Powers, Grand Master of the Odd Fellows and Grand Secretary of the Masons, has received to date for the relief of the sufferers by the cyclone: From the Masons, \$538; from the Odd-Fellows, \$265; from the American Legion of Honor, \$20; from the Knights of Pythias, \$50; from citizens and various committees, \$618; all of which has been distributed at Beauregard, Wesson, Rock Point, Westville, Morton and French Camp.
