We publish in this issue a letter from one of the best citizens of Montgomery, one of the most influential Readjusters of that county, which corroborates our views in a measure. We have received, and been shown many letters of a similar character. It is advisable that there should be no difference of opinion in the party as to who should be the candidate, and there should be no dissensions when he is selected. We have expressed a preference for BLAIR, from the fact that we believed he would prove the strongest candidate, all things considered, and because we thought he deserved to be honored for the brilliant fight he made for the people last fall. Most of the Readjusting papers of the district have agreed with us in our choice, for the same reasons. But if any other man is selected by the party as its candidate, we shall accord him a hearty support. Let there be unity of sentiment, and unity of action, and all will be well.

INDEPENDENT THINKERS AND WORKERS. If it had not been for the independent thinkers, instead of this being a comparatively civilized, enlightened and liberty loving world, it would be one wrapped in the dark clouds of superstition, ignorance and serfdom. The independent thinkers and doers have made the theology of the world progressive and liberal. In all branches of science men of independent thought and action have brought from chaotic confusion facts and truths, so plainly demonstrated that all who desire light can find it. In the political world, all that we now possess and enjoy that is good and true has resulted from the bold positions taken by liberal, independent thinkers. If a pure theology, if a noble and useful school of science can turn with pride to those independent minds that have done so much for them, how much more gratefully can freemen turn their admiring gaze toward those bold spirits who have relieved such a large portion of the human race from autocratic rule, and guided their footsteps to the gushing fountains of happiness found in countries where constitutional freedom is guaranteed all men. The right to think and act for himself in affairs of State or politics is the greatest boon enjoyed by a free son of America. Any party or policy that infringes upon this right is an enemy to constitutional liberty. The application of the party lash is a disgusting means for securing party success. The motto, "my party, right or wrong my party," is a foolish and enslaving one. In matters of religion men are allowed

to be guided by their own consciences and by reason. In matters of science they are treated with the same liberality. Then why may not they be allowed the privilege in this land of freedom of acting and thinking for themselves in political matters, and without the application of the party whip? A dominant party that has the controlling influence in the land, and that may threaten to visit social, political and business proscription upon those who choose to differ in conviction with the controlling element, is a cancerous growth upon the body politic, and the sooner it is destroyed the better it will be for the country.

"I now favor a vigorous application of readjustment principles to the National debt." So writes Capt. Frank S. Blair, of Wytheville, to a friend in Pulaski, and on this statement he asks to be sent to Congress from the Ninth District. If this letter be genuine, Capt. Blair will merit and get a fair share of public opinion for awhile. In order to kill readjustment—"to put it in its little bed"—it would only be necessary for all leading Readjusters to endorse it. As for the Bristol News it emphatically and at once announces that it cannot put any such plank in its platform.—Bristol News.

Why, Bro. FOWLER if readjustment is right in connection with our State debt, it would surely be right in connection with the national debt. If the people of the Union have been cheated and defrauded by an unjust change of the contract on which the bonded debt of the government is based, would not any good Readjuster feel constrained to favor the application of the principles of readjustment to the National debt; so as to restore to the people the right of which they have been defrauded? The very change of the contract was the cause of the origin of the Greenback party. You know, as well as any one, Bro. FOWLER, that the character of the U. S. bonds have twice been changed; that they were originally made payable in currency, by subsequent legislation made payable in coin, and then, by the villainous legislation that demonized silver, made payable in gold. By such legislation the people were defrauded, and the bondholder reaped rich bounties. Every greenbacker in the district two years ago was bold in denouncing this wrong. Even Col. RICHMOND, who was supported by the News, was loud in his denunciations of it.

Capt. BLAIR's position is no new one. It was advocated by every greenbacker in the State, even Jno. W. DANIEL, if we mistake not, favored it.

To be consistent the Readjusters of Virginia will be compelled to favor a return to the original contract under which the bonds of the U. S. were created. Capt. BLAIR is a Readjuster, and we have no doubt but that he will be selected as the candidate of the party of this district for Congress and that the Convention which nominates him will adopt a platform that will be in keeping with the great principles of readjustment, one that BLAIR can stand on.

Letter from Missouri.

SHELBYNA, MO. April 19th, 1880. EDITOR PATRIOT AND HERALD.—If you deem the few lines I shall write worthy of publication give them a place in your valuable paper. Times are flourishing here. Every thing is in a "boom," except corn, which is selling at 18 to 20 cents per bushel. Land has advanced 25 per cent. in the last three months. Three hundred sales of land have been made in Shelby county within that time. Immigration to Mo. is now very fast and considerable. Horses and mules are higher than they have been for several years. The fruit crop will be large if it is not damaged after this writing. Wool is worth, unwashed, 35 to 40 cents per lb. Cattle are very high, and fat hogs are worth \$4 per cwt. There has been a great demand for farms by renters this spring. Most of the farmers are done planting corn. We have had a fine spring for farm work. Very little rain has fallen since last fall. Wheat is now suffering for rain. The past winter was a very warm and open one with us, very little snow fell, and not much ice was put up. The bees nearly all died during the winter. Last summer was so dry that they could not gather sufficient stores to carry them through the winter. Last year's tobacco crop has all been sold. It brought from \$3. to \$8, per hundred. The health of the country has been generally good. Mrs. Fannie Jacobs, daughter of T. J. Byars, Esq., formerly of your county, died at her residence in Monroe county, Mo., a few days ago. There is more money in this State now than there has ever been. Hendricks, of Indiana, is very strongly spoken of out here for President. We would like to have a Western man for our next President, but we will be satisfied with a good Democrat. We want a strong man to beat the Radical party.

KALLOCH'S REVENGE. The Son of the Mayor of San Francisco Kills Charles De Young. SAN FRANCISCO, April 24.—Just before eight o'clock this evening, Charles De Young entered the business office of the Chronicle on the ground floor corner Learney and Bush streets, and stood talking with some gentlemen, leaning against the counter. Directly the door opened J. M. Kalloch entered, and drawing a pistol without, as far as can be learned, speaking a word, began firing at De Young. The latter ran through the gate of the counter to the desk inside, Kalloch firing at him as he ran. On reaching the desk, De Young turned face to face with his opponent with a pistol in his hand, when Kalloch leaning over the counter, firing again, the ball striking De Young in the month. Kalloch then started for the door, and De Young raised his pistol as if to fire, but his strength failed him, for the pistol was not discharged, and sinking backwards, he fell on the floor. Bystanders ran to his assistance, but the ball had evidently pierced the base of his brain, and in a few moments he expired. As Kalloch ran out of the door, he was seized by a citizen and at the same moment an officer came up and took him in charge and conducted him to the city prison, where he was locked up. The news of the murder flew through the city like the wind, and in a few moments the street in the vicinity of the Chronicle office was

crowded with people eager to learn the particulars of the affair. Policemen were at once stationed at the doors of the office to keep out the inquisitive crowd, and only a few personal friends and reporters were admitted in the rear office. M. O. De Young, brother of the deceased, reclined on a lounge surrounded by friends, evidently overcome by the tragedy, but with dry eyes and his voice calm. He was not present at the time of the shooting, having left home after dinner a few minutes later than Charles. The deceased on his back on the floor, his face and breast dabbled in blood, his eyes closed, and his face bearing a calm expression as if as noticeable in case of those dying from shot wounds. Only one wound found on his person although at least four shots were fired by Kalloch, two having pierced the glass door and partition of the office and the third lodging in the window case.

The Lynchburg Virginian says: "In pursuance of an act of the last Legislature, the citizens of our neighboring town of Madison voted Thursday on the question of abolishing the corporation. The vote resulted as follows: Against the corporation, 96; for the corporation, 64. The corporation is abolished, and Madison has glided back to the old order of things.

On account of the absence of several of the attorneys who practice at this bar, occasioned by the illness of themselves or friends, but very few litigated cases have been disposed of. The court has been a dry one, and attended by but very few persons.

Quarterly Meeting.

Next Saturday and Sunday the second quarterly meeting for Marion Station, M. E. Church South, will be held in the church at this place.

Senator Grover is gradually improving. His difficulty is cerebral and spinal inflammation.

Further Details of the Western Cyclone.

St. Louis, April 21.—A special from Marshfield says: seventy-one victims of Sunday's storm have been buried, and twenty-five or more are in a dying condition. The number seriously wounded is about one hundred and fifty. A babe about eighteen months old, whose mother was killed, and whose friends were all wounded, was found on the 19th instant in a ravine north of the town where it lay all night. It is now doing well. Another child, two years old, was found on the afternoon of the 19th in a tree-top, where it had been nearly twenty-four hours. It was considerably bruised but will recover. It was claimed yesterday by its parents, who live two miles and a half from the southern portion of the town. The child's aerial flight therefore, must have extended over three miles. A wagon has been found that was carried four miles by the wind, and a section of the smoke-stack of a mill that was carried three miles and a half. It is reported that from thirty to forty persons have been killed by spurs of the tornado in the country, and that the town of Corsicans, in Barry county, is as badly wrecked as Marshfield.

St. Louis, April 21. Dispatches just received say the storm of Sunday night was very severe in Morgan county, its track being strewn with demolished houses, barns, and other property. The little town of Barnettsville was torn nearly to pieces, and several persons were killed and wounded.

It is now understood that in Webster county, of which Marshfield is the county-seat, fully one hundred people were killed and over two hundred wounded. The loss to property in the county is estimated at \$1,000,000.

ANOTHER TOWN DESTROYED.

ST. LOUIS, April 21.—The latest advices from Texas county, Mo., say that the town of Lieking was entirely destroyed, with the exception of three houses, by Sunday night's storm. Three hundred persons are homeless, one life lost, and seven persons wounded—five of them seriously. The tornado did immense injury to all kinds of property in the county.

THE STORM IN ARKANSAS.

LITTLE ROCK, April 21.—Advices from Fayetteville report that the storm of Sunday night was unprecedentedly severe. It destroyed a large number of buildings, lifting some of them bodily into the air and tearing them to atoms. Quite a number of persons were injured. The storm prevailed with great severity as far south as Jefferson City.

EUROPE.

LONDON, April 24.—On the return of Mr. Gladstone to London he was met by Granville, Hartington and W. P. Adam. Adam informed a press representative that Gladstone had undertaken to form a cabinet. It is said that Mr. Gladstone kissed the hands of the Queen on his appointment as First Lord of the Treasury and Chancellor of Exchequer. Mr. Gladstone found it difficult on his return to London in making his way through the enthusiastic crowd. It is confidently anticipated that Mr. Granville will be foreign minister. Mr. Gladstone received a perfect ovation at Windsor. He spoke from a window of the railway carriage, thanking the people for their kind greeting. A Bombay special says there is no truth in the reports of the death of King Theebau or of the massacre at Mandalay.

Brigandage continues to flourish in Mexico. Several particularly daring attacks have lately been made upon unfortunate travellers. A diligence proceeding from Toluca to the City of Mexico was stopped near El Llano de Salazar by a troop of fifty bandits mounted and armed to the teeth. The fact that the robbers molested none of the passengers save two, who were carrying very large sums of money shows that they were apprised of the character and quality of the travellers and their baggage. Another band pillaged the town of Huejotzingo, killing many of its inhabitants. A similar raid was recently made on the village of Amajac the place being completely sacked and everything of value borne away by "Kings of the Mountains" upon the backs of eighty mules.

In an interview published in the Chicago Journal Friday, Hon. Thomas A. Hendricks says he will not allow his name to be used in connection with the vice-presidency this year; that four years ago, unexpectedly and without consultation, he was elected to the second place on the presidential ticket, and in duty to his party accepted, but now he had a chance to express his views on the subject beforehand. He does not consider the office of Vice-President very attractive to a man who is or has been a United States senator.

According to the Chicago Tribune the practice of serenading newly-married couples, which prevails to such an extent in country districts, is becoming a rather dangerous one. In Illinois, a few days ago, one of the serenading party was shot dead by the bridegroom, and at Manitowish, Tuesday evening three serenaders were quite seriously injured by bullets from a shot-gun in the hands of the bride's father.

Major Reno wants to be reinstated in the army. He claims that he has given the best years of his life to his country, and some of his indiscretions, to put it mildly, should be overlooked. Cheeky fellow the major.

A tramp was put to work cutting the grass in a graveyard at Decatur, Ala. He soon abandoned the job, and declared that a young woman in one of the graves had warned him not to disturb the grass over her. What convinced the neighbors of the man's truthfulness was the fact that he gave the name of the grave's occupant, though there was no tombstone to convey the information, and he was a stranger in those parts.

Mr. Puleston, M. P. and Gen. Baile, United States Consul General at London, arrived in New York last Wednesday night in the Cunard steamer Bothnia.

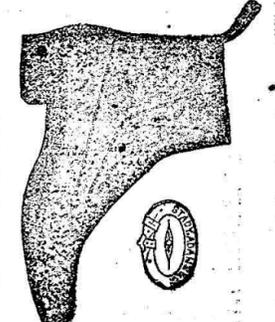
